ORDER

WHEREAS the appeal of Basantapur Physical Education College, Dumkal, Murshidabad, West Bengal dated 23/11/2015 is against the Order No. ERC/7-194.8.3/B.P.Ed./ERCAPP1676/2015/35666 dated 26/09/2015 of the Eastern Regional Committee, refusing recognition for conducting B.P.Ed. course on the grounds that "Show Cause Notice was issued to the institution on 17/12/2013, 12/02/2014 and 22/03/2015. No reply to Show Cause Notice dated 22/05/2015 has been received till date. In view of above the Committee decided as follows: Recognition to the institution is refused."

AND WHEREAS Sh. Nazrul Islam, Administrative Officer, Basantapur Physical Education College, Dumkal, Murshidabad, West Bengal presented the case of the appellant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the reply to Show Cause Notice dated 22/05/2015 was submitted earlier in response to uploaded minutes of 187th Meeting of ERC, NCTE in its website vide our Memo No. 107 dated 14/05/2015 as such Recognition to Basantapur Physical Education College may not be refused."

AND WHEREAS Appeal Committee noted that a Show Cause Notice (S.C.N.) was issued to the appellant institution on 22.05.2015 on grounds of failure to furnish C.L.U. for all plots and non-submission of Non Encumbrance Certificate. The appellant during the course of appeal hearing furnished evidence of having sent a reply to the above S.C.N. even before it was actually issued. Appellant noted the decision taken by E.R.C. to issue a S.C.N. from the website and furnished reply through speed post on 15/05/2015. As evidence the appellant furnished copy of the Speed Post receipt and the reply sent to E.R.C., Bhubaneswar.

AND WHEREAS Appeal Committee, having considered the submission made by appellant and the documentary evidence furnished, decided to remand back the case to

E.R.C. for consideration of the reply dated 14/05/2015 to S.C.N. furnished by the appellant. As the letter dated 14/05/2015 was not found available on relevant file of E.R.C., the appellant is required to furnish a copy of the reply to E.R.C. within 15 days of the receipt of Appeal Orders.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to ERC for consideration of the reply dated 14/05/2015 to S.C.N. furnished by the appellant. As the letter dated 14/05/2015 was not found available on relevant file of E.R.C., the appellant is required to furnish a copy of the reply to E.R.C. within 15 days of the receipt of Appeal Orders.

NOW THEREFORE, the Council hereby remands back the case of **Basantapur Physical Education College, Dumkal, Murshidabad, West Bengal** to the **ERC, NCTE**, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Sunrise College of Education, Chhatarpur, Madhya Pradesh dated 30/11/2015 is against the Order No. WRCAPP3295/B.A.B.Sc./232nd/MP/2015-16/153353 dated 30/09/2015 of the Western Regional Committee, refusing recognition for conducting B.A.B.Ed./B.Sc.B.Ed. course on the grounds that "the institution has submitted online application without No-objection Certificate issued by the affiliating body, Regulation 5(3) of NCTE Regulation, 2014 mandates that the application shall be submitted online along with processing fee and scanned copies of required documents such as No-objection Certificate issued by the concerned authority, Since the institution has not submitted the NOC, hence, the application be rejected."

AND WHEREAS Sh. Mahendra Pal Singh, Secretary and Sh. Ratan Singh Yadav, Teacher, Sunrise College of Education, Chhatarpur, Madhya Pradesh presented the case of the appellatant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the jurisdiction changing of affiliating body from Central University, Sagar to Maharaja Chhatrasal Bundelkhand University Chhatarpur is under process. Due to this reason we got required NOC late. Copy of NOC is attached herewith."

AND WHEREAS Appeal Committee noted that the appellatant institution submitted online application on 30.06.2015 and hardcopy thereof was received in the office of W.R.C. Bhopal on 13/07/2015. Appeal Committee further noted that appellatant institution has failed to furnish N.O.C. of the affiliating University alongwith online application as well as with the hard copy of the application. Though Regulations 5(3) mandates submission of scanned copy of N.O.C. alongwith online application yet NCTE had issued directions to all Regional Committee offices that 15.07.2015 should be last date for submission of hard copy of the application alongwith N.O.C irrespective of the date of online application.

The appellant institution has not furnished N.O.C. to W.R.C. at all and submitted a copy of N.O.C. alongwith its Appeal Memoranda dated 30.11.2015. Appeal Committee keeping in view that the appellant institution has failed to furnish N.O.C. alongwith hard copy of the application even within the extended period, decided to confirm the refusal order dated 30.09.2015 issued by W.R.C., Bhopal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 30.09.2015 issued by W.R.C., Bhopal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of S.R. College of Education, Khureri, Gwalior, Madhya Pradesh dated 02/12/2015 is against the Order No. WRC/APP2835/225/232nd/2015/153785 dated 07/10/2015 of the Western Regional Committee, refusing recognition for conducting M.Ed. course on the grounds that "the institute has submitted the printout of the application after 15 days of the submission of the online application. Regulation 7 of NCTE Regulations, 2014 mandates that the printout of the application should be submitted within 15 days of the submission of the online application. Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS Sh. Ajay Chaudhary, Secretary, S.R. College of Education, Khureri, Gwalior, Madhya Pradesh presented the case of the appellant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the appellant submitted the printout of the online application on 17/06/2015. That, the principles of natural justice also requires that WRC ought to have considered the recognition of appellant as the appellant fulfils all the norms of NCTE, but instead of doing the same, WRC (Regional Committee) ordered for rejection of application, which is contrary to factual and settled legal position and the same deserve to be set aside by this Hon'ble Authority. That, it was obligatory on the part of Regional Committee. The appellant deserves to be granted opportunity of personal hearing in the matter before deciding the appeal. Appellant shall put forth other grounds at the time of said hearing."

AND WHEREAS Appeal Committee noted that appellant institution submitted online application for M.Ed. course on 30.05.2015 and hard copy thereof was received in the office of W.R.C., Bhopal on 22.06.2015. Appeal Committee further noted that NCTE had issued directions to all Regional Committee offices stating that 15.07.2015 shall be the

last date for submission of hard copy of application alongwith N.O.C. irrespective of the date of online application. Committee noted that hard copy of the application was submitted well before the cut of date of 15.07.2015. Committee, therefore, decided to remand back the case to W.R.C., Bhopal for further processing of the application.

AND WHEREAS After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case for further processing of the application.

AND WHEREAS After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to WRC for further processing of the application.

NOW THEREFORE, the Council hereby remands back the case of S.R. College of Education, Khureri, Gwalior, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Rambha College of Education, Jamshedpur, Purba Singhbhum, Jharkhand dated 27/11/2015 is against the Order No. ERC/7-197.9.49/ERCAPP3090/D.El.Ed./2015/47870 dated 16/11/2015 of the Eastern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "the date of application through online is 30/05/2015 and date of dispatch of printout of online application is 26/06/2015 i.e. after 15 days of submission of online application. In view of the above the Committee decided as under: The application of the institution is summarily rejected as per clause 7(2)(b) of NCTE Regulation 2014."

AND WHEREAS Sh. Manoj Kr. Singh, Sr. Advisor & Sh. Gourav Kr. Bachan, Secretary, Rambha College of Education, Jamshedpur, Purba Singhbhum, Jharkhand presented the case of the appellant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "As per NCTE instruction the institute has to take NOC introducing D.El.Ed. course also along with B.Ed. NOC and for that there are two separate authorities to issue NOC of these two courses. We obtained the NOC of B.Ed. from Kolhan University, Chaibasa within a week but for D.El.Ed. we had applied to a concerned authority i.e. Director Primary Education Ranchi (Govt. of Jharkhand) but the same is still awaited. b) Most of the institute tried to cover all relevant documents before filing of online application form so that there will not be any deficiency while filing the form and submitting it properly so we also thought the same to submit the form with all proper authenticated documents especially the NOC and so we submitted on 30/05/2015 last day of filling application form and on the same day we got a notification from NCTE, New Delhi through reference date 30/05/2015 along with 27/02/2015 that the date of filling application extended to 30th June, 2015 and till date i.e. on 30/05/2015 we didn't get the NOC of D.El.Ed. so we thought to submit the application in anticipation of getting the NOC for D.El.Ed. for which we had applied for that but this process would takes so much of time and we made several attempt we couldn't anticipated so we are suggested to attach

affidavit for D.El.Ed. NOC and once the file will be process then will submit the NOC to ERC, NCTE, Bhubaneswar. It is our humble submission that we have done with almost all basic infrastructure and have well established campus for conducting the programmes and we are sorry for our confusion that we didn't submit the application before due date but in future this type of confusion will never happen and we will give our best effort in teacher training.”

AND WHEREAS Appeal Committee noted that recognition for conducting D.El.Ed. course applied by the appellant institution has been refused by E.R.C. on the ground that “the date of online application is 30.05.2015 and date of despatch of printout of online application is 26.06.2015 i.e. after 15 days of the submission of online application.” Appeal Committee further noted that NCTE (HQs) has issued directions to all Regional Committee offices stating that 15.07.2015 shall be the last date for submission of hard copy of application alongwith N.O.C. irrespective of the date of submission of online application. Committee noted that hard copy of application in the present case was received in the office of E.R.C. on 26.06.2015 and as such reason for refusal as mentioned in the refusal order dated 16/11/2015 is not sustainable. Appeal Committee further noted from the documents submitted alongwith the Appeal Memoranda dated 27.11.2015 that N.O.C. of the State School Education & Literacy Department was issued on 26.10.2015 and as such N.O.C. could not have been a part of the hard copy of application which was received in the office of E.R.C. on 26.06.2015. Appeal Committee, therefore, concluded that the appeal deserves to be rejected on the ground that the appellant neither submitted the N.O.C. alongwith the hard copy nor even obtained it from the affiliating body within the extended time limit i.e. 15.07.2015.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded that the appeal deserves to be rejected on the ground that the appellant neither submitted the N.O.C. alongwith the hard copy nor even obtained it from the affiliating body within the extended time limit i.e. 15.07.2015.



AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the ERC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the ERC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.



ORDER

WHEREAS the appeal of Abhilasha College of Education, Chhapri Ratibad, Huzur, Bhopal, Madhya Pradesh dated 16/10/2015 is against the Order No. WRC/APP104/217th/(M.P.)/2015/132034 dated 26/02/2015 of the Western Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "AND WHEREAS, reply submitted by the institution was placed before WRC in its 217th meeting held on February 23-24, 2015 and the Committee observed that "...The Abhilasha College of Education has applied for additional intake in D.El.Ed. Course. Earlier B.Ed. course (100 seats) and D.Ed. (50 seats) has already been sanctioned vide orders dated 30/08/2008 and 20/04/2009 respectively. The applicant has also given an affidavit consenting to follow the NCTE Regulations, 2014. As per the NCTE Regulations, 2014, Appendix-4, one basic unit of B.Ed. is only of 50 seats. Thus, the institution conducting the B.Ed. for 100 seats has to specify whether it wants to continue the B.Ed. course as two units under the NCTE Regulations, 2014 or only one unit of 50 seats. It has to be pointed out to the institution that, in case it wishes to conduct the B.Ed. course as two units in accordance with the Appendix-4 of NCTE Regulations, 2014, it already has one unit of D.Ed. (50 seats), an additional intake of D.Ed. (50 seats) will require 3500 sq.mts. of land area and 4000 sq.mts. of built up area, the position is that there are two certificates one issued by Sarpanch, Gram Panchayat, Ratibad for 3564.70 sq.mts. dated 17/03/2009, and a second certificate also given by the same Sarpanch for 4767 sq.mts. giving the same date i.e. 17/03/2009. Hence, these documents do not inspire confidence. It is also to be pointed out that the VT which inspected on 06/01/2014 had indicated many shortcomings for which Show Cause Notice had already been given. In their reply dated 11/03/2014 the institution furnished details of equipment, multiple set of apparatus, water facilities but no explanation has been given with regard to builtup area. Hence, Recognition is refused u/s 15(3)(b) of NCTE Act, 1993 for additional intake of 50 seats.

The applicant is still required to intimate to RD/WRO whether it wishes to conduct two units of B.Ed. of 50 each as per Appendix-4 of NCTE Regulations, 2014 or one unit."

AND WHEREAS Sh. Syed Khalid Hasan, Chairman, Abhilasha College of Education, Chhapri Ratibad, Huzur, Bhopal, Madhya Pradesh presented the case of the appellant institution on 15/02/2016. In the appeal and during personal presentation it was submitted "that the rejection grounds are not valid and justified because building completion certificate was received on 29/09/2013 instead of 17/03/2009 as shown in rejection order. The date shown in rejection order of building completion certificate is the date of diversion order which is mentioned in building completion certificate in 11 point. Institute has built up area 4767 sq.mts. which is sufficient to run B.Ed. and additional unit of D.Ed. course as per the Regulation 2014 and short."

AND WHEREAS Appeal Committee noted that the refusal order dated 28.02.2015 relates to application made by the appellant institution for conducting D.El.Ed. (Additional) intake and while assessing the built up area required, the co-existence of B.Ed. (intake – 100) and D.El.Ed. (50) already sanctioned to the appellant institute has been considered. In response to a Show Cause Notice the appellant institution furnished copy of Building Completion Certificate (B.C.C.) to W.R.C. in March, 2014 which indicates a total built up area of 3564.70 sq. meters (Grounds + 2 Floors). The appellant during the course of appeal presentation submitted copy of B.C.C. which indicates additional built up area on second floor and thus total built up area undergoes an upward change to be 4767 sq. meters. Appeal Committee further noted that the application for additional intake of D.El.Ed. course is pending since 2012 and the NCTE Regulations of 2009 have been revised in 2014. Appeal Committee, therefore, decided that the matter may be remanded back to W.R.C. for getting another inspection conducted to verify the adequacy of built up area and infrastructural requirements keeping in view the existing intake of B.Ed. & D.El.Ed. and the proposed intake of D.El.Ed. (Additional).

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to W.R.C. Bhopal for getting a composite inspection of institution conducted for verifying the built up area and other infrastructure available for conducting all the existing courses and the proposed one.



AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to WRC getting a composite inspection of institution conducted for verifying the built up area and other infrastructure available for conducting all the existing courses and the proposed one.

NOW THEREFORE, the Council hereby remands back the case of **Abhilasha College of Education, Chhapri Ratibad, Huzur, Bhopal, Madhya Pradesh** to the WRC, NCTE, for necessary action as indicated above.



Mathura, Uttar Pradesh dated 02/12/2015 is against the Order No. NRC/NCTE/NRCAPP-7439/243rd/Meeting/2015/125028 dated 09/10/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "the institution has not submitted the list of recruitment of faculty members and Head of the institution and the NOC from the affiliating University in response to SCN dated 14/08/2015."

AND WHEREAS Sh. Shashi Kumar Sharma, Representative, S.M.B.L. Academy, Vill.- Mahuan Post - Farah, Distt. Mathura, Uttar Pradesh presented the case of the appellatant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the appellatant applied to the respondent, NRC, NCTE for recognition for B.Ed. course on dated 31/12/2012 with the prescribed application format and process. That by the letter reference No. F.NRC/NCTE/NRCAPP-7439/238th Meeting Part-III/2015/111992 dated 06/06/2015 (letter of intent), the respondent NRC, NCTE asked to submit appellatant some documents. That the details of these requisite documents have been shown and marked as sub-para (a) to (f) of para No. 4 of aforesaid letter. That in the context of above letter of intent the proper reply alongwith requisite documents was given and supplied by the appellatant except the one, that is the particulars/list of the teaching staff and the principal/HOD approved by the University/Affiliating body. That for this purpose appellatant had already sent a letter NRC for extending the time because the University/affiliating body was delaying the further process even after starting the approval process. That even after giving the proper response and answered by the appellatant, the respondent/NRC, NCTE published a Show Cause Notice to the appellatant on its website through letter no. "Minutes of 241st Meeting of the NRC held on 3rd to 7th

August, 2015." That by this letter the NRC, falsely made an observation that "The institution has not submitted reply of letter of intent (LOI)". In addition the NRC, NCTE also ordered the appellant to submit some other documents shown in that show cause notice. That although the appellant had replied and clarified on the above essentialities yet the appellant again sent a letter ref. no. SMBL-9/15 dated 18/09/2015. That in the above cited letter the appellant requested again to extend the time for submitting the approved teaching staff as the concerned University/affiliating body was delaying the process of principal and teaching faculty approval. That the appellant also sent all the correspondences held with the concerned University along with above letter. The above all incidents show that the appellant was always keen to get the aforesaid recognition. It was not the fault of appellant and was also beyond the power and jurisdiction of appellant, for which the appellant may not be liable. The appellant received the approval of Principal and teaching faculty from University, on 21.10.2015, by this way the appellant has completed all the essential documents formalities."

AND WHEREAS Appeal Committee noted that a Letter of Intent dated 06/06/2015 was issued to the appellant institution. It is quite surprising that the appellant institution was required to furnish compliance report by 31.05.2015 whereas the L.O.I. itself was issued on 06.06.2015. Committee further noted that through a Show Cause Notice (S.C.N.) dated 17.08.2015 the appellant institution was asked to submit N.O.C. issued by the concerned affiliating body and evidence of its being a composite institution. Committee noted that appellant institution vide its letters dated 04.08.2015 and 18.09.2015 had requested the N.R.C. to extend the time limit for completing necessary formalities. Appeal Committee having regard to the fact that appellant institution had responded to all the communications of N.R.C., sought extension of time and was finally able to furnish list of faculty and principal to N.R.C. on 21.10.2015, decided to remand back the case to N.R.C. for consideration of the compliance report furnished by the appellant to N.R.C. on 21.10.2015

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. for consideration of the compliance report submitted by the appellant institution to the N.R.C. vide letter dated 21.10.2015.



AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for consideration of the compliance report submitted by the appellant institution to the N.R.C. vide letter dated 21.10.2015.

NOW THEREFORE, the Council hereby remands back the case of **S.M.B.L. Academy, Vill.- Mahuan Post - Farah, Distt. Mathura, Uttar Pradesh** to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Dr. Zakir Hussain College of Education, Ibrahimpatnam, Krishna, Andhra Pradesh dated 02/12/2015 is against the Order No. SRO/NCTE/SRCAPP14072/B.Ed./AP/2016-17/76243 dated 15/10/2015 of the Southern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "the institution has not submitted copy of registered land document. The institution has submitted lease deed from Private party."

AND WHEREAS Mohd. Akheel Ahmed, Member of the Society, Dr. Zakir Hussain College of Education, Ibrahimpatnam, Krishna, Andhra Pradesh presented the case of the appellant institution on 15/02/2016. AND WHEREAS Appeal Committee noted that the appellant Trust i.e. The India Education Trust had submitted copy of registered Lease Deed in respect of land measuring 24 acres and 45 cents located in village Ibrahim Patnam, Krishna Dist, A.P. The Lessor in this case in Government Inam Khazi and the land belonged to Andhra Pradesh Wakf Board, Hyderabad. WHEREAS the appeal of Dr. Zakir Hussain College of Elementary Education, Ibrahimpatnam, Krishna, Andhra Pradesh dated 02/12/2015 is against the Order No. SRO/NCTE/SRCAPP3244/D.El.Ed./AP/2016-17/76595 dated 20/10/2015 of the Southern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "the institution has not submitted hard copy of application within 15 days of online application The institution has submitted lease deed dated 11/09/1990."

AND WHEREAS Mohd. Akheel Ahmed, Member of the Society, Dr. Zakir Hussain College of Elementary Education, Ibrahimpatnam, Krishna, Andhra Pradesh presented the case of the appellant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the institution had submitted the online application to NCTE on 30/05/2015. We had erroneously presumed that the institution has to submit the hard copy within 15 days working days and hence submitted it on 15/06/2015, which is a delay of just one day. We earnestly request to the appellate authority to kindly condone the delay of one day in submission which was inadvertent. The institution has submitted the lease deed executed by the Andhra Pradesh State Wakf Board for a period of 99 years which has also been permitted and ratified by Government of Andhra Pradesh vide G.O. Ms. No. 429, dated 25/03/1975 (copy enclosed)."

AND WHEREAS Appeal Committee noted that NCTE had issued instructions to all regional Committee offices that 15.07.2015 shall be the last date for submission of hard copy of application irrespective of the date of online application. NOW THEREFORE, the Council hereby remands back the case of Dr. Zakir Hussain College of Elementary Education, Ibrahimpatnam, Krishna, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

In the appeal and during personal presentation it was submitted that "The date of submission of online application was extended to 30/06/2015. The NOC from the affiliating body i.e. from West Bengal Board of Primary Education was issued on 26/06/2015. Due to this reason we could not submit the hard copy of application even after making the DD of Rs. 1,50,000/- on dated 30/05/2015 as application fee and the fixed deposit of Rs. 12,00,000/- on dated 19/05/2015."

AND WHEREAS Appeal Committee noted that NCTE had issued direction addressed to all Regional Committee offices that hard copy of application submitted upto 15.07.2015 should be accepted irrespective of the date of online application. The appellant had submitted printout of online application on 08/07/2015 by 'Speed Post'.

Appeal Committee, therefore, decided to remand back the case to E.R.C. Bhubaneswar for further processing of the application.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to E.R.C. for further processing of the application.

WHEREAS the appeal of Emmanuel Degree College for Integrated Teacher Education, Andhra Pradesh dated 02/12/2015 is against the Order No. SRO/NCTE/SRCAPP3539/B.A.B.Sc/AP/2016-17/76156 dated 14/10/2015 of the Southern Regional Committee, refusing recognition for conducting B.A. B.Sc. course on the grounds that "the institution has submitted photocopies of land documents in regional language but it is not certified by Sub-Registrar."

AND WHEREAS Sh. B. Suvarna Kumar, Administrative Officer, Emmanuel Degree College for Integrated Teacher Education, Andhra Pradesh presented the case of the appellatant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the institution has submitted photocopies of land documents in regional language however we missed to take photocopies of land documents on the second side (back side), which is certified by Sub-Registrar. The Hon'ble Appeal Committee may consider this mistake as human error and verify our certificates (land documents) once again which we are submitting to your office and consider our application."

AND WHEREAS Appeal Committee noted that appellatant institution had submitted print out of the online application and while submitting copy of the land documents furnished zerox of front pages of the sale deed. Appellant during the course of appeal presentation admitted this inadvertent lapse on the part of institution and furnished complete copy of the land documents including back pages of the sale deed. There has been no change in the land documents already submitted by the appellatant institution except that back pages bearing seals & stamps of registering authority have now been made available.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to S.R.C. for further processing of the application. The appellant is also directed to submit land documents with both sides of all paper duly copied to the S.R.C., Bangalore within 15 days of the receipt of the appellant order.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to SRC for further processing of the application. The appellant is also directed to submit land documents with both sides of all paper duly copied to the S.R.C., Bangalore within 15 days of the receipt of the appellant order.

We had applied to appoint the subject Expert for conducting interview of the faculty on 29/05/2015. The Registrar of Dr. B.R. Ambedkar University, Agra had provided the letter of nomination of subject Expert vide no. affil/2205/2015 dated 09/10/2015. After conducting interview of the faculty, we have submitted application for getting approval from affiliating University on 28/10/2015. List of approved faculty is pending in the University."


AND WHEREAS Appeal Committee noted that the Letter of Intent (L.O.I.) dated 29.05.2015 was issued to appellant institution. The appellant institution was required to furnish compliance including approved list of faculty by 31st May, 2015 which could not

have been possible by any means. Subsequently a Show Cause Notice (S.C.N.) dated 18.08.2015 was issued to submit written representation within 30 days. There is no evidence on record that the appellant institution responded to any of these communication i.e. L.O.I. and the S.C.N. Neither did the appellant institution seek extension of time for furnishing compliance. Appellant orally submitted that he sought some clarification from N.R.C., Jaipur office. However, the appellant could not furnish any documentary evidence of his efforts to seek clarifications from N.R.C. In these circumstances, Appeal Committee decided to confirm the refusal order dated 12-10.2015 issued by N.R.C., Jaipur.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 12.10.2015 issued by N.R.C., Jaipur.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

An affidavit to this effect is required to be submitted by the institution to the NRC, NCTE not submitted. No Objection Certificate issued by the concerned affiliating body as required under clause 5(3) of the NCTE Regulations, 2014 not submitted."


AND WHEREAS Sh. Chandbir Singh, Chairman and Sh. Vijay Kumar, Admin. Clerk, Akshita College of Higher Education, Alipur, Meerut, Uttar Pradesh presented the case of the appellant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the list of faculty members was approved by the University on 07/12/2015 vide letter no. Affi/2972. The University delayed the process of faculty approval, whereas we initiated the entire process at a very early stage. The process of selection followed by approval is a lengthy process and time consuming. List of faculty approved by C.C.S. University, Meerut is enclosed. The institution had submitted an affidavit dated 02/09/2015 bearing that it will become a composite institution before commencement of the academic session 2016-17 and we have applied for B.A. course. Another affidavit to ensure that we will become a composite institution before commencement of academic session 2016-17 dated 07/12/2015 is submitted. No

Objection Certificate has been issued by the University dated 10/11/2015 vide letter no. a-ffil./2664 copy is enclosed.”

AND WHEREAS Appeal Committee noted that Letter of Intent (L.O.I.) dated 28/04/2015 was issued to the appellant institution seeking compliance on certain points within two months. Subsequently a Show Cause Notice (S.C.N.) dated 17/08/2015 was issued asking the appellant institution to furnish written representation for not sending reply to L.O.I. and further requiring the appellant institution to furnish N.O.C. and affidavit declaring that institution would acquire the status of a composite institution. The appellant institution furnished reply to the S.C.N. which was received in the office of N.R.C. on 08/09/2015. The appellant in its reply informed N.R.C. of its efforts to get the faculty selected through subject experts nominated by affiliating body. The institution also furnished an affidavit undertaking to achieve the status of a composite institution and the status of issuance of N.O.C. Appeal Committee noted that institution had applied for B.Ed. course in December, 2012 under NCTE Regulations, 2009 when obtaining N.O.C. from affiliating body was not a pre-requisite and composite nature of institution was also not required. The status intimated to N.R.C. regarding above two conditions should therefore, have been accepted. The appellant during the course of appeal presentation informed that it has now obtained the N.O.C. as well as the approval of affiliating body for appointment of Principal and faculty.

AND WHEREAS Appeal Committee considering the efforts of the appellant institution to get the N.O.C. and faculty approved from affiliating body and also taking into account that appellant has replied to Show Cause Notice duly intimating the status of the case, decided to remand back the case to N.R.C. for acceptance of the final compliance report which the appellant should submit to N.R.C. within 15 days of the receipt of appeal orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. for acceptance of the final compliance report which the appellant institution should submit to N.R.C. within 15 days of the receipt of appeal orders.



AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for acceptance of the final compliance report which the appellant institution should submit to N.R.C. within 15 days of the receipt of appeal orders.

NOW THEREFORE, the Council hereby remands back the case of Akshita College of Higher Education, Alipur, Meerut, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.



ORDER

WHEREAS the appeal of Calicut University Teacher Education Centre, Poomala Sulthan Bathery, Wayanad, Kerala dated 30/11/2015 is against the Order No. SRO/NCTE/APSO2942/B.Ed./KL/2015-16/74727 dated 05/10/2015 of the Southern Regional Committee, withdrawing for conducting B.Ed. course on the grounds that "the institution has not given FDRs. Building Plan is not given. Built up area shown in Building Completion Certificate is only 8150 sq.ft, which is inadequate and not as per NCTE norms. Teaching staff is not at all according to NCTE norms. Principal does not have Ph.D. other are on consolidated pay and not regular."

AND WHEREAS Prof. (Dr) P. Kelu, Director, Directorate of Teacher Education, Calicut University Teacher Education Centre, Poomala Sulthan Bathery, Wayanad, Kerala presented the case of the appellant institution on 15/02/2016. In the appeal and during personal presentation it was submitted that "the Calicut University Teacher Education Centre, Sulthan Battery is directly run by University of Calicut which is funded by Kerala Government/UGC. Hence I request you to exempt from the payment of FDR. With regard to the objection No.2 the approved building plan of the institution is submitted herewith, approved by the University Engineer and counter signed by the Registrar, University of Calicut. With regard to the objection No.3 it may be noted that the proposed building plan is covering 3042 sqm. But the completed area is 757 sqm. The building work is in progress. The University has provided required fund for the completion of works according to the NCTE Norms. A copy of the letter, requesting to complete the remaining works of the centre, addressed to the District Collector of Wayanad who is the implementing agency. There will be enough space for the centre when it is completed. In addition to that an amount of Rupees twenty-five lakhs has been allotted from the MLA fund of Sri Ludy luiz for the building construction of this centre. With regard to the objection



No.4 following may please be noted Teachers and Principal are appointed on full time basis with a scale of pay as per the G.O. (Ms.) No.416/2015/H.Edn dated 09/07/2015 and U.O. No. 5612/2015/Admn. Dt. 03/06/2015. The Principal and Teachers were appointed to this centre before 2014 and according to the existing norms at that time. The NCTE have recently clarified that "All future appointments of faculty and staff including those for existing vacant positions shall be as per qualifications prescribed in regulations (and norms & standards) 2014 (without disturbing the existing faculty and staff)."

AND WHEREAS Appeal Committee noted that recognition for conducting B.Ed. course has been withdrawn by S.R.C. on the grounds that the appellant institution has not furnished (i) F.D.Rs, (ii) Building Plan; (iii) built up area is 8150 sq. feet and (iv) Principal does not have Ph.d., faculty is on consolidated pay and not regular. Appeal Committee further noted that the appellant institution was given an opportunity by issuing a Show Cause Notice (S.C.N) dated 05.01.2015 and the written representation dated 21.01.2015 received on 27.01.2015 submitted by the appellant was duly considered. The appellant in its written representation had furnished a B.C.C. indicating the built up area of 8150 sq. feet and instead of a Building Plan a site plan was enclosed. As regard the qualification of Principal it was stated that he was appointed in 2007 and is doing Ph.D. Regularisation of staff and payment of salary as per pay scale was stated to be under consideration. Appeal Committee, however, observed that the S.C.N. dated 05/01/2015 contained eight deficiencies which did not include the deficiency on account of non-submission of F.D.Rs of Endowment & Reserve Fund. As such citation of this as a reason for withdrawal is not justified.

AND WHEREAS Appeal Committee noted that the appellant university centre had failed to furnish copy of the approved building plan in reply to the S.C.N. and what it submitted was copy of a site plan which did not include any construction details. The appellant in its appeal memoranda still admits that built up area available as on date is 8150 sq. feet.

AND WHEREAS Appeal Committee noted that while furnishing reply to the S.C.N. the appellant institution has furnished an affidavit dated 22.01.2015 sworn by Sh. V. Suresh, Principal, appellant institution undertaking that he would obtain Ph.d. within a



period of one year. During the course of appeal presentation on 15.02.2016 appellant failed to furnish declaration that Principal has now acquired necessary qualification.

AND WHEREAS Committee considered and agreed to the submission made by appellant with regard to appointment of faculty on full time basis and payment of salary as per scale of pay approved by Government of Kerala and notified vide order no. 416/2015/H Edu. dated 09/07/2015.

AND WHEREAS keeping in view the totality of the explanation furnished by appellant, Appeal Committee decided to confirm the withdrawal order dated 5/10/2015 on ground of inadequate built up area as per norm.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the withdrawal order dated 5/10/2015 on grounds of not possessing adequate built up area as per norm.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the SRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the SRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.



AND WHEREAS the appellant during the course of appeal presentation furnished a letter dated 30.11.2015 of the affiliating body conveying approval of five faculty in the field of English, Philosophy, Physical Education, Music and Fine Arts. The appellant, however, could not explain whether the above approved list was furnished to N.R.C. or not as refusal order is dated 13.10.2015. Appeal Committee decided to remand back the case to N.R.C. for consideration of the additional list of faculty approved by affiliating body on 30.11.2015. The appellant is required to furnish this list to N.R.C. within 15 days of the receipt of appeal orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. for consideration of the additional list of faculty dated 30.11.2015. Appellant institution is required to furnish this list to N.R.C. within 15 day of the receipt of appeal orders.

Hence reply of LOI could not be submitted before 31/05/2015 for session 2015-16. The institution initiated the process of selection of staff as per norms of University. The NRC, NCTE issued a Show Cause Notice to the institution vide letter No. NRCAPP-6700/241th meeting/2014/120907 dated 14/08/2015. This institution submitted a letter on 11/09/2015 to NRC, NCTE with request to grant 1 month time to make reply of LOI because the process of approval of staff was pending with University. That approval letter of staff has been received from University on 19/10/2015. That after receipt of approval letter of staff from University, this institution has submitted reply of

L.O.I. for issuance of formal recognition letter for B.Ed. course u/s 7(16) to NRC, NCTE on 23/10/2015.”

AND WHEREAS Appeal Committee noted that a Letter of Intent (L.O.I) dated 29.05.2015 was issued to appellant institution which required compliance to be reported before 31st May, 2015. There is no way that appellant institution could have reported compliance by 31.05.2015. Subsequently a Show Cause Notice (S.C.N.) dated 14.08.2015 was issued for non-submission of reply to L.O.I. and for submitting N.O.C. and affidavit relating to the composite nature of institution. Appeal Committee noted that appellant institution submitted a reply dated 11/09/2015 which was received in the office of N.R.C. on 14/09/2015. The appellant in its reply, narrated the reasons for delay in getting approval of the affiliating body and requested for 30 days time for submission of reply to L.O.I.

AND WHEREAS Appeal Committee further noted that the affiliating body i.e. Chhatrapati Shahu Ji Maharaj University, Kanpur finally approved the list of faculty and H.O.D. on 19.10.2015 and the appellant institution submitted a compliance report to N.R.C. on 23.10.2015. 

AND WHEREAS Sh. Ravinder Kr. Mishra, Member and Sh. Santosh Kr. Mishra, Manager of Pt. Tripurari Mishra Mahavidyalaya, Rohuwa, Mustafabad, Azamgarh, Uttar Pradesh presented the case of the appellant institution on 16/02/2016. In the appeal and during personal presentation it was submitted that "LOI was granted, serious family issues, counselling in University, Zila and Gram Panchayat Elections hovered around which disrupted the entire process, created a big hindrance in fulfilling the desirable actions at that point of time. Surprised by your show cause notice we requested for suitable time explaining reasons to fulfil requirements but received refusal."

AND WHEREAS Appeal Committee noted that a Letter of Intent (L.O.I.) dated 16/06/2015 was issued to appellant institution seeking compliance within a period of two months. Subsequently a Show Cause Notice (S.C.N.) dated 14/08/2015 was issued on ground of non-submission of reply to L.O.I. and further requiring the appellant institution to furnish N.O.C. from affiliating body and an affidavit regarding composite nature of the institution. Appeal Committee further noted that the appellant institution submitted reply dated 15/09/2015 to N.R.C. intimating the status of obtaining N.O.C. and approval of faculty from the affiliating body i.e. Veer Bahadur Singh Purvanchal University, Jaunpur.

The appellant during the course of appeal presentation on 16.02.2016 informed the Appeal Committee that it has now received necessary approvals from the affiliating body. Appeal Committee noted that appellant institution has submitted reply to S.C.N. and sought time for submission of reply to L.O.I. Appeal Committee, therefore, decided to remand back the case to N.R.C. for consideration of the compliance report which the appellant should submit to N.R.C. within a period of 15 days from the date of receipt of appeal orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to N.R.C. for consideration of the compliance report which the appellant should submit to N.R.C. within a period of 15 days from the date of receipt of appeal orders.

NOW THEREFORE, the Council hereby remands back the case of Pt. Tripurari Mishra Mahavidyalaya, Rohuwa, Mustafabad, Azamgarh, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Saveetha University, Kanchipuram, Tamil Nadu dated 30/11/2015 is against the Order No. SRO/NCTE/SRCAPP2703/M.P.Ed/TN/2016-17/76324 dated 15/10/2015 of the Southern Regional Committee, refusing recognition for conducting M.P.Ed. course on the grounds that "University has submitted two land documents dated 08/02/2002 and 26/05/2003 in favour of M/s Saveetha Medical and Educational Trust not in the name of Saveetha Institute of Medical and Technical Sciences."

AND WHEREAS Sh. S. Radha Krishnan, Joint Registrar, Saveetha University, Kanchipuram, Tamil Nadu presented the case of the appellant institution on 16/02/2016. In the appeal and during personal presentation it was submitted that "Appellant states that the application for M.P.Ed. Programme was submitted to the Southern Regional Committee along with the application seeking recognition for B.P.Ed. Programme. It is humbly stated that the NCTE was pleased to accept the application for B.P.Ed. and forwarded the same to the Government of Tamil Nadu for their recommendations vide Regional Director, NCTE Lr. F.No. SRO/NCTE/SRCAPP2701/B.P.Ed/TN/2015/67090 dt. 12/06/2015. As regard to this ground for rejection of the request for recognition, this appellant humbly submit that the entire land comprised in Survey Nos. 83,84,85 etc., measuring about 68 acres and 37 cents belonging to the Saveetha Medical and Education Trust were taken on 99 years lease by the Saveetha Institute of Medical and Technical Sciences by Lease Deed dated 29/08/2007, registered in the Office the Sub-Registrar of Sriperumbudur for the purpose of constructing building for all types of Educational institutions like Medical College & Hospital, Research Institute and any other disciplines. The Survey No. 83/1A Part, 85/2 Part and 84 earmarked for starting B.P.Ed. and M.P.Ed. courses are part and parcel of the lands comprised in Survey Nos. 83, 84 and 85. A copy of the Lease Deed dt. 29/08/2007 is enclosed for favour of kind reference. The appellant


University has the absolute lease hold right over the lands comprised in Survey No. 83/1A Part 85/2 Part and 84 which are shown for starting the said two courses.”

AND WHEREAS Appeal Committee noted that the appellant institution has submitted online application on 29.05.2015 and the name of institution as per details furnished is 'Saveetha University'. The institution is run by 'Saveetha Institute of Medical and Technical Sciences'. Committee further noted that land documents furnished with the application are in name of Saveetha Medical and Educational Trust. Clause 8(4) of NCTE Regulations, 2014 laydown that no institution shall be granted recognition unless the institution or society sponsoring the institution is in possession of required land on the date of application on ownership basis or on lease from Government or Government institution. In this case, Appeal Committee is of the view that land documents neither include the name of institution i.e. 'Saveetha University' nor the name of applicant society/trust which is mentioned as 'Saveetha Institute of Medical and Technical Services'. Strictly speaking the land documents submitted are neither in the name of institution nor in name of sponsoring society/Trust. Appeal Committee, therefore, decided to confirm the order dated 15/10/2015 issued by S.R.C.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the order dated 15/10/2015 issued by S.R.C., Bangalore.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the SRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the SRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

(ii) In the building plan, the total land area is shown as 1863 SQMT. (iii) The certified copy of land document for khasra No.599/31 has not been submitted. Hence, Recognition is refused."

AND WHEREAS Sh. Anand Rathore, Secretary and Sh. Arvind Jagtap, Representative, Pandit Dwarika Das B.Ed. College, Athner, Betul, Madhya Pradesh presented the case of the appellant institution on 16/02/2016. In the appeal and during personal presentation it was submitted that:-

- (i) Khasra No. 599/14 total land 0.105 Hect. And diverted land area is 599/14 in 0.052 Hect. And 0.053 Hect. = 0.105 Hect. = 1050 sqmt.
- (ii) Khasra No. 599/35 total area 0.109 Hect. And diverted area is 0.109 Hect. = 1090 sqmt.
- (iii) Khasra No. 599/1 total land area 0.063 Hect. And diverted area is 0.039+0.024=0.063 Hect. = 638 sqmt."

Khasra No. 599/14, 599/35, 599/1 total land area 1050+1090+638 sqmt. = 2778 sqmt. Building plan, CLU certificate (2778 sqmt.)."

AND WHEREAS Appeal Committee noted that appellant institution had submitted online application seeking recognition for B.Ed. course on 23.12.2012 under NCTE

Regulations, 2009. Recognition has been refused by W.R.C. vide order dated 17/11/2015 on following three grounds:-

- (i) C.L.U. is only for 1860 sq. meters.
- (ii) In the building plan, the total land area is shown as 1863 sq. meters.
- (iii) Originally certified copy of land document for Khasra no. 599/31 has not been submitted.

AND WHEREAS Appeal Committee noted that the appellant institution in its online application has furnished three plot numbers as land identification numbers and these number are 599/14, 599/31 & 599/35. Details of plot area in corresponding sale deeds are mentioned as:

599/35	0.109 Hec.
599/14	0.105 Hec.
599/1	0.172 Hec.

Committee noted that khasra no. 599/1 is not mentioned in the online application.

AND WHEREAS Appeal Committee further noted that following three change of land use certificate (CLUs) were submitted by the appellant institution:

599/31	0.039	For constructions of residential house.
599/14	0.053	For constructions of residential house.
599/1	0.024	For constructions of residential house.

The appellant's statement that Change of Land Use Certificate is for entire area has not been found correct as C.L.U. specifically mentions the area of land diverted for construction of residential building much less than the total area of land in the particular khasra numbers. Moreover Khasra no. 599/1 has not been found mentioned in the online application.

AND WHEREAS the appellant institution is, however, under no obligation to furnish original certified copy of land deed under the NCTE Regulations, 2014. Appellant has furnished different copies of building plan at different times. In one of these Building Plans

submitted by appellant in July, 2013 four khasra numbers i.e. 599/14, 599/16, 599/31 & 599/35 have been mentioned. Whereas Khasra no. 599/16 was not mentioned in the online application.

AND WHEREAS Appeal Committee is of the view that building plan and Change of Land Use Certificate relating to any plot number or Khasra number other than mentioned in the application form has no relevance. Committee, therefore, decided to confirm the refusal order dated 17/11/2015 issued by W.R.C. on the ground that diverted area on khasra numbers 599/14, 599/31 and 599/35 put together do not meet the requirement of NCTE norms.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 17/11/2015 issued by W.R.C., Bhopal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against

AND WHEREAS Appeal Committee noted that Letter of Intent (L.O.I.) dated 10.04.2015 was issued to appellant institution seeking compliance within a period of two months. The appellant institution furnished a reply dated 05.06.2015 to N.R.C. intimating that affiliating body has been requested to nominate subject experts for selection of faculty. The appellant also furnished copies of F.D.Rs. N.R.C. subsequently issued a Show Cause Notice (S.C.N.) dated 26/08/2015 on ground of non-submission of reply to L.O.I. and further asking the appellant to submit N.O.C. from affiliating body and affidavit to the effect of being a composite institution.

AND WHEREAS Appeal Committee further noted that appellant institution furnished reply to S.C.N. by E-mail acknowledged in N.R.C. office on 1.10.2015. Appeal Committee considering the fact that appellant institution had furnished replies to L.O.I. and S.C.N. and had also sought extra time for fulfilment of conditions which were not within his control, decided to remand back the case to N.R.C. for consideration of the compliance report of appellant institution. The appellant should furnish a composite compliance report to N.R.C. within 15 days of the issue of appeal orders.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC for consideration of the compliance report to be submitted by the appellant within 15 days of the receipt of appeal orders.

NOW THEREFORE, the Council hereby remands back the case of Vimla Devi College of Education, Meerut, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

Committee, therefore, decided to remand back the case to N.R.C. for consideration of the final compliance report which should be submitted by appellant to N.R.C. within 15 days of the receipt of appeal orders.





Now we are submitting the English version of the Sale Deed, duly notarized, as a proof of the ownership of the land in favour of the Trust. Kindly consider our case favourably."

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to SRC for further processing of application. Appellant institution is required to furnish copy of authenticated English translation of the sale deed to SRC within 15 days of the receipt of appeal orders.

WHEREAS the appeal of Sri G.G. Venu B.Ed. College, Hobli, Srinivaspur, Kolar, Karnataka dated 07/12/2015 is against the Order No. SRO/NCTE/SRCAPP2232/B.Ed./KA/2016-17/76279 dated 15/10/2015 of the Southern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "land document as required under Regulation 5(4) is not submitted. The institution has submitted a private lease deed for a period of 30 years. As per Regulations, 2014, Govt. lease is allowed."

AND WHEREAS Sh. M. Lokesh Murthy, Administrator and Sh. G. Govinda Gowda, Trustee, Sri G.G. Venu B.Ed. College, Hobli, Srinivaspur, Kolar, Karnataka presented the case of the appellant institution on 16/02/2016. In the appeal and during personal presentation it was submitted that "Sri G.G. Venu Vidya Peeta Charitable Trust Unikili (V), Kasaba Srinivaspur (T), Kolar (D) Karnataka has got NCTE permission to run D.Ed. college as per code no. APSO5804, reference no. SRON/NCTE/D.Ed/2006-2007, 4102 dated 14/06/2007. At that time as per the NCTE Norms only the lease deed has been executed between the land owner Sri G. Govinda Gowda and Sri Venu Vidya Peeta Trust for 30 years. The same land document of lease has been submitted to NCTE Southern Regional, Centre, Bangalore to obtain permission for B.Ed. College for the year 2015-16. The 3 stairs of the constructed building are for both present D.Ed. and proposed B.Ed. College for 2015-16."

AND WHEREAS Appeal Committee noted that Clause 5(4) of the NCTE Regulations, 2014 is further supplemented by Clause 8(4) and 8(11) of the NCTE Regulations, 2014. Relevant to the case, these regulations provide that 'no institution shall be granted recognition unless the institution or society sponsoring the institution is

in possession of required land on ownership basis. The revised land area norms shall not be applicable to existing institutions but these institutions are not allowed to expand by way of additional programmes or additional intake. The plea of the appellant that a D.El.Ed. programme already is being conducted on the same premises since 2007, does not hold good for sanctioning additional course till land is acquired by the institution on ownership basis. Appeal Committee decided to confirm the refusal order dated 15.10.2015 issued by S.R.C. in this regard.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 15/10/2015 issued by S.R.C., Bangalore.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the SRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the SRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.



WHEREAS the appeal of Sri Darbarilal Vimla Devi Krishan Kumar Mahavidyalaya Kaluwamau Faizabad, Uttar Pradesh dated 03/12/2015 is against the Order No. NRC/NCTE/NRC APP-6337/243th/Meeting/2015/126498-501 dated 19/10/2015 of the Northern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "The institution has not submitted the list of teachers and Head of the institution approved by the affiliating University. The NOC of the affiliating University has not been enclosed."

AND WHEREAS Sh. Krishan Kumar Lal, Manager and Sh. Ashok Kumar, Member, Managing Committee of Sri Darbarilal Vimla Devi Krishan Kumar Mahavidyalaya Kaluwamau Faizabad, Uttar Pradesh presented the case of the appellant institution on 16/02/2016. In the appeal and during personal presentation it was submitted that, "The institution received the letter of intent dated 10th April, 2015. The institution applied for sending the panel for selection of faculty to the Registrar, Dr. Ram Manohar Lohia Avadh University, Faizabad just after receiving the letter of intent. The University constituted panel and the names of experts were sent to the institution vide letter dt. 08/07/2015. The institution persistently requested the experts to fix the date for selection of faculty, and the date of selection was fixed as on 15/09/2015, 18/09/2015 and 24/09/2015 and the selection were made by the experts. The institution immediately sent the documents for approval to the University on 28/09/2015. The Show Cause Notice was issued to the institution in the terms of 241st meeting of NRC, it was received by the institution on dated 25/08/2015. The application of the institution was rejected in the 243rd meeting of the NRC, which was held on 28-30, September, 2015. It is specific feature of the entire episode that there was fixed time for sending the reply to the letter of intent on the one hand and there is no fixed timer for sending the experts for making selection of the faculty

and granting approval though the entire formalities were completed by the institution and no short coming was ever informed to the institution by the University. NRC cannot control the University which is autonomous body, but the NRC can extend the time to submit the information regarding the selection of the faculty and its approval by the University. The institution has already established Graduation course from session 2015-16. The institution has already applied for running B.Ed. course and after recognition it will be composite institution. As for as 'No Objection Certificate' is concerned if is most respectfully submitted that the provisions of NCTE Regulation whereby NOC was required was declared illegal and void by the High Court and when the institution applied for recognition of 1 year B.Ed. course there was no requirement of submitting the NOC. Now as later stage the NRC cannot force to the institution to submit the NOC."

AND WHEREAS Appeal Committee noted that Letter of Intent (L.O.I.) dated 10.04.2015 was issued to appellant institution seeking compliance within a period of two months. Appellant institution in its letter dated 03.06.2015 received in the office on 04.06.2015 informed N.R.C., Jaipur of the action taken by it to seek approval of the affiliating body and further sought extension of time till approval of University is received.

AND WHEREAS N.R.C., Jaipur issued a Show Cause Notice (S.C.N) dated 17/08/2015 to the appellant institution on ground of not submitting reply to L.O.I. and further asked the appellant institution to furnish N.O.C. and evidence to the effect of becoming a composite institution. The appellant institution furnished an interim reply to the S.C.N. stating that subject experts have been nominated by the affiliating body and as soon as selection of faculty is finalised, N.R.C. will be informed. The appellant during the course of appeal presentation informed that affiliating body has conveyed its approval to the selection and appointment of faculty after the refusal order dated 19/10/2015 was issued by N.R.C.



AND WHEREAS Appeal Committee noted that Letter of Intent (L.O.I.) dated 20.03.2015 was issued to appellant institution and further a Show Cause Notice (S.C.N) dated 14.08.2015 was issued on grounds of non-submission of reply to L.O.I. and further requiring the institution to submit N.O.C. from affiliating body and a affidavit about the composite nature of the institution.

AND WHEREAS Appeal Committee observed that appellant institution has not furnished any reply to L.O.I. or S.C.N. and did not even send an interim reply requesting N.R.C. to grant extension of time for fulfilment of the conditions laid down in the L.O.I. or S.C.N. Appeal Committee, therefore, decided to confirm the refusal order dated 09/10/2015 issued by N.R.C.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 09/10/2015 issued by N.R.C., Jaipur.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Kasthooribha Gandhi Integrated Education College, Namakkal Dist. – Tamil Nadu dated 15/12/2015 is against the Order No. SRO/NCTE/SRCAPP3158/B.A.B.Sc/TN/2016-17/76318 dated 15/10/2015 of the Southern Regional Committee, refusing recognition for conducting B.A., B.Sc. course on the grounds that “The institution has not submitted hard copy of application within 15 days from the date of online application.”

AND WHEREAS No one from, Kasthooribha Gandhi Integrated Education College, Namakkal Dist. – Tamil Nadu appeared on behalf of the appellant institution on 17/02/2016. In the appeal memoranda it submitted that “The application for four years integrated course leading to B.A. B.Ed./B.Sc.B.Ed, was sent on online on 30/05/2015 at 4.33 P.M. The hard copy of the application with all required documents including demand drafts for the prescribed fees was sent through speed post on 13/06/2015, within 15 days from the date of online application. The hard copy of the application which was sent on 13/06/2015 has reached the Regional Director, NCTE, Bangalore on 15/06/2015, since 14/06/2015 being Sunday & Govt. holiday. Interim day (i.e.) 14/06/2015 being a Sunday, an inevitable week holiday, the hard copy of application which was sent on 13/06/2015 has been delivered in the Regional Director NCTE, Bangalore on 15/06/2015 and the delay caused due to administrative reasons and not on the part of the individual.”

AND WHEREAS Appeal Committee noted that neither the relevant file has been received from S.R.C. nor did appellant appear before the Committee for personal hearing of the case on 17.02.2016. Appeal Committee further noted that recognition was refused on the ground that hard copy of application was not received within 15 days of the submission of online application. From the copy of refusal order dated 15/10/2015, it is revealed that online application for B.A./B.Sc. course was submitted on 30.05.2015 and

hard copy thereof was received in the office of S.R.C. on 15/06/2015. Appeal Committee is also aware that NCTE (HQs) had issued directions to all Regional Committee offices stating that 15.07.2015 shall be the last date of submission of hard copy of application alongwith N.O.C. irrespective of the date of online application. As hard copy of the application was received in the office of S.R.C., Bangalore much before the cut-off date, Appeal Committee decided to remand back the case to S.R.C. for further processing of the application.

AND WHEREAS after perusal of the memorandum of appeal, affidavit and refusal order dated 15/10/2015, the Committee concluded that the appeal deserves to be remanded to SRC for further processing of the application.

NOW THEREFORE, the Council hereby remands back the case of **Kasthooribha Gandhi Integrated Education College, Namakkal Dist. – Tamil Nadu** to the SRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Sri Raaja Raajan College of Education for Women, Amaravathiputhur, Karaikudi, Sivaganga, Tamilnadu dated 03/12/2015 is against the Order No. SRO/NCTE/SRCAPP2264/M.Ed/TN/2016-17/76323 dated 15/10/2015 of the Southern Regional Committee, refusing recognition for conducting M.Ed. course on the grounds that "The institution has not submitted hard copy of application within 15 days from the date of online application."

AND WHEREAS Dr. N. Mohan Raj, Director of Student Affairs and Sh. P. Sathaiah, Assistant Professor, Sri Raaja Raajan College of Education for Women, Amaravathiputhur, Karaikudi, Sivaganga, Tamilnadu presented the case of the appellant institution on 17/02/2016. Appeal Committee further noted that NCTE (HQs) had issued directions addressed to all Regional Committee offices stating that 15.07.2015 shall be the last date for receipt of hard copy of application alongwith N.O.C. irrespective of the date of online application. Appeal Committee noted that the hard copy of the application submitted by the appellant institution was received in the office of S.R.C., Bangalore much earlier than the cut of date i.e. 15/07/2015. Appeal Committee, therefore, decided to remand back the case to S.R.C., Bangalore for further processing of the application.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to SRC for further processing of the application.

ORDER

WHEREAS the appeal of Sri Rajarajeswari College of Education, Siruganur, Tiruchirappalli, Tamilnadu dated 13/01/2016 is against the Order No. SRO/APS04929/B.Ed/TN/2015-16/74740 dated 05/10/2015 of the Southern Regional Committee, withdrawing recognition for conducting B.Ed. course on the grounds that "The faculty list given is not approved by the T.N.T.E.U. Return the FDRs after verifying settlement of all faculty/staff claims."

AND WHEREAS Dr. Subbha Somu, Chairman, Sri Rajarajeswari College of Education, Siruganur, Tiruchirappalli, Tamilnadu presented the case of the appellant institution on 17/02/2016. In the appeal and during personal presentation it was submitted that "We received approved faculty list from T.N.T.E.U. on 23/11/2015 for 1 Unit (50 students) and the same is submitted to SRC-NCTE on 24/11/2015 by registered post with Acknowledgement. Hence we pray for restoration of recognition."

AND WHEREAS Appeal Committee noted that appellant institution was granted recognition for conducting B.Ed. course with an annual intake of 100 seats in the year 2008. At the time of grant of recognition, the institution was functioning in a rented premises and the institution sought permission to shift premises to a permanent building in 2013. It is observed that the proposed premises of the appellant institution was got inspected by S.R.C. and after due deliberations, S.R.C. decided to withdraw recognition for B.Ed. course on the ground that appellant institution has not furnished faculty list approved by Tamil Nadu Teacher Education University (TNTEU). Withdrawal order was issued on 05.10.2015 and it was made effective from the academic session 2015-16. Making the withdrawal order effective from year 2015-16 would mean that the appellant institution would have no recognition under the NCTE Regulations, 2014. Appeal


Committee further noted that appellant institution was in the process of getting the faculty list approved by the affiliating body and soon after the issue of withdrawal order dated 05/10/2015 the institution was able to furnish a list of faculty and Principal to S.R.C. on 24.11.2015.

AND WHEREAS it is observed from the remarks contained in last para of forwarding letter dated 29.01.2016 of the S.R.C. that faculty list approved by TNTEU confirms to 2009 regulation and existing institutions have been given (extended) time till 29.02.2016 to appoint faculty as per 2014 Regulations. It is however, not clear from the relevant records whether the appellant institution was informed by S.R.C. of the extended period to furnish faculty list conforming to 2014 regulations.

AND WHEREAS Appellant during the course of appeal presentation stated that appellant institution intends to continue the B.Ed. course with a single unit of 50 seats and as such faculty approved by T.N.T.E.U. is adequate for first year of two year course. Keeping in view the submission made by appellant, Appeal Committee decided to remand back the case to S.R.C. for giving the appellant institution an option to conduct B.Ed. course with a single unit of 50 seats and get the faculty requirements reassessed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to SRC for giving the appellant institution an option to conduct B.Ed. course with a single unit of 50 seats and get the faculty requirements reassessed.

NOW THEREFORE, the Council hereby remands back the case of Sri Rajarajeswari College of Education, Siruganur, Tiruchirappalli, Tamilnadu to the SRC, NCTE, for necessary action as indicated above.



WHEREAS the appeal of Srinivasa College of Education, Seethanagaram, Vizianagaram, Andhra Pradesh dated 23/12/2015 is against the Order No. SRCAPP636/D.El.Ed./AP/2012-13/44933 dated 15/10/2015 of the Southern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "The institution has not submitted hard copy of application within 15 days from the date of online submission of application."

AND WHEREAS No one from, Srinivasa College of Education, Seethanagaram, Vizianagaram, Andhra Pradesh appeared on behalf of the appellant institution on 17/02/2016. In the appeal memoranda it was submitted that "we submitted application online dt. 30/05/2015. We submitted hard copy on dt. 15/06/2015. We confused that this is extended upto dt. 15/06/2015 for submission of online application and the dt. 13/06/2015 is second Saturday and 14/06/2015 is Sunday. As per Govt. Norms, the above two days are public holidays. At the same time our correspondent was suffering from ill-health. Due to the above reasons we submitted the application with hard copies on dt. 15/06/2015."

AND WHEREAS Appeal Committee noted that appellant institution had filed a Writ Petition no. 38628/2015 in the Hon'ble High Court of Hyderabad at Telangana, Andhra Pradesh and Hon'ble Court had directed the petitioner to first avail the alternative remedy by preferring an appeal under Section 18 of the Act. Hon'ble Court has also directed the authority to dispose of the appeal within 4 weeks of it being filed. Online appeal was filed on 23.12.2015.

AND WHEREAS Appeal Committee noted that relevant file has not been received from S.R.C. Bangalore. However, from the details available on the appeal file it is observed that appellant institution submitted online application on 30.05.2015 and hard copy thereof was submitted on 15.06.2015. Appeal Committee further noted that NCTE (HQ) had issued directions addressed to all Regional Committee offices stating that 15.07.2015 shall be the last date for submitting hard copy of the application alongwith N.O.C. irrespective of the date of online application. Keeping in view that the hard copy of the application was submitted by the appellant institution much earlier than the cut of date of 15.07.2015, Appeal Committee decided to remand back the case to S.R.C. for further processing of the application.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to SRC for further processing of the application.

NOW THEREFORE, the Council hereby remands back the case of Srinivasa College of Education, Seethanagaram, Vizianagaram, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

WHEREAS Pursuant to an order dated 20.01.2016 passed by Hon'ble High Court of Gujarat at Ahmedabad in the SLP no. 11209 of 2015, Appeal Committee in its meeting held on 17/02/2016 considered the case of withdrawal of recognition to Shree Swaminarayan B.Ed. College, Vijapur, Mehsana, Gujarat.

AND WHEREAS Appeal Committee noted that recognition granted to appellant institution for conducting B.Ed. course was withdrawn by W.R.C., Bhopal vide its order no. WRC/APWO 4330/323430/151/2011/80202 dated 25.07.2011 on the ground that 'Principal has not been appointed.' The appellant aggrieved by the impugned order dated 25.07.2011 preferred an appeal and the appellate authority vide its order no. 89-400/2011/Appeal/2nd Meeting 2012/ A52250 dated 28.05.2012 confirmed the order dated 25.07.2011 issued by W.R.C. Bhopal.

AND WHEREAS the appellant, after making appointment to the post of Principal, preferred a second appeal before appellate authority in June, 2015 which was not allowed as there is neither a provision of filing a second appeal under Section 18 of the NCTE Act, nor appellate authority can review or recall a matter already decided under the relevant provisions of the NCTE Act.

AND WHEREAS Hon'ble High Court of Gujarat at Ahmedabad vide order dated 20.01.2016 invoking powers under Article 226 of the Constitution of India directed the Appellate Authority to reconsider the matter provided the appellant makes appropriate prayer for reconsideration of the matter to the Appellate Authority.

AND WHEREAS Appellant, in its Appeal Memoranda dated 22.01.2016 has stated that a Principal has been appointed and in support of his claim has furnished certain

documents which are in vernacular language. The staff profile indicating the name of Dr. Jogindra Singh Yadav recommended for appointment as Principal bears the signature and seal of Joint Registrar, Hemchandra-charye North Gujarat University, Patan.

AND WHEREAS Appeal Committee, decided to remand back the case to W.R.C. with the directions to review the case in the light of the approval given by affiliating body to the selection and appointment of Principal and all other conditions to be fulfilled under the provisions of NCTE Regulations, 2014 and take further necessary action.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to WRC with the directions to review the case in the light of the approval given by affiliating body to the selection and appointment of Principal and all other conditions to be fulfilled under the provisions of NCTE Regulations, 2014 and take further necessary action.

NOW THEREFORE, the Council hereby remands back the case of Shree Swaminarayan B.Ed. College, Vijapur, Mehsana, Gujarat to the WRC, NCTE, for necessary action as indicated above.
