ORDER

WHEREAS the appeal of C.S. Jain College of Education, Cuddalore, Tamil Nadu dated 28/12/2015 is against the Order No. SRO/APSO1132/D.T.Ed/TN/2015-16/78128 dated 23/11/2015of the Southern Regional Committee, withdrawing recognition for conducting D.T.Ed. course on the grounds that "The institution appears to have taken this case very casually. Several deficiencies still persists. The documents produced i.e. The staff list-are also quite old. Withdraw recognition w.e.f. 2015-16. If some students have already been admitted be adjusted in other colleges. Ask the University and SCERT to stop sponsoring students forthwith. Ask the University/SCERT to disaffiliate the institutions forthwith."

AND WHEREAS Sh. S. Mahaveer Chand, Secretary & Correspondent, C.S. Jain College of Education, Cuddalore, Tamil Nadu presented the case of the appellant institution on 17/03/2016. In the appeal and during personal presentation it was submitted that "The institutions which were started by a Jain Minority Community Trust with adequate infrastructure facilities like permament own building (for each Courses and from starting of the institutions itself) in our own trust land, qualified staff and lab, Library and other necessary facilities for smooth running of the institutions with a service motive and earned good name and reputation in the rural downtrodden community people without any restriction as to caste, religion."

AND WHEREAS Appeal Committee perused the impunged order dated 23.11.2015 and noted that through a single order recognition granted to appellant institution between

2004 to 2007 for courses like D.T.Ed., D.T.Ed. (Addl.), B.Ed. and M.Ed. were withdrawn from academic session 2015-16. Appeal Committee noted that a Show Cause Notice (S.C.N.) dated 08/07/2011 was issued by S.R.C. on eight grounds which are briefly mentioned below:

- (i) Non furnishing Legible copy of building plan.
- (ii) Lack of entry on invoice/bills relating to 18 computers being entered in stock register.
- (iii) Non mentioning approval of affiliating body in respect of three lecturers.
- (iv) Inadequate faculty for B.Ed.
- (v) Principal for M.Ed. course does not possess required qualification.
- (vi) List of teaching staff for B.Ed. & M.Ed. approved by affiliating body not furnished.
- (vii) No documentary evidence of payment of salary as per UGC/State Government scales.
- (viii) Accession Register entry not on the invoice/bills in respect of books.

and whereas Appeal Committee noted that reasons given for withdrawing recognition in the impunged order dated 23.11.2015 are cryptical. The withdrawal order should have made on specific grounds for each individual course and the suggestive action as narrated on serial no. 4 to 6 of the withdrawal order should not have been included in the reasons for withdrawal. Such a sketchy withdrawal order has also prevented the appellant to prepare and put up a proper appeal memoranda. The impunged order dated 23.11.2015 is therefore, set aside with the direction that S.R.C. Bangalore should examine in detail the requirement for each individual course treating it as a composite institution and then pass a reasoned and speaking order.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to set aside the withdrawal order dated 23.11.2015 with the direction that SRC, Bangalore
