ORDER

WHEREAS the appeal of Sarswati Teachers Training College, Sihali Khurd, Munadawar Sihali Khurd Road, Mundawar, Rajasthan dated 14/09/2018 is against the Letter F. No. Old APP/NRCAPP-7808/49/2017/169172 dated 15/03/2017 of the Northern Regional Committee, returning their application for grant of recognition for conducting D.El.Ed. course on the grounds that "In cases where the institutions have submitted the applications by offline mode along with Court orders and where no processing has been initiated by NRC, all such applications be returned to the institutions along with all documents as they have not submitted the applications as per Clause 5, of NCTE Regulations, 2014."

AND WHEREAS the appellant filed a S.B. Civil Writs No. 19740/2018 before the Hon'ble High Court of Judicature for Rajasthan, Bench at Jaipur. The Hon'ble High Court, in their order dt. 05/09/2018, disposed of the petition reserving liberty to the petitioner to avail the remedy of appeal. The Hon'ble High Court also observed that in case an appeal is instituted by the petitioner, the Appellate Authority would deal with the same as expeditiously as possible, in accordance with law.

AND WHEREAS Sh. Veer Singh Mehra, Secretary, Sarswati Teachers Training College, Sihali Khurd, Munadawar Sihali Khurd Road, Mundawar, Rajasthan presented the case of the appellant institution on 17/11/2018. In the appeal and during personal presentation it was submitted that "NCTE, New Delhi had issued a public notice on 27.11.2012 through which applications for grant of recognition for various Teacher Education courses had been invited from all stake holders in which no ban for D.El.Ed. course was imposed. In the State of Rajasthan there was no ban. This institution has applied online for grant of recognition of D.El.Ed. course (02 units) to NCTE from

2013-14 on 31.12.2012. The hard copy was submitted in the office of NRC, NCTE, Jaipur on 07.01.2013. Copy of receipt letter, challan for processing fees and online application is annexed and marked as Annexure-5. 3. The NRC, NCTE had returned the application for grant of recognition of D.El.Ed. (02 units) submitted by this institution vide letter 18.06.2013. Copy of returning letter is annexed. Being aggrieved from the action of NRC, NCTE, this institution has filed a S.B. Civil writ No. 4955/2016 in the Hon'ble High court of Rajasthan, Jaipur. Hon'ble Court had passed an order on 23.04.2016 in which court had directed the petitioner to move an application before NRC, NCTE for grant of recognition of D.El.Ed. course (02 units) and also directed to NRC, NCTE to decide the recognition application in accordance with Regulations 2014. Copy of order of Hon'ble High Court is annexed. In compliance to the order of Hon'ble High Court of Rajasthan dated 23.04.2016 this institution has submitted the required documents and processing fees in the office of NRC, NCTE on 28.04.2016. Copy of receipt letter is annexed. Instead of processing the application of this institution for granting recognition for D.El.Ed. course (02 units), NRC, NCTE had again returned the application of this institution on 15.03.2017 on arbitrary, unjust fied, illegal and unconstitutional basis. Copy of returning letter is annexed. Being from the order of NRC, NCTE, this institution has filed a S.B. Civil writ Petition No. 19740/2018 in Hon'ble High Court of Rajasthan, Jaipur. Hon'ble High Court has passed an order on 05.09.2018 and directed to petitioner to file an appeal u/s 18 of NCTE Act. 1993 and Appellate Authority is directed to dispose the appeal filed by the petitioner as expeditiously as possible, in accordance with law. Copy of the order of Hon'ble High Court is annexed. This institution is running B.Ed. course in the college campus. Copy of recognition order issued by NRC, NCTE is annexed. The appellate Authority, NCTE had already decided by its order dated 27.11.2017 that "Once applications are invited, the Regional Committee had no right to reject it on the grounds of ban imposed subsequently by the State Govt." Copy of Appeal Order is The Appellate Authority, NCTE had already decided by its order dated annexed. 16.10.2017 that "The ground of non-submission of application online can not be held against the appellant at this stage and therefore, the matter deserved to be remanded to the NRC for taking further action as per the NCTE Regulations 2014" Copy of

Appeal Order is annexed. The NRC, NCTE had conducted inspection of Royal Shikshak Prashikshan Center, Chomu, Jaipur (Raj.) who had applied for D.El.Ed. course in 2012. After Inspection of the institution NRC, NCTE had rejected the application. Appellate Authority, NCTE had decided by its order dated 05.06.2018 that the rejection ground of non-submission of application online is not applicable to this institution because this institution has applied before the enactment of Regulations 2014. Copy of Appeal Order dated 05.06.2018 is annexed. The NRC, NCTE had conducted inspection of Tak Sniksha Niketan Girls BSTC College, Lohagal, Ajmer (Raj.) who had applied for D.El. Ed. course in 2012. After Inspection of the institution NRC, NCTE had rejected the application. Appellate Authority, NCTE had decided by its order dated 05.06.2018 that the rejection ground of no submission of application online is not applicable to this institution because this institution has applied before the enactment of Regulations 2014. Copy of Appeal Order dated 05.06.2018 is annexed. The NRC, NCTE had conducted inspection of SRN School of Education, Neem ka thana, Sikar (Raj) who had applied for D.El.Ed. course in 2012. After Inspection of the institution NRC, NCTE had rejected the application. Appellate Authority, NCTE had decided by its order dated 24.07.2018 that the rejection ground of non-submission of application online is not applicable to this institution because this institution has applied before the enactment of Regulations 2014. Copy of Appeal Order dated 24.07.2018 is annexed. The NRC, NCTE has conducted inspection of Annpurana BSTC School, Neem ka thana, Sikar (Raj) who had applied for D.E.Ed. course in 2012. After Inspection of the institution NRC, NCTE had rejected the application. Appellate Authority, NCTE had decided by its order dated 24.07.2018 that the rejection ground of non-submission of application on ine is not applicable to this institution because this institution has applied before the enactment of Regulations 2014. Copy of Appeal Order dated 24.07.2018 is annexed. The NRC, NCTE had conducted inspection of Swami Vivekanand T. T. College, Gothara, Bassi (Raj.) who had applied for D.El.Ed. course in 2012. After Inspection of the nstitution NRC, NCTE had rejected the application. Appellate Authority, NCTE had decided by its order dated 24.07.2018 that the rejection ground of non-submission of application online is not applicable to this institution because this institution has applied before the enactment of Regulations

2014. Copy of Appeal Order dated 24.07.2018 is annexed. It is pertinent to mention here that Deptt. of Elementary Education (Ayojana) Deptt., Govt. of Rajasthan had sent a letter to Member Secretary, NCTE, New Delhi on 01.01.2018 in which it is clearly mentioned that no ban has been imposed for D.El.Ed. course for session 2019-2020. Copy of letter is annexed. The NRC, NCTE had considered the application of above institution and conducted inspection for granting recognition for D.El.Ed. course after Order of the Hon'ble High Court but the application of this institution for grant of recognition for D.El.Ed. course was returned despite of order of Hon'ble High Court. The NRC, NCTE had returned the application of this institution on totally arbitrary, unjustified, illegal and unconstitutional basis because this institution has submitted application for grant of recognition for D.El.Ed. course (02 units) through online electronically mode and required processing fees of Rs. 50100/- has been submitted to NRC, NCTE on 31.12.2012. Thus, NRC, NCTE has rejected the application of this institution for grant of recognition for D.El.Ed. course (02 units) on illega, unlawful, unjustified and unconstitutional basis. So, it is prayed that the rejection order issued by NRC, NCTE be set aside and direction be issued to NRC, NCTE for further processing of the application of this institution for grant of recognition for D.El.Ed. course (02 units).

AND WHEREAS the relevant file of the N.R.C. is not available. It has been brought to the notice of the Committee in their meeting held on 27/12/2018 that the Council, in their letter NO. F. 67/19/2018 – US (Legal) – HQ dt. 18/12/2018. addressed to all their Regional Committees, in the context of the various orders of the Hon'ble High Court of Delhi and the Hon'ble Supreme Court of India referred to therein, directed ensuring compliance of the orders of the Hon'ble Courts and adherence to the provisions of the Regulations 5 (3), 7(4), 7 (5) and 7 (6) of the NCTE Regulations, 2014, irrespective of its stage of processing of application, course, year of application and State it pertains.

AND WHEREAS in view of the above categorica decision of the Council, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, and the documents available on records, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Mahadev STC College, Choti Khatu, Didwana, Rajasthan dated 08/09/2018 is against the Order No. Old App/RJ-----/279/2017/169540 dated 23/03/2017 of the Northern Regional Committee, returning their application for grant of recognition for conducting D.El.Ed. course on the grounds that "In cases where the institutions have submitted the applications by offline mode along with Court orders and where no processing has been initiated by NRC, all such applications be returned to the institutions along with all documents as they have not submitted the applications as per Clause 5, cf NCTE Regulations, 2014."

AND WHEREAS the appellant filed a S.B. Civil Writs No. 20782/2018 before the Hon'ble High Court of Judicature for Rajasthan, Bench at Jaipur praying direction to the respondents to adjudicate upon the pending appeal instituted by the petitioner on 08/09/2018. The Hon'ble High Court, in their order dt. 12/09/2018, disposed of the petition, directing the respondents to expedite the proceedings and adjudicate on the pending appeal as expeditiously as possible, preferably within six weeks from the date a certified copy of this order is presented.

AND WHEREAS Sh. Munnalal Verma, Secretary, Mahadev STC College, Choti Khatu, Didwana, Rajasthan presented the case of the appellant institution on 17/11/2018. In the appeal and during personal presentation and in a letter dt. 17/11/2018, it is submitted that they applied for D.El.Ed. course on 03/09/2008, their application was returned by the N R.C. with their letter dt. 02/03/2009 deciding not to grant recognition to any institution in Rajasthan for B.Ed./STC/Shiksha course for the academic session 2009-10; they filed a S.B. Civil Writ Petition No. 15826/2016 before the Hon'ble Rajasthan High Court; the Hon'ble High Court in their order dt. 16/11/2016

granted liberty to the petitioner to move an application before N.R.C. for recognition of STC course under NCTE Regulations, 2014; they again submitted their returned application with court orders on 21/11/2016; and the N.R.C. again returned their application with their letter dt. 23/03/2017.

AND WHEREAS the appellant further submitted that requirement of online submission of applications was introduced first time under NCTE Regulations, 2014, which can be filed only when the NCTE portal is open and 2008 Regulations did not contain this provision, the controversy regarding online submission was settled by the Appellate Authority in a similar matter vide order dt. 16/10/2017, copy annexed; the respondent had already granted recognition to several institutions ignoring the above shortcomings vide recognition order dt. 26/08/2016 for D.El.Ed. course; the act of respondent giving recognition to various institutions and rejecting their application is faulty and discriminatory; the respondent did not issue any show cause notice before passing an adverse order as per the requirements of Section 14 (3) (b) of the NCTE Act, 1993 providing a reasonable opportunity to the institution for making a written representation; they made necessary arrangements with regard to physical infrastructure and other facilities; and returning their application in an arbitrary manner is bad in the eye of law and is liable to be quashed and set aside.

AND WHEREAS the relevant file of the N.R.C. is not available. It has been brought to the notice of the Committee in their meeting held on 27/12/2018 that the Council, in their letter NO. F. 67/19/2018 – US (Legal) – HQ dt. 18/12/2018, addressed to all their Regional Committees, in the context of the various orders of the Hon'ble High Court of Delhi and the Hon'ble Supreme Court of India referred to therein, directed ensuring compliance of the orders of the Hon'ble Courts and adherence to the provisions of the Regulations 5 (3), 7(4), 7 (5) and 7 (6) of the NCTE Regulations, 2014, irrespective of its stage of processing of application, course, year of application and State it pertains.

AND WHEREAS in view of the above categorical decision of the Council, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, and the documents available on records, the Committee concluded that the N.R.C. was justified in returning the application and the efore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

AND WHEREAS the appellant, aggrieved by the Letter of the N.R.C. returning their application, filed a S.B. Civil Writs No. 21147/2018 before the Hon'ble High Court of Judicature for Rajasthan, Bench at Jaipur. The Hon'ble High Court, in their order dt. 18/09/2018, disposed of the petition, reserving liberty to the petitioner to avail remedy of appeal. The Hon'ble High Court also observed that in case an appeal is instituted by the petitioner, the Appellate Authority would deal with the same as expeditiously as possible, in accordance with law.

AND WHEREAS Sh. Sushil Kumar, Secretary, Shri Kanhi Ram Memorial College of Education, Churina, Buhana Rajasthan presented the case of the appellant institution on 17/11/2018. In the appeal and during personal presentation it was submitted that "they applied for grant of recognition for B.Ed. course on 30/10/2008; the N.R.C. returned their application on 08/03/2009 in an illegal manner as NCTE Regulations do not have any Clause to return the file; in compliance with the orders of the Hon'ble High Court dt. 20/07/2016 in S.B. C.W.P. No. 9232/2016 filed by them, they submitted a representation to N.R.C cn 14/10/2016; and again N.R.C. returned their application on 23/03/2017.

AND WHEREAS the appellant further submitted that the NRC erred in deciding the matter and did not make any effort to even look at the application in consonance of NCTE's Regulation under which the application was submitted offline. Further, also reiterated here that there was virtual impossibility in submitting the application online and after directions of Hon'ble Court narrated above the application was submitted offline. If the institution were provided opportunity to move an application before the NRC as per the directions of Hon'ble Court given in another identical matters, it would have been done but due to the virtual impossibility, online submission was totally impossible. The appellant institution submitted his application along with in reference to another identical/similar matters, but the respondent Committee not considered the matter as per reference. Further, in a similar matter while disposing of the appeal u/s 18 of NCTE Act, 1993, the Appellate Authority of NCTE vide order No. 89-534/E8922/2017 Appeal/ 15th Meeting-2017 dt. 16.10.2017 titled "St. Meera T.T. College" directed the NRC to process further the application on the ground that "...the Committee noted that the appellant could not have submitted the application online within the time frame allowed by the Hon'ble High Court on 10.12.2015 i.e. one month, which is a virtual impossibility due to closure of NCTE portal." A copy of order dated 16.10.2017 is annexed. The controversy was settled by the Appellate Authority vide order dt. 05/06/2018 (copy enclosed) in the case of Sorabh College of Teacher Training, Sawai Madhopur, Rajasthan. The respondent granted recognition to several institutions ignoring the above said shortcomings vide order dt. 26/08/2016, copy enclosed. The act of respondent giving recognition to various institutions and rejecting their application is faulty and discriminatory in nature. The respondent did not issue any Show Cause Notice before passing an adverse order as per Section 14 (3) (b) of the NCTE Act, 1993, providing a reasonable opportunity to the institution for making a written representation. The rejection order is neither speaking nor reasoned. The appellant made necessary arrangements with regard to physical infrastructure and other facilities but their application has been returned in a most arbitrary manner, making the order bad in the eye of law and liable to be quashed and set aside.

AND WHEREAS the relevant file of the N.R.C. is not available. It has been brought to the notice of the Committee in their meeting held on 27/12/2018 that the Council, in their letter NO. F. 67/19/2018 – US (Legal) – HQ dt. 18/12/2018, addressed to all their Regional Committees, in the context of the various orders of the Hon'ble High Court of Delhi and the Hon'ble Supreme Court of India referred to therein, directed ensuring compliance of the orders of the Hon'ble Courts and adherence to the provisions of the Regulations 5 (3), 7(4), 7 (5) and 7 (6) of the NCTE Regulations, 2014, irrespective of its stage of processing of application, course, year of application and State it pertains.

AND WHEREAS in view of the above categorical decision of the Council, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

The Hon'ble High Court also observed that in case an appeal is instituted by the petitioner, the Appellate Authority would deal with the same as expeditiously as possible, in accordance with law.

AND WHEREAS Sh. Vinoc Kumar Lamba, Administrator, Sardar Patel B.Ed. College, Hanuman Nagar, Vistar, Jaipur, Rajasthan presented the case of the appellant institution on 17/11/2018. In the appeal and during personal presentation it was submitted that "they applied for grant of recognition for B.Ed. course on 07/10/2008; their application was returned in an illegal manner as the Regulations of NCTE did not have any Clause to return the file; aggrieved by the action of respondents, they preferred a S.B. C.W.P. No. 14991/2015 before the Hon'ble High Court; in compliance of the Hon'ble Court's order dt. 28/10/2015 they submitted a representation on 31/08/2016; and the respondent again their application on 14/03/2017.

AND WHEREAS the appellant further submitted the NRC erred in deciding the matter and did not make any effort to even look at the application in consonance of NCTE's Regulation under which the application was submitted offline. Further, it is also reiterated here that there was virtual impossibility in submitting the application online and after directions of Hon'ble Court narrated above the application was submitted offline. If the institution were provided opportunity to move an application before the NRC as per the directions of Hon'ble Court given in another identical matters, it would have been done but due to the virtual impossibility, online submission was totally impossible. The appellant institution submitted his application along with in reference to another identical/similar matters, but the respondent Committee not considered the matter as per reference. The act of the respondent giving recognition to various institutions and rejecting their application is faulty and discriminatory in nature; the respondent did not issue any Show Cause Notice to the appellant as per the provisions of Section 14 (3) (b) of NCTE Act, 1993 providing a reasonable opportunity to the institution for making a representation before passing an adverse order; the appellant made necessary arrangement with regard to physical infrastructure and other facilities; and their application has been returned in a most arbitrary manner, making it bad in the eyes of law and liable to be quashed and set aside.

ORDER

WHEREAS the appeal of S.G. College, Churina, Narnaul Road, Buhana, Rajasthan dated 02/10/2018 is against the Letter F.No. Old APP/NRCAPP-6114/191/2017/169558 dt. 23/03/2017 of the N.R.C. returning their application for grant of recognition for conducting D.El Ed. course on the grounds. "The N.R.C. in its 264th meeting held from 20th to 23rd February, 2017 (Part 5) considered the matter regarding applications received from the Teacher Education Institutes in the State of Rajasthan alongwith legal advice obtained and decided as under:- In cases where the institutions have submitted the applications by offline mode alongwith Court orders and where no processing has been initiated by NRC, all such applications be returned to the institutions along with all documents as they have not submitted the applications as per Clause 5, of NCTE Regulations, 2014."

AND WHEREAS the appellant, aggrieved by the Letter of the NRC returning their application file a S.B. Civil Writs No. 21091/2018 before the Hon'ble High Court of Judicature for Rajasthan, Bench at Jaipur. The Hon'ble High Court, in their order dt. 18/09/2018, disposed of the petitioner, reserving liberty to the petition to avail remedy of appeal. The Hon'ble High Court also observed that in case an appeal is instituted by the petitioner, the Appellate Authority would deal with the same as expeditiously as possible, in accordance with law.

AND WHEREAS Sh. Sushil Kumar, Secretary, S.G College, Churina, Narnaul Road, Buhana, Rajasthan presented the case of the appellant institution on

17/11/2018. In the appeal and during personal presentation it was submitted that "they submitted an online application for D.El.Ed. course on 29/12/2012; the N.R.C. returned their application on 19/06/2013 in an illegal manner as NCTE Regulations do not have any Clause to return the file; in compliance with the orders of the Hon'ble High Court dt. 20/07/2016 in S.B. C.W.P. No. 9229/2016 filed by them, they submitted a representation to N.R.C. on 31/08/2016; and again N.R.C. returned their application on 23/03/2017. The NRC erred in deciding the matter and did not make any effort to even look on the application of our institution which surely is an online application bearing application ID NRCAPP-6114 which was submitted online on 29.12.2012.

AND WHEREAS the appellant further submitted that the NRC erred in deciding the matter and did not make any effort to even look at the application in consonance of NCTE's Regulation under which the application was submitted. Further, it is also reiterated here that there was virtual impossibility in submitting the application online and after directions of Hon'ble Court narrated above the application was submitted offline. If the institution were provided opportunity to move an application before the NRC as per the directions of Hon'ble Court given in another identical matters, it would have been done but due to the virtual impossibility, online submission was totally impossible. The appellant institution submitted his application along with in reference to another identical/similar matters, but the respondent Committee not considered the matter as per the reference. Further, in the similar matter while disposing of the appeal u/s 18 of the NCTE Act, 1993, the appellate authority of NCTE vide order No. 89-534/E-8922/2017 Appeal/15th Meeting-2017 dt. 16.10.2017 titled "St. Meera T.T. College" directed the NRC to process further the application on the ground that "...the Committee noted that the appellant could not have submitted the application online within the time frame allowed by the Hon'ble High Court on 10.12.2015 i.e. one month, which is a virtual impossibility due to closure of NCTE portal." A copy of order dated 16.10.2017 is annexed. The controversy was settled by the Appellate Authority vide order dt. 05/06/2018 (copy enclosed) in the case of Sorabh College of Teacher Training, Sawai Madhopur, Rajasthan. The respondent granted recognition to several institutions ignoring the above said shortcomings vide order dt. 26/08/2016, copy enclosed. The act of respondent giving recognition to various institutions and rejecting their application is faulty and discriminatory in nature. The respondent did not issue any Show Cause Notice before passing an adverse order as per Section 14 (3) (b) of the NCTE Act, 1993, providing a reasonable opportunity to the institution for making a written representation. The rejection order is neither speaking nor reasoned. The appellant made necessary arrangements with regard to physical infrastructure and other facilities but their application has been returned in a most arbitrary manner, making the order bad in the eye of law and liable to be quashed and set aside.

AND WHEREAS the relevant file of the N.R.C. is not available. It has been brought to the notice of the Committee in their meeting held on 27/12/2018 that the Council, in their letter NO. F. 67/19/2018 – US (Legal) – HQ dt. 18/12/2018, addressed to all their Regional Committees, in the context of the various orders of the Hon'ble High Court of Delhi and the Hon'ble Supreme Court of India referred to therein, directed ensuring compliance of the orders of the Hon'ble Courts and adherence to the provisions of the Regulations 5 (3), 7(4), 7 (5) and 7 (6) of the NCTE Regulations, 2014, irrespective of its stage of processing of application, course, year of application and State it pertains.

AND WHEREAS in view of the above categorical decision of the Council, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, and the documents available on records, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Aravali College of Education, Neema Ka Thana, RIICO Industrial Area, Neem Ka Thana, Rajasthan dated 15/10/2018 is against the Letter No. Old App/RJ-1545/206/2017/169474 dated 23/03/2017 of the Northern Regional Committee returning application seeking recognition for conducting D.El.Ed. course on the grounds that "In cases where the institutions have submitted the applications by offline mode along with Court orders and where no processing has been initiated by NRC, all such applications be returned to the institutions along with all documents as they have not submitted the applications as per Clause 5, of NCTE Regulations, 2014."

AND WHEREAS the appellant aggrieved by the letter of the N.R.C. dated 23/03/2017 returning their application, filed a S.B. Civil Writs No. 21832/2018 before High Court of Judicature for Rajasthan, Bench at Jaipur. Hon'ble High Court in their order dated 25/09/2018 disposed of the petitioner granting liberty to the petitioner to avail remedy of Appeal which is required to be disposed of expeditiously.

AND WHEREAS Sh. Kailash, Secretary, Aravali College of Education, Neema Ka Thana, RIICO Industrial Area, Neem Ka Thana, Rajasthan presented the case of the appellant institution on 19/11/2018. In the appeal and during personal presentation it was submitted that "NRC erred in deciding the matter and did not make any effort to even look on the application in consonance of NCTE's Regulation under which the application was submitted offline. Further, it is also reiterated here that there was virtual impossibility in submitting the application online and after directions of Hon'ble Court narrated above the application was submitted offline. Had the institution been provided opportunity to move an application before the NRC as per the directions of

Hon'ble Court given in other identical matters, it would have been done but due to the virtual impossibility, online submission was totally impossible. The appellant institution submitted application along with in reference to another identical/similar matters but the respondent committee did not consider the matter. On the grounds discussed and narrated above, the ground of rejection of our application is solely baseless. In similar matter while disposing of the appeal u/s 18 of NCTE Act, 1993, the appellate authority of NCTE vide order No. 89-534/E-8922/2017 Appeal/15th Meeting-2017 dt. 16.10.2017 titled "St. Meera T.T. College" directed the NRC to process further the application on the ground that "...the Committee noted that the appellant could not have submitted the application online within the time frame allowed by the Honble High Court on 10.12.2015 i.e. one month, which is a virtual impossibility due to closure of NCTE portal."

AND WHEREAS the relevant file of the N.R.C. is not available. It has been brought to the notice of the Committee in their meeting held on 27/12/2018 that the Council, in their letter NO. F. 67/19/2018 – US (Legal) – HQ dt. 18/12/2018, addressed to all their Regional Committees, in the context of the various orders of the Hon'ble High Court of Delhi and the Hon'ble Supreme Court of India referred to therein, directed ensuring compliance of the orders of the Hon'ble Courts and adherence to the provisions of the Regulations 5 (3), 7(4), 7 (5) and 7 (6) of the NCTE Regulations, 2014, irrespective of its stage of processing of application, course year of application and State it pertains.

AND WHEREAS in view of the above categorical decision of the Council, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, and the documents available on records, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Swami Vivekanand Teacher Training School, Bhawani Mandi Dug Road, Pachpahar, Rajasthan dated 17/10/2018 is against the Letter No. Old App/NRCAPP-9308/204/2017/169588 dated 23/03/2017 of the Northern Regional Committee, returning their application for grant of recognition for conducting D.El.Ed. course on the grounds that "In cases where the institutions have submitted the applications by offline mode along with Court orders and where no processing has been initiated by NRC, all such applications be returned to the institutions along with all documents as they have not submitted the applications as per Clause 5, of NCTE Regulations, 2014."

AND WHEREAS the appellant filed a S.B. Civil Writs No. 21835/2018 before the Hon'ble High Court of Judicature for Rajasthan, Bench at Jaipur. The Hon'ble High Court, in their order dt. 25/09/2018, disposed of the petition reserving liberty to the petitioner to avail remedy of appeal. The Hon'ble High Court also observed that in case an appeal is instituted by the petitioner, the Appellate Authority would deal with the same as expeditiously as possible, in accordance with law.

AND WHEREAS Sh. Rajkumar, Secretary, Swami Vivekanand Teacher Training School, Bhawani Mandi Dug Road, Pachpahar, Rajasthan presented the case of the appellant institution on 20/11/2013. In the appeal and during personal presentation it was submitted that they applied for D.El.Ed. course online on 31/12/2012; the N.R.C. returned their application in a gross illegal manner as the Regulations of NCTE did not have any Clause to return the file; aggrieved by the action of the respondent, they preferred a S.B. C.W.P. No. 13495/2016 and in consonance of the order of the Hon'ble Court dt. 29/09/2016, they submitted a representation dt. 37/10/2016 to the N.R.C. to

consider their file; and N.R.C., without giving a reasonable opportunity of hearing to the appellant returned their application with their letter dt. 23/03/2017.

AND WHEREAS the appellant further submitted that the NRC erred in deciding the matter and did not make any effort to even look at the application in consonance of NCTE's Regulation under which the application was submitted offline. Further, it is also reiterated here that there was virtual impossibility in submitting the application online and after directions of Hon'ble Court narrated above the application was submitted If the institution were provided opportunity to move an application before the NRC as per the directions of Hon'ble Court given in another identical matters, it would have been done but due to the virtual impossibility, online submission was totally impossible. The appellant institution submitted his application along with in reference to another identical/similar matters, but the respondent Committee not considered the matter as per reference. On the grounds discussed and narrated above, the ground of rejection of our application is solely baseless. Further, in the similar matter while disposing of the appeal u/s 18 of NCTE Act, 1993, the appellate authority of NCTE vide order No. 89-534/E8922/2017 Appeal/ 15th Meeting-2017 dt. 16.10.2017 titled "St. Meera T.T. College" directed the NRC to process further the application on the ground that "...the Committee noted that the appellant could not have submitted the application online within the time frame allowed by the Hon'ble High Court on 10.12.2015 i.e. one month, which is a virtual impossibility due to closure of NCTE portal." A copy of order dated 16.10.2017 is annexed. The controversy was settled by the Appellate Authority vide order dt. 05/06/2018 in the case of Sorabh College of Teacher Training, Sawai Madhopur, Rajasthan. The respondent had already granted recognition to several institutions, ignoring the above said shortcomings vide recognition order for D.El.Ed. dt. 26/08/2016. The act of the respondent giving recognition to various institutions and rejecting their application is faulty and discriminatory in nature. The respondent, before issuing the adverse order did not provide a reasonable opportunity to the institution for making a written representation under Section 14 (3) (b) of the NCTE Act, 1993. The appellant made necessary arrangements with regard to physical infrastructure and other facilities. The rejection order which is neither reasoned nor speaking is bad in the eye of law and is liable to be quashed and set aside.

AND WHEREAS the relevant file of the N.R.C. is not available. It has been brought to the notice of the Committee in their meeting held on 27/12/2018 that the Council, in their letter NO. F. 67/~9/2018 – LS (Legal) – HQ dt. 18/12/2018, addressed to all their Regional Committees, in the context of the various orders of the Hon'ble High Court of Delhi and the Hon'ble Supreme Court of India referred to therein, directed ensuring compliance of the orders of the Hon'ble Courts and adherence to the provisions of the Regulations 5 (3), 7(4), 7 (5) and 7 (6) of the NCTE Regulations, 2014, irrespective of its stage of processing of application, course, year of application and State it pertains.

AND WHEREAS in view of the above categorical decision of the Council, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, and the documents available on records, the Committee concluded that the N.R.C. was justified in returning the application and therefore, the appeal deserved to be rejected and the decision of the N.R.C. confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.
