ORDER

WHEREAS the appeal of Crescent College of Education, Nipani, Khandwa, (East dated 26/03/2016 against the Order Nimar), Madhya 👚 Pradesh WRC/APP3229/222/240th/{M.P.}/2016/159089 dated 27/01/2016 of the Western Regional Committee, rejecting their application for grant of recognition for conducting D.El.Ed. course on the grounds that "This is a Minority Society. The applicant Society is not conducting any other Teacher Education Course, nor has it applied for any Teacher Education Course. It is not conducting any other Higher Education Course. An examination of the documents shows that the society does not possess land in accordance with NCTE Regulations, 2014. The copies of land documents submitted by it, show that it is a private lease. Since possession of land is a mandatory condition for the consideration of a case, this application is summarily rejected. In view of the above, the application of the institution is hereby summarily rejected."

AND WHEREAS Sh. M. Salim Khan, Treasurer and Mr. Shahbaz Khan, Representative, Crescent College of Education, Nipani, Khandwa, (East Nimar), Madhya Pradesh presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation it was submitted that "a registered lease deed for 33 years according to NCTE Regulations, 2014 is attached herewith."

AND WHEREAS the Committee noted that the appellant is neither conducting any teacher education course nor applied for any other teacher education course (besides applying for D.El.Ed. course) nor conducting any higher education course. According, to the provisions of clause 8(i) of the NCTE Regulations, 2014 new teacher education institutions shall be located in a composite institution. The Committee also noted that the land is taken by the appellant on lease from a private person while clause 8(4) of the NCTE Regulations, 2014 stipulates that, on the date of application, the land should be

on ownership basis or on lease from Government or Government institutions. In these circumstances, the Committee concluded that the W.R.C. was justified in rejecting the application and the refore, the appeal deserved to be rejected and the order of the W.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Al Fatima Educational Society B.Ed. College, Phulwari Sharif, Patna, Bihar dated 28/03/2016 is against the Order No. ERC/7-198.9(i).26/ERCAPP2891/B.Ed. (Additional Intake)/2015/46634 dated 21.05.2016 of the Eastern Regional Committee, summarily rejecting their application for grant of recognition for conducting B.Ed. course (Additional Intake) on the ground that "copy of the registered land document not submitted with the hard copy of the print out of online application."

AND WHEREAS Sh. Asadullah Khan, Secretary, Al Fatima Educational Society B.Ed. College, Phulwari Sharif, Patna, Bihar presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation it was submitted that "they are running B.Ed. College from session 2013-14 and the original document of land paper for land measuring approx. 2 acre is with the ERC. The appellant enclosed a copy of the sale deed to the appeal and in the course of hearing submitted a certified copy thereof."

AND WHEREAS the Committee, noted that the appellant, with the hard copy of the application did not enclose copy of the sale relating to the land. While the appellant in the course of hearing stated that the original land document was submitted while seeking recognition for the basic unit of B.Ed., he did not mention this fact while applying for the additional intake. According, to the provisions of Clause 7(2)(b) of the NCTE Regulations, 2014, failure to submit land documents along with the print out of the application attracts summary rejection of the application. Since, the appellant did not furnish the land document with his application, the Committee concluded that the ERC was justified in rejecting the application and therefore, the appeal deserved to be rejected and the order of the ERC confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the ERC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the ERC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Balipukur Teachers Training College, Tapan, Dakshin Dinajpur, West Bengal dated 28/03/2016 is against the Order No. ER/7-204.9(i).193/ERCAPP2299/(B.Ed.)/2016/44479 dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "a. Show Cause Notice was issued on 15/01/2016 on the following grounds: (i) The applicant submitted two applications simultaneously one for D.El.Ed. in the name of Balipukur Teacher Training College and another for B.Ed. in the name of Tapan Kumar Ghosh which does not come under the category of composite institution. Hence the institution comes under the category of stand-alone institution. b. Reply dated 25/01/2016 submitted by the institution is not satisfactory. In view of the above, the Committee decided as under:- The Committee is of the opinion that application bearing code No. ERCAPP2299 of the institution regarding recognition for B.Ed. Course is refused under section 14(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Subrata Sarkar, Member and Sh. Najibur Rahaman, Treasurer, Balipukur Teachers Training College, Tapan, Dakshin Dinajpur, West Bengal presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation it was submitted that "(i) the applicant Trust, set-up with the objective to build up an academic environment of higher education for the under privileged students of the District "Dakshin Dinajpur" in West Bengal, resolved in its general meeting held on 15th October, 2013 at Dakshin Dinajpur office, starting D.El.Ed. and B.Ed. college for the academic session 2016-17 in the name of "Balipukur Teacher Training College" under "Balipukur Minority Educational and Health Welfare Trust"; (ii) the applicant Trust, submitted its online applications for grant of recognition for the academic session 2016-17 on 19/05/2015 for D.El.Ed. Programme (ERCAPP2284) and

on 20/05/2015 for B.Ed. programme (ERCAPP2299) with annual intake 100 (two basic units) as a composite institute; (iii) the applicant Trust, before submitting online application was in possession of 100 decimal of land and 3198.372 sq. mts. of built-up area in the name of managing body "Balipukur Minority Educational and Health Welfare Trust" which satisfied the norms for composite institution as per NCTE Regulations, 2014; (iv) the applicant Trust obtained NOC from W.B.B.P.E and the University of Gour Banga in the name of the institution "Balipukur Teachers Training College" and all other relevant documents including building plan is in favour of the trust; (v) the applicant Trust had submitted its online application for D.El.Ed. (ERCAPP2284) Programme in the name of the institution "Balipukur Teacher Training College" and for B.Ed. (ERCAPP2299) Programme in the name of the Secretary "Tapan Kumar Ghosh", instead of the name of the institution, which was absolutely an unintended typographical error/mistake or technical inaccuracy that was not considered; (vi) the managing body "Balipukur Minority Educational and Welfare Trust" is in possession of all functional aspects to establish the institution as a parent body, since in the initial stage, there was no existence of the institution; (vii) the applicant Trust, in its reply dated 25/01/2016 to the Show Cause Notice vide proceedings of 201 meeting held on 4th - 5th January 2016 by ERC, NCTE, Bhubaneswar explained its stance on such typographical error/mistake and also prayed for consideration of the application; and (viii) the application for D.El.Ed. (ERCAPP2284) is complete in all respects but there is only the typographical error/mistake in B.Ed. (ERCAPP2299) application but both the applications were rejected by the ERC NCTE, whereas in the affidavit and undertaking it was clearly mentioned that the proposed B.Ed. application is in the name of the institution "Balipukur Teacher Training College" under the Trust "Balipukur Minority Educational and Health Welfare Trust". The appellant further submitted that the ERC, NCTE rejected the application (ERCAPP2299) for B.Ed. Programme without considering the facts of the applicant Trust/Institution despite passing of 9 months (approx.) from the receipt of the hard copies of the online application (28/05/2015) to the issuance of rejection order (03/03/2016). The applicant Trust, found a precedent in an appeal order F.No. 89-306/2010/Appeal, dated 01/06/2010, from internet, where the Hon'ble Appeal Committee considered the case of typographical errors/mistake and reverted back the matter to the NRC, NCTE for reconsideration, which is analogous to the Applicant Trust/Institution. The appellant, therefore, requested to reconsider the case for further processing of the application."

and whereas the Committee, noting the detailed and self-explanatory submissions of the appellant, which confirm that their institution falls under the category of composite institution, concluded that the matter deserved to be remanded to the E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

NOW THEREFORE, the Council hereby remands back the case of Balipukur Teachers Training College, Tapan, Dakshin Dinajpur, West Bengal to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Arunachal University of Studies, Namsai, Lohit, Arunachal Pradesh dated 29/03/2016 İS against the Order No. ER/7-204.9(i).194/ERCAPP2650/D.El.Ed./2015/44219 dated 01/03/2016 of the Eastern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "1. Show Cause Notice was issued on 09/02/2016 on the following grounds: (i) NOC issued from affiliating/examining body not submitted. 2. Reply dated 10/02/2016 submitted by the institution is not satisfactory. In view of the above, the Committee decided as under: The Committee is of the opinion that application bearing Code No. ERCAPP2650 of the institution regarding recognition for D.El.Ed. Course is refused under section 14(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. H.B. Sharma, Representative and Dr. A.L. Agarwal, Director, Arunachal University of Studies, Namsai, Lohit, Arunachal Pradesh presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation it was submitted that "in Arunachal Pradesh the D.El.Ed. Programme is conducted by the Directorate of Elementary Education, Govt. of Arunachal Pradesh, Itanagar. The Directorate of Elementary Education, Govt. of Arunachal Pradesh, Itanagar has issued NOC to the Arunachal University of Studies vide D.O. No. DEE/TE/2014-15 dated May 14, 2015 which states as follows: "This is to certify that the Directorate of Elementary Education, Govt. of Arunachal Pradesh, Itanagar has no objection on two years Diploma in Elementary Education (D.El.Ed.) programme to be conducted by the Arunachal University of Studies after due approval from National Council for Teacher Education". (copy enclosed) The Arunachal University of Studies has already created required infrastructure and laboratories in accordance with NCTE Norms to conduct the programme. Further in support of their appeal they submitted that the condition of

Arunachal Pradesh in terms of Teacher's Education requires lot of efforts and training. The Govt. of Arunachal Pradesh is facing the problem in appointing trained teachers. The entire Arunachal Pradesh is having only 345 seats for the D.El.Ed. Programme (as per information available on ERC, NCTE website), which is highly insufficient in catering to the needs of D.El.Ed. Programme. Moreover, none of the institutions is situated in Namsai and even surrounding Districts. Thus in the light of above facts, kindly consider the appeal and constitute VT for the purpose of inspection."

AND WHEREAS the Committee noted that with reference to the proceedings of E.R.C., the appellant, with their letters dt. 10.02.2016 and 25.02.2016 forwarded copies of two N.O.C's issued by the Government of Arunachal Pradesh, Elementary Education on 14.05.2015 and 08.02.2016 to the E.R.C. The letters and copies of the NOCs are available in the file of the E.R.C. In these circumstances, the Committee concluded that the matter deserved to be remanded to the E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

NOW THEREFORE, the Council hereby remands back the case of Arunachal University of Studies, Namsai, Lohit, Arunachal Pradesh to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Kalimuddin Smriti B.Ed. College, Raiganj, Uttar Dinajpur, West dated 30/03/2016 Bengal is against the Order No. ER/7-205.8.8/ERCAPP2510/B.Ed./2016/44436 dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "(a) Show cause notice was issued on 19/01/2016 on the following grounds: (i) the applicant submitted single application for B.Ed. programme which comes under the category of stand-alone institution. (ii) In response to show cause notice the institution has submitted its reply 10/02/2016 with a request to change the name of the institution from Kalimuddin Smriti B.Ed. College to Uttar Dinajpur Primary Teacher Training Institution. (c) The Committee has not accepted the request of the institution. In view of the above, the Committee decided as under:- The Committee is of the opinion that application bearing code No. ERCAPP2510 of the institution regarding recognition for B.Ed. course is refused under section 14(3)(b) of NCTE Act 1993."

AND WHEREAS Md. Altaf Hossain, Secretary and Sh. Saiful Alam, Representative, Kalimuddin Smriti B.Ed. College, Raiganj, Uttar Dinajpur, West Bengal presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation it was submitted that "(i) the applicant society, set-up with the objective to build up an academic environment of higher education for the under privileged students of the District "Uttar Pradesh" in West Bengal, resolved in its general meeting held on 7th May, 2015 at Uttar Dinajpur office, of starting a B.Ed. programme for the academic session 2016-17 along with the existing D.Ed. programme (APE00765) as a composite institution as per NCTE Regulation 2014; (ii) the applicant "Sariabad Welfare Society" has already been granted recognition for D.Ed. programme (APE00765) for the academic session 2009-10 with an annual intake of 50 by ERC.

NCTE. (Recognition order No. ERC/7-99.6(I)(1S).13/2009/979(1), dated 4th August, 2009 in the name of "Uttar Dinajpur Primary Teachers Training Institute"; (iii) the applicant Society after considering the NCTE Regulation 2014 did not find any restriction of any bar or clear direction in the names of a composite institute as per NCTE Regulation 2014 and moreover in general aspects a PTTI may not provide any higher education or may not become a B.Ed. college; (iv) therefore at the outset the applicant society has decided a separate name of the B.Ed. College "Kalimuddin Smriti B.Ed. College" under the same society; (v) the applicant "Sariabad Welfare Society" submitted its online application in the name of "Kalimuddin Smriti B.Ed. College" for grant of recognition for the academic session 2016-17 with annual intake (100) for B.Ed. programme (ERCAPP2510) on 27/05/2015; (vi) the applicant Society has clearly mentioned in detail about the existing course of D.Ed. programme (APE00765) in the online application form of B.Ed. programme (ERCAPP2510), in Page No.4 under "Details of Existing Teacher Education Programmes run by the same applicant Society/Trust/Organisation/Company; (vii) the applicant Society has satisfied all the norms for B.Ed. application as laid down by NCTE Regulations, 2014 and is running its 8th year of D.Ed. programme successfully since its inception from the academic session 2009-10 onward (2009-10, 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 & 2016-2017); (viii) the applicant Society, before submitting its online application was in possession of 4734 sq.mts. of Land and 4566 sq.mts. of built-up area which satisfied all the norms for composite institution as per NCTE Regulation 2014; (ix) the applicant Society has received its No Objection Certificate from the University of Gour Banga, vide ref. No. 548/UGB/R-15, dated 15/07/2015, which is one of the basic criteria of B.Ed. application; (x) the applicant Society, in its reply vide Ref. No. -R/238/U.D.P.T.T.I/2016, dated 10/02/2016 to the Show Cause Notice vide proceedings of 201 meeting on 4th -5th January 2016 by ERC, NCTE Bhubaneswar, submitted about the existing code of D.Ed. programme (APE00765) which was running under the same managing body "Sariabad Welfare Society" from the academic section 2009-10, in the name of "Uttar Dinajpur Primary Teacher Training Institute." (xi) the Applicant Society, in its reply dated 10/02/2016 also prayed for the change of name of the B.Ed. programme (ERCAPP2510) from "Kalimuddin Samriti B.Ed. College" to "Uttar Dinajpur Primary Teachers Training

Institute" to avoid the dispute as per show cause notice issued by ERC, NCTE; (xii) the appellant Society, has good intention and willingness to become a composite institute and filed the online application for B.Ed. programme (ERCAPP2510) along with existing D.Ed. programme (APE00765) in compliance with the NCTE Regulation 2014, but the dispute in names of the colleges was completely unintended due to insufficient information of NCTE Regulations 2014; and (xiii) ERC, NCTE without consideration of the facts and documentations including affidavit/undertaking rejected the application of B.Ed. programme (ERCAPP2510) applied for the academic session 2015-17 (vide order No. ER/7-205.8.8/ERCAPP2510/B.Ed./2016/44436, dated 03/03/3016) with liberty to file an appeal to the applicant institution as per NCTE Act 1993. ERC, NCTE, after passing of 9 Months (approx.) from the receipt of the hard copies of the online application (27/05/2015) to the issuance of rejection order (03/03/2016). The applicant, therefore, requested to consider the case for further processing of the application."

AND WHEREAS in the course of presentation the Secretary, Sariabad Welfare Society submitted a letter dt. 30.05.2016 affirming that the existing Uttar Dinajpur Primary Teachers Training Institute (D.El.Ed.) and Kalimuddin Smriti B.Ed. College (Proposed B.Ed.) (Composite) are run by the same society with the same address, at the same place and also in the same building as a composite institute.

AND WHEREAS the Committee, noting the detailed submissions of the appellant which confirm that their institution falls under the category of composite institution, concluded that the matter deserved to be remanded to the E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

NOW THEREFORE, the Council hereby remands back the case of Kalimuddin Smriti B.Ed. College, Raiganj, Uttar Dinajpur, West Bengal to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of The Institute for Academic Excellence, Kharagpur, Midnapore, West Bengal dated 31/03/2016 is against the Order No. ER/7-205.8.1/ERCAPP3479/(D.El.Ed.)/2016/44471dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that a. Show Cause Notice was decided in 202nd ERC meeting held on 18-23 January, 2016 on the following grounds: "(i) The institution has submitted land document in the name of Sri Kartick Chandra Acharya i.e. in the name of individual which is not acceptable as per NCTE Regulation 2014. b. The institution submitted its reply on 31/01/2016 on the basis of proceedings uploaded in the website of the ERC. The reply of the institution is not satisfactory. In view of the above, the Committee decided as under: The Committee is of the opinion that application bearing code No. ERCAPP3479 of the institution regarding recognition for D.El.Ed. (Addl. Course) is refused under section 15(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Kartick Chandra Acharya, Chairman and Sh. Yudhistir Mishra, Representative, The Institute for Academic Excellence, Kharagpur, Midnapore, West Bengal presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation and in a letter dt. 30.05.2016 it was submitted that "the deed of gift vide no. 05495 dated August 20, 2010 and the deed of gift vide no. 03052 dated April 13, 2015 were executed for establishment of the institute and Kartick Chandra Acharya received the said deed of gift as Secretary on behalf of the institution. The Secretary also purchased a plot of land on behalf of the college in his capacity as the Secretary of the institute, vide deed of conveyance No. 07468 dated October 25, 2013. Kartick Chandra Acharya received the total land in his capacity as the Secretary of the institution and on behalf of the institution. The institution has been recognised by the NCTE for running B.Ed. Courses on the basis of the same set of documents – including those related to land – on previous occasions, both under the Regulations of

2009 as well as 2014. The State Govt., the affiliating University and the West Bengal Board of Primary Education has granted their approval, affiliation, no objection to the institution respectively. Those records were annexed to the application by which recognition was sought for. The institution was granted recognition by the National Council for Teacher Education (NCTE) from the year 2012-13 to conduct B.Ed. courses of one year duration with an annual intake of 100 students. In terms of Regulation 8(4)(i) of the NCTE Regulations of 2009, the applicant institution was required to be in possession of the required land on the date of application. After being satisfied with the records and considering physical verification report of the college the NCTE granted recognition to the institution. Therefore, NCTE was satisfied with the land in possession of the institution. Under the new Regulations of 2014, which contain similar provisions in respect of land, revised recognition order dated May 25, 2015, was issued to the institution for running two units in B.Ed. course of 50 students each. On June 17, 2015 the institution made online application seeking recognition for running composite course of D.El.Ed. from the existing premises of the college. In other words the institution was seeking status of composite institution under the regulations of 2014. The application of the institution was accepted and assigned application number being ERCAPP3479. Along with said application all relevant documents including recognition of the institute for B.Ed. course since 2012 were enclosed. While no formal show cause was received, on the basis of information in the website, by a letter dated January 31, 2016, the appellant informed the Director of the Eastern Regional Committee that there might have been some confusion regarding the record of rights wherein the name of the individual as Secretary was appearing before the institution due to inadvertence. necessary correction has already been done in the record of rights. To substantiate the different documents including corrected record of rights were enclosed with the said letter. On February 16, 2016, the appellant made representation enclosing copies of mutation of land, Kajhna receipts, tax receipts by the panchayat, conversion certificate, etc. to the ERC for further clarification. To remove any future confusion regarding the title of the land, the said Kartick Chandra Acharya as the then Secretary of the institution executed a deed declaring that the land in question is owned by the institution and the said deed was duly registered as deed no. 100901505 dated February 26, 2016 before

the Additional District Sub-Registrar, Narayangarah, District Paschim Medinipur. Without considering the records submitted by the appellants and / or without considering the letters dated January 31, 2016 and February 16, 2016 and even after a rectified deed was executed, E.R.C, NCTE by a non-speaking resolution at serial number 29 refused the prayer for recognition of the appellants. In the circumstances, the appellant requested to set aside the impugned order."

and whereas the Committee noted that the appellant along with his detailed submissions and documents, enclosed a copy of the certificate dt. 29.01.2016 issued by the Block Land and Land Reforms Officer Narayangarh at Belda, Government of West Bengal certifying the lands at various survey numbers mentioned therein are under the possession of the Institute for Academic Excellence free from from all encumbrances and any litigation. It is also certified that the Institute is running B.Ed. course on these plots. It is seen that the same plot numbers shown in this certificate have been mentioned in the appellants online application for D.El.Ed. course. In these circumstances, the Committee concluded that the matter deserved to be remanded to the E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee condended that the appeal deserves to be remanded to E.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

NOW THEREFORE, the Council hereby remands back the case of The Institute for Academic Excellence, Kharagpur, Midnapore, West Bengal to the ERC, NCTE, for necessary action as indicated above.

The appellant is directed to submit a copy of the certificate to the S.R.C. within 15 days of receipt of the orders on the appeal.

The appellant, in his letter dt. 30.05.2016, submitted that the delay in submission of the appeal was due to delay in the process of getting approval for the Head of the Department and lecturers. AND WHEREAS Sh. Suresh Kumar, Member and Sh. Chandrkesh, Member, Janhit Mahavidyalaya, Gomtinagar, Jaunpur, Uttar Pradesh presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation it was submitted that "Veer Bahadur Singh Purvanchal University, Jaunpur has not given subject expert in time for interview of HOD and Lecturer. During the presentation, the appellant submitted copies of the letters dt. 20.04.2016 and 28.04.2016 from the Vir Bahadur Singh Purvanchal University, Jaunpur approving the lecturers and the Head of the Department."

AND WHEREAS the Committee noted that the NRC issued the Letter of Intent (L.O.I) to the appellant on 10.04.2015. The appellant in his reply dt. 06.07.2015 requested for five months time as the process of getting approval of the university for teaching staff is under way. N.R.C. thereafter issued a show cause notice on

20.08.2015. As no response was received to the show cause notice, NRC refused recognition and issued the refusal order on 14.10.2015.

and whereas the Committee, noting that (i) the appellant requested time for complying with the requirements of teaching staff; (ii) the process of approval was under consideration of the university; and (iii) the university has since approved the teaching faculty, concluded that the matter deserved to be remanded to the N.R.C. with a direction to consider the approved staff list and take further action as per the NCTE Regulations. The appellant is directed to submit the list of faculty approved by the university and other relevant documents to the N.R.C. within 15 days of receipt of the orders on the appeal.

available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to N.R.C. with a direction to consider the approved staff list and take further action as per the NCTE Regulations. The appellant is directed to submit the list of faculty approved by the university and other relevant documents to the N.R.C. within 15 days of receipt of the orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Janhit Mahavidyalaya, Gomtinagar, Jaunpur, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Jangaon College of Education, Nidigonda, Warangal, Telangana dated 01/04/2016 is against the Order No. SRO/NCTE/SRCAPP3580/B.Ed.M.Ed/TS/2016-17/81709 dated 15/02/2016 of the Southern Regional Committee, rejecting their application for grant of recognition for conducting B.Ed., M.Ed. course on the ground "of non-submission of reply to SCN issued for non-submission of NOC."

AND WHEREAS Sh. Nagula Raju, Representative and Sh. S. Vinod, Office Superintendent, Jangaon College of Education, Nidigonda, Warangal, Telangana presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation and in a letter dt. 29.05.2016 it was submitted that "the Management has applied for NOC from the affiliating body, i.e. Kakatiya University, Warangal in June, 2015 but they have not responded. The Govt. of Talengana State has not yet issued NOC, though the Regional Director of School Education, T.S. conducted an inspection. The society has provided all infrastructural and instructional facilities for the new course by spending huge amounts. The appellant request to consider their appeal and process the file for the grant of recognition by conducting inspection. The appellant, with his appeal, enclosed a copy of his letter dt. 30.12.2015, which is a reply to the show cause notice dt. 21.10.2015 and which was sent by speed post on 06.01.2016 (as per the speed post receipt copied on the letter), but this letter is not available in the file of the S.R.C."

AND WHEREAS the Committee noted that the appellant in his reply dt. 30.12.2015 has only informed that the university has not responded to their application for N.O.C. The Committee noted that according to the provisions of Clause 5(3) of the NCTE Regulations, 2014, a No Objection Certificate issued by the concerned affiliating body

has to be submitted along with the application. Since the appellant has not fulfilled this requirement the Committee concluded that the appeal deserved to be rejected and the order of the S.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the SRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the SRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Teachers Training College, Mirza, Guwahati, Kamrup, Assam dated 02/04/2016 is against the Order No. ERC/7-207.8.4/D.El.Ed. (Addl. Course)/ERCAPP3540/2016/44321 dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting D.El.Ed. (Additional) course on the grounds that "1. Show Cause Notice was issued on 10/02/2016 on the following grounds: a) The institution submitted single application D.El.Ed. programme. Neither institution is recognized from NCTE nor applied for more than one course simultaneously. The institution comes under the category of stand-alone institution. b) Any institution desirous to running any Teacher Education Programme must be composite institution as per NCTE Regulation 2014. c) Total land area and total built-up area is not indicated in the submitted building plan. The institution is required to submit a blue print of building plan indicating plot Nos., total land area, total built-up area etc. & duly approved by any Govt. Engineer. The institution vide reply dated 25/02/2016 submitted alongwith a copy of building plan in response to show cause notice, as per new building plan the built up area is existing 527.0 sqm and proposed building with toilet 469.36 sq. mts. i.e. 996.36 sq. mts. only which less than the requirement of B.Ed. plus D.El.Ed. programme. Also the multipurpose hall and other instructional facilities have not been indicated. In view of the above, the Committee decided as under: The committee is of the opinion that application bearing code no. ERCAPP3540 of the institution regarding permission for D.El.Ed. (Additional course) is refused under section 15(3)(b) of NCTE Act 1993."

AND WHEREAS Ms. Kanika Dalal, Principal and Sh. Abani Kr. Das, Representative, Teachers Training College, Mirza, Guwahati, Kamrup, Assam presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation and in a letter dt. 23.05.2016 it was submitted that "the college

vide letter no. recognition for its B.Ed. course obtained already Order)/2015/31759 20/05/2015. dated ERC/NCTE/APE00462/B.Ed. (Revised Complying with the new building guidelines as per 2014 Regulation, the college authority of T.T. College, Mirza decided to enhance its built up area by 2592 sq.mtr. above existing 527 sq. mts. The total built up area will be 3119 sq.mt. which will satisfy the requisite Norms of the NOTE and guidelines to make the college a composite institute.

AND WHEREAS the Committee noted that the appellant, who has applied for D.El.Ed. course, has been granted recognition for conducting B.Ed. course. Therefore, the appellant falls under the category of a composite institution. However, according to the copy of the building plan, submitted in response to the show cause notice with the appellant's letter dt. 25.02.2016, as rightly pointed out by the E.R.C., the total built up area, including the proposed construction, comes to only 996.36 sq. mts., which is not adequate even for the existing B.Ed. course. Further this plan did not indicate the existence of a multipurpose hall. The Committee also noted that subsequently, the appellant with his letter dt. 1.03.2016, which was received in the E.R.C. on 09.03.2016, forwarded copy of a different building plan, proposing construction of an additional area of 2592 sq. mts, which also does not indicate the existence of a multipurpose hall. The appellant with his letter dt. 25.03.2016 enclosed a copy of the building plan proposing construction of an additional area of 2592 sq. mts., showing multipurpose hall also. This indicates that the appellant has been submitting different building plans at different times. In the circumstances the Committee concluded that the E.R.C. was justified in refusing recognition on the ground that the appellant does not have built up area adequate for B.Ed. and proposed D.El.Ed. courses, and therefore the appeal deserved to be rejected and the order of the E.R.C. confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the ERC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the ERC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.



It is submitted that theirs is a University established under the Jharkhand Govt. Act No. 15 of 2012 vide Gazette Notification dated 19th July 2012. Having the Status of University, it is empowered to conduct the examination and award Degree/Diploma as per the Act and statute of Sai Nath University. The UGC also in reply to one RTI vide dated 1st August, 2014 had clarified that Sai Nath University can start any Degree/Diploma course at its main campus (copy of letter attached). The appellant also submitted that the NRC had changed the affiliation of Amity Institute of Education, Noida from SCERT, Uttar Pradesh to Amity University, Noida for D.E.C.Ed. and D.El.Ed. Courses. The NRC vide its order dated 3rd March, 2016 had changed the affiliating bodies of five institutions running D.El.Ed. from SCERT, Uttar Pradesh to J.S. University, Shikokabad. (copy attached).

The WRC also vide order dated 20th Oct. 2015 had changed the affiliating body of Swami Vivekanand College, Sagar for running D.El.Ed. course from M.P. Board of Secondary Education to Swami Vivekanand University (copy attached). It is submitted to the Appellant Authority that as per UGC letter dated 1st August 2014, their University can start the D.El.Ed. Course in their campus and it stands on the same lines as the Amity University, J.S. University, Shikohabad and Swami Vivekanand University, for which the NRC and WRC had changed the affiliating body from SCERT to the universities."

Hence, the institution name is different which does not come under the category of composite institution. The institution is standalone institution. In view of the above, the Committee decided as under: The Committee is of the opinion that application bearing code No. ERCAPP3155 of the institution regarding permission for B.Ed. Additional course is refused under section 15(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Mahabir Kumar Das, President, Sova Rani College of Education B.Ed. Malda, West Bengal presented the case of the appellant institution on 30/05/2016. In the appeal and during personal presentation it was submitted that "The institution have submitted two sale deeds in the name of Sova Rani College of Education (D.El.Ed.) comprising of 75 dc. of land equal to 3073.73 sq. mts. which is more than as per NCTE Norms. The land is in the name of the institution but at the time of submission of online application by typical mistake the name of the college was

wrongly mentioned as Sova Rani College of Education (B.Ed.). The institution name may be read as Sova Rani College of Education (D.El.Ed.), in this respect an affidavit is enclosed."

AND WHEREAS the Committee noted from the submissions of the appellant that the area of the two lands purchased by Sova Rani College of Education through sale deeds dt. 08.06.2011 and 26.05.2015 is adequate as per the norms. The Committee also noted that the appellant in their letter dt. 10.06.2015 forwarding the hard copy of the application, stated that they have arranged for opening new course i.e. B.Ed. at their institution i.e. Sova Rani College of Education (D.Ed.), where the existing D.Ed. course is being run since 2013. The appellant, besides admitting in the appeal that the name of the institution as given in the online application i.e. Sova Rani College of Education (B.Ed.) was a typographical mistake, submitted a letter dt. 30.05.2016 stating that the Sova Rani College of Education (D.El.Ed.) is running under the Malda Sova Rani Memorial Education Trust and they want to add another B.Ed. course in the same trust and same place i.e. village Gobindapur, P.O. Birampur, Distt. Malda. These submissions establish that the appellant falls under the category of a composite institution. Incidentally it is noticed that the ground relating to composite institution was not envisaged when the E.R.C. decided to issue a show cause notice in their 202nd meeting held on 18-23, Jan, 2016 and it was included in the refusal order only.

WHEREAS the appeal of Province College of Education, Sonapur, Kamrup, Assam dated 08/04/2016 against the Order No. is ERC/7-207.8.5/ ERCAPP2238/B.Ed./2016/44320 dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "I, "Show cause notice was issued on 09/02/2016 on the following grounds: (i) The institution has not submitted building plan duly approved by any Govt. Civil Authority indicating the demarcated land area and built up area etc. for proposed B.Ed. programme. II. The institution vide reply dated 24/02/2016 submitted copy of building plan in response to show cause notice which is also deficient on the following grounds: Total built up area as per building plan is 316.58 sqm. Which is less than the requirement. The name of the General College is Province College Dr. A.P. whereas as per online application name of the institution is Province College of Education which does not come under the category of composite institution. As per NCTE Regulation 2014, stand-alone institution is not permissible to run any teacher education programme. In view of the above, the committee decided as under: The Committee is of the opinion that application bearing code No. ERCAPP2238 of the institution regarding recognition for B.Ed. is refused under section 14(3) (b) of NCTE Act 1993."

AND WHEREAS Ms. Nabia Ch. Saxena, President, Province College of Education, Sonapur, Kamrup, Assam presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "Appeal under Section 18 of the NCTE Act, against the decision of the 207th meeting of NCTE for refusal for granting permission under section 14(3)(b) of NCTE Act 1993 for the reason insufficient built up area. Ref.-ERC/7-207-85/ERCAPP2238/B.Ed./2016/44320 dated 03/03/2016. The total built up area consists of two buildings i.e.

(i) Assam Type House (floor area)

316.58 Sq. Meters

(ii) 3 Storey building @ 418.91 Sq. Meters

1256.73 Sq. Meters

(per floor)

Total

1573.31 Sq. Meters

As regards composite status of the institute, it is imparting 3 year Degree Course in Arts and Commerce at 'Kaliram Bhawan, Siba path, R.P. Road, Dispur, Guwahati-6. The society has applied for B.Ed. course at Tetalia, sonapur, Guwahati, Kamrup. Institute thus falls under the composite category."

AND WHEREAS Appeal Committee noted that appellant institution did not submit any building plan alongwith hardcopy of the application submitted on 15.05.2015. Appellant submitted alongwith its application a certificate/letter dated 14.05.2015 issued by Tetalia Gaon Panchayat which mentioned a Assam Type House of area 316.58 Sq. Meters and permission for construction of a R.C.C. Building having an area of 135.72 Sq. Meters each of 1st and 2nd floor for Province College of Education. The appellant institution was issued a Show Cause Notice (S.C.N.) dated 09/12/2015 on the ground that the institution has not submitted building plan duly approved by Government civil authority indicating demarcated land and built up area for proposed B.Ed. programme.

The appellant in its reply dt. 24.02.2016 submitted a building plan which was in confirmation of the approval dated 19.05.2015 issued by Tetalia Gaon Panchayat.

AND WHEREAS refusal of the recognition for B.Ed. course by E.R.C. is justified as the built up area of both existing and proposed building plan comes to 588.02 sq. meters as per following calculations:-

(i) Existing Assam Type Bldg.

316.58

(ii) Two floors of 135.72 each

(135.72x2 = 271.44)

271.44

Total 588.02

The building plan as shown approved by Tetalia Gaon Panchayat on 25.02.2016 was not submitted to the Regional Committee. Appeal Committee is also of the view that the institution is not covered under the definition of a composite institution as other courses

being conducted by institution are at a location other than where the B.Ed. programme is proposed to be run by the society. The appellant during the course of appeal presentation also admitted that other courses are being conducted at a different address.



AND WHEREAS Sh. Pabindra Nath Das, President and Sh. Bhabesh Ch. Choudhury, Member, President & B. Roy, Member of the Society for SDP College of Teachers Education, Tihu, Nalbari, Assam presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "Clarification on SCN on opening new course was sent on 24/02/2016. Besides after receipt of your order dated 03/03/2016 our institution has paid the online appeal fee of Rs. 25000/- through D/D on 28/03/2016. Required documents will be sent via post immediately for your perusal."

AND WHEREAS Appeal Committee noted that application for D.El.Ed. course was made by the appellant institution in the name of S.D.P. College of Teacher Education, TINU, Nalbari, Assam. A Show Cause Notice (S.C.N.) dated 10.02.2016 was issued to the appellant institution on following two grounds:

- (i) Approved building plan indicating plot number, land area & built up area not submitted.
- (ii) Land is in the name of Teacher Training College, Tihu whereas the name of applicant institution is SDP College of Teacher Education.

AND WHEREAS Appeal Committee noted that appellant institution in reply to the above S.C.N. furnished copy of two building plans as follows:

(i) Assam Type Building Carpet area 348.00

(ii) Existing ground + proposed first and 2nd floor (Plinth area 252x3) 756.00

The appellant in its reply to S.C.N. also stated that earlier the institution was known as College of Teacher Education, Tihu but the college authority has subsequently decided to change the name of college to S.D.P. College of Teacher Education in memory of the land donor's parent. The appellant during the course of appeal presentation stated that mutation for the change in name has now been done and in the revenue records land is now in name of Sudharani Daloiram Pathak (SDP) College of Teacher Education. The society is already running a B.Ed. course since 1996 in the name of SDP College of Teacher Education.

AND WHEREAS Appeal Committee noted that whereas Show Cause Notice dated 11/02/2016 was on two grounds i.e. (i) building plan, land area, built up area and (ii) land not being in the name of applicant institution. The second ground of refusal relating to request made by institution for change of name of institution from Sudharani Daloiram Pathak College of Teacher Education, Tihu to College of Teacher Education, Tihu is not substantiated. Appellant's reply to S.C.N. was misinterpreted by E.R.C. Appeal Committee further noted that built up area as per details furnished in the building plans submitted by appellant is also not adequate for a composite institution but the Regional

Committee (E.R.C.) has not examined this point. Appeal Committee, decided to remand back the case to E.R.C. Bhubaneswar for revisiting the submission of appellant and for making an appropriate reasoned order.

Now, the institution submitted a letter issued from Mukhiya and signed by Assistant Engineer, Sadar Prakhand, Darbhanga indicating built up area 31850 sq.ft. 4. AND WHEREAS Dr. S.N. Kumar, Representative, Vivekananda Institute of Primary Education, Sadar, Darbhanga, Bihar presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "the applicant trust has submitted its online application for grant of recognition for the academic session 2016-17 for additional course of 100 students (2 units) for D.El.Ed. programme (ERCAPP3371) on 03/06/2015 in compliance with the NCTE Regulation 2014 as a composite institute in the name of the "Vivekananda Institute of Primary Education" under the trust "Social Reform Society". The applicant trust dispatched the hard copy printout of the online application along with all relevant

documents along with an application fees of Rs. 1, 50,000/- on 03/06/2015, which was received by the ERC NCTE on 08/06/2015 (mentioned in the ERC NCTE online application). The applicant trust has already been granted recognition for B.Ed. programme for the academic session 2012-13 with an annual intake of 100 by NCTE, Recognition order No. ERC/NCTE/B.Ed./2012/13293, dated 16/08/2012 in the name of "Swami Vivekananda B.Ed. Teachers Training College". The applicant trust initially has its 3050 sqm. Of land and 3000 sqm. Of build-up area which complies with the NCTE Regulation 2009 and also NCTE Regulation 2014. NCTE Regulation 2014, Appendix-4, Clause (6) (6.1) (1) clearly mention the following: "For the institutions established prior to this Regulations, for an additional intake of one hundred students, built up area is to be increased by 500 sqm. (five hundred square metre) and the requirement of additional land may not apply to them". The applicant trust increase its build-up areas for the forthcoming D.El.Ed. Programme (composite institute) and present buildup area is 3273.60 sqm. (35236.73 sqft. (approx.) which satisfies the NCTE Regulation 2014. The applicant trust obtained NOC from the SCERT (Bihar Board) dated 28/05/2015 and all other relevant documents including building plan is in favour of the trust. The applicant trust, in its reply dated 16/01/2016 against Show Cause Notice the present infrastructure. Built-up area is 3273.60 sqm. (35236.73 sqft. (approx.)"

recognised for conducting B.Ed. course (2 units of 50 each) and has applied for D.El.Ed. course to achieve the status of a composite institution. The appellant in its application has disclosed that institution is in possession of land measuring 3050 sq. m² and built up area measuring 300 sq. m². Land identification number as per application is khasra no. 749&750, village Basudevpur, Dharbanga Sadar, Bihar. Copy of the building plan enclosed with the application is and respect of plot no. 849, 850 & 851 for a plot area of 45838 sq. feet which does not conform to the details furnished in the application. Course and the total built up area for B.Ed. & D.El.Ed. is calculated to be 3273.60 sq. meters which is adequate for conducting B.Ed. & D.El.Ed. Building Completion Certificate dated 20.05.2016 issued by Gram Panchayat was made available by the appellant as evidence.

AND WHEREAS during the course of appeal presentation on 31.05.2016, the appellant submitted copies of three building plans as follows:

WHEREAS the appeal of Sri Komals Sahu Smarak Shikshan Evam Prashikshan Sansthan, Jeanpur, Azamgarh, Uttar Pradesh dated 19/04/2016 is against the Order No. NRC/NCTE/NRCAPP-8826/246th Meeting/2015/131941 dated 18/12/2015 of the Northern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "The institution has not submitted the reply of LOI dated 15/07/2015 in given period of two months. On this ground a SCN was issued on 09/10/2015 to reply the same in next 30 days. But institution has not submitted the required documents."

AND WHEREAS Dr. B.P. Gupta, Manager and Sh. Manish Mishra, Principal, Sri Komals Sahu Smarak Shikshan Evam Prashikshan Sansthan, Jeanpur, Azamgarh, Uttar Pradesh presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "After receipt of letter of intent dated 15th July 2015 under clause 7(13), our society conducted a meeting on 22nd May 2015 and had made a resolution to initiate the process for getting the staff approved by SCERT, Uttar Pradesh. The advertisement was published in the newspapers for the recruitment of staff. Immediately after the interview the minutes of the Selection Committee and the staff list were submitted to the Board of Examinations, Allahabad for approval. In response to Show Cause Notice dated 9th October 2015, the institution vide letter dated 7th Nov. 2015 had intimated that the minutes of the Selection Committee and the staff list have been submitted to Board of Examinations, Allahabad for approval and had requested for grant of two month time for submission of reply to 7(13). The approval for the staff was received from Board of Examination, Allahabad on 10th February 2016, a copy of which is attached. Detailed appeal attached."

AND WHEREAS Appeal Committee noted that there is a delay of about two months in preferring appeal by the appellant institution. On being asked appellant stated that delay occurred as appellant had first approached the Court of Law and then on being advised filed the Appeal Committee decided to condone the delay and take up the appeal on its merits.

AND WHEREAS Appeal Committee noted that a Letter of Intent (L.O.I) dated 15.07.2015 was issued to the appellant institution for submitting compliance within 2 months. Subsequently a Show Cause Notice (S.C.N.) dated 09.10.2015 was issued to appellant institution on ground of non submission of compliance report. Through the S.C.N. issued, the institution was also required to submit N.O.C. from affiliating body and proof/evidence to the effect that it is composite institution. The appellant institution submitted reply dated 07.11.2015 (received in the office of N.R.C. on 21.11.2015) to the S.C.N. wherein it submitted N.O.C. from affiliating body. Appellant also stated that institution is already recognised for conducting B.A. course and as such is covered under the definition of 'Composite Institution.' Whereas the appellant institution replied to S.C.N. and furnished compliance of additional points raised in the S.C.N., it did neither submit any compliance of the L.O.I. nor any clarification was furnished. The institution also did not seek extra time for submitting compliance to L.O.I.

appeal memoranda submitted copy of its letter dated 07.11.2015 addressed to N.R.C. wherein it was requested that two months time be given for submitting recommendation of affiliating body. The above letter is not found placed on the relevant file. Further verification by the Appeal Committee revealed that the diary number given on this letter is the same as given on another letter with similar date. Whereas date and diary number of the two letters are same, their contents differ. Obviously, the copy of letter submitted with the appeal memoranda is a manufactured one.

AND WHEREAS Appeal Committee taking note that the appellant institution has not submitted reply/compliance of the L.O.I. dated 15/07/2015 even after the issue of a

S.C.N. dated 09.10.2015 by submitting faculty list approved by the affiliating body, decided to confirm the refusal order dated 18.12.2015 issued by N.R.C.

AND WHEREAS After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 18.12.2015 issued by N.R.C. Jaipur on the ground that appellant institution has not submitted reply of L.O.I. dated 15.07.2015.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Shri Umiya Kanya Mahavidyalaya, Rangwasa, Indore, 13/04/2016 Madhya Pradesh dated is against the Order No. WRC/APP2559/223/241st/2016/161530 dated 25/02/2016 of the Western Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "Show Cause Notice dt. 10/11/2015 was issued on the grounds of State Government's negative recommendation, non-submission of NOC from affiliating body, nonsubmission of land documents and non-submission of notarized copies of Building Plan, Building Completion Certificate, CLU and Non-Encumbrance Certificate. The institution has sent a reply dt. 07/12/2015 and 05/01/2016, however, the institution has not been able to submit either the NOC from the affiliating body nor the other documents which are required as per the NCTE Regulations, 2014. Hence, Recognition is refused."

AND WHEREAS Sh. R. K. Patidar, Trusty and Sh. Hari Narayan, Trusty, Shri Umiya Kanya Mahavidyalaya, Rangwasa, Indore, Madhya Pradesh presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "as per list, relevant document are enclosed."

AND WHEREAS Appeal Committee noted that appellant institution submitted application for grant of recognition for B.Ed, course on 08/05/2015. A Show Cause Notice (S.C.N) dated 10.11.2015 was issued to appellant institution for the following deficiencies:

- 1. Negative recommendation of the State Government.
- Non submission of N.O.C. from affiliating body.
- Non submission of certified copy of land documents.

4. Seeking copies of building plan, building completion certificate, CLU, nonencumbrance certificate.

AND WHEREAS Appeal Committee further noted that the appellant institution submitted reply dated 07.12.2015 and 05/01/2016 to the S.C.N. and enclosed therewith (i) a copy of the letter dated 25.07.2015 received from Commissioner, Higher Education, (ii) building plan and approval (iii) Building Completion Certificate.

AND WHEREAS Appeal Committee noted that appellant institution did not submit copy of land documents and N.O.C. issued by the affiliating body. The above documents are to be submitted alongwith application as required under Clause 7(2) (b) and 5(3) of the NCTE Regulations, 2014. The Land Title Certificate given by an advocate and submitted by appellant repeatedly is not a substitute of land documents and N.O.C. of affiliating body dated 13.04.2016 by no means could have been made available to W.R.C. alongwith application. Appeal Committee, therefore, decided to confirm the refusal order dated 25.02.2016 issued by W.R.C., Bhopal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced by the appellant, Appeal Committee concluded to confirm the refusal order dated 25.02.2016 issued by W.R.C. on the ground that N.O.C. of affiliating body and copy of land documents were not submitted by appellant.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Balaji College of Education, Guthni, Siwan, Bihar dated 18/04/2016 is against the Order No. ERC/208.8.8/APP3998/D.EI.Ed./2016/45536 dated 14/04/2016 of the Eastern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "1. Show Cause Notice was issued on 10/02/2016 on the following grounds: (i) NOC issued from affiliating/examining body not submitted. In response to Show Cause Notice, the institution submitted reply dated 29/02/2016 without NOC. The institution is still deficient on the following grounds: (i) NOC from affiliating/examining body not submitted. (ii) Land possession/mutation certificated issued from Land Registering authority not submitted. (iii) Nonencumbrance certificate issued from Land Registering authority not submitted. (iv) Proper building plan indicating total land area, total built-up area and duly approved by any Govt. Engineer not submitted. In view of the above, the Committee decided as under: The Committee is of the opinion that application bearing code No. ERCAPP3998 of the institution regarding recognition for D.El.Ed. is refused under section 14(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Jagdeesh Chaudhary, President, Balaji College of Education, Guthni, Siwan, Bihar presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "NOC of D.El.Ed. from Bihar School Examination Committee, Patna with letter no. TTP583 dated 29/06/2015 has already been submitted. Non-encumbrance certificate has already been submitted along with application. A duly approved building plan from the office of circle officer has been submitted with clear details of land and building plan. NOC of D.El.Ed. from Bihar School Examination Committee, Patna with letter no. TTP 583 dated 29/06/2015 has already been submitted. Non-encumbrance certificate has

already been submitted along with application. A duly approved building plan from the office of circle officer has been submitted with clear details of land and building plan."

AND WHEREAS Appeal Committee noted that impugned order dated 14.04.2016 related to refusal of recognition for D.El.Ed. course. Appeal Committee further noted that a Show Cause Notice (S.C.N.) dated 10.02.2016 was issued to appellant institution on the ground that 'N.O.C. for B.Ed. and B.El.Ed. programmes has not been submitted which will render D.El.Ed. programme to come under the category of standalone institution.' The appellant institution submitted reply dated 29.02.2016 to the S.C.N. by stating that for B.Ed. & B.El.Ed. programme the affiliating body is J.P. University, Chhapra. The appellant further stated that the affiliating body was not in a position to issue N.O.C. for the reasons that Charges against Vice Chancellor were being investigated and subsequently the V.C. was sent jail.

AND WHEREAS Appeal Committee noticed that while E.R.C. issued Show Cause Notice dated 10 02.2016 on only one ground, the refusal order dated 14.04.2016 is on four grounds of non-submission of (i) N.O.C., (ii) Land Mutation Certificate, (iii) Building plan and (iv) non encumbrance certificate. Obviously the appellant institution was not given opportunity to submit clarification on other points whereas non submission of N.O.C. related to B.Ed. & B.El.Ed. programmes applied for by the appellant institution was used for refusal of D.El.Ed. Appeal Committee decided to remand back the case to E.R.C. for revisiting the case and issue S.C.N. on all the points of refusal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to E.R.C., Bhubaneswar for revisiting the case and issuing S.C.N. on all the points of refusal.

NOW THEREFORE, the Council hereby remands back the case of Balaji College of Education, Guthni, Siwan, Bihar to the ERC, NCTE, for necessary action as indicated above.

College B.Ed., Malda, West Bengal dated Order 21/04/2016 is against the No. ER/7-206.8.8/ERCAPP3991/(B.Ed.)/2016/44462 dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that a. Show Cause Notice was issued on 10/02/2016 on the following grounds: "As per online application name of the institution is Charaktala D.Ed. College B.Ed. whereas actual name of the institution Charaktala D.Ed. College which does not match with the actual name. The institution comes under the category of standalone institution. As per NCTE Regulation 2014 standalone institution is not considerable. b. The institution submitted it reply dated 20/02/2016 on the basis of proceeding uploaded in the website of ERC, NCTE which is not satisfactory. In view of the above, the committee decided that the application bearing Code No. ERCAPP3991 of the institution regarding permission for B.Ed. (Addl. Course) is refused under section 15(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Senaul Hoque, Secretary and Sh. Avimanyu Mandal, Member, Charaktala D.Ed. College B.Ed., Malda, West Bengal presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "The word B.Ed. was inadvertently written in the online application, which was only a typographical mistake. It was only written in order to mention the course about which the application is submitted for. The above fact was also submitted to ERC in reply to Show Cause Notice. All the enclosed documents, viz Land documents, NOC, Building Plan etc. only makes a mention of Charaktala D.Ed. College. It is submitted to the Appeals Committee that our institution had submitted an application for additional course of B.Ed. in our institution i.e. Charaktala D.Ed. College in order to become a composite institution as stipulated in the NCTE Regulations 2014."

and whereas Appeal Committee noted that appellant institution is already recognised for conducting D.El.Ed. course with name of the institution as 'Charaktala D.El.Ed. College' run by Charaktala Manab Sampad Vikas Samiti. Appeal Committee further observed that the same applicant society applied for B.Ed. course by putting up the name of applicant institution as 'Charaktala D.El.Ed. College B.Ed.", implying that both the courses will be run in the same institution.

AND WHEREAS Appeal Committee further noted that a Show Cause Notice (S.C.N.) dated 10.02.2016 was issued to appellant institution on the ground that since the name of institution with the proposed B.Ed. does not match with actual name, the institution comes under the category of stand-alone institution and hence application cannot be considered.

AND WHEREAS though the appellant institution had furnished a clarification to E.R.C. on 11.02.2016, Appeal Committee is of the view that decision taken by E.R.C. to refuse recognition on the ground that institution is not covered under the category of composite institution is against the spirit of the relevant clause. If the same management/society is running or proposing to conduct two programmes with in the same institution, it has to treat as a 'Composite Institute.' Appeal Committee, therefore, decided to remand back the case to E.R.C. Bhubaneswar for further processing of the application.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to E.R.C. for further processing of the application.

NOW THEREFORE, the Council hereby remands back the case of Charaktala D.Ed. College B.Ed., Malda, West Bengal to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of SBS College of Education, Khandwa, Khandwa (East Nimar). Madhva Pradesh dated 19/04/2016 against the Order WRC/APP2590/222/241st/{M.P.}/2016/161348 dated 24/02/2016 of the Western Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "Show Cause Notice dt. 13/01/2016 was issued. The applicant has replied vide letter dt. 20/01/2016. The applicant has claimed that it has submitted an originally certified land ownership document. This document was examined. It is only a photocopy. Apart from this, there is a letter from the Building Officer of Nagar Palika, Khandwa which is a building permission only. No other documents which are required under NCTE Regulations, 2014 have been submitted - notarized Building Plan and notarized Non-Encumbrance Certificate. With respect to the point about an institution being composite, the application has claimed that his institution is composite, stating "no other course is run by the institution". Thus, an acceptable reply has not been given to the Show Cause Notice, Recognition is refused."

AND WHEREAS Sh. Vineet Kumar Singh, Representative and Sh. Prashant Kumar Singh, Member, SBS College of Education, Khandwa, Khandwa (East Nimar), Madhya Pradesh presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "No non-compliance with the prescribed norms, explanation already provided."

AND WHEREAS Appeal Committee noted that a Show Cause Notice (S.C.N.) dated 13.01.2016 was issued to appellant institution on following grounds:

- (i) Original certified copy of land documents not submitted.
- (ii) It is not clear whether all the lands are contiguous.

- (iii) Original notarised C.L.U., building plan, building completion certificate, non encumbrance certificate not submitted.
- (iv) F.D.Rs not submitted.
- (iv) No evidence of a composite institution.

AND WHEREAS Appeal Committee noted that appellant institution furnished reply dated 20.01.20 16 to the S.C.N. Appeal Committee noticed that appellant institution had furnished alongwith its application copy of registered land documents in respect of khasra no. 190/2 & 190/3 measuring 1.20 Hec. As per land documents the landed property is located in Patwari Halka no. 63, Gram Panchayat Sihara, Khandwa. The building completion certificate dated 12.08.2007 issued by Nagar Palik Nigam is for a built up area of 1875 Sq. M² (625 Sq. M² on ground + first and second). Copy of a building plan for SBS College at 14 Jai Nagar, Khandwa, M.P. approved by the Municipal authority is also found placed on the file but there is no mention of khasra numbers of land to match it with the sale deed agreement.

and whereas while furnishing reply to S.C.N. the appellant institution did not submit non encumbrance certificate, C.L.U. and evidence to the effect that institution is a composite institution. From the reply given by institution stating that "The institution is a composite institution as per clause 2(b) of NCERT Regulation, 2014 and no other course is run by the institute.", it appears that appellant does not understand what a composite institution means as defined in clause 2(b) of NCTE Regulations, 2014. The appellant as per details furnished in the application form is a stand-alone institution and such Appeal Committee decided to confirm the refusal order on the following grounds:

- (i) Non encumbrance certificate and Change of Land Use Certificate not submitted.
- (ii) It is a stand-alone institution not covered under the definition of 'composite institution' as per 2(b) of the NCTE Regulations, 2014.

AND WHEREAS After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee

concluded to confirm the refusal order dated 24.02.2016 issued by W.R.C., Bhopal on the ground that appellant institution has not submitted non encumbrance certificate, Change of Land Use Certificate and the institution is not covered under the definition of 'composite institution' as per Clause 2(b) of the NCTE Regulation, 2011.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Biswanath Bera, Panskura, Midnapore, West Bengal Order No. dated 19/04/2016 is against the ER/7-204.9(i)21/ERCAPP2287/(D.El.Ed.)/2016/44398 dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that "As per online application, name of the institution is Biswanath Bera whereas all documents are in the name of Dhamait Shikshak Shikshan Mahavidyalaya. The institution requested vide letter dated 11/01/2016 to change the name of institution which was filed wrongly. The Committee has not accepted the request of institution as it is not possible to make change in the online system. Permission for D.El.Ed. course is refused under section 15(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Birwanath Bera, Secretary and Sri Sri Kanta Manna, Office Assistant, Biswanath Bera, Panskura, Midnapore, West Bengal presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "Affidavit submitted for correction of Institute's name. The institute's name is Dhamait Shikshak Shikshan Mahavidyalaya."

AND WHEREAS Appeal Committee noted that appellant society 'Dhamait Swamiji Netaji Subhash Social Welfare society' is recognised for conducting B.Ed. course and the institution name is 'Dhamait Shikshak Shikshan Mahavidyalaya. To become a composite institution, the appellant society applied for recognition of a D.El.Ed. course on 20.05.2015. While the name of applicant authorised to sign the application is its secretary 'Biswanath Bera', the same name was put/filled up against the column 'Name of the institution.' The mistake appears to have been inadvertently made as all other documents enclosed with application such as building plan, undertaking, N.O.C. of the affiliating body are in the name of 'Dhamait Shikshak Shikshan Mahavidyalaya.' The

appellant in reply to the Show Cause Notice has admitted to this clerical mistake and requested for rectification. Appeal Committee having been convinced that it was a clerical error, decided to remand back the case to E.R.C. Bhubaneswar for further processing of the application taking the name of institution as 'Dhamaik Shikshak Shikshan Mahavidyalaya.'

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to E.R.C. Bhubaneswar for further processing of the application by taking the name of institution as 'Dhamaik Shikshak Shiksha Mahavidyalaya.

NOW THEREFORE, the Council hereby remands back the case of Biswanath Bera, Panskura, Midnapore, West Bengal to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of The Ideal Teachers Training Academy, Imphal, Imphal 20/04/2016 East. Manipur dated is against the Order No. ERC/7.207.8.7/ERCAPP2226/B.Ed./2016/44319 dated 03/03/2016 of the Eastern Regional Committee, withdrawal recognition for conducting B.Ed. course on the grounds that "institution applied single application for B.Ed. programme which comes under the category of standalone institution. Standalone institution is not considerable as per NCTE Regulation 2014. Recognition for B.Ed. course is refused under section 14(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Yengkokpam Ranjan Singh, Secretary, The Ideal Teachers Training Academy, Imphal, Imphal East, Manipur presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "Ours is now permitted for opening Bachelor of Social Work (BSW) under same University of which NOC for B.Ed. furnished. Its proof has been submitted to ERC, NCTE at the time of submitting Compliance letter for Show Cause. If ERC, NCTE allowed our application for opening B.Ed., then ours will be automatically Composite from the coming. Ours has been refused under said section but it seems to be not related but we are not legal experts of it. Humble, request to NCTE, Hqrs. New Delhi is for your kind consideration and giving a positive instruction to ERC, NCTE for reconsidering our application.

AND WHEREAS Appeal Committee noted that a Show Cause Notice (S.C.N) dated 22.02.2016 was issued to the appellant institution on the following ground:

"The institution applied single application for B.Ed. programme which comes under the category of stand-alone institution not considerable as per NCTE Regulation, 2014."

AND WHEREAS Appeal Committee further noted that the appellant institution in its reply dated 25.02.2016 to the S.C.N. informed E.R.C. that it is proposing to start Bachelor of Social Work under the same university from 2016-17. The appellant during the course of appeal presentation submitted evidence in support of its claim which included (i) Permission letter dated 07.04.2016 issued by Manipur University for opening 1st year Bachelor of Social Work (BSW) from academic session 2016-17 (ii) selection order dated 14/05/2016 of faculty (iii) Temporary affiliation by Manipur University dated 2.05.2015.

AND WHEREAS Appeal Committee is also aware that recognition order if issued by E.R.C. Bhub aneswar can be earliest for the academic year 2017-18. Taking into account that a L.O.I. for BSW courses has already been issued by Manipur University, Appeal Committee decided to remand back the case to E.R.C. for further processing of application for B.Ed. course and the fact relating to the composite nature of institution may be verified by the Visiting Team at the time of inspection.

and whereas after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to E.R.C. Bhubaneswar for further processing of the application for B.Ed. course and the facts relating to composite nature of the institution may be verified by the visiting team at the time of inspection.

NOW THEREFORE, the Council hereby remands back the case of The Ideal Teachers Training Academy, Imphal, Imphal East, Manipur to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Matoshri Sayarbai Champalaji Chopda B.Ed. College, Buldhana. Maharashtra dated 20/04/2016 is against the Order No. WRC/APP2754/243rd/B.A.B.Ed.Integ./2016/161767 dated 27/02/2016 of the Western Regional Committee, refusing recognition for conducting B.A., B.Ed. course on the grounds that "the institution has applied for B.A. B.Ed. integrated course. It is also running B.Ed. course with 2 units. Show Cause Notice was issued to the institution regarding the following: Certificate of Registration and by laws not submitted. Building Plan not approved by competent Authority; CLU not submitted; Non-Encumbrance Certificate not submitted; and FDRs also not submitted. Hence, Recognition is refused."

AND WHEREAS Dr. Gajanan Shrinarayan, Principal and Prof. Yogesh Shrikrushna, Asstt. Professor, Matoshri Sayarbai Champalaji Chopda B.Ed. College, Buldhana, Maharashtra presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "We have already submitted two building plan of our B.Ed. College existing building one is the approved and second is not approved. Out of two, first old building plan is approved by the Chief Executive officer, Nagar Parishad, Khamgaon and in the second building plan we have shown only the class rooms, as per your requirement. After show cause notice, we have again submitted second plan to the Nagar Parishad, Khamgaon. We have already submitted Certificate of Land Use (CLU) (Certificate No. 58/Bhumi.. dated 29/05/2015) with the signature of competent authority, Chief Officer, Nagar Parishad, Khamgaon Dist. Buldana while application for new course B.A. B.Ed. and again submitted same certificate. Institute has already submitted Non-Encumbrance Certificate at the time of application of B.A. B.Ed. as per show cause notice, that certificate not sign by

competent authority. But in the Maharashtra state there is no competent authority for issuing this certificate. In this state this certificate issue by the Advocate on the basis of search Report. So we have submitted Non-Encumbrance Certificate with Search Report issued by Advocate against the reply of Show Cause. We have already submitted FDR's at the time application as follows: FDR Details: Endowment Fund – Rs. 5 Lakhs FDR No. 0275368 dt. 03/02/2016 Scheduled Bank KUCB, Khamgaon. Reserve Fund – Rs. 7 Lakhs FDR No. 0274502 dt. 03/02/2016 Scheduled Bank KUCB, Khamgaon."

AND WHEREAS Appeal Committee noted that a Show Cause Notice (S.C.N.) dated 04.01.2016 was issued to appellant institution on following grounds:-

- (i) Certificate of Registration of society not submitted.
- (ii) Building plan is not approved by competent authority.
- (iii) Building Completion Certificate is not in prescribed format.
- (iv) CLÜ not submitted
- (v) Non encumbrance certificate signed by competent authority.
- (vi) FDRs not submitted.
- (vii) State Government has not recommended the case.

AND WHEREAS Appeal Committee further noted that appellant institution submitted reply dated 02/02/2016 (received in the office of W.R.C. Bhopal on 04.02.2016). Appeal Committee noted that appellant institution alongwith the above quoted reply had submitted F.D.Rs of Rs. 5 lakh & 7 lakh, certificate of Regisration of society and its by laws, copy of Building Completion Certificate, Land Use Certificate issued by Nagar Parishad, Khamgaon, Non encumbrance certificate and building plan with certain clarifications.

AND WHEREAS Appeal Committee noted that refusal order dated 27.02.2016 (impugned order) is on the ground that 'applicant has not submitted any of the above mentioned documents except the F.D.Rs and reply of applicant is not satisfactory.' By above mentioned documents W.R.C. has referred to Certificate of Registration and bye laws, (ii) building plan, (iii) CLU, (iv) Non encumbrance Certificate and (v) F.D.Rs.

Impugned order therefore, lacks consistency and is not a reasoned order. Appeal Committee, therefore, decided to remand back the case to W.R.C. for revisiting the reply dated 02.02.2016 to the S.C.N. and processing the case accordingly. The negative recommendations of the State Government should also be kept in view.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to W.R.C. Bhopal for revisiting the reply dated 02.02.2016 to the S.C.N. and processing the case further. The negative recommendations of the State Government should also be kept in view.

NOW THEREFORE, the Council hereby remands back the case of Matoshri Sayarbai Champalaji Chopda B.Ed. College, Buldhana, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of North Bengal College of Education, Ghokshadanga, Cooch Behar, West Bengal dated 24/04/2016 is against the Order No. ER/7-207.6.37/ERCAPP1782/(B.Ed.)/2016/44494 dated 03/03/2016 of the Eastern Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "Letter of Intent u/c 7(13) was issued on 24/05/2015. The institution vide letter dated 23/06/2015 had requested for extension of two months. The ERC in its 193rd meeting considered the request of the institution and allowed 15 days more time. Accordingly, a letter dated 31/08/2015 was issued to the institution with direction to submit the compliance of the LOI issued u/c 7(13) within 15 days. No reply received from the institution. Show cause notice was issued to the institution on 03/12/2015. In response to the SCN, the institution has submitted a representation dated 15/01/2016 reqeusted to grant some more time for compliance of reply of LOI. The Committee has not accepted the request of the institution. In view of the above, the Committee decided to refuse recognition for B.Ed. under section 14(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Debasish Saha, Secretary & Sh. Anup Kumar Barman, Asstt. Secretary, North Bengal College of Education, Ghokshadanga, Cooch Behar, West Bengal presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "The ERC, NCTE issued Letter of Intent (LOI) for grant of recognition/permission for B.Ed. course under clause-7(13) of NCTE the Regulation 2014. Vide order No. ER-188.5.9/NCTE/ERCAPP1782/B.Ed/32005 dated 24/05/2015. The Applicant Society, in compliance with the LOI issued by ERC, NCTE applied to the concerned University "University of North Bengal" for faculty/staff section vide letter Ref. No. 01/15, dated 26/05/2015.

The Applicant Society, in compliance with the LOI issued by the ERC, NCTE, converted FDR's (for a period of five years) in favour of Joint Name of the institution and

the Regional Director, ERC, NCTE, Bhubaneswar, with joint operation mode, on 09/06/2015, F.No. 445932, Rs. 5,00,000/-(Endowment funds) and F.No. 445933, Rs. 7,00,000/- (Reserve Fund) from Union Bank of India, Coochbehar Branch. The applicant Society, in compliance with the LOI issued by the ERC, NCTE, arranged the consent letter of permission for conducting practice & final teaching of B.Ed. course, from the District inspector of Schools (S.E.), Cooch Behar, vide memo No. 628/Estt., dated 09/06/2015. The Applicant Society, apprehended of losing time for delaying procedure of Faculty/Staff selection by the University of North Bengal, and to avoid the dispute informed the status with a prayer to grant 2 (two) months' time in compliance with the LOI to the ERC, NCTE vide its reply dated 08/02/2016, which was accepted and allowed for only 15 days by the ERC, NCTE. The Applicant Society, thereafter made several request to the University of North Bengal, to complete the procedure of Faculty/Staff approval, vide letter Ref. No. 02/15, dated: 27/07/2015, Ref. No. 03/15, dated 14/08/2015, Ref. No. 02-2015, dated 30/11/2015, but no such positive initiative was taken by the University. The Applicant Society, in its reply against Show Cause Notice, vide No. 3944, dated 03/12/2015 by ERC NCTE, Bhubaneswar, submitted in its written submission explained its situation and also prayed for some time to complete the formalities and consideration of the application. Unfortunately, the application was not further considered by the ERC, NCTE. ERC, NCTE without consideration of the facts and written submission rejected the application of B.Ed. (ERCAPP1782) vide order ER/7-207.6.37/ERCAPP1782/(B.Ed.)/2016/44494 dated 03/03/2016. The Applicant Society is not at fault in the whole procedure and the affiliating University after a long delay finally approved the Final/Staff Selection on 22/04/2016. Hence, the Applicant Society/Institute had but no other alternate but to file an Appeal under Section 18 of the NCTE Act to reconsider the case."

AND WHEREAS Appeal Committee noted that a Letter of Intent (L.O.I) dated 24.05.2015 was issued to appellant institution for submitting compliance within 30 days. The appellant institution vide its letter dated 23.06.2015 addressed to E.R.C. stated that due to stringent and Lengthy procedures of the affiliating university, it would require some more time to get approval of affiliating body to the appointment of faculty and at least two months more time should be given for compliance. E.R.C. after considering

the request made by appellant allowed 15 day's time for submitting reply to L.O.I. <u>vide</u> its letter dated 31.08.2015. E.R.C. issued a Show Cause Notice (S.C.N.) dated 03/12/2015 on ground of non-submission of compliance to L.O.I. and the appellant institution <u>vide</u> its reply dated 15.01.2016 again requested for extension of time. The Regional Committee denied the request of appellant for further extension of time and issued the refusal order dated 03.03.2016.

AND WHEREAS appellant during the course of appeal presentation on 31.05.2016 informed the Appeal committee that affiliating body has approved the list of one principal and 15 faculty members on 22.04.2016 and now the appellant is in a position to submit final compliance report to E.R.C. Bhubaneswar. Appeal Committee taking note of the fact that the appellant institution has been keeping the Regional Committee informed of the developments and seeking extension of time for appointment of faculty, which of course has to be finally approved by the affiliating body, decided to remand back the case to E.R.C. for considering the final compliance which the appellant should submit within 15 days of the receipt of Appeal Orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to E.R.C. Bhubaneswar for consideration of the final compliance report to L.O.I. The appellant institution is required to submit final compliance report to L.O.I. within 15 days of the receipt of Appeal Orders.

NOW THEREFORE, the Council hereby remands back the case of North Bengal College of Education, Ghokshadanga, Cooch Behar, West Bengal to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Jagannath Das Premwati Welfare Society, Jabalpur, Madhya Pradesh dated 16/04/2016 against the Order No. WRC/APP146/222/241st/{M.P.}/2016/161599 dated 25/02/2016 of the Western Regional Committee, refusing recognition for conducting D.El.Ed. course on the grounds that Further, in his letter dt. 16/04/2015, signed by "Director, Premwati College of Education, Jabalpur", it has been stated that the applicant has now acquired 20,000 sq. mtrs. Land area, with built up area 41,686 sq.ft. located at Scheme No.5, Ahinsa Chowk, Vijayanagar, It has also been stated that the existing B.Ed. and the proposed D.El.Ed. will be conducted on this land at Shivnagar. The other documents which have been submitted also relate to Vijaynagar i.e. Building Plan and Building Completion Certificate. As Quoted in Clause 8 (4) (i) above, the applicant / institution/Society must have the land in its name on which the course is to be conducted. The applicant has himself stated that the existing B.Ed. course and the proposed D.El.Ed. course are to be conducted on the land which is not mentioned in the application. In other words, on the date of application, the applicant institution/society did not have the land in its name. Hence, this case cannot be considered under the Rule quoted above [Clause 8 (4) (i) and 7(1)]. Show Cause Notice dt. 08/04/2015 had already been given. Hence, Recognition is refused."

AND WHEREAS Sh. Ajay Kumar Tiwari, Director, Jagannath Das Premwati Welfare Society, Jabalpur, Madhya Pradesh presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "It is clear that even after Grant of approval, the concerned institution is permitted to shift to new premises, by sending advance intimation to the NCTE. Therefore, the pending application of any society / trust can be rightly accordingly

processed if, during the pendency (at the preliminary stage) of the application, request is made for change of site and change of name of applicant. Because in the present case, the application for change of site dated 26/02/2016 was necessitated solely because the previous site was not meeting the newly introduced NCTE norms and standards. Further since the new site in the name of the trust, therefore change of name of applicant was also applied for. It would be pertinent to mention that the Board of Trustees the Seth Mannulal Jagannathdas Trust are the same as the Governing Body members of Jagannat Premvati Welfare Society, in fact the society is one of the members / trustees of the aforementioned Seth Mannulal Trust. Therefore, there is also no material change in the name / identity of the applicant, which is simply necessitated because of the newly introduced NCTE, Regulations 2014. Because otherwise in pursuance of the communication dated 08/01/2015, the applicant no.1 had complied with all the formalities including the deposit of differential amount of fees, increased amount of FDR, etc. and therefore it cannot be said that the intentions of the applicant society were in any manner mischievous. They have genuine intentions for opening of and starting of a additional D.El.Ed. Institution. Therefore, till and until it is found that the action of the applicant no. 1 society is mischievous or not bonafide, their application could not have been refused."

AND WHEREAS Appeal Committee noted that appellant institution i.e. 'Premwati College of Education' is already recognised for conducting B.Ed. programme and it applied for D.El.Ed. programme on 31.12.2012 with the proposed institution address as '1972/1236 M.P. Housing Board, Shiv Nagar, Jabalpur. The land documents enclosed with the application included a lease deed from M.P. Housing Board and the land measured 2459 Sq. M. leased to Sh. Krishna Malpani, Secretary of Jagannathdas Premwati Welfare Society.

The affidavit furnished by Sh. Krishan Malpani, Secretary also mentioned the land area of 2459 Sq. M and a built up area of 17470 sq. feet. Recognition for D.El.Ed. course was refused to the institution by an order dated 20.08.2013 issued by W.R.C. on the ground of negative recommendations of the State Government. The institution preferred an appeal against the refusal order and Appeal Committee vide its appeal order dated 15/10/2014 remanded back the case to W.R.C. to re-examine the matter by seeking

recommendation of the State Government afresh by following guidelines circulated by NCTE on 02.02.1996. On re-examination W.R.C. has again refused recognition by issuing the impugned order dated 25.02.2016 on following two grounds:

- (i) The society has a lease from M.P. Housing Board in the name of Sh. Krishan Malpani, Secretary, Jagannath Das Premwati Welfare Soceity, Jabalpur. The name of an individual as owner of land even though he may be Secretary of the Trust, is not acceptable.
- (ii) The appellant in its letter dated 16.04.2015 addressed to W.R.C. stated that land measuring 20000 Sq. M. with built up area of 41686 sq. feet located at scheme no. 5, Ahinsa Chowk, Vijay Nagar has been acquired by the Trust for relocation of the existing B.Ed. course and proposed D.El.Ed. course. As the applicant institution did not have the said land in its name as on the date of application, recognition for D.El.Ed. course is refused.

AND WHEREAS Appeal Committee noted that Clause 8(4) of the NCTE Regulations, 2014 provides that 'No institution shall be granted recognition unless it is in possession of required land on the date of application.' Committee, further noted that appellant institution proposed to seek recognition on a piece of land where B.Ed. course was already being conducted and land and built up area was not adequate for adding another course. The management, thereafter, acquired another property to accommodate existing B.Ed & proposed D.El.Ed. course to satisfy. The provision of Clause 8(i) of the NCTE Regulations, 2014. Appeal Committee has following aspects in view:

- (i) The proposed site for accommodating B.Ed. & D.El.Ed. courses was not available to the appellant institution at the time of making application i.e. 31.12.2012.
- (ii) Appellant institution has not yet been allowed to shift B.Ed. course to the new proposed premises.
- (iii) NCTE Regulations do not allow any change of proposed site before recognition is granted as it would be against the spirit of Clause 8(4) of the

NCTE Regulations, 2014 which is a replica of Clause 7(i) of NCTE Regulation, 2009.

AND WHEREAS Appeal Committee, therefore, decided to confirm the refusal order dated 25.02.2016 on the ground that appellant did not have the proposed land in the name of institution or trust as on the date of application i.e. 31.12.2012. Change of address for conducting the proposed course is not admissible before grant of formal recognition.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, document on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 25.02.2016 on the ground that appellant institution did not have the proposed land in the name of institution/trust as on the date of application.

NOW THEREFORE, the Council hereby confirms the Order appeared against.

WHEREAS the appeal of Baba Shrichand College, Chhidwara, Madhya Pradesh dated 21/04/2016 is against the Order No. WRC/APP2861/223/242nd/2016/161679 dated 27/02/2016 of the Western Regional Committee, refusing recognition for conducting B.Ed. course on the grounds that "The institute has applied for the B.Ed. course and it is not running any other course. Hence, it is a standalone institution which is not permitted under the under clause 2(b) and 8(1) of the NCTE Regulations, 2014. Further, examination of the file shows that the land is on private lease which is not permitted under NCTE Regulations, 2014. Hence, the application is summarily rejected."

AND WHEREAS Sh. Manjeet Singh Bedi, Secretary & Sh. Amit Mehta, Representative, Baba Shrichand College, Chhidwara, Madhya Pradesh presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that Due to the sudden change made with respect to the affiliating body which earlier was Sagar University but now is Rani Durgawati University, there was a situation of confusion regarding affiliation which led to delay in acquiring of required documents and could not be re-examined properly, moreover, then rejection letter is the only letter conferred to us after submission of application back on May 2015 also no opportunity for correction was provided to us. However as per the NCTE Norms the institution will conduct two or more courses and does not wish to be a stand-alone institution as per clause 2(b) and 8(1) NCTE Regulation 2014. The land documents were mistakenly uploaded the society has required land for opening up of such institution and if given chance the society prays for correction of such as mistake and self-remain duty bound for such an Act of kindness."

AND WHEREAS appellant Committee noted that appellant during the course of appeal presentation furnished evidence that land measuring 0.809 Hec. at khasra no. 76/2 is owned by 'Baba Srichand Education Societies, Chindwara but it is also an admitted fact that copy of land documents submitted alongwith application pertained to lease agreement which is not acceptable keeping in view the Clause 8(4) of the NCTE Regulations, 2014. Appeal Committee further noted that appellant institution does not fulfil the requirement of Clause 8(i) of the Regulations which lays down that 'New Teacher Education Institution shall be located in composite institutions.' Appeal Committee, therefore, decided to confirm the refusal order dated 27.02.2016 issue of W.R.C. Bhopal for the reasons stated therein.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 27.02.2016 for the reasons stated therein.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Prashanti College of Professional Studies, Ujjain, M.P. dated 23/04/2016 İS against the Order No. WRC/APP2814/222/247th /(M.P.)/2016/165151 dated 20/23/04/2016 of the Western Regional Committee, withdrawal recognition for conducting D.El.Ed. course on the grounds that "The institution is already running the B.Ed. course (APW05948/223663) with two units and has now applied for the D.El.Ed. Course. Show Cause Notice was issued to the institution on 27/01/2016. The institution has submitted all the required documents as per Show Cause Notice, except for originally certified copy of land documents and non-Encumbrance Certificate. Further, built up area is not sufficient as per NCTE Norms. Hence, Recognition is refused."

AND WHEREAS Sh. Avnish Gupta, Vice-Chairman, Prashanti College of Professional Studies, Ujjain, M.P. presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "we have submitted notarized copy of land documents along with diversion order and copy of khasra and other land documents along with original application. Now we have again attached the certified copy of land document. That is our original application we have attached the non-encumbrance certificate and in reply to your show cause notice dated 27/01/2016 we have already submitted the non-encumbrance certificate. All this paper we have an already submitted to Western Regional office at Bhopal as on 25/02/2016 and the acknowledgement of this document submitted at Regional office is enclosed herewith once again the copy is enclosed. 3rd ground of refusal relates to built-up area is not sufficient as per NCTE Regulation. With regard to this we have to bring to your kinds notice that no such deficiency was mentioned in the show cause notice dated 27/01/2016. As per NCTE regulation the built-up area required for D.El.Ed. College is

1500 sq.mts. however we have constructed the building measuring 2095,67 sq.mts. on ground floor and 596 sq. mts. On 1st floor. The approved map of the building was already submitted alongwith."

AND WHEREAS Appeal Committee noted that Show Cause Notice (S.C.N.) dated 27.01.2016 was issued to appellant institution for non-submission of following documents with its application:

- (i) Originally certified copy of land documents.
- (ii) Originally notarised C.L.U.
- (iii) Originally notarised building plan.
- (iv) Originally notarised non encumbrance certificate.
- (v) F.D.Rs.

and whereas Appeal Committee noted that NCTE Regulations, 2014 require only a copy of the registered land documents issued by competent authority and the word 'originally certified copy'has nowhere been mentioned in the regulations. The appellant along with its application dated 30.05.2015 has submitted a zerox copy of the land documents. The appellant in its reply to the S.C.N. again submitted notarised copy of land documents besides furnishing notarised copy of C.L.U., building plan, Building Completion Certificate, non-encumbrance certificate and original F.D.Rs.

AND WHEREAS Appeal Committee further noted that refusal order dated 20/23.04.2016 is on the ground that:

- (i) Original certified copy of land document and non-encumbrance not submitted.
- (ii) Built up area is not sufficient.

AND WHEREAS after observing the building plan submitted by appellant, Appeal Committee observed that the area statement on the plan refers to ground floors of 1848 Sq. M. and first floor of 1848 Sq. M. whereas the Building Completion Certificate (BCC) submitted is only for the ground floor area of 19910 sq. feet. The appellant has also failed to indicate the specific demarcated area for conducting existing B.Ed. and proposed D.El.Ed. programme keeping aside the area of MBA, ITI (NCVT) and B.E.


programmes. Appeal Committee is of the view that since appellant was not given an opportunity to furnish clarification on adequacy of built up area, W.R.C. may give another opportunity to the appellant institution to submit a comprehensive building plan and built up area certificate to prove adequacy of space for conducting the twin courses.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing. Appeal Committee conclude to remand back the case to W.R.C. for giving appellant institution another opportunity to submit comprehensive building plan and Building Completion Certificate to prove adequacy of space for conducting twin courses.

NOW THEREFORE, the Council hereby remands back the case of Prashanti College of Professional Studies, Ujjain, M.P. to the WRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Kamla Bhubneshwar B.Ed. College, Begusarai, Bihar dated 19/04/2016 is against the Order No. ERC/7-202.9(i).446/ERCAPP4296/D.El.Ed. (Addl. Course)/2016/42770 dated 10/02/2016 of the Eastern Regional Committee, refusing recognition for conducting D.El.Ed. (Addl.) course on the grounds that "The institution has not submitted land document with hard copy of online application. In view of the above the Committee decided as under: The application of the institution is summarily rejected as per clause 7(2)(b) of NCTE Regulation 2014."

AND WHEREAS Ms. Vandana Kumari, Secretary, Kamla Bhubneshwar B.Ed. College, Begusarai, Bihar presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "Kamla Bhubneshwar B.Ed. college is a Teacher's Education College with modern infrastructure facilities including land, building, instructional resource. institution as mentioned above that it is well established institution for B.Ed. course and it has got its recognition from NCTE in 2014. While getting recognition of B.Ed. course, we have submitted land documents to NCTE, ERC and same was verified and recommended by inspection team and NCTE for granting permission under "The National Council for Teacher Education Act, 1993". It is not the case of the applicants who have applied to NCTE for recognition of D.El.Ed. Course in the abs. Section 15 of the National Council for Teacher Education Act, 1993 Section 15(3)(b) of the NCTE Act, para 2 says "Provided that before passing an order refusing permissions under sub-class (b), the Regional Committee shall provide a reasonable opportunity to the institution concerned for making a written representation". In this case, we have not got any written communication before the passing of order as per the line of NCTE, Act 1993. If this order continue then it is eclipsing of sub."

AND WHEREAS Appeal Committee noted that appellant institution had not submitted copy of land documents alongwith hard copy of the online application dated 30.06.2015 as required under Clause 7(2) (b) of the NCTE Regulations, 2014. Appellant has raised two points questioning the validity of refusal order i.e.

- (i) Appellant institution is an existing institution recognised for conducting B.Ed. course in 2014. As such there was no requirement to submit land documents again with the D.El.Ed. application.
- (ii) Before passing refusal order, the appellant institution was not given an opportunity for making a written representation.


AND WHEREAS as per Clause 7(2)(b) of the NCTE Regulations, 2014 an application is liable to be summarily rejected in case of failure of the applicant to submit land documents alongwith printout of the online application. Appeal Committee observed that in cases of summary refusal/rejection, the right of the applicant to submit written representation is not warranted.

AND WHEREAS Appeal Committee further observed that no applicant is exempted from submitting copy of essential required documents merely on the ground that copies of such documents are already available in the Regional Committee office having been submitted with some other course application. Every application submitted by the applicant has to be independently supported by required documents which has not been done in case. Appeal Committee, therefore, decided to confirm the refusal order dated 10.02.2016 issued by E.R.C. Bhubaneswar.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the refusal order dated 10.02.2016 issued by E.R.C., Bhubaneswar.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Indian Council of Basic Education, Juhu, Mumbai, Mumbai Suburban, Maharashtra dated 22/04/2016 is against the Order No. WRC/APP2810/241/2016/161610 dated 25/02/2016 of the Western Regional Committee, refusing recognition for conducting M.Ed. course on the grounds that In reply to the Show Cause Notice, the following explanation was given by the applicant. "An affidavit has been given for changing the name of the applicant from "Indian Council of Basic Education" to "Smt. Surajba College of Education"; Land documents, Building Plan, Building Completion Certificate are under process; An affidavit has been attached for non-encumbrance Certificate; and The applicant has requested the State Govt. to give positive recommendation as a special case. The above reply was considered. As regards the first point, it amounts to correction of name in the application for M.Ed. course. There is no provision in the Regulations to consider such a request. As regards the second point, relating to the submission of documents, the fact is that the applicant has not yet submitted the documents. These are documents which should have been submitted with the hard copy of the application (the hard copy was submitted on 04/05/2015), whereas these documents have not been submitted even after so many months and Show Cause Notice given on this issue. As regards the third point, the State Govt. has categorically not recommended the case on the basis of supply and demand. For all these reasons, Recognition is refused."

AND WHEREAS Ms. Nupur Mitra, Treasure and Ms. Sabiha More, Representative, Indian Council of Basic Education, Juhu, Mumbai, Mumbai Suburban, Maharashtra presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "Considering the self-financing course the institution's name entered instead of college name – error occurred, affidavit

is already submitted for the cause. Already submitted respective documents to NCTE WRO on 10/02/2016 by speed post Track ID – EM785944492IN. Building is owned by the Management and affidavit is given. Already given recommendation vide letter No. B.Ed.-4615/C.R./203/Mashi-2 dated 15th March, 2016 issued by Government of Maharashtra."

AND WHEREAS Appeal Committee noted that online application dated 30.05.2015 for M.Ed. course was made in the name of 'Indian Council of Basic Education' which itself is the name of registered society. The society is running B.Ed. course in the name of 'Smt. Surajba College of Education. Western Regional Committee, Bhopal issued a Show Cause Notice (S.C.N) dated 02.12.2015 advised the applicant to avoid naming the institution by using words like 'National', Indian'. Going by the advice of W.R.C., the applicant has desired to change the name of institution and proposed to use the name of existing B.Ed. institution which is 'Smt. Surajba College of Education.' Having advised the applicant which is suggestive to change the name of institution, W.R.C. should not have made it a point to refuse recognition.

AND WHEREAS Other points raised in the S.C.N. related to non-submission of original certified copy of land documents, notarised copy of building plan, non-encumbrance certificate and building completion certificate. It was also stated that state government has not recommended the case. The appellant during the course of appeal presentation on 31.05.2016 stated that since B.Ed. course is conducted in the name of Smt. Surjaba College of Education, the N.O.C. given by University of Mumbai was also in the name of 'Smt. Surjaba College of Education.' Appellant also stated that land related documents were lost during the floods of July, 2005 and it took time for them to obtain certified copies from the office of sub-registrar afresh. Applicant was however, able to furnish to W.R.C. on 10.02.2016 copies of building plan and allotment letters issued by Municipal corporation of Greater Bombay.

AND WHEREAS Appeal Committee noted that Government of Maharashtra, vide its letter dated 09.10.2015 has categorically stated not to sanction new B.Ed./M.Ed. College. Appellant during the course of appeal presentation submitted copy of letter dated 15.03.2016 issued by Government of Maharashtra (Higher and Technical

Education Department) conveying recommendation of the State Government to start new M.Ed. course for the appellant institution for the academic year 2016-17.

AND WHEREAS Appeal Committee is of the view that a number of developments have taken place during the processing of the case going in favour of the appellant institution whereas fact remains that appellant institution had failed to submit land documents at the time of submitting printout of the application which is essential as per Clause 7(2)(b) of the NCTE Regulations, 2014. Appeal Committee, therefore, decided to confirm the refusal order dated 25.02.2016 issued by W.R.C. Bhopal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Smt. Kapila Khandvala College of Education, Mumbai, Mumbai Suburban, Maharashtra dated 22/04/2016 is against the Order No. WRC/APP2857/241st/2016/161566 dated 25/02/2016 of the Western Regional Committee, refusing recognition for conducting M.Ed. course on the grounds that "The land documents are certified by the Principal and not by competent revenue authority as is required. Originally notarized copy of non-Encumbrance Certificate and Building Completion Certificate have not been submitted. Attestation by the Principal is not acceptable; While the copy of Bye-laws and Memorandum of Society have been submitted, these are not originally notarized. The Certificate of Registration has been certified only by the Principal; and The State Govt. has not recommended the case. The application was originally made on 08/06/2015. In spite of sufficient opportunity, the applicant has not submitted the required documents. Hence, Recognition is refused."

AND WHEREAS Ms. Smita Gupta, Representative, Smt. Kapila Khandvala College of Education, Mumbai, Mumbai Suburban, Maharashtra presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "The notarized copy of maps, land documents & Original affidavit for Non-Encumbrance Certificate have been sent in the reply of show cause notice. The notarized copy of building completion certificate and remaining land documents we are sending by post. We have received the permission letter from the State Govt. which we are attaching for your reference."

AND WHEREAS Appeal Committee noted that appellant institution is run by 'Sadhna Education Society' and is already recognised for conducting B.Ed. and Ph.D. affiliated to University of Bombay since 1990. The land documents submitted by the appellant alongwith printout of online application included (i) a letter dated 05.12.1963

issued by Revenue Department of Government of Maharashtra addressed to President Sadhna Education Society (ii) Allotment letter dated 08.01.1964 issued by Additional Collector, Bombay Suburban Dist. granting land measuring 1500 sq. yards to Sadhna Education society. Copies of these documents are self-attested by the appellant institution. Appeal Committee observed that in reply to Show Cause Notice issued by W.R.C., the appellant institution submitted copies of documents attested by Principal of the institution whereas W.R.C. has raised a point that these documents should have been certified by the Revenue Officers and originally notarised. Appeal Committee is of the opinion that the appellant institution is already an established institution and is NAAC accredited ('A' Grade). The State Government has <u>vide</u> its letter dated 15/03/2015 also recommended the proposed to start new M.Ed. course by the institution. Appeal Committee, therefore, decided to remand back the case to W.R.C. for further processing of the application.

AND WHEREAS after perusal of the Memoranda of appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to W.R.C. Bhopal for further processing of the application.

NOW THEREFORE, the Council hereby remands back the case of Smt. Kapila Khandvala College of Education, Mumbai, Mumbai Suburban, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Seva Sadans College of Education, Ulhasnagar, Thane, Maharashtra dated 21/04/2016 is against the Order No. WRC/APP2682/242nd/B.Ed. (Part Time) 2016/161443 dated 25/02/2016 of the Western Regional Committee, refusing recognition for conducting B.Ed. (PT) course on the grounds that "The institute has applied for B.Ed. part time course. As per clause 2(1) of Appendix-14 of the NCTE Regulations, 2014, only institutions offering B.Ed. and M.Ed. programs for at least five years and having NAAC accreditation with minimum B-Grade are eligible to offer this course. The institution was granted Recognition for the M.Ed. course only on 03/03/2015. Therefore, the institution is not eligible to run B.Ed. Part Time course. Hence, Recognition is refused."

AND WHEREAS Prof. P. Arul Pragasam, Librarian, Seva Sadans College of Education, Ulhasnagar, Thane, Maharashtra presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "Appeal under section 18 of the NCTE Act, 1993 against Refusal order of the Western Regional Committee, NCTE dated 25/02/2016 bearing No. WRC/APP2682/242nd/B.Ed (Part Time)2016/161443."

AND WHEREAS Appeal Committee noted that as per norms and standards for conducting B.Ed. (Part Time) following institutions are eligible for offering B.Ed. (Part-Time)

- (i) NCTE recognised Teacher Education Institutions offering B.Ed. and M.Ed. programme which have been in existence for atleast 5 years and having NAAC accreditation with minimum 'B' grade.
- (ii) Departments/schools of education in UGC recognised Central/ State Universities.

and whereas Appeal Committee observed that appellant institution was granted recognition for M.Ed. course in 2015 and it has not completed five-year term prescribed as eligibility condition for conducting B.Ed. (Part time).

AND WHEREAS Appeal Committee, therefore, decided to confirm the refusal order dated 25.02.2016 issued by W.R.C.

<u>ORDER</u>

WHEREAS the appeal of Gautam College, Mandi Road, Dabra, Gwalior, M.P. dated 09/03/2016 is against the Order No. WRC/APW04341/223516/240th/2016/159887 dated 10/02/2016 of the Western Regional Committee, withdrawing recognition for conducting B.Ed. course on the grounds that "Since, the institution has not conducted the B.Ed. course in accordance with either the NCTE Regulations, 2009 or NCTE Regulations, 2014, Recognition is withdrawn under Section 17 of the NCTE Act, 1993, from the end of the academic section next to the date of issue of withdrawal order."

AND WHEREAS Sh. Anil Kumar, Assistant Professor & Dr. Mamta, Principal, Gautam College, Mandi Road, Dabra, Gwalior, M.P. presented the case of the appellant institution on 31/05/2016. In the appeal and during personal presentation it was submitted that "We have submitted documents related to approval of the faculty done by affiliating body namely Jiwaji University, Gwalior from time to time. The detail of submission of such documents is as follows: Recommendation of Selection Committee Meeting held on 02/09/2013. List of the approved faculty uploaded on the website. Copy of the Selection Committee Meeting held on 15/11/2015."

AND WHEREAS Appeal Committee noted that Show Cause Notice (S.C.N) dated 24.12.2015 was issued to appellant institution on the ground that 'the institution does not have required number of qualified teaching staff.' Further the appellant institution was given a chance to send the list of staff duly approved by the competent authority. Appellant institution in its reply dated 31.12.2015 (received in the office of W.R.C. on 11.01.2016) submitted list of faculty which was not approved by the affiliating body and was signed by the Principal. Appellant institution with its reply dated 31.12.2015 also submitted copies of the selection Committee recommendation made in the meeting held on 15.11.2015 to select Principal and faculty. During the course of appeal presentation

on 31.05.2016, appellant submitted list of faculty countersigned by Registrar Jiwaji University, Gwalior.

AND WHEREAS Appeal Committee noted that appellant institution did not submit list of faculty approved by affiliating body to the W.R.C. and what it submitted was a list signed by Principal. The minutes of the selection Committee which the appellant institution submitted alongwith its reply to S.C.N. cannot be treated as list approved by affiliating body. Withdrawal order dated 10.02.2016 is therefore justified and confirmed.
