WHEREAS the appeal of Maharishi Shiksha Sansthan (Department of Education), Lamti, Kanchan Vihar, Distt. - Gram - Lamti, Jabalpur, Madhya Pradesh dated 01/06/2017 is against the Order No. WRCAPP2798/B.A. B.Ed./275th/{M.P.}/2017/186141 dated 18/05/2017 of the Western Regional Committee, refusing recognition for conducting B.A. B.Ed. Course on the grounds that show cause notice was issued on the ground that the Registrar had not approved the list and the subjects at the PG level were not given. The institution has replied with the approval of the Registrar but subjects at the PG level have still not been given. Hence, Recognition is refused."

AND WHEREAS Prof. (Col.) TPS Kandra, National Co-ordinator and Sh. Birendra Choubey, Sr. Admn. Officer, Maharishi Shiksha Sansthan (Department of Education), Lamti, Kanchan Vihar, Distt. - Gram - Lamti, Jabalpur, Madhya Pradesh presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation and in a letter dt. 23.09.2017 it was submitted that (i) as per LOI, documents/ informations were required to be submitted before 02.05.2017 for consideration of the case for the session 2017-18; (ii) the institute handed over all the documents to the WRC on 28.04.2017; (iii) through NCTE WRC Portal vide minutes of the 275th meeting of the WRC held on 1-2 May, 2017, the institute came to know that subjects at the PG level have not been given for most of the staff in the list of faculties submitted to the WRC; (iv) the institute handed over a photocopy of all the faculties approved, giving subjects, by the Registrar of RDVV, Jabalpur i.e. the affiliating body on 02.05.2017 at 04:37 p.m. without waiting for the show cause notice, when the meeting of the WRC was in progress; and (v) the WRC, however, refused recognition on the ground that the subjects were not mentioned, without issuing show cause notice. The appellant enclosed a copy of their letter dt. 02.05.2017 sent to the WRC, which contained the details of the subjects at P.G. level,

with percentage of marks of eight faculty members and which bears the receipt stamp of WRC dt. 02.05 2017.

been received by the WRC and it is available in the file. The Committee also noted that the appellant had applied for B.Ed. Course also, recognition for which has been refused and an appeal against refusal also has been filed. From the list of factly submitted by the appellant for B.A. B.Ed. and B.Sc. B.Ed. courses, it is seen that four faculty members namely Dr. Satya Prakash Shukla, Swati Shrivastava, Deeksha Shrivastava and Devendra Kumar Yadav are common for B.Ed. and B.A B.Ed. courses. The Committee also noted that the faculty in content for B.A B.Ed. course is inadequate and the faculty in botany has no role. It is not clear from the subject faculty as to what type of teachers the appellant wants to produce i.e. whether in Sanskrit, Hindi or Political Science.

AND WHEREAS in view of the above position, the Committee concluded that the appeal deserved to be rejected and the order of the WRC confirmed on account of inadequate staff in the relevant subjects as evidenced by the documents submitted by the appellant.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

AND WHEREAS Prof. (Col.) TPS Kandra, National Co-ordinator and Sh. Birendra Choubey, Sr. Admn. Officer, Maharishi Shiksha Sansthan (Department of Education), Lamti Kanchan Vihar, Distt. - Gram - Lamti, Jabalpur, Madhya Pradesh presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation and in a letter dt. 23.09.2017 it was submitted that (i) as per LOI, document/ informations were required to be submitted before 02.05.2017 for consideration of the case for the session 2017-18; (ii) the institute handed over all documents to WRC on 28.04.2017 in accordance with LOI; (iii) through NCTE WRC portal vide minutes of the 275th meeting of the WRC held on 1-2 May, 2017, the institute came to know that subjects at PG level have not been given for most of the staff in the list of faculties submitted to the WRC; (iv) the institute handed over photocopy of all faculties approved, giving subjects, by the Registrar, RDVV, Jabalpur i.e. the affiliating body on 02.05.2017 at 04:40 p.m. without waiting for the show cause notice, when the meeting of the WRC was in progress; and (v) the WRC, however, refused recognition on the ground that the subjects were not mentioned, without issuing a show cause notice. The appellant enclosed a copy of their letter dated 02.05.2017 sent to the WRC, which contained the details of the subjects at PG level,

with percentage of marks of eight faculty members and which bears the receipt stamp of WRC dt. 02.05.2017.

AND WHEREAS the Committee noted that the appellant's letter dt. 2.5.2017 has been received by the WRC and it is available in the file. The Committee, however, noted that faculties in perspectives of education and faculties in Mathematics and Science as required in the Norms and Standards for B.Ed. course are not available in the list of faculty submitted by the appellant. The Committee also noted that four faculty members are shown as common in the lists of faculty for B.A, B.Ed. and B.Ed. courses.

AND WHEREAS in view of the above position, the Committee concluded that the appeal deserved to be rejected and the order of the WRC confirmed on account of inadequate staff in the relevant subjects as evidenced by the documents submitted by the appellant.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the WRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the WRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of G.D. Babaria Teachers Training College, Boro Aerodrome Road, Giridih, Jharkhand dated 30/05/2017 is against the Order No. ERC/234.10.4/ID-9076/D.EI.Ed./2017/51957 dated 31/03/2017 of the Eastern Regional Committee, refusing recognition for conducting D.EI.Ed. Course on the grounds that "a. Show cause notice was issued the following grounds:- (i) The applicant has submitted Demand Draft of Rs. 1.50 lacs towards processing fee. As per the online NCTE portal, payment through online only is accepted. (ii) As per the print out copy of the online application it is observed that application number is not available. (iii) The application has not appeared on the dashboard of the online NCTE portal due to which online process cannot be carried out. In view the above, the Committee decided as under: The Committee decided that recognition to the institution for D.EI.Ed. is hereby refused under section 14/15(3)(b) of NCTE Act 1993."

AND WHEREAS Sh. Alok Mishra, Correspondent and Sh. Ajay Bagaria, President, G.D. Babaria Teachers Training College, Boro Aerodrome Road, Giridih, Jharkhand presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation and in a written representation, it has been submitted that (i) according to the Instructions for filing up the on-line application displayed on the website of the NCTE, payment may be made through demand draft and the appellant forwarded the demand draft along with the hard copy of the application; (ii) as the application bore ID Number 9076, it cannot be said that the application cannot be identified; (iii) photocopy of the hard copy of application status was displayed on the dashboard of the on-line NCTE portal; (iv) the ERC would not have issued a letter dt. 30.06.2016 to the HRD Department, Govt of Jharkhand, if the application would not have been processed and hence the objection that the application did not appear on the dash board of the on-line portal does not hold water; (v) the appellant submitted a reply on 24.11.2016 to the show cause notice dt. 09.11.2016; and (vi) the ERC passed the impugned order in the most mechanical

and arbitrary manner. The appellant also submitted that if their application had been summarily rejected in time, they would have had sufficient time to apply afresh.

AND WHEREAS the Committee noted that the Terms and Conditions for online applicat6ions for grant of recognition or permission in the NCTE website were last updated on 9.3.2016 i.e. well before the issue of the Public Notice inviting applications for the academic session 2017-18. According to these terms, processing fee is accepted only through on-line payment by credit card/debit card/Net banking processed by interlinked payment Gateway. These terms do not provide for any other mode of payment like demand draft. These latest terms and conditions were available in the public domain when the appellant filed their on-line application on 28.5.2016. According to the provisions of Clause 7(2) (a) of the NCTE Regulations, 2014 failure to furnish the application fee on or before the date of submission of on-line application attracts summary rejection of the application. The appellant has not fulfilled this fundamental requirement of furnishing the application processing fee within the prescribed time and through the permissible mode(s) of payment. In these circumstances, the Committee concluded that the ERC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the ERC confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the ERC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the ERC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

Show Cause Notice was issued to the institution on 31/01/2017 for premium receipts of CLU and regarding contiguity of the two plots. The institution has not given specific response to both the issues. Hence, Recognition is refused."

AND WHEREAS Dr. R.N. Yadav, Principal and Sh. Bhanu Pratap Yadav, Member, Shri Dwarika Prasad Yadav Shiksha Mahavidyalaya, Padariya, Ashok Nagar, Madhya Pradesh presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation the appellant submitted a Praman Patra dt. 06.06.2017 regarding contiguity of the two plots khasra nos. 108/3, and 115, issued by the Patwari, Tahsil Ashok Nagar and a site map giving the details of these two plots.

AND WHEREAS the Committee noted that the appellant in their reply dt. 27.2.2017 to the show cause notice dt. 31.1.2017 regarding premium receipts of CLU has submitted that the fee for getting land diversion certificate is pending in the office of the Commissioner and it has no relevance to the grant of recognition. This submission may be considered sufficient. The appellant has submitted with the appeal, the relevant documents about contiguity of the plots. In these circumstances, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the documents relating to contiguity of the plots, to be submitted by the appellant to them, and take further action as per the

NCTE Regulations, 2014. The appellant is directed to forward the documents relating to contiguity of plots submitted in the appeal, to the WRC within 15 days of receipt of the order on the appeal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to WRC with a direction to consider the documents relating to contiguity of the plots, to be submitted by the appellant to them, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward the documents relating to contiguity of plots submitted in the appeal, to the WRC within 15 days of receipt of the order on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Shri Dwarika Prasad Yadav Shiksha Mahavidyalaya, Padariya, Ashok Nagar, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

The institution has not submitted the Land Use Certificate issued by the Competent Authority to use the land for educational purpose. The institution has not submitted the Non-Encumbrance certificate issued by the Competent Authority indicating that the land is free from all encumbrances. Hence, the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

AND WHEREAS Sh. Chandrakant Sharma, Society Member, Pavan Rokadiya B.Ed. College, Tehsil Road, Garhi, Rajasthan presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation it was submitted that their college is a composite institution as the affiliating university has granted affiliation on 09.05.2016 for conducting B.A. and B. Com courses for the academic session 2015-16. The appellant submitted a copy of a registered document dt. 12.05.2017 altering the status of the land registered as lease on 26.06.2008 into sale deed from that date itself. The appellant also submitted copies of the land use certificate and Non-Encumbrance Certificate issued by Sub=Registrar, Garhi, Distt. Banswara, Rajasthan.

AND WHEREAS the Committee noted that as per the copy of the certificate of land dt. 29.06.2008 submitted along with the hard copy of the on-line application dt. 17.05.2016, the land was taken on lease from a private person. The Committee noted the according to the provisions of clause 8(4)(i) of the NCTE Regulations 2014 no institution shall be granted recognition under these Regulations unless the institution or the society sponsoring the institution is in possession of the required land on the date of application free from all encumbrances either on ownership basis or on lease from Government or Government institutions for a period of not less than thirty years. Since the appellant, on the date of application, was in possession of the land on private lease basis only and not on the terms laid down in the Regulations, the Committee concluded that the appeal deserved to be rejected and the order of the NRC confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

In the appeal and during personal presentation it was submitted that they sent many letters requesting for time for the submission of NOC since it was in process on 11/02/2017 with wrong Application No. ERCAPP201646244 by mistake and on dated 20.04.2017 and 29.05.2017 with right Application No. ERCAPP201646366. NOC was sent on 30.05.2017 again by mistake in wrong application no. ERCAPP201646244 but their real application no. is ERCAPP201646366. Building Completion certificate duly signed by the Assistant Engineer, Building Sub Division 1, Darbhanga Govt. Engineer was sent by email on 29.05.2017 and hard copy on 30/05/2017. The prescribed format of Building Completion Certificate of NCTE is only for the recognized Colleges. They have already submitted earlier the required documents by a wrong application No. that is ERCAPP201646244 by mistake instead of Application No. ERCAPP201646366 on

dated 11/02/2017 and on 20/04/2017 by actual Application No. ERCAPP201646366 by speed-post. The Affidavit, Building Plan and Site Plan clearly show the Built-up Area and Land Area. All the above letters were sent by speed post in stipulated period but a few could not be sent through Email by mistake. The appellant with their letter dt. 25.09.2017 submitted various documents including copies of the NOC dt. 29.05.2017 issued by the affiliating body and building completion certificate signed by Asst. Sub-Engineer, Building Sub-Division-1, Darbhanga and building plan.

AND WHEREAS the Committee noted that according to the provisions of clause 5(3) of the NCTE Regulations, 2014, a No Objection Certificate (NOC) issued by the concerned affiliating body shall be submitted along with the copy of the online application. The appellant has not fulfilled this requirement as they obtained the NOC from the affiliating body only on 29.05.2017 long after submitting hard copy of their on-line application on 30.06.2016. In these circumstances, the Committee concluded that the ERC was justified in refusing recognition on the ground that the appellant did not submit the NOC from the concerned affiliating body and therefore, the appeal deserved to be rejected and the order of the ERC confirmed.

AND WHEREAS After perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the ERC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the ERC is confirmed.

AND WHEREAS Dr. Madhurima Sinha, Managing Director, Dr. Madhurima Sanjay Teachers Training College, Ballopur (Bhigo), Laheriasarai, Bihar presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation the appellant submitted a copy of the building completion certificate in the format prescribed and signed by the Asst. Engineer, Building Sub-Division – I, Darbhanga and a copy of the building plan indicating the measurement of various facilities and a copy of the site plan.

AND WHEREAS the Committee noted that one of the grounds for refusal is that as the application of the appellant for B.Ed. course has been refused, the institution with one application for D.El.Ed. course falls under the category of stand alone institution. The Committee noted that the appellant has preferred an appeal separately against the refusal for grant of recognition for B.Ed. course but the Council

decided to reject the appeal on the ground that the institution did not submit the No Objection Certificate (NOC) issued by the affiliating body along with the application as required under Clause 5(3) of the NCTE Regulations, 2014. AND WHEREAS the Committee noted that the appellant, with the application, forwarded a copy of the lease deed dt. 5.5.2016 in respect of Khasra No. 1664/1 and a copy of the sale deed dt. 26.8.2013 in respect of Khasra Nos. 1933/1, 1934/1, 1935 and 1959/1. In the on-line application, the appellant mentioned all these Khasra nos. In reply to the show cause notice, the appellant, with their reply dt. 18.4.2017, enclosed a copy of the lease deed and a copy of Non-Encumbrance Certificate in respect of Khasra No. 1664/1. The appellant, in the course of personal presentation, submitted copies of two certified sale deeds dt. 26.8.2013 and 28.11.2016 for land in

Khasra numbers 1933/1, 1034/1, 1935/1 and 1959/1 and also a copy of the Non-Encumbrance Certificate dt. 10.5.2017 issued by the Sub-Divisional Officer, Aspur, Distt. Dungarpur Rajasthan in respect of these Khasra numbers.

WHEREAS the appeal of M.B. College of Education, Sridilpur (Rambhadrapur), Bahadurpur, Bihar dated 12/06/2017 is against the Order No. ER-239.6.126 (Part-4)/ID No.-8043/D.El.Ed./2017/52959 dated 02/05/2017 of the Eastern Regional Committee, granting recognition for conducting D.El.Ed. Course of one unit (intake of 50). The appellant wants recognition for two units.

AND WHEREAS M.B. College of Education, Sridilpur (Rambhadrapur), Bahadurpur, Bihar presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation and in an affidavit dt. 25.09.2017 it was submitted that (i) they applied for grant of recognition for two units (100 intake) of D.El.Ed course; (ii) they selected 1+15=16 faculty and got them approved by Bihar School Examination Board (iii) the ERC granted recognition for only one unit (50) on the ground that there is only one teacher for mathematics instead of two; (iv) at the time of selection, there were more than two candidates for the posts of teacher in mathematics but the selection committee, taking into account the fall in the students opting for mathematics, selected only one candidate for mathematics; (v) the appellant took up the matter regarding selection of one more teacher for mathematics with Bihar School Examination Board on 22.05.2017 but in spite many efforts they have not responded in writing; (vi) however the officials of the Board informed (verbally) that as the number of students taking up teaching of mathematics is on the decline and out of 16 faculty members selected there is already one faculty for mathematics and; (vii) in fact the number of candidates opting for teacher of mathematics is only 3 to 5 in 100. The appellant, submitting that they have provided all the requisite instructional and infrastructural facilities at heavy cost, they may be granted recognition for two units (100 intake) of D.El.Ed course.

AND WHEREAS the Committee noted that the appellant applied for grant of recognition for two units (100 intake) of D.El.Ed. course; inspection of the institution was conducted for two units and the visiting team recommended recognition for two units. The minutes of the 237th meeting (part-I) of the ERC held on 9-11 April, 2017, wherein a decision was taken to issue the Letter of Intent, do not indicate the number of units. In reply the appellant, inter-alia, forwarded a list of 16 faculty members duly approved by the Bihar School Examination Board, which included one faculty in mathematics.

AND WHEREAS the Committee noted that according to the Norms and Standards for D.El.Ed. course contained In Appendix-2 to the NCTE Regulations, 2014, for an intake of upto two basic units of 50 students, the faculty strength shall be 16 including Principal/HoD. This faculty should consist of two faculties for mathematics. The Committee, noting the submissions of the appellant, namely, that (i) the Bihar School Examination Board has already approved a total faculty of 16; and (ii) there is a decline in the candidates opting for teaching of mathematics, concluded that the matter deserved to be remanded to the ERC with a direction to consider grant of recognition of one more unit of D.El.Ed. to the appellant institution.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to ERC with a direction to consider grant of recognition of one more unit of D.El.Ed. to the appellant institution.

NOW THEREFORE, the Council hereby remands back the case of M.B. College of Education, Sridilpur (Rambhadrapur), Bahadurpur, Bihar to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of J.L.N. Degree College, Sangod, Jolpa Road, Sangod, 07/06/2017 is Rajasthan dated against the Order No. NCTE/NRC/NRCAPP201616092/B.A.B.Ed./B.Sc.B.Ed. Year Integrated/RJ/2017-18/2; dated 25/04/2017 of the Northern Regional Committee, refusing recognition for conducting B.A. B.Ed./B.Sc. B.Ed. Course on the grounds that "Recognition order for B.Ed. course submitted by the institution is in the name of Jawahar Lal Nehru Shikshan Prashikshan Mahavidyalaya whereas name of the institution in online application for proposed course is J.L.N. Moreover, the khasra numbers mentioned in the land documents do not match with the online application. Size of Multi-Purpose Hall is not mentioned on the Building Plan. Hence, the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

AND WHEREAS Dr. Azam Baig, Director, J.L.N. Degree College, Sangod, Jolpa Road, Sangod, Rajasthan presented the case of the appellant institution on 25/09/2017. In the appeal and during personal presentation it was submitted that they have replied to the show cause notice dt. 27.02.2017 through their letter dt. 22.03.2017, but the NRC has not considered their reply and refused recognition. The institution has already mentioned in online application that this institution is running a degree college in the name of J.L.N. Degree College and a B.Ed. college in the name of Jawahar Lal Nehru Shikshan Prashikshan Mahavidyalaya in the same campus in different building. A copy of Recognition order for B.Ed. course was submitted to NRC, NCTE along with reply of Show Cause Notice. Copy of NOC

issued by College Education Deptt. Govt. of Rajasthan & Affiliation order issued by Kota University, Kota in the name of J.L.N. Degree College was submitted to NRC, NCTE along with application form. Copy of NOC and affiliation letter are annexed. Kota University Kota has issued NOC for proposed B.A. B.Ed./B.Sc. B.Ed. course in the name of J.L.N. Degree College which was submitted to NRC, NCTE along with online application form. Copy of NOC for proposed course is annexed. As per clause 2(b) of NCTE Regulations 2014, "composite institution" means a duly recognized Higher Education Institution offering undergraduate or postgraduate programmes of study in the field of liberal arts or humanities or social sciences or sciences or commerce or mathematics, as the case may be, at the time of applying for recognition of Teacher Education Programmes, or an institution offering multiple Teacher Education programmes. Thus, the college offering U.G. programme is eligible for grant of recognition for B.A. B.Ed./B.Sc. B.Ed. course. The Appellate Authority, NCTE has passed an appeal order on 04.08.2016 in which it is clearly stated that the institution proposed to be established by the same Management Society or Trust in the same premises irrespective of little modification in the name shall be treated to be a composite institution. Copy of appeal orders are annexed. Looking into the above fact, it is very clear that college running degree course is eligible for grant of recognition of B.A. B.Ed. / B.Sc. B.Ed. course. This institution has submitted certified copy of registered land documents to NRC, NCTE along with reply of SCN Copy certified registered land documents is annexed. Due to typing error, Plot No. of society office C-4, 5, 6 has been mentioned in online application in place of Khasra number. The Khasra No. of land registered in the name of society is 76, 77 & 7/8. In this regard a certificate issued by Tehsildar, Sangod, Kota was submitted to NRC, NCTE along with reply of SCN. Copy of the certificate issued by Tehsildar is annexed. The size of Multipurpose Hall is already mentioned on approved Building Map. The approved building map was submitted to NRC, NCTE along with reply of SCN. Copy of approved building map is annexed. Thus, NRC. NCTE has rejected their application on wrong, illegal, unlawful and unconstitutional basis. So, it is prayed that the rejection order be set side and directions be issued to NRC, NCTE for further processing of application of this institution for grant of recognition for B.A. B.Ed. / B.Sc. B.Ed. course.

AND WHEREAS the Committee noted from a perusal of the documents in the file and the documents submitted by the appellant in appeal, that the society applied for grant of recognition for conducting the four year integrated course B.A., B.Ed./B.Sc, B.Ed. in an institution named J.L.N. Degree College, which is running under graduate courses of Kota University. In the circumstances, the appellant qualifies to be considered as a composite institution in terms of clause 2(b) of the NCTE Regulations, 2014 as also the provisions of clause 1.1. (preamble) to the Norms and Standards for the 4 year Integrated B.A., B.Ed./B.Sc., B.Ed. course contained in Appendix 13 to the NCTE Regulations, 2014. If the name of the institution in which B.Ed. course is being run and which is different from the appellant college, it should not affect consideration of the present proposal to conduct the integrated course in J.L.N. Degree College.

AND WHEREAS in view of the position stated above, the Committee concluded that the matter deserved to be remanded to the NRC with a direction to consider the replies furnished in appeal to various points and take further action as per the NCTE Regulations, 2014. The Appellant is directed to forward all the documents submitted in appeal, to the NRC within 15 days of receipt of the issue of orders on appeal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC with a direction to consider the replies furnished in appeal to various points the provisions of para 1.1 of the preamble to the Norms and Standards for the 4-year Integrated programme and take further action as per the NCTE Regulations, 2014. The Appellant is directed to forward all the documents submitted in appeal, to the NRC within 15 days of receipt of the issue of orders on appeal.

NOW THEREFORE, the Council hereby remands back the case of J.L.N. Degree College, Sangod, Jolpa Road, Sangod, Rajasthan to the NRC, NCTE, for necessary action as indicated above.

B.Ed. is rejected."

AND WHEREAS Sh. Suraj Prasad Upadhyay, Managing Director, Pandit Deen Dayal Upadhyay Smriti Mahila Shikshak Prashikshan Mahavidyalaya, Baswa, Bandikui, Rajasthan presented the case of the appellant institution on 25/09/2017. The appellant with their appeal enclosed copies of certain letters written by them to the NRC before and after refusal of recognition. In their letter dt. 23.010.2017, the appellant submitted that their institution has been recognised for B.Ed. and D.El.Ed. course and hence they are a composite institution. In their letter dt. 13.10.2016 it has been submitted that they are enclosing copies of the land registry, copy of building plan with Khasra number and a true copy of the registration of their society. All these letters are available in the file.

AND WHEREAS the Committee noted that according to the provisions of para 1.1 of the Norms and Standards for 4-year Integrated programme leading to B.Sc. B.Ed./ B.A. B.Ed. degree, contained in Appendix-13 to the NCTE Regulations, 2014, this programme aims at integrating general studies comprising science (B.Sc. B.Ed.) and social sciences or humanities (B.A., B.Ed.) and professional studies comprising foundations of education, pedagogy of school subjects and practicum related to the tasks and functions of a school teacher. In the light of these provisions, availability of B.A./ B.Sc. courses in an institution intending of offer the integrated B.A. B.Ed./ B.Sc. B.Ed. programmes, can only fulfil the objectives of the integrated programme. The Committee also noted that keeping this in view, the NCTE in their letter dt. 07.04.2016 addressed to the Regional Committees laid down that (i) the application for a 4-year integrated programme can be processed, if the applicant has simultaneously applied to the affiliating body for a graduate programme, and (ii) the affiliating body has undertaken to regulate the B.A./B.Sc. component of the integrated programme, in accordance with the curriculum and norms of the University. The latter condition has been re-iterated in the NCTE's letter dt. 10.02.2017.

AND WHEREAS the Committee is of a opinion that the applications for introduction of integrated 4 year B.A. B.Ed./ B.Sc. B.Ed. should satisfy the requirements mentioned in para 3 above for fulfilling the objectives of the integrated programme, clearly laid down in the preamble of the Norms and Standards for this course. The B.Ed. programme being conducted by the appellant institution, can, under no, circumstances, be considered as an undergraduate programme of study in the field of liberal arts or humanities etc. mentioned in clause 2 (b) of the NCTE Regulations, 2014. In the above circumstances the Committee concluded that, as the appellant has not fulfilled the required conditions mentioned in para 3 above for being a composite institution, the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the NRC was justified in refusing recognition and therefore, the appeal deserved to be rejected and the order of the NRC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of R.J. Girls Degree College, Rampur, Balbhadra Manihari to Jakhaniyan, Jakhania, Uttar Pradesh dated 14/06/2017 is against the Order No. NRC/NCTE/NRCAPP-3532/262nd (Part-8) Meeting/2017/166750 dated 06/02/2017 of the Northern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "the institution was granted recognition under clause 7(16) vide order 02.03.2015. After recognition, NRC received letter from the Registrar, Veer Bahadur Singh Purvanchal University, Jaunpur. In the letter, the Registrar mentioned that the institution has been given recognition on fake faculty list. Hence, institution was given show cause notice. The reply submitted by the institution is not acceptable. The institution misled the NRC by submitting a fake list of teachers. Hence, the Committee decided to withdraw the recognition granted to the institution of B.Ed. course under section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal."

and whereas the Committee noted that the appellant, aggrieved by the order of the NRC, filed a Writ C. No. 26498 of 2017 before the Hon'ble High Court, Allahabad. The Hon'ble High Court, in their order dt. 07.06.2017, disposed of the petition with liberty to the petitioner to file an appeal within a period of four days before the respondent along with a certified copy of the order of the court. The Hon'ble High Court also ordered that in case, such appeal is filed, the respondent shall decide the appeal in accordance with law without entertaining any objection to the limitation, within a further period of ten days.

AND WHEREAS Sh. Umesh Yadav, Member, R.J. Girls Degree College, Rampur, Balbhadra Manihari to Jakhaniyan, Jakhania, Uttar Pradesh presented the

case of the appellant institution on 26/09/2017. In the appeal and during personal presentation it was submitted that the recognition has been withdrawn in a mechanical manner without any documentary evidence and/or without any physical verification of the faculty members. In fact the faculty members mentioned in the list are actually teaching in the institution. The appellant, in their letter dt. 16.06.2017 enclosed to the appeal, submitted that in response to the decision to issue a show cause notice they have submitted a copy of the letter of the University dt. 28.05.2015 freshly approving their faculty to the NRC, but still NRC withdrew recognition. The appellant in the course of presentation submitted a copy of this letter.

AND WHEREAS the Committee noted that the NRC, in their order dt. 02.05.2015 granted recognition to the appellant college for conducting B.Ed. course with an intake of 100 (2 units). For obtaining this recognition, the appellant, in response to the Letter of Intent dt. 30.01.2014 issued to them, inter alia submitted a copy of the letter dt. 19.03.2014 from the Registrar, Veer Bahadur Singh Purvanchal University, Jaunpur approving eight faculty members for B.Ed. course in the appellant institution.

AND WHEREAS the Committee noted that the Registrar, Veer Bahadur Singh Purvanchal University, Jaunpur wrote a letter dt. 28.07.2016 to the Regional Director, NRC, indicating the dates of issue of LOI, approval of the faculty by them and formal recognition orders by NRC in respect of a number of institutions, including the appellant institution, and suggesting verification of the orders issued by NRC and taking further necessary action. In respect of the appellant institution, the date of issue of LOI, date of approval of faculty and date of issue of formal recognition order have been mentioned as 30.01.2014, 28.05.2015 and 02.03.2015 respectively. The NRC, on the basis of the letter of the University dt. 28.07.2016, decided in their 256th meeting held from 22 to 25 August, 2016 to issue a show cause notice to the appellant on the ground that the list of faculty approved by the affiliating body and submitted by the institution for getting recognition was fake. The appellant sent a reply dt. 30.09.2016 affirming that the University had in fact approved the faculty. The appellant also enclosed a self-attested copy of the

University's letter dt. 19.03.2014. Thereafter the NRC wrote a letter dt. 05.12.2016 to the Registrar, VBS Purvanchal University requesting them to verify the authenticity of the contents of the approval order dt. 19.03.2014 submitted by the institution while no reply was received from the University, the NRC decided to withdraw recognition and issued the order on 06.03.2017.

AND WHEREAS the Committee noted that the appellant, with their reply dt. 30.09.2016 to the show cause notice, submitted a copy of the faculty approval letter dt. 19.03.2014 issued by the University and not their subsequent letter dt. 28.05.2015, as claimed in the appeal. It is seen that the appellant submitted copies of the University's letters dt. 19.03.2014 and 28.05.2015 with their writ petition filed before the Hon'ble High Court. In the averments in the writ petition, the petitioner stated that he got a fresh staff list approved to meet the requirements of NCTE Regulations, 2014.

AND WHEREAS the Committee, noting that VBS Purnvanchal University did not send a reply to the NRC's letter dt. 05.12.2016 and the appellant is standing by both the letters of approval dt. 19.03.2014 and 28.05.2015, concluded that the matter deserved to be remanded to the NRC with a direction to get the authenticity of both the letters verified and take further action as per the NCTE Regulations, 2014. The appellant is directed to intimate the NRC the full circumstances under which they got the approval of their faculty a second time from the affiliating University, within 15 days of receipt of the orders on the appeal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC with a direction to get the authenticity of both the letters verified and take further action as per the NCTE Regulations, 2014. The appellant is directed to intimate the NRC the full circumstances under which they got the approval of their faculty a second time from the affiliating University, within 15 days of receipt of the orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of R.J. Girls Degree College, Rampur, Balbhadra Manihari to Jakhaniyan, Jakhania, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

The institute falls in the area of Hindaun City which has been notified for educational purpose in the master plan. Other academic and educational activities are continuously going on since 1969. The land use conversion has already been permitted by the competent authority under section 90A of Rajasthan land revenue act. The institution has completed all the formalities and only issuance of lease deed is expected. All these facts are evident from the letter dated 23 April 2015 issued from the office of

Commissioner, Municipal Council, Hindaun City. A certified copy of this letter is also uploaded.

AND WHEREAS the Committee, noting that the appellant has submitted the necessary documents with reference to the grounds mentioned in the NRC's order dt. 28.04.2017 concluded that the matter deserved to be remanded to the NRC with a direction to consider these documents, to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the NRC, all the documents submitted in the appeal, within 15 days of receipt of the order on the appeal.

AND WHEREAS the NRC, while taking the further action suggested above, should keep in view (i) the provisions of para 1.1. of the Norms and Standards for 4-year Integrated programme leading to B.Sc. B.Ed. / B.A.B.Ed. degree, contained in Appendix-13 to the NCTE Regulations, 2014 relating to integration of general studies comprising of Science (B.Sc.B.Ed.) and Social sciences or humanities (B.A.B.Ed.) and professional studies; and (ii) the instructions contained in the NCTE's letter dt. 07.04.2016 about the requirements of (a) simultaneous application for a graduate programme; and (b) an undertaking of the affiliating body to regulate the B.A./B.Sc. component of the integrated programme in accordance with the curriculum and norms of the University. The Committee noted that the appellant is conducting B.Ed. and D.El.Ed. programmes only.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC with a direction to consider the documents, to be submitted to them by the appellant in the light of the provisions contained in para 1.1 of the Norms and Standards for the 4 year Integrated programme and take further action as per the NCTE Regulations, 12014. The appellant is directed to forward to the NRC all the documents submitted in the appeal, within 15 days of receipt of the order on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Nehru College of Education, Bayana Road, Hindaun City, Rajasthan to the NRC, NCTE, for necessary action as indicated above.

In the appeal and during personal presentation it was submitted that (i) they filed application for additional intake of D.El.Ed. with an intake of 100 (two units); (ii) the visiting team's report was found satisfactory and NRC issued Letter of Intent; (iii) the appellant submitted an affidavit for consent / willingness for two units of additional intake in B.Ed. and two units of additional course of D.El.Ed. and furnished the list of faculty course-wise approved by affiliating body; and (iv) the ERC without issuing any show cause notice issued their order dt. 02.05.2017 for one additional unit of B.Ed. only and two units of D.El.Ed. The order dated 02.05.2017 is not sustainable in the eye of law for the reason that the applicant institution has not received any show cause notice related to applied intake B.Ed. (Additional Intake 100 (two units) and Additional course D.El.Ed. with intake 100 (two units). The ERC only issued a LOI as per 238th Meeting held from 18th to 20th April 2017 on the following grounds:- The institution which is already recognized for B.Ed. / D.El.Ed. course(s) and sought recognition / permission for additional course / additional intake is required to furnish the previous faculty list alongwith compliance of the Letter of Intent, copy of which enclosed. Institution be asked to submit two separate FDRs of Rs. 5.00 lakh and Rs. 7.00 lakh for each

applied course towards endowment fund and reserve fund in the joint name of RD, ERC, NCTE and institution with reply of letter of intent. This incident reveals that the Committee has not done justice to the institute and decision are not properly taken by the Committee by suppressing the truth / original records submitted by the institute. This is the impression the appellant has got from the errant and unmindful decision of ERC.

AND WHEREAS the Committee noted that the appellant in their on-line application dt. 31.05.2016 applied for one additional unit (50) in B.Ed. and two basic units in D.El.Ed. However, in the affidavit enclosed, he mentioned new D.El.Ed. 100 (2 units) and additional B.Ed. (2 units). In the on-line application it is mentioned that B.Ed. with two units (100) is already existing. In the VT report under the heading 'proposed courses' the intake for B.Ed. and D.El.Ed. course is mentioned two units (100) each. The VT in their report has stated that the institution has infrastructural and instructional facilities for the proposed B.Ed. and D.El.Ed. courses. The ERC in their Letter of Intent dt. 28.04.2017 asked the institution to intimate their willingness in an affidavit about the number of units either one or two. The appellant furnished an affidavit expressing their willingness for two units of B.Ed. and D.El.Ed. courses. The minutes of the 239th meeting of the ERC held from 28th April to 2nd May, 2017, in which a decision was taken to grant recognition for one additional unit in B.Ed. and not for two units, do not contain any reasons. In these circumstances, the Committee concluded that the matter deserved to be remanded to the ERC with a direction to issue a speaking order stating the reasons for granting recognition for one additional unit of B.Ed. only.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to ERC with a direction to issue a speaking order stating the reasons for granting recognition for one additional unit of B.Ed. only.

College of Education, Shadipur, Jind Rohtak 24/06/2017 is against the Order Road, Julana, Haryana dated NRC/NCTE/NRCAPP-8243/268th (Part-1) Meeting/2017/171888 dated 25/04/2017 of the Northern Regional Committee, refusing recognition for additional intake in D.El.Ed. Course on the grounds that "Govt. of Haryana has requested NCTE not to recommend any fresh opening / recognition / increase on intake of any D.El.Ed. Institute for the year 2017-18. Hence, the Committee decided that the application is rejected and recognition / permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

AND WHEREAS Sh. Suresh Chand, Director, J.B.M. College of Education, Shadipur, Jind Rohtak Road, Julana, Haryana presented the case of the appellant institution on 26/09/2017. In the appeal and during personal presentation it was submitted that the NRC has rejected the application inter alia on the ground that NOC from the affiliating body has not been submitted. It is submitted that the appellant had submitted the application in the year 2012 in response to public notice dt. 26.11.2012 issued by the NCTE. The application was illegally rejected by NRC and in the appeal their plea had already been accepted and returned back the application to NCTE, Jaipur for further processing but they rejected on same ground.

AND WHEREAS the Committee noted that the submission of the appellant that their application was refused again on the same ground i.e. non-submission of NOC from the affiliating body is not correct because on an earlier appeal preferred by the appellant, the Council held that the requirement of NOC cannot be made mandatory in respect of the application submitted in 2012. The refusal was on the ground that the State Govt. of Haryana has requested NCTE not to recommend fresh opening/recognition/ increase intake of any D.El.Ed. institute for the year 2017-18.

AND WHEREAS the Committee noted that the application of the appellant for increase in intake in D.El.Ed. course dt. 30.12.2012 has been under consideration for quite some time and during the course a deficiency letter dt. 23.08.2013 and four show cause notices dt. 05.01.2015, 06.08.2015, 26.11.2015 and 09.03.2017 were issued to the appellant. The latest show cause notice was on the ground of State Govt's request as mentioned in the refusal order, appealed against.

AND WHEREAS the Committee noted that in the matter of the applications submitted in the year 2012 and which were rejected on the grounds of the State Govt's subsequent stand that they do not want to recommend opening of new D.El.Ed. institution or increase in intake in the existing institutions for the years from 2013-14, 2017-18, the Council sought legal advice, which has since become available. The crux of this legal opinion is that recognition is granted prospectively under Section 15(3 (a) and as such it should be only after complying with the existing Regulations. Once the State Government gives its opinion and recognition is granted by NCTE, such grant attains supremacy vis-a vis the State Government as well as the affiliating body. The final authority to grant or refuse recognition rests with NCTE but State has a vital role to offer by way of properly commenting as and when its opinion is called for and NCTE should take into consideration the recommendations and views of the State despite the fact that it has the final say.

AND WHEREAS the Committee is also for the view that when recommendations of the State Government under Clause 7(4), (5) and (6) of the NCTE Regulations, 2014 are sought by the Regional Committee, the State Government should assess the institution on individual merit basis and wherever it is not in favour of recognition, shall provide detailed reasons and grounds with necessary statistics. Appeal Committee noted that when the appellant applied in 2012, there was no ban by the State Government. Further the Appeal Committee is of the view that the blanket general ban imposed by the State Government can be taken into account by NCTE only before issuing any notification inviting applications for teacher education courses in a particular State for the prospective academic year(s). Once applications are invited, the Regional Committee has no right to reject it on grounds of ban imposed subsequently by the State Government.

AND WHEREAS in view of the position stated above, the Committee concluded that the matter deserved to be remanded to the NRC with a direction to process the application further as per the NCTE Regulations, 2014.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to N.R.C. with a direction to process the application further as per the NCTE Regulations, 2014.

unit as mentioned in the SRC Minutes. SRC has granted the Formal Recognition for one basic unit of B.Ed. Two Year programme which they applied along with B.Sc. B.Ed. Four Year Integrated of one basic unit. As per the Regulations of NCTE, for one basic unit of 50, both for B.Ed. and B.Sc. B.Ed. one faculty for Perspectives in Education and one Faculty either for Fine Arts or Performing Arts are required. The faculty list submitted to SRC by their University on 02.05.2017 fulfils the NCTEs norms and standards with one Assistant Professor in Sociology of Education and another Assistant Professor with M.Sc. in Psychology for Perspectives in Education. In the light of above facts, permission may be granted to start the B.Sc. B.Ed. Four Year Integrated programme with one basic unit from 2017 onward.

Course on the grounds that "the applicant institution has not submitted the reply of the SCN issued by the NRC on 19.01.2017 till date. Hence, the Committee decided that the application is rejected and recognition / permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

AND WHEREAS Sh. Arun Mittal, Secretary, Vidya Bharti B.Ed. College, Todi Nagar, Sikar, Rajasthan presented the case of the appellant institution on 26/09/2017. In the appeal and during personal presentation it was submitted that (i) the NRC, NCTE has issued a Show Cause Notice on 19.01.2017 in which certain deficiencies have been mentioned. Copy of SCN is annexed. (ii) The secretary Mr. Arun Mittal was hospitalized from 10.01.2017 to 15.05.20 7 and he had to be kept on complete bed rest during this period. Copy of Medical Certificate is annexed; (iii) Due to hospitalization of Mr. Arun Mittal, Secretary, this institution has not seen the email and did not send a reply to the Show Cause Notice to NRC, NCTE; (iv) NRC, NCTE has rejected the application of this institution due to non-submission of reply of SCN vide letter dated 17.04.2017; (v) After discharge from hospital of Mr. Arun Mittal Secretary, this institution has submitted reply of SCN to NRC, NCTE on 30.05.2017. Copy of reply letter is annexed. Copy of Bye Laws of society has been submitted along with reply of SCN to NRC, NCTE. Copy of Bye Laws of society is annexed; (vii) copy of recognition and affiliation order for B.Ed. and S.T.C. course was submitted to NRC, NCTE along with hard copy of application. Recognition and Affiliation order for B.Ed. and S.T.C. course is annexed; (viii) certified copy of registered land documents has been submitted to NRC, NCTE along with reply of SCN. Copy of registered land documents are annexed; (ix) Non-Encumbrance Certificate issued by Tehsildar was submitted to NRC, NCTE along with hard copy of application. Copy of Non-Encumbrance Certificate is annexed; (x) Land Use Certificate issued by Nagar Parisad for Educational purpose was submitted to NRC, NCTE along with hard copy of application. Copy of Land Use Certificate is annexed; and (xi) copy of approved building map on which all required information as per NCTE Regulations 2014 has been mentioned and building completion certificate was submitted to NRC, NCTE along with hard copy of application. Copy of approved building map and building completion certificate are annexed. Thus NRC, NCTE has rejected the application of this institute for grant of recognition for B.A. B.Ed./B.Sc. B.Ed. course on illegal, unlawful, arbitrary and unjustified basis. Therefore, it is prayed that the rejection order issued by NRC, NCTE be set aside and directions be issued to NRC, NCTE for further process of application of this institute for grant of recognition of B.A. B.Ed./B.Sc. B.Ed. course.

AND WHEREAS the Committee noted from a copy of the reply to the show cause notice, enclosed to the appeal, that it was received in the NRC on 30.05.2017 as per stamp affixed on one of the pages of the reply, but without any dairy number. However, this reply is not available in the file of the NRC. The appellant, with their appeal, enclosed the various documents mentioned in the show cause notice. In the course of hearing the appellant submitted some more land related documents. In these circumstances, the Committee concluded that the matter deserved to be remanded to the NRC with a direction to consider the reply to the show cause notice, to be re-submitted by the appellant to them, with all the documents, and take further action as per the NCTE Regulations, 2014. The appellant is directed to resubmit their reply to the show cause notice along with all its enclosures and other documents submitted in appeal to the NRC within 15 days of receipt of orders on the appeal.

AND WHEREAS the Committee noted that according to the provisions of para 1.1 of the Norms and Standards for 4-year integrated programme of B.A.B.Ed. / B.Sc.B.Ed. contained in Appendix-13 to the NCTE Regulations, 2014, this programme aims at integrating general studies comprising science (B.Sc.B.Ed.) and social sciences or humanities (B.A. B.Ed) and professional studies. Keeping this in

view, the NCTE in their letter dt. 07.04.2016 addressed to all Regional Committees laid down that (i) application for 4-year integrated programme can be processed, if the applicant has simultaneously applied to the affiliating body for a graduate programme, and (ii) the affiliating body has undertaken to regulate the B.A./B.Sc. component of integrated programme in accordance with the curriculum and norms of the University. The Committee also noted that the appellant is presently conducting B.Ed. and B.El.Ed. programmes only. The NRC, while taking the further action suggested in para 3 above should also take into account the provisions of the Regulations and the instructions contained in the NCTE's letter mentioned herein.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to NRC with a direction to consider the reply to the show cause notice, to be re-submitted by the appellant to them, with all the documents in the light of the provisions of Para 1.1 of the Norms and Standards for the 4 year Integrated programme and take further action as per the NCTE Regulations, 2014. The appellant is directed to resubmit their reply to the show cause notice along with all its enclosures and other documents submitted in appeal to the NRC within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Vidya Bharti B.Ed. College, Todi Nagar, Sikar, Rajasthan to the NRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Sanjeevani Mahila Teacher Training School, Sagwara, Gourav Path, Sagwara, Rajasthan dated 06/06/2017 is against the Order No. NRC/NCTE/NRCAPP-10532/254th Meeting/2016/171360 dated 17/04/2017 of the Northern Regional Committee, refusing recognition for conducting D.El.Ed. Course on the grounds that "the name of the applicant institution is Sanjeevani Mahila T.T. School whereas video CD submitted by VT revcals that the institution shown to VT is Mahila Mahavidyalaya. NOC has also been issued for affiliation of UG courses to Mahila Mahavidyalaya and not to applicant institution. The land is in the name of individual which is not acceptable as per norms. Certified copy of land documents not submitted. Building plan duly approved by the competent authority not submitted. Notarized copy of CLU not submitted."

AND WHEREAS Sh. Paresh Bhatt, Member, Sanjeevani Mahila Teacher Training School, Sagwara, Gourav Path, Sagwara, Rajasthan presented the case of the appellant institution on 26/09/2017. In the appeal and during personal presentation it was submitted that (i) The institution has submitted online application for grant of recognition of D.El.Ed. course on 26.05.2015; (ii) NRC, NCTE has issued a Show Cause Notice dated 11.12.2015 in which only one deficiency has been mentioned; (iii) The institution has submitted a reply letter to NRC, NCTE on 30.12.2015 along with required documents; (iv) NRC, NCTE has constituted V.T. for inspection of this institution for proposed course vide letter dated 01.02.2016; (v) NRC, NCTE has issued a L.O.I. u/s 7(13) of NCTE Regulations 2014 to this institution for D.El.Ed. course on the basis of scrutiny of documents submitted by this institution, input received from V.T. report and videography vide letter dated 24.02.2016; (vi) Before sending reply to the L.O.I. by this institution, NRC, NCTE has issued a Show Cause Notice to this institution indicating certain deficiencies on 15.03.2016; (vii) the institution has submitted a request letter for granting some time for sending a reply

of Show Cause Notice; (viii) the institution has submitted reply of SCN to NRC, 09.08.2016 along with all required documents and explanations. Copy of letter is annexed; and (ix) NRC, NCTE has not considered the reply of this institution and rejected the application of this institution for grant of recognition of D.El.Ed. course on wrong, unlawful, illegal and unconstitutional basis. The rejection order is against the principles of natural justice. The appellant also submitted that their institution is running a degree college in the same campus. The name of degree college is "Mahila Mahavidyalaya". Due to lack of knowledge regarding NCTE Act & Regulations, this institution has mentioned "Sanjeevani Mahila T. T. School" in the online application. Copy of N.O.C. issued by College Education Deptt., Govt. of Rajasthan and copy of Affiliation letter issued by M.L.S. University, Udaipur was submitted to NRC, NCTE along with reply of SCN for proof of composite institution. Copy of N.O.C. & Affiliation letter is annexed. The Appellate Authority, NCTE has passed an appeal order on 04.08.2016 in which it is clearly stated that the institution proposed to be established by the same Management Society or Trust in the same premises irrespective of little modification in the name shall be treated to be a composite institution. Copies of appeal orders are annexed. After coming to know the provisions regarding composite institution, this society has passed a resolution regarding change of name of the college to fulfil the provisions of clause 2(b) of NCTE Regulations 2014. Copy of resolution has also been given to V. T. members along with other documents and the same has also been submitted to NRC, NCTE along with reply of Show Cause Notice. Copy of resolution submitted to NRC, NCTE is annexed. The chairman of the Society has submitted an affidavit to NRC, NCTE along with reply of SCN in which it is clearly mentioned that application for grant of recognition for D.El.Ed. course of this institution be processed in the name of "Mahila Mahavidyalaya" in place of "Sanjeevani Maḥila T.T. School". Copy of affidavit is annexed. 9797 sg. yard (8194.51) sqm.) land of Khasra No. 4269/1, 4347/1, 3359/1, 3359/2, 3361 & 3362 at Sagwara Distt. Dungarpur (Raj) is registered in the name of Shri Kshetrapal Jan Seva Sansthan, Khadgada on ownership basis. Certified copy of registered sale deed was submitted to NRC, NCTE along with reply of SCN. Copy of registered sale deed and Jamabandi (Khatauni) in the name of society are annexed. Building plan approved by the Nagar Palika, Sagwara was submitted to NRC, NCTE by this institution along with reply of SCN. Copy of approved building map, building completion certificate and approval letter issued by Nagar Palika are annexed. 9797 Sq. Yard (8194.51

Sqm.) land which is registered in the name of society is converted for educational purpose by the Nagar Palika, Sagwara. Copy of conversion letter issued by Nagar Palika is annexed. Thus NRC, NCTE has rejected their application on wrong, illegal, unlawful and unconstitutional basis. So, it is prayed that the rejection order be set aside and directions be issued to NRC, NCTE for issuance of LOI u/s 7(13) and formal recognition letter u/s 7(16) of NCTE Regulations, 2014.

AND WHEREAS the Committee noted that the NRC, after issuing the Letter of Intent on 24.02.2016, issued a show cause notice to the appellant on 15.03.2016 mentioning six grounds. The appellant sent a reply dt. 12.04.2016 (which was received in NRC on 16.05.2016) requesting extension of time for fulfilling the requirements of the show cause notice. The NRC, in their 254th meeting held from 28 to 30 June, 2016, considering the interim reply dt. 12.04.2016, decided to refuse recognition. But the formal refusal order was issued only on 17.04.2017 i.e. after more than ten months of taking the decision.

AND WHEREAS the Committee also noted that the appellant sent a formal reply to the show cause notice on 09.08.2016, which was received in the NRC on the same day. The appellant enclosed a number of documents supporting their reply. The file does not indicate any consideration of this reply, through formal refusal order was not issued by that time. The appellant enclosed all the documents supporting their submissions with the appeal also. In these circumstances, the Committee remanded the matter deserved to be remanded to the NRC with a direction to consider the reply of the appellant dated 09.08.2016 and also further relevant documents to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward the documents submitted in the appeal to the NRC within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded the matter to N.R.C. with a direction to consider the reply of the appellant dated 09.08.2016 and also further relevant documents to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The

appellant is directed to forward the documents submitted in the appeal to the NRC within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Sanjeevani Mahila Teacher Training School, Sagwara, Gourav Path, Sagwara, Rajasthan to the NRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Manas Mahavidyalaya, Chitri, Galiyakot, Rajasthan dated 06/06/2017 is against the Order No. NCTE/NRC/NRCAPP201616605/B.A. B.Ed./B.Sc. B.Ed.- 4 Year Integrated/RJ/2017-18/2; dated 11/04/2017 of the Northern Regional Committee, refusing recognition for conducting B.A. B.Ed./B.Sc. B.Ed. Course on the grounds that "reply of SCN dated 03.03.2017 has been considered and the following observations were made:- (i) The institution has submitted two building plans. One of the Building Plans does not mention the Khasra No. and on the other Building Plan it is mentioned that the building is under construction. (ii) The land documents regarding Khasra No. 3738/1, 6025/310 and 2298/492 not submitted. (iii) The institution has not submitted LUC for khasra no. 6025/310 and 2298/492. (iv) The LUC for 3738/1 is only for 648 sq. mtr. which is not sufficient. (v) The institution has not submitted the Non-Encumbrance Certificate issued by the Competent Authority indicating that the land is free from all encumbrances. (vi) The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014. Hence, the Committee decided that the application is rejected and recognition / permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

AND WHEREAS Sh. Paresh Bhatt, Member, Manas Mahavidyalaya, Chitri, Galiyakot, Rajasthan presented the case of the appellant institution on 26/09/2017. In the appeal and during personal presentation it was submitted that (i) NRC, NCTE has issued a Show Cause Notice vide letter dated 24.02.2017 in which only one deficiency has been mentioned. Copy of SCN is annexed; (ii) The institution has submitted a reply letter to NRC, NCTE on 03.03.2017 along with required documents. Copy of reply is annexed; (iii) NRC, NCTE has not considered the reply of SCN submitted by this institution and rejected the application of this institution on some

other grounds which were not mentioned in the Show Cause Notice. NRC, NCTE has never communicated those deficiencies to this institution which are mentioned in rejection order; (iv) The action of NRC, NCTE is totally wrong, unlawful, illegal and unconstitutional. The rejection order is against the principles of natural justice; The appellant also submitted that their institution has submitted approved building map along with reply of SCN Khasra No. is already mentioned on building map. Approval of building plan is to be made before construction of building. After approval, construction of building is to be done. The construction of building for running the above course is already completed. Copy of approved building map is annexed. Certified copy of registered land documents in the name of society has already been submitted to NRC, NCTE along with hard copy of application. Copy of registered land documents is annexed. 5508 Sqm. land is already converted for educational purpose and 2710 Sqm. Land is already residential converted land in the name of society. Copy of Land Use Certificate issued by Competent Authority is annexed. 8218 Sqm. land registered in the name of society is free from all encumbrances. Copy of Non-Encumbrance is sued by Competent Authority is annexed. The this institution is running B.A. and B.Sc. course in the campus. Copy of N.O.C. issued by College Education Deptt: Govt. of Rajasthan and Affiliation letter issued by M.L.S. University, Udaipur is annexed. Thus, NRC, NCTE has rejected their application on wrong. illegal, unlawful and unconstitutional basis. So, it is prayed that the rejection order be set side and directions be issued to NRC, NCTE for further processing of application of this institution for grant of recognition for B.A. B.Ed./B.Sc. B.Ed. course.

AND WHEREAS the Committee noted that, as submitted by the appellant, the refusal order has been issued on grounds, which are different from those mentioned in the show cause notice dt. 24.02.2017 which has been replied to by the appellant. While the show cause notice mentioned only one ground, the refusal order contains several grounds. The file of the NRC does not indicate that a new show cause notice has been issued on the new grounds. In these circumstances, the Committee concluded that the matter deserved to be remanded to the NRC with a direction to issue a fresh show cause notice to the appellant on the grounds mentioned in the refusal order and take further action as per the NCTE Regulations, 2014.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the appeal deserves to be remanded to N.R.C. with a direction to issue a fresh show cause notice to the appellant on the grounds mentioned in the refusal order and take further action in the light of the provisions of Para 1.1 of the Norms and Standards for the 4 year Integrated Programme contained in the NCTE Regulations, 2014.

NOW THEREFORE, the Council hereby remands back the case of Manas Mahavidyalaya, Chitri, Galiyakot, Rajasthan to the NRC, NCTE, for necessary action as indicated above.
