WHEREAS the appeal of V.G. Solanki B.Ed. College, Kodinar – Una Highway At. Dolasa, Una Road, Gujarat dated 11/06/2018 is against the Order No. WRC/APW02089/323245/Guj./292<sup>nd</sup>/2018/198002 dated 22/05/2018 of the Western Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "the case file was seen. Consequent to the Revised Recognition order, Show Cause Notice dated 29.08.2016 &05.07.2017 were issued. The institution replied vide dated 31.08.2017 is under process. It appointed four additional staff approved by the Registrar. The appointment of the Principal is under process. The institution has not submitted the staff profile in original. FDRs for Rs.12.00 lakhs have not been submitted. Hence, Recognition is withdrawn from the next academic session 2018-2019."

AND WHEREAS Sh. Surinder Singh Solanki, Campus Director, V.G. Solanki B.Ed. College, Kodinar – Una Highway At. Dolasa, Una Road, Gujarat presented the case of the appellant institution on 01/08/2018. In the appeal and during personal presentation it was submitted that 1. "we have appointed a principal approved by the registrar. 2. original staff profile is also being sent approved by the registrar. 3.FDR worth 12 lakhs are also presented".

AND WHEREAS Appeal Committee noted that impugned withdrawal order dated 22.05.2018 was issued by W.R.C. on the grounds that appellant institution had failed to rectify deficiencies on account of (i) appointment of required number of faculty with the approval of affiliating body, (ii) F.D.Rs as required under NCTE Regulations, 2014.

AND WHEREAS Appeal Committee further noted that the appellant institution is an existing institution conducting B.Ed. course since 2007, Committee is of the opinion that relevance of seeking C.L.U., N.E.C. and Building Plan for existing institutions should not be over stressed and Regional Committee should have focused on the requirement of

adequate built up area in compliance of Clause 8 (11) of NCTE Regulations, 2014. Appeal Committee also noticed that institutions already recognized for conducting a teacher education programme are not required to enhance the amount of F.D.Rs.

AND WHEREAS appellant institution during the course of appeal proceedings has been able to submit adequate evidence to prove that it has now obtained the required documents including approval of affiliating body for the appointment of required number of faculty for conducting the programme. The list containing the name of Principal and faculty as approved by affiliating body submitted by the appellant prima-facie appears to be in accordance with the Norms and Standards for the course. Appellant institution is required to submit complete list alongwith all supporting documents submitted by them in appeal to the Regional Committee within 15 days of the issue of appeal order. Appeal Committee decided to remand back the case to W.R.C. for revisiting the matter after the appellant institution submits required documents and taking further action expeditiously.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the W.R.C. for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

NOW THEREFORE, the Council hereby remands back the case of V.G. Solanki B.Ed. College, Kodinar – Una Highway At. Dolasa, Una Road, Gujarat to the WRC, NCTE, for necessary action as indicated above.

## ORDER

WHEREAS the appeal of Pioneer College of Education, Mediaraas, Anuppur Chachai Road, Anuppur, Madhya Pradesh dated 22/03/2018 is against the Order No. WRC/APW06197/223683/288th/2018/195739 dated 27/02/2018 of the Western Regional Committee, withdrawing recognition for conducting B.Ed. (Co-Ed) Course on the grounds that "Consequent to the issue of Revised Recognition order. Show Cause Notice was issued on 21.12.2016. Institution has not submitted staff profile. Building Completion Certificate countersigned by the Government Engineer in original and additional FDR for Rs. 4.00 lakhs in original. Hence, Recognition is withdrawn from the academic session 2018-19. FDRs if any, be returned."

AND WHEREAS Pioneer College of Education, Mediaraas, Anuppur Chachai Road, Anuppur, Madhya Pradesh presented the case of the appellant institution on 01/08/2018. In the appeal and during personal presentation it was submitted that "Selection of Staff was in process, and the selected staff list by the committee appointed by the affiliating body was sent in January 2017 along with the appointment letter of Principal issued by the Affiliating body. The Teaching Staff as per new regulations has been appointed in the college in 18/04/2017 by the Affiliating Body. The Building completion Certificate approved by SDO, PWD has already been submitted in original by the college vide letter no. PCE/2016/26 Dated 10/07/2016. Our college is the oldest and most reputed institution of our Region. We have always followed the norms and standards set by NCTE and pledge to follow it in future. Please recall the withdrawal order and give us an opportunity to serve the Educational needs of the District".

AND WHEREAS Appeal Committee noted that appellant institution had filed a Writ Petition no. 13105/2018 in the Hon'ble High Court of Madhya Pradesh and the Hon'ble Court by its order dated 25.6.2018 has directed as follows:-

"The petitioner has filed this petition being aggrieved by order dated 27.02.2018 passed by the Additional Director of National Council for Teachers Education under Section 17 of the NCTE. Act withdrawing the recognition granted to the petitioner – institution. Admittedly, the petitioner has already filed an appeal which is pending before the appeal authority. As the petitioner has already filed an appeal and as the petitioner cannot be permitted to pursue paralled proceedings, the petition filed by the petitioner is dismissed with liberty to the petitioner to pursue the appeal filed by if before the appellate authority. It goes without saying that the appellate authority shall consider and decide the appeal I accordance with law as early as possible. Preferably before the second round of counseling is over".

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 27.2.2018 was issued on following grounds:--

"Institution has not submitted staff profile. Building Completion Certificate countersigned by the Government Engineer in original and additional FDR for Rs. 4.00 lakhs in original. Hence, Recognition is withdrawn from the academic session 2018-19. FDRs if any, be returned."

AND WHEREAS Committee noted that as per terms and conditions of revised recognition order dated 26.5.2015, the appellant institution was required to submit compliance on certain points inter-alia appointment of faculty and staff as required under NCTE Regulations, 2014. The revised recognition order was issued for an intake of 2 units (100 seats) and the faculty required as per norms and standards (Appendix 4) of NCTE Regulations, 2014 should have consisted of one Principal and fifteen faculty members. Show Cause Notice (SCN) dated 21.12.2016 was issued to give an opportunity to appellant for making written representation for the reason of non

compliance. Committee observed that appellant in reply to the SCN dated 21.12.2016 submitted copy of proceedings of Selection Committee Meeting held on 5.1.2017. No communication from the side of appellant institution followed thereafter till impugned order of withdrawal dated 27.2.2018 was issued.

AND WHEREAS appellant during the course of appeal proceedings on 1.8.2018 submitted to Appellate Authority (i) A list of 12 faculty members approved by affiliating body on 18.4.2017; (ii) Approval for appointment of Principal; (iii) Building Completion Certificate signed by S.D.O, PWD, Shahdol; (iv) FDRs for 12 lakh. Appeal Committee also noted that appellant has assured that remaining three faculty will be appointed with the approval of affiliating body shortly.

AND WHEREAS after considering the submissions made by appellant, Appeal Committee observed that Regional Committee was justified to have issued the impugned order of withdrawal dated 27.2.2018 as appellant was unable to comply with the terms and conditions of revised recognition order dated 26.5.2015 even after getting a Show Cause Notice dated 21.12.2016. Even as on date of appeal proceedings the appellant was not able to submit any evidence in support of having appointed the full quota of faculty with the approval of affiliating body.

AND WHEREAS the request dated 1.8.2018 made by appellant for grant of conditional recognition pending submission of staff profile of remaining faculty within 2 months is found unacceptable as there is no provision for continuation of recognition conditionally. Appeal Committee, decided to confirm the impugned order dated 27.2.2018.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the impugned refusal order dated 27/02/2018.

# NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of Anand College of Education, Near Town Hall, Anand, Gujarat dated 08/06/2018 is against the Order No. WRC/323025/Guj./292nd/2018/197938 dated 22/05/2018 of the Western Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "the case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 12.08.2016 followed by a compliance letter dated 17.11.2017 were issued. The institution vide reply dated 07.12.2017 has not submitted the required documents. Hence, Recognition is withdrawn from the next academic session 2018-19."

AND WHEREAS Smt. Jyotsnaben K. Patel, Hon. Secretary, Anand College of Education, Near Town Hall, Anand, Gujarat presented the case of the appellant institution on 01/08/2018. In the appeal and during personal presentation it was submitted that "the staff profile of this college is approved by the syndicate section of the S.P. University of which this college is affiliated. The staff profile proposal was sent to S.P. University for approval on 21/07/2016 However the staff profile approval was pending due to litigation in Supreme Court of India. Subsequently, the apex court of India i.e. The Supreme court by its order date 16/11/2017 in SLP no 14574/2017 has disposed of the appeal in favour of despondent. Hence the staff profile send for approval is still pending before S.P. University Hence as and when it is approved the same approval will be submitted to you in due course of time. Fixed deposit of 7 lakh and 5 lakh towards reserve fund has been put in Union Bank of India, Anand branch and certificate issued regarding the same in original is enclosed here with as desired. Building completion cum occupation certificate issued by competent authority of state government is enclosed here in original duly notarized as desired".

AND WHEREAS Appeal Committee noted that impugned withdrawal order dated 22.05.2018 was issued by W.R.C. on the grounds that appellant institution had failed to rectify deficiencies on account of (i) appointment of required number of faculty with the approval of affiliating body, (ii) submit valid building plan, Building Completion Certificate (B.C.C.), Non Encumbrance Certificate (N.E.C), Change of Land Use Certificate (C.L.U.) and (iii) F.D.Rs as required under NCTE Regulations, 2014.

AND WHEREAS Appeal Committee further noted that the appellant institution is an existing institution conducting B.Ed. course since 2005 Committee is of the opinion that relevance of seeking C.L.U., N.E.C. and Building Plan for existing institutions should not be over stressed and Regional Committee should have focused on the requirement of adequate built up area in compliance of Clause 8 (11) of NCTE Regulations, 2014. Appeal Committee also noticed that institutions already recognized for conducting a teacher education programme are not required to enhance the amount of F.D.Rs.

WHEREAS the appeal of Shree Saraswati Shikshan Mahavidyalay (M.Ed. College), Bhutvad, Dhoraji – Jétpur Highway, Near Bhutvad Patiya, Dhojaji, Gujarat dated 27/12/2017 is against the Order No. WRC/APP04043/325044/Guj /282nd/2017/192461 dated 02/11/2017 of the Western Regional Committee, withdrawing recognition for conducting M.Ed. course on the grounds that "The case file was seen. AND WHEREAS Sh. Ranchhodbhai D. Vaghasiya, Secretary and Sh. Vipul B. Padariya, Clerk, Shree Saraswati Shikshan Mahavidyalay (M.Ed. College), Bhutvad, Dhoraji - Jetpur Highway, Near Bhutvad Patiya, Dhojaji, Gujarat presented the case of the appellant institution on 04/04/2018. In the appeal and during personal presentation it was submitted that "we have given advertisement so many times recently as well as in past. We are enclosing herewith copy of advertisement, copy of applicant resume, copy of letter from University for staff interview as well as original affidavit reg. recruitment of required staff within three months for your verification and record."

AND WHEREAS the appellant during the course of appeal presentation on 04.04.2018 requested for another opportunity to come fully prepared with the

complete list of faculty approved by affiliating body. As per extant rules appellant can seek three adjournments. Appeal Committee, therefore, decided to grant another (second) opportunity to the appellant.

AND WHEREAS Sh. Ranchhodbhai D. Vaghasiya, Secretary and Sh. Vipul B. Padariya, Clerk, Shree Saraswati Shikshan Mahavidyalay (M.Ed. College), Bhutvad, Dhoraji – Jetpur Highway, Near Bhutvad Patiya, Dhojaji, Gujarat presented the case of the appellant institution on 02/08/2018. In the appeal and during personal presentation it was submitted that "we have now submitted all the required documents on account of which the impugned withdrawal order was made".

# ORDER

WHEREAS the appeal of Govt. College of Education, Thirumayam Road, 20/07/2018 is dated Pudukottari. Tamil Nadu against the Order No. SRC/NCTE/AOSO0196/B.Ed./TN/2018-19/97520 dated 31/05/2018 of the Southern Regional Committee, refusing recognition for conducting B.Ed. Course on the grounds that "In RPRO case, it is very essential for TEIs to give an Affidavit affirming adherence to the 2014 Regulations. The institution has not yet submitted the affidavit inspite of a SCN. Withdraw recognition for B.Ed. (2 units) w.e.f. 2016-17".

ļ AND WHEREAS Dr. M. Anbu Chezhian, Principal, Govt. College of Education, Thirumayam Road, Pudukottari, Tamil Nadu presented the case of the appellant institution on 02/08/2018. In the appeal and during personal presentation it was submitted that "appellant institution is Govt. College and decision making involves various levels and procedures which has resulted in the delay. Affidavit is now submitted which is requested to be accepted for restoration of recognition".

AND WHEREAS Appeal Committee noted the submission made by appellant. Appellant institution is required to submit to SRC the required affidavit affirming adherence to the NCTE Regulations, 2014 within a period of 15 days of the issue of appeal orders.

AND WHEREAS Appeal Committee further understands that as per proviso of Clause 17(1) of the NCTE Act the order withdrawing recognition shall come into force only with effect from the end of the academic session next following the date of communication of such order. The impugned order having been issued on 31.5.2018 and made effective from 2016-17 is therefore, bad in law. Appeal Committee decided to

set aside the impugned withdrawal order dated 31.5.2018. SRC is required to reconsider the matter taking in account the affidavit which appellant institution has been directed to submit to SRC within 15 days of the issue of appeal order.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to set aside the impugned withdrawal order dated 31.5.2018. SRC is required to reconsider the matter taking in account the affidavit which appellant institution has been directed to submit to SRC within 15 days of the issue of appeal order.

In the appeal and during personal presentation it was submitted that "Now we have approved staff qualified as per Appendix IV of the NCTE Regulation 2014 and as per NCTE notification published on 9th June 2017".

AND WHEREAS appellant institution during the course of appeal proceedings has been able to submit adequate evidence to prove that it has now obtained the required documents including approval of affiliating body for the appointment of required number of faculty for conducting the programme. The list containing the name of Principal and faculty as approved by affiliating body submitted by the appellant prima-facie appears to be in accordance with the Norms and Standards for the course. Appellant institution is required to submit complete list alongwith all supporting documents submitted by them in appeal to the Regional Committee within 15 days of the issue of appeal order. Appeal Committee decided to remand back the case to W.R.C. for revisiting the matter after the appellant institution submits required documents and taking further action expeditiously.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the W.R.C. for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

NOW THEREFORE, the Council hereby remands back the case of Shri Ambalal M. Patel (Avani Seeds) Mahila Education College, Sardar Chowk, Unjha, Gujarat to the WRC, NCTE, for necessary action as indicated above.
