ORDER

WHEREAS the appeal of Shree Sai Nath Shiksha Mahavidhyalaya, Jaura Khurd, MIN, New Housing Board Colony, Pani Ki Tanki Wali Road, Morena, Madhya Pradesh dated 18/02/2021 is against the Order No. WRC/APW05197/222267/D.Ed./322nd/M.P./2020/212920 dated 19.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for D.El.Ed. Course on the grounds that "Recognition was granted to the institution on 15.01.2008 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Notice was issued to the institution on 24.09.2020. The institution has not submitted the reply of the Show Cause Notice till date."

AND WHEREAS Sh. Chandrapal Singh, Chairman and Sh. M.S. Tomar, Principal, Shree Sai Nath Shiksha Mahavidhyalaya, Jaura Khurd, MIN, New Housing Board Colony, Pani Ki TankiWali Road, Morena, Madhya Pradesh presented the case of the appellant institution on 31/03/2021. On being given another opportunity to present its case on 28.5.2021, the Appellant submitted that the Appeal Committee may consider the submission made on 31.3.2021 and decide the case on merits. In the appeal and during personal presentation it was submitted that "Institution has not received WRC letter dated 24.09.2020 due to Corona Pandemic so we have not replied said letter to WRC."

AND WHEREAS Appeal Committee noted that appellant institution was granted recognition to conduct D.El.Ed. programme by an order dated 15/01/2008 with an intake of 50 seats. Appellant institution was granted recognition while functioning in a leased building. The registered lease deed was for a period of 30 years valid from 10/05/2007

to 09/05/2037. Appeal Committee noted that after grant of recognition no notice was issued to appellant institution seeking its explanation on the commitment to shift to its own premises provided recognition order dated 15/01/2008 contained any such condition.

AND WHEREAS Appeal Committee further noted the submission of appellant with regard to non-receipt of the S.C.N. dated 20/09/2020 due to Covid Pandemic.

AND WHEREAS Appeal Committee, therefore, decided that WRC is required to reissue the S.C.N. and appellant institution will be required to submit reply to S.C.N. within 15 days of its receipt. As covid pandemic still continues, online mode of communication may also be resorted to in addition to issuing Show Cause Notice by speed post.

NOW THEREFORE, the Council hereby remands back the case of Shree Sai Nath Shiksha Mahavidhyalaya, Jaura Khurd, MIN, New Housing Board Colony, Pani Ki Tanki Wali Road, Morena, Madhya Pradesh to the WRC to reissue the S.C.N. and appellant institution will be required to submit reply to S.C.N. within 15 days of its receipt. As covid pandemic still continues online mode of communication may also be resorted to in addition to issuing Show Cause Notice by speed post.

ORDER

WHEREAS the appeal of Jyotiba Shikshan Sanstha's N.T.S. College of Education, Parbhani, Vasmat Road, Parbhani, Maharashtra dated 18/02/2021 is against the Order No. WRC/APW00851/123185/321st/2020/213199 dated 20.12.2020 of the Western Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "Recognition was granted to the institution on 27.06.2005 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 29.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

AND WHEREAS Sh. Madhusudan N Sarnaik, President of Jyotiba Shikshan Sanstha's N.T.S. College of Education, Parbhani, Vasmat Road, Parbhani, Maharashtra presented online the case of the appellant institution on 31/03/2021 and 28.5.2021. In the appeal and during online presentation it was submitted that "Show Cause Notice was received on 07/10/2020 and in the pandemic situation reply dated 27/10/2020 was sent by registered post which was delivered in NCTE on 10/11/2020. The premises of the college are available through a registered lease deed valid upto 2046."

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 20/12/2020 is on the ground that appellant institution has not submitted reply of the Show Cause Notice. Appellant on the other hand submitted evidence of having sent a reply to

the Show Cause Notice by speed post. The speed post receipt dated 07/11/2020 and track report indicates delivery of communication on 10/11/2020.

AND WHEREAS Appellant institution is required to resubmit its reply along with enclosures to WRC within 15 days of the issue of appeal order. Appeal Committee decided that WRC is required to revisit the case considering the reply dated 07/11/2020 of the appellant institution which is required to be submitted by the Appellant.

NOW THEREFORE, the Council hereby remands back the case of Jyotiba Shikshan Sanstha's N.T.S. College of Education, Parbhani, Vasmat Road, Parbhani, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Smt. Rukma Devi Mahila Shikshak Prashikshan Mahavidyalaya, Veer Durga Das Nagar, Pali, Rajasthan dated 12/02/2021 is against the Order No. WRC/NCTE/RJ-623/B.Ed./321st/2020/212692 dated 14.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 07.11.2006 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 27.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

AND WHEREAS Sh. Bhupendra Chauhan, Secretary of Smt. Rukma Devi Mahila Shikshak Prashikshan Mahavidyalaya, Veer Durga Das Nagar, Pali, Rajasthan presented the case of the appellant institution on 31/03/2021 and 28.5.2021. In the appeal and during personal presentation it was submitted that in the year 2006, the institute had submitted its application for grant of recognition of B.Ed. course. In column no.3 of the application dealing with "infrastructural facilities", the institute had clearly indicated against para no. 3.1 that "land is available in the name of secretary of the institution". Further, the institution was proposed to be run in its own building and approved building plan / map was also attached. Thus, the institution was given recognition to run the course in its own building existing on the land in the name of the society. Thus, the ground of withdrawal that the institution was given recognition on the condition to shift in its own premises within a period of three years from the date of issue of recognition order, is

incorrect and not applicable to the institution. It is submitted that on production of land documents in the name of society of the institution, the Department of Education, Government of Rajasthan, issued the letter dated 30.08.2010 granting continuation of NOC without any condition. A copy of letter dated 30.08.2010 is attached. Subsequently, as the building in question became very old, the society constructed another building at the same place on the same plot of land as per norms of NCTE and the institution is running in the building and land owned by the society of the institution. Thus, the allegations against the institution that it has not shifted the institution in its own premises till date, is factually incorrect. The land documents in the name of society of the institution and Building Completion Certificate approved by the competent authority shall be submitted & produced before the appellate authority. WRC issued show cause notice dated 12.10.2020, in which the institution was required to submit details of land and other documents. The institution submitted its reply to the said show cause notice by letter dated 22.10.2020 by speed post. As per tracking report of the speed post, the said reply was received in the office of WRC on 29.10.2020, i.e. within the time stipulated by WRC. The allegation against the institution that the institute has not submitted reply to the show cause notice, is factually incorrect."

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 14/12/2020 is on the ground that appellant institution has not submitted reply to the Show Cause Notice dated 27/09/2020 which was issued for the reason that institution was granted recognition in rented premises and has not shifted to its own premises. Appellant in its appeal memoranda has stated that institution is running in its own premises since the very beginning and has also replied to the Show Cause Notice (S.C.N.) dated 27/09/2020. As evidence of having submitted reply to the Show Cause Notice the appellant has furnished copy of the speed post receipt dated 20/11/2020 and track report which indicates delivery of article on 29/10/2020.

AND WHEREAS Appeal Committee decided to remand back the case to WRC to consider the reply of appellant institution which is required to be sent again by the appellant to WRC within 15 days of the issue of appeal order.

ORDER

WHEREAS the appeal of College of Education for Women (B.Ed.), Bahirwadi, 25, Main Road, Beed, Maharashtra dated 17/02/2021 is against the Order No. WRC/APW00847/123181/321st/2020/213171 dated 20.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 23.04.2005 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 30.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

AND WHEREAS No one from, College of Education for Women (B.Ed.), Bahirwadi, 25, Main Road, Beed, Maharashtra appeared to present to the case of the appellant institution on 31/03/2021. In the appeal memoranda it was submitted that "Condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order was not inserted in the recognition order dated 23.04.2005. Sponsoring society had constructed its own college building on its own premises and had shifted the college into its own premises from academic session 2008-2009. Show Cause Notice No. 210415 dt. 30.09.2020 was issued by WRC but the SCN was received after 35 days. Though 30 days' Show Cause Notice was issued to the institution by Speed Post but it was received by the institution after 35 days i.e., on 4th November 2020, as certified by the Post Master PO Raimoha. WRC withdrew the recognition before expiry of notice period of 30 days i.e. on 5th day, in its 321st meeting held on 9th to 11th of November 2020."

AND WHEREAS Appeal Committee made efforts to get the appellant online on 31/03/2021 (4 P.M. to 4:05 P.M.). Appellant neither appeared before Appellate Authority in person nor online link could be established. Appeal Committee, as per extant appeal rules decided to grant another (2nd) opportunity to the appellant.

AND WHEREAS Shri Madan Ramkrishna Rao Jadhav, Secretary of the Institution made on-line presentation of the case on 28.5.2020. Appellant submitted that there was no condition, in the Recognition Order dated 6.4.2005/23.4.2005, to shift the institution within a period of 3 years to its own premises.

AND WHEREAS Appeal Committee noted that before grant of recognition an inspection was conducted and the inspection Report dated 30.12.2004 mentions that the institution is to function in a rented premises. The recognition order dated 23.4.2005 is addressed to SNDT University and copy endorsed to appellant institution at A/P Raimoha, TQ. Shirur (K), Beed, Maharashtra. All subsequent communications to the appellant institution including Show Cause Notices (SCNs), Revised Recognition order and impugned withdrawal order are issued at the same address.


AND WHEREAS Appellant with its Appeal Memoranda has submitted photographs of two different buildings (i) where institution was granted initial recognition and (ii) second building where the course is being conducted at present.

AND WHEREAS Regulatory file does not contain any application of the appellant seeking permission to shift. Hence, NCTE has not conducted any inspection of the land and building where course is being conducted. Appellant has not replied to the Show Cause Notice (SCN) dated 30.9.2020 seeking information from appellant on shifting/non-shifting of premises. Appellants shifting of college premises without seeking approval of WRC is in gross violation of NCTE Regulations. Appeal Committee, therefore, decided to confirm the impugned order of withdrawal dated 20.12.2020.



NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Mahila College of Education, Market Yard Kolhapur, Shri Shahu Market Yard, Karveer, Kolhapur, Maharashtra dated 01/02/2021 is against the Order No. WRC/APW00787/123121/322nd/2020/213114 dated 20.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 31.08.2006 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 29.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(3) of the NCTE Act from the next academic session 2021-2022."

AND WHEREAS Dr. Smita Dattatray Rane, Principal of Mahila College of Education, Market Yard Kolhapur, Shri Shahu Market Yard, Karveer, Kolhapur, Maharashtra presented the case of the appellant institution on 31/03/2021 and 28.5.2021. In the appeal and during personal presentation it was submitted that "Appellant institution had applied to respondent for grant of recognition for new B.Ed. college from the academic year 2005-2006. The Respondent, by an order No. WRC/5-6/86-87/2006/8067 dated 31/08/2006 granted permission for conducting B.Ed. Course with an annual intake of 100 women students. The initial permission was granted to start the B.Ed. College in a rented premise and was directed to produce a lease deed for 30 years. As such the applicant institution started the B.Ed. College in a rental premises and lease deed for 30 years was executed and same was produced to respondent. Accordingly, the appellant institution started a new B.Ed. College exclusively for women in a rental premise as per

the Norms and Rules of N.C.T.E. prevailing at the relevant time. The norms of N.C.T.E. were changed and as such the appellant institution was required to shift the B.Ed. College to its own premises as per the revised norms. Thereafter as per letter No. WRC/APW00787/ 123121/MH/2016/180680 dated 27/02/2017 the appellant institution started to shift the college to its new premises owned by the appellant institution. As stated hereinabove the Appellant institution was trying its best level to shift the B.Ed. College from the rental premises to its own premises. But as some infrastructure of the building was incomplete the appellant institution could not shift the B.Ed. college to its own building within the stipulated period of three years. The Appellant institution, in the year 2019, completed the infrastructure for B.Ed. college and was intending to shift the B.Ed. college to its own premises from June 2020 for the academic year 2020-2021. But because of lock down due to corona virus it was not possible to shift the B.Ed. College to its own premises. The respondent on 29/09/2020 issued a show cause notice under Sec. 17 (1) of N.C.T.E. Act, as why recognition granted to Appellant institution for B.Ed. college should not be withdrawn and directed the Appellant institution to file written representation within 30 days. The show cause notice was received by the Appellant institution on 05/10/2020. After receipt of show cause notice the Appellant institution, on 17/11/2020 filed the application / proposal for permission to shift the B.Ed. college in its own premises and the same has been received by the respondent on 24/11/2020. But unfortunately, the respondent committee on the same day i.e. 24/11/2020 in its 322nd meeting decided to withdraw the recognition of the Appellant institution. Being aggrieved and dissatisfied by the said order the Appellant preferred this appeal. The Appellant institution has not committed any deliberate delay in shifting the B.Ed. college in its own premises. Because of non-availability of suitable premises, the Appellant institution did not shift the college within the prescribed period. The Appellant institution had decided and started to shift the B.Ed. College at Rukadi, Tal. Hatkanangale, Dist. Kolhapur in the premises owned by the appellant institution, from the academic year 2020-2021. But because of lockdown condition due to Corona Virus it was not possible for the Appellant institution to shift the B.Ed. College from the rental premises to its own premises. The respondent committee issued a show cause notice on 29/09/2020 and the same has been received by the Appellant institution on 05/10/2020. But because of non-availability of some important




documents from the concerned authorities, due to lock down condition, the Appellant institution could not send the explanation/letter for permission for shifting the B.Ed. college from rental premises to its own premises within 30 days of receipt of show cause notice. The Appellant institution on 17/11/2020 has forwarded the complete proposal for shifting of the college along with the requisite fee of Rs.1,50,000/- to respondent committee. The proposal of the Appellant institution has been received in the office of Respondent Committee on 24/11/2020 i.e. on the date on which the Respondent Committee has passed resolution for the withdrawal of the recognition. Because of unavoidable mistake or circumstances on the part of Appellant institution the proposal did not reach the office of respondent committee and therefore the respondent has taken the decision to withdraw the recognition of the Appellant institution."

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 20/12/2020 is on the ground that appellant institution has not shifted from rented premises to its own premises and has also not submitted reply to the Show Cause Notice (SCN) dated 29/09/2020.

AND WHEREAS Appellant in its appeal memoranda has stated that Show Cause Notice was received on 05/10/2020 and a reply to S.C.N. was submitted by speed post on 17/11/2020. Before submitting a detailed reply to the Show Cause Notice appellant had also remitted shifting fee of Rs. 1,50,000/-. The letter dated 10/11/2020 sent by appellant institution with a Demand Draft of Rs. 1,50,000/- and the reply to Show Cause Notice submitted by speed post on 17/11/2020 are not found placed on the relevant regulatory file.

AND WHEREAS Appeal Committee decided to remand back the case to WRC for revisiting the matter with reference to the reply dated 17/11/2020 to be resubmitted by appellant to WRC within 15 days of the appellate order. WRC of its own should also make efforts to locate the letters, Demand Draft and other relevant documents stated to have already been sent by speed post.



NOW THEREFORE, the Council hereby remands back the case of Mahila College of Education, Market Yard Kolhapur, Shri Shahu Market Yard, Karveer, Kolhapur, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Chaitanya College of Education, Darimadugu, Markapur, Srisailam Road, Prakasam, Andhra Pradesh dated 18/12/2020 is against the Order No. SRO/NCTE/APS00368/B.Ed./AP/2020/122217-2223 dated 05.01.2020 of the Southern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "Committee noted that the institution has failed to submit reply / written representation in respect to the Final Show Cause Notice dt 03.11.2020 issued to the institution."

AND WHEREAS Sh. Y. Rama Koteswar Rao, Vice Principal, Chaitanya College of Education, Darimadugu, Markapur, Srisailam Road, Prakasam, Andhra Pradesh presented online the case of the appellant institution on 31/03/2021 and 28.5.2021. In the appeal and during online presentation it was submitted that "SRC vide its order dated 16.12.2020 (date mentioned in Withdrawal Order as 05.01.2020 is incorrect) has withdrawn our recognition observing deficiencies which were already clarified / ratified by our institution. SRC vide its order dated 28.02.2003 granted recognition to our institution for running the B.Ed. course of one year duration from the session 2002-03 with annual intake of 120 students. Thereafter, SRC issued the revised recognition order dated 11.05.2015 to our institution for running B.Ed. course of two year duration from the session 2015-16 with annual intake of 100 students. SRC issued show cause notice dated 24.10.2019 to our institution for submitting the relevant documents. Our institution vide letter dated 14.11.2019 submitted (on 15.11.2019) the relevant documents to SRC, as desired by the SRC. A copy of letter dated 14.11.2019 submitted by our institution is enclosed. SRC issued another show cause notice dated 03.11.2020 to our institution for submitting some more documents. Our institution vide letter dated 21.11.2020 submitted (on 24.11.2020) the relevant documents as desired by the SRC, which the SRC was

having already. A copy of letter dated 21.11.2020 of our institution is enclosed. SRC issued the withdrawal order dated 16.12.2020 without looking into the documents already submitted by our institution with replies dated 14.11.2019 and 21.11.2020 submitted to show cause notices 24.10.2019 and 03.11.2020 respectively. It is submitted that we are once again submitting herewith all the relevant documents as were desired by the SRC and submitted by us to SRC. (i) notarised copy of land use certificate (ii) copy of non-encumbrance certificate (iii) copy of building plan (iv) copy of building completion certificate in the name of changed society (v) notarised copy of faculty list of latest session duly approved by affiliating university (vi) Form A issued by the Bank in respect of FDRs for Endowment & Reserve Funds (vii) Details pertaining to domain name. SRC has issued the withdrawal order dated 16.12.2020 without looking into the documents submitted by our institution vide reply dated 21.11.2020 submitted to show cause notice date 03.11.2020. It is submitted that the impugned decision taken by the SRC is completely arbitrary as the SRC as our institution has already submitted the documents desired by the SRC."

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 05/01/2020 was issued on the ground that appellant institution has failed to submit representation in respect of Final Show Cause Notice dated 03/11/2020.

AND WHEREAS Appeal Committee noted that date of impugned withdrawal order mentioned as 05/01/2020 is incorrect as the Final Show Cause Notice itself is stated to have been issued on 03/11/2020 and the SRC's 392nd Meeting was held on 15th – 16th December, 2020. The date of issue of impugned order seems to be a typo mistake which should be corrected by SRC.

AND WHEREAS appellant with its appeal memoranda has submitted copy of its reply dated 21/11/2020 submitted in response to the Final Show Cause Notice. The reply was submitted by hand in SRC office and receipt Diary no. 170492 dated 24/11/2020 appears as acknowledgement. This reply is not found placed on the relevant regulatory file.



AND WHEREAS Appeal Committee decided to remand back the case to SRC for revisiting the matter by locating the relevant receipt. Appellant institution is also required to submit to SRC within 15 days of the issue of appeal order copy of its reply dated 21/11/2020 with all relevant enclosures.

NOW THEREFORE, the Council hereby remands back the case of Chaitanya College of Education, Darimadugu, Markapur, Srisailam Road, Prakasam, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Sivaranga College of Education, Nagula Katta Street, Koilkuntla, Kurnool, Andhra Pradesh dated 17/11/2020 is against the Order No. SRO/NCTE/APS09574/B.Ed./AP/2021 dated 31.10.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Institution only submitted a letter dt. 26.12.2019 stating that they are running the B.Ed. course with only one unit following all norms and standards of NCTE Regulations. The committee observed that the institution has written that they are submitting the required documents with this letter, but the institution did not submit any document regarding adherence of provisions of NCTE Regulations, 2014 such as land, building plan, NEC, BCC, approval of affiliating body regarding faculty. Further, the committee felt the reluctance of institution in submission of documents desired under Show Cause Notices."

AND WHEREAS Sh. J. Ravinder Reddy, Admn Officer, Sivaranga College of Education, Nagula Katta Street, Koilkuntla, Kurnool, Andhra Pradesh presented online the case of the appellant institution on 31/03/2021. Another opportunity was given to the appellant to present it case before Appellate Authority on 28.5.2021. The representative of the institution presented its case online on 28.5.2021. In the appeal and during online presentation it was submitted that "SRC, NCTE has taken decision to withdraw recognition for not submitting relevant documents as we mentioned in our letter dated on 26/12/2019. We have submitted all the relevant documents as mentioned in the letter dated 26/12/2019 and now also we are submitting once again all the documents which are mentioned in our letter for your kind consideration and further needful action. Kindly consider the relevant enclosures which already submitted and please hold withdraw of recognition. We once again submit the letter and all documents. Kindly consider and hold withdraw of recognition. In view of the above the NCTE, Southern Regional Committee

may kindly consider the application for further action. Enclosures:- 1. Recognition order issued by SRC, NCTE F.SRO/NCTE/APSO9574/ BED/AP 2015/77441 dated 31/10/2015. 2. Revalidated FDRs as per Regulations 2014. 3. Supporting documents for Additional built up area as per Regulations 2014. 4. Supporting documents for Additional infrastructure as per Regulations 2014. 5. Supporting documents for Additional staff as per Regulations 2014. 6. land documents 7. Encumbrance Certificate 8. Land use certificate (LUC) 9. Building plan (BP) and letter submitted on 26/12/2019.”

AND WHEREAS Appeal Committee noted that appellant has preferred appeal against the Minutes of 390th Meeting of SRC held on 28th& 29th October, 2020. The order of withdrawal issued is not found available on the relevant regulatory file.

AND WHEREAS Appeal Committee noted that a Final Show Cause Notice (SCN) dated 10/12/2019 was issued to appellant institution. Appellant institution was required to submit following documents to SRC:-

- (i) Certified copy of land documents.
- (ii) Attested copy of Land Use Certificate issued by Competent Authority.
- (iii) Non Encumbrance Certificate.
- (iv) Copy of approved building plan.
- (v) Site Plan.
- (vi) Building Completion Certificate.
- (vii) Staff list approved by affiliating body.
- (viii) FDRs.
- (ix) List of other courses & Affidavit etc.

AND WHEREAS Appeal Committee noted that appellant by its reply dated 26/12/2019 did not submit any of the required documents. During online presentation of appeal, appellant was asked to submit by mail copy of the bank statement to verify that the faculty included in list submitted by appellant with its appeal memoranda, actually exists. This was required because the list of faculty submitted by appellant did not bear any date or session for which it was approved and also that faculty is required to be paid salary as per U.G.C. norms or the norms laid down by the respective State Government.



AND WHEREAS Appellant has failed to submit the required documents. Appeal Committee, therefore, decided that decision taken by SRC in its 390th Meeting shall be confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

In the appeal and during personal presentation it was submitted that "First and final show cause notice was not posted to existing college address. We constructed a new building in Sy.no 132/i, acre 1.10 Gunta wide reg. Doc.no.10000/2007 situated at NH.202 (163) Main Road, Anantharam Village, Bhogir Mandal, Nalgonda Dist-508116. Further we applied shifting permission to NCTE SRC, Bangalore from temporary building to own building dated 06-08-2010. Further the Osmania University three men committee inspected our premises and accorded grant of affiliation to Mother Teresa College of Education, sy.no 132/i, Anantharam Village, Bhogir Mandal, Nalgonda Dist-508116 Lr.no .800-MR/H-B.Ed./Aff./4304/2010-11/ACAD-IV – 2 dated 25-09-2010. Further we have submitted revised application to NCTE SRC on 10-03-2013 for shifting temporary premises to permanent (own) premises. But still pending at NCTE, SRC, Bangalore. Further we applied D.El.Ed. course in own premises. The NCTE inspection VT team inspected both colleges and issued recognition order file no SRC APP1293/D.El.Ed./AP2012-13/44915 dated 02-08-2012 with college code no. SRCAPP1293 on 02-08-2012. Further submitted


(performance appraisal report) with requisite fee online portal on 09-01-2018. Hence above circumstances and evidences the college address is Sy.132/I, Anantharam, Bhongir, Yadadri-Bhongir Dist-508116 and college has been running since 2010. Till now we have not received any show cause notice to existing college address.”


AND WHEREAS Appeal Committee noted that appellant institution was recognised to conduct B.Ed. programme in the year 2005 and the address of the institution as per recognition order dated 08/03/2005 was 669, Raigiv Village, Bhongir Mandal, Nalgonda District, A.P. Appellant during the course of appeal hearing made a submission that the institution is now functioning at Survey No. 132/1, 132, Anantharam, Bhongir (M), Yadadri – Bhongir where it was subsequently granted recognition for conducting D.El.Ed. programme. Due to change in the address appellant institution may not have received the final S.C.N. dated 21/11/2019. Appeal Committee, however, could not find any evidence on the relevant regulatory file to prove that appellant institution ever applied for shifting after completing the required formalities and depositing the shifting fee. The revised recognition order dated 11/05/2015 under NCTE Regulation, 2014 was issued and mailed to appellant institution at the old address. Appellant did not lodge any complaint that it did not receive the revised recognition order.

AND WHEREAS Appeal Committee having considered the submissions of appellant and records available on regulatory file decided that SRC is required to revisit the matter afresh after reissuing the final S.C.N. at the new address and also seeking clarification for having shifted without seeking prior permission of SRC as per NCTE, Regulation.

NOW THEREFORE, the Council hereby remands back the case of Mother Teresa College of Education, Anantharam, Near Renuka Yellamma Temple, Bhongir, Nalgonda, Telangana to the SRC, NCTE, for necessary action as indicated above.

Submitted the Building Completion Certificate issued by the competent authority. We submitted the latest Faculty Approved List for 2020 – 2021. WHEREAS the appeal of Indu Memorial Teacher Training Centre, 598/4, Kuzhalmannam, Alathur, Palakkad, Kerala dated 22/02/2021 is against the Order No. SRO/NCTE/APSO1072/B.Ed./392th/{KL}/2020/121689 dated 23.12.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Institution in its representation dt. 24.09.2020 has mentioned that the College is functioning on the same land and building where the initial recognition was accorded in 2006. The SRC on perusal of VT report dt. 27.02.2006 observed that the institution was functioning in rented premises which belies the statement of the institution. The institution had also submitted a lease deed dt. NIL having stamp of Sub – Treasury on 23.02.2006 for a period of 11 months which also confirms that the institution was granted recognition on rented premises with the condition to shift to its permanent building within a period of 3 years. Now, it is evident that the management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C). The institution has submitted Land Use Certificate but land in the name which Society not mentioned. The institution has submitted photocopy of NEC in Regional Language. Encumbrance Certificate is unsigned not approved by the Competent Authority. The institution has submitted photocopy of Building plan approved by the competent authority. In Building plan, college name not mentioned in the documents. The size of the classrooms are less than 500 sq. ft. which is not adequate as per NCTE norms and multipurpose hall is not shown in the Building Plan. However, the seminar hall has mentioned in Building Plan but, the size of same is not mentioned. The Institution has not submitted BCC in proper prescribed format. The Institution has submitted photocopy of staff list."

AND WHEREAS the representative of Indu Memorial Teacher Training Centre, 598/4, Kuzhalmannam, Alathur, Palakkad, Kerala presented online the case of the

appellant institution on 31/03/2021. Another opportunity was given to appellant to present its case before Appellate Authority on 28.5.2021. Dr. M.K. Ramkumar, Principal of the institution presented its case online on 28.5.2021. In the appeal and during online presentation it was submitted that "All the deficiencies pointed out 1 to 7 have been complied and the appeal is being submitted in terms of Section 18 of the NCTE Act for a judicious and kind reconsideration of the entire issues for the purpose of recognition. The main dispute raised in all prior notices were as regards the shifting of the institute from the temporary building to a permanent building within a period of 3 years and the requirement to remit the fees of Rs. 1.5 lakhs for approval of shifting by the NCTE. As a matter of fact, the Institute had constructed its own building at Kuzhalmannam by the time NCTE had issued recognition for the establishment of Teachers Training Centre at Kollengode, Palakkad for offering B.Ed. Course. Initial recognition was extended from time to time and necessary fees and remittances were made by the Institute as well. Though NCTE had granted approval for the Academic Year 2006-07 by Order dated 15.07.2006 for the commencement of Course at Kollengode, the University accorded affiliation only from the Academic Year 2007-08 and by the time the Institute had completed the permanent building at Kuzhalmannam and the course commenced only from the permanent building as reflected in the Recognition Order dated 16.11.2007 issued by the University of Calicut. Thus, on facts, there was no shifting at all. The course commenced in the permanent structure. However, on legal or technical sense, the approval for commencement of the Course was not from the permanent building and therefore, for the purpose of regularizing the act of commencing the Course from the permanent building, the fee as required for shifting is being remitted herewith for full compliance of the show cause notices issued by the NCTE. The demand draft for Rs. 1.5 lakhs has been remitted and the same is being forwarded along with the applications in the prescribed format. The Institute has already collected all the required documents mentioned in the Order dated 23.12.2020 and the same is being forwarded along with the Appeal being submitted in compliance of the Section 18 of the NCTE Act. The steps have already been taken to regularize the technical shifting of the building to the permanent building by the remitting the prescribed fees."



AND WHEREAS from the submissions made online by the appellant, Appeal Committee observed that recognition for conducting B.Ed. programme was granted to appellant institution in the 2006. Inspection conducted was, of infrastructure, available in a building which was on rental basis and the recognition granted on 15/07/2006 was subject to the condition that the institution shall shift to its own premises within 3 years. Appeal Committee noted that revised recognition order dated 15/05/2015 was issued mentioning the address where recognition order dated 15/07/2006 was issued.

AND WHEREAS Appeal Committee observed that appellant institution by its letter dated 24/09/2020, submitted in reply to the final S.C.N. dated 07/09/2020, informed SRC that inspection of the College conducted in 2006 was at the same address where institution is functioning at present.

AND WHEREAS Appeal Committee on perusal of the Inspection Report dated 24/05/2006 observed that Visiting Team at several columns of the inspection report remarked that building proposed for conducting the course is on rental basis. There is no other inspection report subsequent to the inspection conducted by NCTE appointed Visiting Team. The appellant also did not make any formal application for shifting. Appeal Committee, therefore decided to confirm the impugned order of withdrawal dated 23/12/2020.

NOW THEREFORE, the Council hereby confirms the Order appealed against.
