#### ORDER

WHEREAS the appeal of Government College of Physical Education, Nayapalli, Khordha, Bhubaneswar, Orissa dated 25/10/2019 is against the Order No. ER-275.14.14/ (OR-SO/N-2/2000)/B.P.Ed./2019/61454 dated 30.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting B.P.Ed. Course on the grounds that "Faculty list is not in NCTE prescribed proforma and not as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course. Building Plan and Building Completion Certificate approved by Govt. Engineer are not submitted."

AND WHEREAS Sh. Devndra Nath, Principal and Dr. Ansuman Mishra, Assistant Professor, Government College of Physical Education, Nayapalli, Khordha, Bhubaneswar, Orissa presented online the case of the appellant institution on 09/10/2020. Appeal Committee noted the online submission made by appellant and the request made by Government of Odisha with regard to sympathetic consideration of case in the larger interest of students. Appellant institution had informed that due to severe cyclonic storm 'FANI', the Kalinga stadium where the college was functioning was heavily damaged and institution had to shift to NMIET building.

AND WHEREAS Appeal Committee noted that appellant institution is a Government College and it has shifted with the consent of Government of Odisha to a new premises i.e. Narayan Memorial Institute of Education & Technology (NMIET) Campus, Sijua, Sarakantara, Patrapada, Bhubaneswar. So as to ensure regular functioning of College, Government of Odisha has informed that Government College of Education has been shifted to the new site from 15/10/2019.

AND WHEREAS Appeal Committee noted that neither the Government of Odisha nor the appellant Government College has sought prior approval for change of premises in terms of Clause 8 (9) of NCTE Regulation, 2014. As per Regulations change in premises may be permitted to a site which, if applied initially, qualifies for establishment of institution as per Norms and Standards for the programme. The infrastructure required for a course of physical education includes a minimum of 2700 sq. meters of built up area for B.P.Ed. & M.P.Ed. and 5 – 8 acres of land.

AND WHEREAS Appeal Committee noted that appellant institution has submitted a list of faculty containing the names of 1 Principal (Incharge), 2 Associate Professors, 6 Assistant Professors, Sports Trainer, Yoga Teacher and Dietician. Committee decided that appellant institution is required to submit original of the list of faculty to ERC within 15 days of the issue of appeal order along with a formal proposal in prescribed performa for shifting of premises. Keeping in view that appellant institution is a Government college in the state of Odisha where private teacher education institution are not allowed and encouraged, Appeal Committee decided to remand back the case to ERC for expediting inspection of the proposed premises where Government of Odisha proposed to conduct the programme temporarily. of the premises shall be after getting a formal proposal from the Government of Odisha to shift and there shall be no compromise on the infrastructural and instructional requirements of the programme. Appeal Committee further decided that inspection of the proposed new premises shall be done expeditiously after getting a formal proposal as per NCTE Regulations.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online submission made by appellant, Appeal Committee concluded to remand back the case to ERC for expediting inspection of the proposed premises where Government of Odisha proposed to conduct the programme temporarily. Inspection of the premises shall be after getting a formal proposal from the Government of Odisha to shift.

NOW THEREFORE, the Council hereby remands back the case of Government College of Physical Education, Nayapalli, Khordha, Bhubaneswar, Orissa to the ERC, NCTE, for necessary action as indicated above.

#### ORDER

WHEREAS the appeal of Shiksha Shastri B.Ed. (Shri Jagannath Sanskrit Vishwavidyalaya), Shri Vihar, Puri, Orissa dated 21/03/2020 is against the Order No. ER-278.5/ERCAPP1305/B.Ed./2020/62159 dated 28.01.2020 of the Eastern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "two show cause notices issued on 20.04.2018 & 18.05.2019 and no reply has been received till date. Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from next academic session 2020-21."

AND WHEREAS Sh. Laxmidhar Panda, Assistant Professor, Shiksha Shastri B.Ed. (Shri Jagannath Sanskrit Vishwavidyalaya), Shri Vihar, Puri, Orissa presented the case of the appellant institution on 09/10/2020. In the appeal memoranda it is submitted that "Approved faculty list is already uploaded on our website - <a href="https://www.sjsv.nic.in.">www.sjsv.nic.in.</a>. Approved building plan by the concerned competent authority is uploaded in our website. Approved building completion certificate by concerned Competent Authority is uploaded in our website. As it is Govt. institution there is no necessity of FDRs towards endowment fund and reserve fund. Confirmation on website updates of the institutions with all details along with affidavit has been updated and uploaded."

AND WHEREAS Appeal Committee noted that appellant institution is a University established under Shri Jagannath Sanskrit Vishwavidyalaya Act, 1981 having jurisdiction over the whole of State of Orissa. Appeal Committee noted that appellant institution in its online application dated 10/01/2011 had declared that institution is under Government management and as such there was no requirement on part of the institution to furnish FDRs. Appellant during the course of appeal hearing on 09/10/2020 submitted that due to cyclonic storm 'FONI' the entire area of institution

remained flooded and Show Cause Notice (SCN) dated 18/05/2019 was neither received nor could be replied. Appellant during the course of appeal hearing on 09/10/2020 submitted copies of (i) list of faculty, (ii) building plan, (iii) Building Completion Certificate (BCC) and (iv) website printout. Appellant informed Appellate Authority that appellant institution is conducting the programme with a single unit.

AND WHEREAS Appeal Committee decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order a formal request for reduction of intake from 2 units to one unit and documents mentioned at (i) to (iv) in para 4 above. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Shiksha Shastri B.Ed. (Shri Jagannath Sanskrit Vishwavidyalaya), Shri Vihar, Puri, Orissa to the ERC, NCTE, for necessary action as indicated above.

#### ORDER

WHEREAS the appeal of Mizoram Hindi Training College, Durtlang, College Road, Tlangnuam, Aizawal, Mizoram dated 27/02/2020 is against the Order No. ER-278.58/APE00252/HSP (B.Ed.)/2020/62153 dated 28.01.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "approved latest faculty list duly signed by the affiliating body has not been submitted. Certified copy of registered land document has not submitted. Building plan (BP) duly signed by the competent authority has not been submitted. Building Completion Certificate (BCC) duly signed by the competent authority has not submitted."

AND WHEREAS Dr. Louis Hauhnar, Principal, Principal from Mizoram Hindi Training College, Durtlang, College Road, Tlangnuam, Aizawal, Mizoram presented the case online on behalf of the appellant institution on 09/10/2020. In the appeal memoranda and during online presentation it was submitted that "photocopy of approved latest faculty list duly signed by the Principal and Registrar Central Institute of Hindi Agra the affiliating body is enclosed. Certified copy of registered land is enclosed. Photocopy of Building Plan (BP) duly signed by competent authority and certified by the Principal and the registrar Central Institute of Agra is enclosed. Photocopy of Building Completion Certificate duly signed by the Principal and registrar Central Institute of Hindi Agra is enclosed herewith."

AND WHEREAS Appeal Committee noted that appellant institution is conducting the programme since June, 1980 and in September, 2004 was granted recognition for conducting Hindi Shikshan Parangat (HSP) course with an intake of 30 seats. Revised recognition order dated 31/05/2015 for HSP course was issued for an intake of 50 seats (one basic unit). Affiliating body for the programme is Central Institute of Hindi (Ministry

of Human Resource Development, Government of India) Agra. Appellant during the course of online appeal hearing on 09/10/2020 submitted (i) list of faculty, (ii) B.C.C., (iii) Building Plan and (iv) Certificate of land lease issued by Land Revenue and Settlement, Mizoram. Appeal Committee decided that Appeal Section should detach the originals of these documents from Appeal file and forward to ERC. Appeal Committee further decided to remand back the case to ERC for revisiting the case.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online submissions made by appellant, Appeal Committee concluded to remand back the case to ERC for revisiting the case.

NOW THEREFORE, the Council hereby remands back the case of Mizoram Hindi Training College, Durtlang, College Road, Tlangnuam, Aizawal, Mizoram to the ERC, NCTE, for necessary action as indicated above.

#### ORDER

WHEREAS the appeal of Govt. College of Teacher Education, Magistrate Colony, Mangaldai, Darrang, Assam dated 25/10/2019 is against the Order No. ER-274.14.29/(AS-S/E-3/97)/B.Ed./2019/61431 dated 28.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "approved faculty list by the concerned affiliating body along with requisite documents. Approved building plan by the concerned competent govt. engineer/authority. Approved building completion certificate by the concerned competent Govt. Engineer/Authority. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014. Confirmation on website updates of the institutions with all details along with affidavit."

AND WHEREAS Dr. Tapan Kumar, Principal, Govt. College of Teacher Education, Magistrate Colony, Mangaldai, Darrang, Assam presented online the case of the appellant institution on 09/10/2020. In the appeal and during online presentation it was submitted that "Govt. College of Teacher Education, Mangaldai authority has submitted the list of faculty duly approved by the concerned affiliating body (G.U.) on 24-06-2019 through the emails: revisedordercomplianceerc2015@gmail.com & erc@ncte-india.org and also sent the hard copy of same on the same date in the name of Mr. Pradeep Kumar Yadav, Regional Director by speed post. Testimonials of five newly appointed faculties were sent through above said email on 09-07-2019. Being a Govt. institution, the Government has fulfilled the terms & conditions as per latest NCTE norms by engaging another 4 nos. faculties. The updated faculty list is submitted to the concerned affiliating body for approval. Govt. College of Teacher Education, Mangaldai authority has provided a building completion certificate by the concerned competent Govt. Engineer/ Authority (PWD building division) i.e. more than 1500 square meter of total

built up area for one basic unit. FDRs are not applicable for a Govt. institution. So, the question of FDRs towards endowment fund and reserved fund does not arise. In compliance to this ground, the Govt. College of Teacher Education authority updated the website with all data relating to the college concerned in <a href="www.ctemangaldai.co.in">www.ctemangaldai.co.in</a> on 17-05-2019. Downloaded copies of website in pdf format are available at our new website <a href="www.ctemangaldai.co.in">www.ctemangaldai.co.in</a> as intimated earlier."

AND WHEREAS Appeal Committee noted that appellant institution is a Government College of Teacher Education recognised for conducting B.Ed. programme since 2001. Revised recognition order dated 26/05/2015 under NCTE Regulation, 2014 was issued for an intake of one unit i.e. 50 seats. Appeal Committee noted that being a Government institution, appellant is not required to furnish FDRs towards endowment and reserve fund.

AND WHEREAS from the Building Plan and Building Completion Certificate (B.C.C.) submitted by appellant, Appeal Committee observed that out of total built up area of 883.20 sq. meters, built up area earmarked for B.Ed. programme is only 3148 sq. feet. Appeal Committee noted that even if total built up area is allowed to be used for B.Ed. programme the prescribed built up area norm which is 1500 sq. meters for an intake of one basic unit will not be met.

institution contains the names of 3 faculty (Ms. Karabi Kalita, Minakshi Patgiri, Papori Nath) who are shown appointed in May, 2019. These faculty neither possess Ph.D. degree nor are they NET/SLET qualified. Faculty whose name appear at serial nos. 7, 8, 9, 10 appointed in September/October, 2019 are shown as Guest Faculty. The Norms and Standards relating to Academic Faculty (para 5.1 – Appendix -4) prescribe that there shall be 8 full time faculty members for one basic unit.

AND WHEREAS Appeal Committee noted that appellant institution neither possess adequate built up area nor requisite number of faculty qualified as per Norms

Standards. Appeal Committee decided to confirm the impugned order of withdrawal dated 28/08/2019 issued by ERC.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online submission of arguments, Appeal Committee concluded to confirm the impugned order of withdrawal dated 28/08/2019 issued by ERC.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

Course on the grounds that "list of teaching faculty list is not in the NCTE prescribed proforma and also faculty is not appointed as per NCTE Regulation, 2014."

AND WHEREAS Dr. Debudulal Baioya, Principal, Regional College of Physical Education, Panisagar, College Road, Tripura, North Tripura presented online the case of the appellant institution on 09/10/2020. In the appeal and during online presentation it was submitted that "List of Teaching faculty has been prepared now according to NCTE prescribed format and the same has been approved by the Registrar of Tripura University, affiliated university for our college and also, adequate number of faculties have been placed to fulfil the requirement of faculties as per regulations of NCTE, 2014 for running B.P.Ed. programme with 100 intake capacity."

AND WHEREAS Appeal Committee noted that appellant institution is a Government institution conducting B.P.Ed. programme since 2001 with an intake of 100 seats. The impugned order of withdrawal dated 16/07/2020 is on the ground that teaching faculty is not in NCTE prescribed Performa and also faculty is not appointed as per NCTE Regulation, 2014.

AND WHEREAS Appeal Committee noted that NCTE Regulation, 2014 (Appendix – 7), prescribed for following faculty:-

Three (Part time if needed)

AND WHEREAS appellant during the course of online appeal hearing submitted a list of faculty containing the names of Principal (Incharge), 2 Associate Professors, 6 Assistant Professors, 3 Part time Assistant Professors and Dietician, Yoga Training & Sports Trainer. Appeal Committee noted the submission made by appellant institution that one Associate Professor is at present designated as Principal (Incharge) and it is in Appeal Committee decided that appellant addition to two Associate Professors. institution is required to submit the original of the list to ERC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and arguments advanced during the online submission, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

WHEREAS the appeal of College of Teacher Education, Village-Tura, P.O.-Tura, West Garo Hills, Meghalaya dated 23/03/2020 is against the Order No. ER-280.61/APE00176/B.Ed./2020/62520 dated 03.03.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "list of teaching faculty not as per NCTE proforma and not approved by concerned affiliating authority. Building Plan (BP) duly signed by competent authority not submitted. Building Completion Certificate (BCC) duly signed by competent authority not submitted."

AND WHEREAS Sh. Samir Bhowmik, Principal, College of Teacher Education, Village—Tura, P.O.—Tura, West Garo Hills, Meghalaya presented online the case of the appellant institution on 09/10/2020. In the appeal and during online presentation it was submitted that "list of teaching faculty duly filled in the NCTE prescribed proforma and duly approved by concerned affiliating authority is enclosed. Present intake of regular teaching faculty including principal is 6(six) and 3(three) part-time lecturers. Two vacant posts owing to transfer to other colleges will be filled up shortly by Government. Building plan (BP) duly signed by competent authority is submitted. Building Completion Certificate (BCC) duly signed by competent authority is submitted."

AND WHEREAS Appeal Committee noted that appellant institution was conducting B.Ed. programme with an intake of 60 seats from 2001 and additional intake of 40 seats was granted by an order dated 16/12/2002 of NCTE. Appeal Committee further noted that revised recognition order dated 15/05/2015 under NCTE Regulation, 2014 was for an intake of 50 seats only. NCTE Regulation, 2014 (Appendix – 4)

provide that an institution conducting B.Ed. programme with an intake of 50 seats (one unit) should possess.

Land area - 2000 sq. meters

Built up area - 1500 sq. meters

Faculty 1 Principal

7 Faculty

Building plan and Building Completion Certificate (B.C.C.) should be approved by Competent Civic authority and faculty appointed should possess academic qualifications as per NCTE Norms and Standards with the approval of affiliating authority.

withdrawal order dated 03/03/2020, appellant institution was given an opportunity by issue of a Show Cause Notice (SCN) dated 20/04/2018 to rectify the deficiencies and submit written representation. Appellant submitted on 23/03/2020 online documents which contained (i) List of faculty, (ii) Building Plan and (iii) Building Completion Certificate. Copies (printout) of these documents, which are available on regulatory file, indicate that there is a Principal and 5 faculty. Additional three faculty which are engaged on part time basis are not as per NCTE norms. Appeal Committee further noted that Building Completion Certificate (B.C.C.) is for 601.85 sq. meters which is inadequate as compared to minimum requirement of 1500 sq. meters.

AND WHEREAS Appeal Committee noted that appellant institution, off late, has been able to seek (i) a fresh list of faculty consisting the names of the Principal and 7 faculty, (ii) building plan, (iii) Building Completion Certificate (B.C.C.) for a built up area of 6285 sq. meters. Appeal Committee decided that appellant institution is required to submit within 15 days of the issue of appeal orders faculty list and B.C.C. in original to ERC. Appeal Committee decided to remand back the case to ERC for revisiting the matter. Appellant institution is required to submit to ERC within 15 days of the issue of appeal orders (i) complete list of faculty, (ii) Building Plan and Building Completion Certificate indicating the built up area.

AND WHEREAS after perusal of the Memoranda of appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of College of Teacher Education, Village-Tura, P.O.-Tura, West Garo Hills, Meghalaya to the ERC, NCTE, for necessary action as indicated above.

Roy Road, Block-1, North 24-Pargana, West Bengal dated 30/10/2019 is against the Order No. ER-275.14.71/APE00098/B.P.Ed./2019/61483 dated 02.09.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.P.Ed. Course on the grounds that "building plan is not legible. Principal is not appointed. Submitted faculty list is not in NCTE prescribed proforma. Faculty comprises 09 instead of 1+16 as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course. Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

AND WHEREAS Dr. C. Chakraborty, Office in Charge and Assistant Professor, Post Graduate Govt. Institute for Physical Education, Banipur, K.N. Roy Road, Block-1, North 24-Pargana, West Bengal presented online the case of the appellant institution on 09/10/2020. In the appeal and during online presentation it was submitted that "This is an old college (87 years), established in the year 1932. The executive engineer (PWD) is unable to provide such document at present. Apart from that the old building plan was lost since 1978-79 during Naxal Movement and that why the college is unable to produce fresh building plan. Still the college approached to the Executive engineer (PWD) for a fresh plan. The building plan of the extended part of the administrative building has already been submitted to the NCTE and the matter was informed previously. The higher Education Department, Govt. of West Bengal has been requested to fill up the post of principal after the superannuation of Dr. Ashim Kumar Bose, Former Principal on 30th Nov., 2016. The process of filling the post of principal is under process of the H.E. Dept. The college has already uploaded the faculty list in detail in the NCTE website as per their proforma. However, the college is furnishing the newly prepared faculty list for your

consideration. In spite of 100 approved intake capacity, the college is running with 58 students (35 in Sem - III and 23 in Sem - I). The college possess 08 full time teaching staff and 01 part time teaching staff. With these 09-teaching stuff, the teaching learning process is not hampered as student strength is small. The H.E. Dept. has started the process to fill up the post of Principal and the other vacant posts. In absences of full-time Principal, as per provision of the State Govt. one senior teacher acts as Officer-In-Charge of the college who is looking after the administrative, teaching and other functions. This college is fully a government college, under the control of Higher Education Department and is the second Physical education college in India."

AND WHEREAS Appeal Committee noted that appellant institution is Government college under the control of Government of West Bengal and is conducting B.P.Ed. programme since 2002. Appeal Committee further noted that Show Cause Notice (SCN) dated 17/06/2019 was issued on the grounds that (i) Building Plan and Building Completion Certificate not submitted, (ii) Faculty list not submitted. The impugned order of withdrawal contains ambiguity so far as it says that faculty comprises 09 instead of 1 + 16 as per NCTE Regulation. Appendix 7 of NCTE Regulation, 2014 contains the faculty requirement as:-

Principal - One

Associate Professor- Two

Assistant Professor - Six

Assistant Professor - Three (Part time if needed)

Dietician

Yoga Trainer

Sports Trainer

AND WHEREAS Appeal Committee noted that appellant with its appeal memoranda has submitted copy of Building plan which is quite exhaustive but built up in this plan is shown as 1375 sq. meters. The B.C.C. available on regulatory file submitted by appellant in response to S.C.N. is dated 23/07/2004 issued by Executive Engineer P.W.D. Government of West Bengal.

AND WHEREAS Appeal Committee noted that additional faculty (3 Assistant Professor if needed) is optional and appellant institution has 2 Associate Professors and 6 Assistant Professors. The appointment of a regular Principal is under process. However, appellant institution has not mentioned the names of Sports Trainer, Yoga Trainer and Dietician which are required to be appointed on part time basis. Appellant institution is short of built up area and essentially required part time trainers and dietician. Appeal Committee, therefore, decided to confirm the impugned order of withdrawal dated 02/09/2019.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online arguments advanced during the hearing, Appeal Committee concluded to confirm the impugned order of withdrawal dated 02/09/2019.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

#### ORDER

WHEREAS the appeal of Department of Education, Dibrugarh University, Rajabheta, Dibrugarh, Assam dated 18/09/2020 is against the Order No. ER-282.21/AS-SO/E-8/99/M.Ed./2020/62819 dated 22.07.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for M.Ed. Course on the grounds that "no separate faculty list for M.Ed. Course duly approved by Registrar of the concerned affiliating body submitted. Certificate copy of Fire Safety Certificate duly signed by the Govt. competent authority is not submitted."

AND WHEREAS the 2<sup>nd</sup> appeal of Department of Education, Dibrugarh University, Rajabheta, Dibrugarh, Assam dated 20/09/2020 is against the Order No. ER-282.28/AS-S/E-1/96/B.Ed./2020/62834 dated 27.07.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "no separate faculty list for B.Ed. Course duly approved by Registrar of the concerned affiliating body submitted. Certificate copy of Fire Safety Certificate duly signed by the Govt. competent authority is not submitted."

AND WHEREAS Dr. M. Gogai, H.O.D, Department of Education, Dibrugarh University, Rajabheta, Dibrugarh, Assam presented online the case of the appellant institution on 09/10/2020. In the appeal and during online presentation it was submitted that "Department of Education, Dibrugarh University has been functioning as a composite multidisciplinary Department offering both B.Ed. and M.Ed. programmes. As such, at the time of appointment, a teacher is appointed as a faculty member in the Department and she / he has to accordingly take classes in both the programmes of the Department. However, after receiving the ERC, NCTE Order, the Dibrugarh University authority has now assigned the teachers in the two programmes, viz. B.Ed. and M.Ed., as per their specializations. The list of faculty members of M.Ed. programme is attached. Understanding the importance of the Fire Safety Certificate from the competent authority

for the Departmental Building as an important eligibility criterion for recognition by the NCTE, the University authority had initiated the process for securing the same from the competent authority of the Government for issuance of Fire Safety Certificate. Unfortunately, due to the nationwide lock-down imposed w.e.f. 24<sup>th</sup> March, 2020, and subsequent COVID19 scenario, the process of installation of fire safety measures was delayed at that time. However, it has since been completed and the requisite Fire Safety Certificate from the competent authority of the Government is obtained. A certified copy of the same is enclosed herewith."

AND WHEREAS Appeal Committee noted that appellant University is conducting M.Ed. programme since 2001 as Multidisciplinary Department and recognition for B.Ed. programme was also issued in year 2001. Appeal Committee noted that the Department of Education is conducting M.Ed. and B.Ed. programme with an intake of 50 seats in each programme. The faculty requirement combined for M.Ed. and B.Ed. programmes as assessed by the Appeal Committee is as follows:-

AND WHEREAS appellant University has further made available the Fire Safety Certificate dated 18/09/2020 which is applicable both for M.Ed. and B.Ed. programme.



Approved building completion certificate by the concerned competent Govt. Engineer/Authority. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014. Confirmation on website updates of the institutions with all details along with affidavit."

AND WHEREAS Dr. Ratna Roy, Principal, Institute of Advanced Studies in Education, Kunjaban, VIP Road, Indranagar, West Tripura, Tripura presented online the case of the appellant institution on 09/10/2020. In the appeal and during online presentation it was submitted that "Approved faulty list (current) has been furnished by the college vide No. F.3 (41)-IASE/NCTE/2014/116 dated 21/05/2019 to the Regional Office, NCTE, Bhubaneshwar which has been received by email. Now the same approved faculty list duly certified by the Tripura University (affiliating body) has been sent to the Regional Office at Bhubaneshwar which has been received by speed post vide consignment number ee498607558in dated 20/08/2019. Approved building plan has been furnished by the college vide no. F.3 (41)-IASE/NCTE/2014/116 dated 21/05/2019 to the Regional Office, NCTE, Bhubaneshwar which has been received by email. The same has been sent to the Regional Office at Bhubaneshwar which has been received by speed post vide consignment number ee498607558in dated 20/08/2019. Approved Building Completion Certificate has been furnished by the college vide no. F.3

(41)-IASE/NCTE/2014/116 dated 21/05/2019 to the Regional Office, NCTE, Bhubaneshwar which has been received by email. The same has been sent to the Regional Office at Bhubaneshwar which has been received by speed post vide consignment number ee498607558in dated 20/08/2019. Our college is a Govt. College established long back in 1964 and all the expenses are borne by the Govt. of Tripura and therefore, the FDRs for additional fund is not applicable for our college. The college website is maintained and updated time to time following the guidelines of the NCTE, 2014. The link of the website is given below for your kind perusal -www.lasetripura.com."

AND WHEREAS Appeal Committee noted that appellant institution is conducting M.Ed. programme since 1999 and the present intake of the programme is 50 seats (one unit). Appellant along with its appeal memoranda has submitted copies of (i) List of faculty, (ii) Building Plan, (iii) Building Completion Certificate (B.C.C.) and (iv) Printout of website pages. Appellant has further stated that being an existing Government institution conducting M.Ed. programme for the last 21 years, it is not required to furnish additional amount of FDRs.

AND WHEREAS Appeal Committee perused the list of faculty submitted by appellant and observed that appellant institution, whereas has on its rolls a Principal, 3 Associate Professors, and 8 Assistant Professors, there is a shortage of faculty in the grade of Professors. Appellant institution with the assurance of State Government of Tripura had assured that process to promote faculty in the grade of Professor is underway and shortly the deficiency, which is grade levelling, will be rectified with departmental promotions. Appeal Committee, therefore, decided that appellant institution is required to submit within 15 days of the issue of appeal order to ERC originals of faculty list, (ii) Building Plan, (iii) Building Completion Certificate (B.C.C.), (iv) Printout of website pages. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Institute of Advanced Studies in Education, Kunjaban, VIP Road, Indranagar, West Tripura, Tripura to the ERC, NCTE, for necessary action as indicated above.
