ORDER

WHEREAS the appeal of A.R.M. College, Bika Bamhori, Sironja Narsinghpur, Sagar, Madhya Pradesh dated 22/09/2019 is against the Order No. WRC/APP2996/223/283/2017/192777 dated 17.11.2017 of the Western Regional Committee, refusing recognition for conducting for B.Ed. Course on the grounds that "Matter was placed before a WRC in its 283rd meeting held on 14-15 November, 2017 and the committee decided that "show Cause Notice was issued to the institution on 11.04.2017 the institution has not replied to the show Cause Notice till date Hence recognition is refused."

AND WHEREAS A.R.M. College, Bika Bamhori, Sironja Narsinghpur, Sagar, Madhya Pradesh was asked to present the case of the appellant institution on 31/01/2020 but no one from the appellant institution appeared before Appellate Authority to present the case. Appeal Committee, as per extent appeal rules, decided to grant another (second) opportunity to the appellant to present its case. Sh. Rakesh Sthapak, Director, ARM College, Bika, Bamhori, Sagar, Madhya Pradesh presented the case of appellant institution on 04/09/2020. In the appeal memoranda, appellant institution submitted that "Organisation was trying to change the name of organisation in the Revenue Department from 'Group India Society' to 'Group Institution Society' which has been completed today.

AND WHEREAS Appeal Committee noted that a Show Cause Notice (SCN) dated 11/04/2017 was issued to appellant institution for seeking clarification regarding change in the name of society. Appellant institution was required to submit reply to S.C.N. within 30 days.



AND WHEREAS Appeal Committee noted that failure of the appellant institution to submit reply to the S.C.N. resulted in issue of impugned refusal order dated 17/11/2017 which was required to be appealed against within a period of 60 days. Appellant did not prefer any appeal within the time limit prescribed.

AND WHEREAS NCTE Regulation, 2014 prescribe that certified copy of land documents is to be furnished by applicant alongwith printout of online application. The applicant institution could neither submit land documents as required under the NCTE Regulation nor did send any reply to S.C.N. and further failed to prefer appeal within the time limit prescribed. The delay of two years in preferring appeal without any valid justification is not condonable. Further the Appeal Committee decided to confirm the impugned refusal order dated 17/11/2017 issued by WRC.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the impugned refusal order dated 17/11/2017 issued by WRC.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Pandit Rajpati Mishra College of Education and Research, Janata Shikshan Prasarak Samiti, Manorama Nagar, Krishana Compound, Near Shankar Mandir, Dokali, Thane (W), Maharashtra dated 29/11/2019 is against the Order No. WRC/APW02727/123323/311th/2019/206785 dated 11.10.2019 of the Western Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "Show Cause Notice was issued to the institution vide letter dated 28.03.2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice. Hence, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS Sh. Vivek Kumar Mishra, Clerk and Sh. Krishna Kant Ojha, Member, Pandit Rajpati Mishra College of Education and Research, Janata Shikshan Prasarak Samiti, Manorama Nagar, Krishana Compound, Near Shankar Mandir, Dokali, Thane (W), Maharashtra presented the case of the appellant institution on 01/02/2020. In the appeal and during personal presentation it was submitted that the Institution has not received show cause notice dated 28/03/2017 before withdrawal of the recognition order. The institution requested to consider the appeal and give one opportunity to submit required relevant documents. The appellant, in their letter dt. 01/02/2020, given in the course of presentation, submitted that he was unwell and requested a new date for hearing. The Committee acceded to the request and decided to give the appellant another opportunity i.e. the second opportunity to present their case.

AND WHEREAS Sh. Krishna Kant Ojhat, Member of Trust presented the case of appellant institution on 04/09/2020. Appeal Committee noted that appellant institution is recognised to conduct B.Ed. programme since 2006 with an intake of 100 seats. Appeal Committee further noted that a revised recognition order dated 29/07/2015 was issued under NCTE Regulation, 2014 for an intake of 100 seats (2 units) which was subject to the condition that appellant institution will ensure adherence to the revised norms and standards (Appendix- 4) of NCTE Regulation, 2014. A Show Cause Notice (SCN) dated 28/03/2017 was issued to appellant institution for submitting documents as mentioned in the revised recognition order.

AND WHEREAS Appeal Committee noted that appellant institution in reply to the Show Cause Notice (S.C.N.) submitted a letter dated 07/04/2017 stating that institution requires only one unit as adequate number of students are not available to run two units.

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 11/10/2019 is on the ground that appellant institution has not submitted reply to S.C.N. whereas facts reveal that appellant had submitted reply dated 07/04/2017 which is available on the regulatory file.

AND WHEREAS Appeal Committee further noted that submission made by appellant in its appeal memoranda that it did not receive S.C.N. dated 28/03/2017 is not correct as appellant institution in its reply dated 07/04/2017 has referred to the S.C.N. dated 28/03/2017. Appeal Committee noted that by issue of S.C.N., WRC had required the appellant institution to submit (i) staff profile for session 2015-16, (ii) original notarised C.L.U., N.E.C., Building Plan and Building Completion Certificate. The appellant institution irrespective of the intake of units was duty bound to have submitted all these documents to WRC as revised recognition was conditional to the fulfilment of certain conditions. Appeal Committee noted that appellant has failed to submit required documents in compliance of thee revised recognition order and subsequent Show Cause Notice dated 07/04/2017. Appeal Committee decided that the impugned withdrawal order dated 11/02/2019 deserves to be confirmed.



AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to confirm the impugned withdrawal order dated 11/02/2019.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Swami Vivekanand Mahavidyalaya, Deendayal Nagar Batalion, Sagar, Madhya Pradesh dated 08/11/2019 is against the Order No. WRC/APW03051/224110/311th/{M.P.}/2019/206534 dated 09.10.2019 of the Western Regional Committee, withdrawing recognition for conducting for B.P.Ed. Course on the grounds that "the revised recognition order was issued to the institution vide order dated 16.05.2015. The SCN was issued to the institution on 01.02.2017. The institution has submitted reply of SCN on 03.04.2017. The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice. Moreover, from the reply of the institution the Committee observed that: The institution has submitted photocopy of staff list. The institution has not submitted letter of granting approval from affiliating University in original. The original staff profile signed on each page with Seal and date of signature of the Registrar of the University not submitted. The institution has not submitted NEC issued by the competent authority. The institution has submitted copy of building plan but not proper readable and not mentioned khasra/Plot No., total land area, total built-up area and earmarked area for each course being run in the same premises. The institution has not submitted additional FDR Rs. 4 lakhs. Hence, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.P.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS Sh. Pradeep Chourasiya, Administrative Officer, Swami Vivekanand Mahavidyalaya, Deendayal Nagar Batalion, Sagar, Madhya Pradesh presented the case of the appellant institution on 01/02/2020. In the appeal and during personal presentation it was submitted that the relevant documents are attached. The appellant, in a letter dt. 01/02/2020, requested for another opportunity to enable them to

remove the deficiencies. The Committee acceded to the request and decided to give the appellant another opportunity i.e. the second opportunity to present their case.

AND WHEREAS Sh. Rakesh Sthapak, Director, Swami Vivekanand Mahavidyalaya, Deendayal Nagar Batalion, Sagar, Madhya Pradesh presented the case of appellant institution on 04/09/2020 and submitted (i) original staff profile, (ii) approval letter of University, (iii) Building Plan, (iv) Building Completion Certificate, (v) Non Encumbrance Certificate. Appellant was advised to submit original documents to the office of Regional Committee.

AND WHEREAS Appeal Committee noted that appellant institution is recognised to conduct B.P.Ed. programme since 2006 and a revised recognition order dated 16/05/2015 under NCTE Regulation, 2014 was issued for an intake of 100 seats. Appeal Committee noted that a Show Cause Notice (S.C.N.) dated 01/02/2017 was issued to appellant institution requiring submission of (i) staff profile approved by affiliating body, (ii) original notarised C.L.U., (iii) N.E.C., (iv) Building Plan, (v) B.C.C. Appellant institution in its reply dated 03/04/2017 to the S.C.N. submitted, (i) original list of faculty, (ii) copy of Building Plan (Built up area 5165 sq. meters), (iii) B.C.C., (iv) copy of sale deed. Appeal Committee noted that appellant in the appeal hearing on 04/09/2020 submitted copies of (i) staff profile signed by affiliating university on the last page, (ii) FDRs, (iii) B.C.C., (iv) C.L.U., (v) N.E.C. Appellant submitted copy of a letter dated 02/03/2020 issued by Director, University Development Council stating that list of faculty is signed on page 4 thereof.

AND WHEREAS Appeal Committee noted that deficiencies pointed out in the impugned order of withdrawal dated 09/10/2019 are not of serious nature and appellant institution is conducting B.P.Ed. programme for the last 14 years. It is noted that many university / affiliating bodies while approving faculty list do not sign on every page of the list and seal and signature of the affiliating University are put on the last page of the list of faculty. If the Regional Committee has any bona-fide doubt regarding genuineness of



the faculty list, it is always open for them to confirm the approvals from the affiliating / approving body.

AND WHEREAS Appeal Committee decided that appellant institution is required to submit original list of faculty and originally notarised documents to WRC within 15 days of the issue of appeal order. The built up area earmarked the B.P.Ed. programme shall be demarcated on the plan. Appeal Committee further decided to remand back the case to WRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Swami Vivekanand Mahavidyalaya, Deendayal Nagar Batalion, Sagar, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Gyanveer Institute of Management and Science, Rajghat Road, Sagar, Madhya Pradesh dated 03/12/2019 is against the Order No. WRC/APW06942/225127/311th/{M.P.}/2019/206470 dated 09.10.2019 of the Western Regional Committee, withdrawing recognition for conducting for M.Ed. Course on the grounds that "the SCN was issued to the institution on 06.01.2017. The institution has submitted reply on 14.01.2017. On perusal of the reply of the institution the Committee observed that: The institution has submitted photocopy of staff profile signed by Registrar, Dr. Hari Singh Gour University, Sagar, Madhya Pradesh. The institution has not submitted letter of granting approval from affiliating University in original. The original staff profile signed on each page with Seal and date of signature of the Registrar of the University not submitted. The institution has not submitted FDRs towards Endowment Fund & Reserve Fund as per NCTE Regulations, 2014. The institution has not submitted building plan approved by the competent authority mentioning name of institution, khasra/plot No., total land area, total built up area and earmarked area for each course being run in the same premises. The institution has submitted photocopy of building completion certificate issued by Private Engineer, Khasra No. not mentioned in BCC. The institution has not submitted latest NEC issued by the competent authority."

AND WHEREAS Sh. Manish Jain, HOD and Sh. Mahesh Shukla, Principal, Gyanveer Institute of Management and Science, Rajghat Road, Sagar, Madhya Pradesh presented the case of the appellant institution on 01/02/2020. In the appeal and during personal presentation it was submitted that in the previous show cause notice dated 06/01/2017 WRC/APW06942/225127/MP/2016/178192, nowhere it is mentioned about original copy of staff profile, rather they have asked original notarized copy of staff profile. They have sent notarized copy of staff profile with their reply. Now they are giving notarized copy of staff profile. They will be presenting these papers in original

before the Committee. Approval letter was not mentioned in the show cause notice dated 06/10/2017. That is why they have not sent it. But now they are sending a notarized copy of it. They will be presenting these papers in original before the Committee. The original staff profile signed on each page with seal and date of signature of Registrar, was not demanded in the show cause notice dated 06/10/2017. So, they have submitted notarized copy of staff profile. As per the requirement now they are submitting staff profile signed on each page with seal and date of signature of Registrar. They will be presenting these papers in original before the Committee. They have given details of FDR in their letter no. 3082/GIMS/2019 dated 29/03/2019 worth 7 lakh Rupees FDR no. 092372 and letter no. FDR/NCTE/WRC/2015/733 dated 23/10/2015 worth 5 lakh Rupees FDR no. 167306. Once again they are submitting details of FDR in photocopy for consideration. They have already submitted notarized building plan approved by competent authority mentioning name of institution, khasra no., total land area, built up area with their reply. But once again they are submitting notarized copy of building plan approved by Competent Authority. They will be presenting these papers in original They have submitted photocopy of building completion before the Committee. certificate issued by registered engineer with khasra number. Once again, they are submitting notarized copy of building completion certificate issued by registered engineer with khasra number. They will be presenting these papers in original before the Committee. They have already submitted NEC issued by the competent authority but now once again they are submitting latest notarized copy of NCE issued by competent authority for consideration. In the previous show cause notice dated 06/01/2017 only two points have been mentioned which they have replied via letter number GIMS/SAGAR/2017/2501 dated 14/01/2017 but in the withdrawal order seven point have been mentioned without giving a chance to institute for reply. They have given each and every information earlier in prescribed notarized format. Being a NAAC accredited college they request to consider their appeal on above mentioned grounds and restore the recognition of Master of Education. The appellant, in a letter dt. 01/02/2020, requested another opportunity to furnish some information in the prescribed The Committee acceded to the request and decided to give the appellant another opportunity i.e. the second opportunity to present their case.



AND WHEREAS Sh. Manish Jain, H.O.D., Gyanveer Institute of Management and Science, Rajghat Road, Sagar, Madhya Pradesh presented the case of appellant institution on 04/09/2020 and submitted copies of (i) letter dated 26/11/2019 issued by Dr. Hari Singh Gaur University, Sagar conveying approval of faculty and (ii) Building Completion Certificate signed by Executive Engineer, Municipal Corp. Sagar. Appeal Committee noted that Khasra No. 211 is mentioned in this Building Completion Certificate. Appeal Committee noted that appellant institution is conducting M.Ed. programme since 2008. Appeal Committee noted that appellant institution had already submitted with its appeal memoranda copies of (i) Building Plan, (ii) C.L.U., (iii) N.E.C. and (iv) list of faculty approved by affiliating body. Appeal Committee decided that appellant institution is required to submit to WRC originals / notarised copies of these documents within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to WRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Gyanveer Institute of Management and Science, Rajghat Road, Sagar, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of T.P. College, Madhepura, Bihar dated 23/09/2019 is against the Order No. ER-274.12.(ii).1/(ERCAPP1423)/B.Ed./2019/61196 dated 05.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "Applicant institution is still deficient on following points:- (i) approved faculty list by the concerned affiliating body along with requisite documents. (ii) Approved building plan by the competent Govt. Engineer/Authority. (iii) Approved building completion certificate by the competent Govt. Engineer/Authority. (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014. (v) Confirmation on website updates of the institutions with all details along with affidavit. (vi) The institution is to comply fulfilment of conditions mentioned under Clause 7(14)(i) of NCTE Regulations, 2014 and display the same on their official website. (vii) The institution has failed to comply the deficiencies mentioned in the SCN. Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

AND WHEREAS Dr. Jawed Ahmed, Head of Department, T.P. College, Madhepura, Bihar presented the case of the appellant institution on 22/11/2019 and 04/02/2020. Appellant during the course of appeal hearing submitted written requests dated 22/11/2019 and 04/02/2020 seeking adjournment of the date of hearing. Appeal Committee as per extant appeal rules, decided to grant 2nd and 3rd opportunity to the appellant to present its case before Appellate Authority.

AND WHEREAS Sh. Jawed Ahmed, Head of Department, T.P. College, Madhepura, Bihar presented the case of appellant institution on 04/09/2020 and submitted:-



- (i) Approved list of faculty.
- (ii) Approved Building Plan.
- (iii) Building Completion Certificate (Built up area 4513 sq. meters).
- (iv) FDRs (In Joint name) for 7 lakh & 5 lakh.
- (v) Printout of website.

AND WHEREAS Appeal Committee noted that appellant institution is a constituent college of B.N. Mandal University and is recognised to conduct B.Ed. programme since 2014. Appeal Committee decided that appellant institution is required to submit original faculty list and FDRs and copies of the Building Plan, Building Completion Certificate and printout of website pages to ERC. The above documents should be submitted to ERC within 15 days of the issue of appeal orders. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of T.P. College, Madhepura, Bihar to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Maulana Azad National Urdu University (MANUU), PO – Chandanpatti, Bahadurpura, Dist. Darbhanga, Bihar dated 02/10/2019 is against the Order No. ER-274.1.9/ERCAPP2046)/M.Ed./2019/61139 dated 05.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting M.Ed. Course on the following grounds that "Institution requested for extension of time to comply the deficiencies mentioned in the SCN, which is not accepted by the Committee. No new appointment of faculty made as per NCTE norms. Faculty list is not as per NCTE Regulations, 2014. Recognition granted to M.Ed. course of the application bearing Code No. ERCAPP2046 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

AND WHEREAS Prof. Noushad Husain, Dean & Head, Maulana Azad National Urdu University (MANUU), PO – Chandanpatti, Bahadurpura, Dist. Darbhanga, Bihar presented the case of the appellant institution on 22/11/2019. In the appeal and during personal presentation it was submitted that "CTE, Darbhanga is a constituent college of Maulana Azad National Urdu University, which is a Central University. UGC did not sanction additional teaching posts for CTE, Darbhanga as per revised norms of NCTE. The matter has been taken up at HRM level in a meeting. The UGC has now agreed to sanction additional posts and the recommendations of the Expert Committee awaits the approval of the full Commission of the UGC. The University has already increased the faculty strength through new appointments. Matter needs reconsideration by the Appellate Authority." Appeal Committee noted the request dated 22/11/2019 made by appellant for seeking adjournment of the hearing and another opportunity to be provided



to present its case before the Appellate Authority. Prof. Adam Paul Patteti, Professor and Sh. Jawed Alam, Section Officer, Maulana Azad National Urdu University (MANUU), PO – Chandanpatti, Bahadurpura, Dist. Darbhanga, Bihar appeared before Appeal Committee on 04/02/2020 and again submitted a written request seeking another opportunity. Appeal Committee as per extant appeal rules decided to grant another (third) opportunity to the appellant to present its case.

AND WHEREAS Sh. M.A. Sikandar, Dy. Dean and Prof. MD. Faiz Ahmad, Professor & Principal, presented the case of appellant institution on 04/09/2020 and submitted a list of faculty approved by affiliating University. This list contained the names of one Principal (Professor designated as Principal), one Professor, two Associate Professors and 7 Assistant Professors. One of the Assistant Professor is engaged on full time contractual basis.

AND WHEREAS Appeal Committee noted that appellant university is a Central University conducting M.Ed. programme since 2014. Appellant University is dependent on U.G.C. for creation of posts. Appeal Committee noted the oral request made by appellant assuring that deficiency of one Professor will be met before start of the academic session and till such a time the vacancy of Professor is filled up, Principal of the CTE who is of the rank of Professor will be utilised as per academic needs. Appeal Committee decided that appellant institution is required to submit to ERC, within 15 days of issue of appeal order, list of faculty in original. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Maulana Azad National Urdu University (MANUU), PO – Chandanpatti, Bahadurpura, Dist. Darbhanga, Bihar to the ERC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Department of Physical Education, University of Kalyani, Kalyani, Nadia, West Bengal dated 30/09/2019 is against the Order No. ER-274.14.44/APE00282/B.P.Ed./2019/61305 dated 20.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.P.Ed. Course on the grounds that Institution has not submitted "Approved faculty list by the concerned affiliating body along with requisite documents. Approved building plan by the concerned competent Govt. Engineer/Authority. Approved building completion certificate by the concerned competent Govt. Engineer/Authority. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014. Confirmation on website updates of the institutions with all details along with affidavit. In view of the above, the Committee decided as under: Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

AND WHEREAS Dr. Nita Bandyopadayay, Head & Director, Department of Physical Education, University of Kalyani, Kalyani, Nadia, West Bengal appeared on behalf of appellant institution on 22/11/2019 and 04/02/2020. In the appeal and during personal presentation appellant sought adjournment of hearing and another opportunity for personal presentation of its case. Appeal Committee as per extant appeal rules decided to grant another opportunity to the appellant to present its case.

AND WHEREAS Dr. Nita Bandyopadayay, Head of Department of Physical Education and Sh. Divanshu Ray, Registrar, University of Kalyani, Kalyani, Nadia, West Bengal presented online the case of appellant institution and also submitted online:-

- (i) Building Plan approved by University Engineer.
- (ii) Building Completion Certificate (B.C.C.) approved by University Engineer & Assistant Engineer, Public works, DTe of Government of West Bengal.
- (iii) List of faculty approved by Registrar.

AND WHEREAS Appeal Committee noted that appellant is a State University conducting B.P.Ed. and M.P.Ed. programmes. Appeal Committee noted that being a Government University initial recognition was granted to appellant university in the year 2005 without insisting on the requirement of Fixed Deposit on account of Endowment and Reserve Fund as salaries of staff and faculty are paid by Government of West Bengal.

AND WHEREAS Appeal Committee noted that the list of faculty submitted by appellant includes the names of one H.O.D., 2 Professors and 7 Assistant Professors. Appellant University has also submitted a list containing the names of Sports Trainer, Yoga Trainer and Dietician.

AND WHEREAS Appeal Committee, decided that appellant university is required to submit to ERC, within 15 days of the issue of appeal order original list of faculty, Building Plan, Building Completion Certificate and printout of website. Appeal Committee further decided to remand back the case to ERC to revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during online hearing, Appeal Committee concluded to remand back the case to ERC to revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Department of Physical Education, University of Kalyani, Kalyani, Nadia, West Bengal to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of B.J. Patel College of Education, Jaikishan Nagar, Bardoli, Surat. Gujarat dated 05/10/2019 is against the Order WRC/323048/GUJ./309th/B.Ed./2019/205209 dated 08.08.2019 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the committee considered the order dated 18.07.2019 passed by the Hon'ble High Court of Gujarat at Ahmedabad in SCA No. 9884/2019. The Show Cause Notice was issued to the institution on 03.01.2018. The institution has submitted reply vide letter dated 14.02.2018 received in WRC office on 20.02.2018. The institution has not submitted reply within 30 days as stipulated. Moreover, the reply submitted by the institution is not as per NCTE Regulations. Further, letter dated 01.11.2017 & 19.07.2019 received from Register, VNSG University, Surat, Gujarat regarding irregularities in the institution. Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS Sh. Bharatbhai J. Patel, Managing Trustee and Dr. (Ms.) Kinnori Patel, Principal, B.J. Patel College of Education, Jaikishan Nagar, Bardoli, Surat, Gujarat presented the case of the appellant institution on 25/11/2019 and 04/02/2020. In the appeal and during personal presentation it was submitted that "In the academic year 2015-16, the college has recruited all the 16 faculty members, but the university did not give permission to two Asst. Professors of special subjects: Fine Arts and Performing Arts. The process of permission of two Asst. Prof. was in process and the university had asked for the opinion of the Dean of the Education Faculty regarding qualification of the staff. So only 14 faculty was recruited and two were appointed on Adhoc basis. After that in September, 2016, 16 faculty members were recruited and staff



profile was prepared and we had sent that staff profile with P.A. Report of the year 2015-16 vide our letter outward no. 319/NCTE/2016-17 dated 01/10/2016 to WRC, NCTE. At present, we had given advertisement for recruitment of staff in two leading newspapers. We have received applications from qualified candidates. We will recruit the required faculty soon after getting V.C. Nominee and subject expert names from the University. We will submit the Original Building Completion Certificate in the prescribed format and counter signed by a Govt. Engineer during hearing of appeal. We had requested the Registrar, VNSG University to provide us with the copy of the letter which they have written to NCTE on 1/11/2017 & 19/07/2019 regarding irregularities in the institution so that we can give reply. But even after writing three request letters they have not provided us the copy of the letter. So, we can give explanation only after receiving the copy of the same." The appellant, in the course of presentation gave letters dt. 25/11/2019 and 04/02/2020 and requested for another opportunity to present the case. The Committee decided to give the appellant another opportunity i.e. the third and final opportunity to present the case.

AND WHEREAS Appeal Committee noted that appellant institution was recognised to conduct B.Ed. programme in the year 2002 and a revised recognition order dated 31/05/2015 under NCTE Regulation, 2014 was issued which was subject to adherence and compliance of the revised Norms and Standards of the B.Ed. programme. Appeal Committee noted from the regulatory file that affiliating University by its letter dated 01/11/2017 informed WRC about a compliant against management of the institution regarding non payment of salary to the faculty. Further a Show Cause Notice (SCN) dated 03/01/2018 was issued to appellant institution by WRC on grounds of inadequate faculty and non submission of Building Completion Certificate signed by Government Engineer. Appellant institution by its letter dated 14/02/2018 sought extension of time to furnish required documents.

AND WHEREAS Appeal Committee noted that appellant institution subsequently filed Special Civil Application No. 9884/2019 in the High Court of Gujarat impleading the affiliating University for discontinuing the affiliation of the appellant institution. Hon'ble

High Court by its order dated 18/07/2019 issued directions for the affiliating university as under:-

"Having regard to the provisions contained in the National Council for Teacher Education Act, 1993 (hereinafter referred to as NCTE Act), more particularly Section 14 (6) thereof to the effect that every examining body i.e. University on receipt of the order granting recognition to the institution for a course or training in teacher education is required to grant affiliation to the institution, where recognition has been granted, and cancel the affiliation of the institution where the recognition has been refused. In the instant case, the petitioner institution was granted recognition by the NCTE vide order dated 23/08/2011 and subsequently revised recognition order was issued vide order dated 31/05/2015. There is nothing on record to show that the recognition of the petitioner institution has been withdrawn or cancelled by the NCTE. Hence, the impugned order dated 24/06/2019 is required to be stayed and is hereby stayed till the pendency of this petition."

AND WHEREAS Dr. Kirti Patel, Principal and Sh. B. Bhai Patel, Trustee presented online the case of appellant institution and re-iterated that conditional recognition be given to this very old institution and directions be given to University to nominate subject experts so as to finalise the selection and appointment of faculty.

AND WHEREAS Appeal Committee noted that after issue of revised recognition order dated 31/05/2015 appellant institution was issued a Show Cause Notice (SCN) dated 03/01/2018 and appellant institution, thereafter has not able to submit list of faculty approved by the affiliating body. Appeal Committee noted that Hon'ble High Court of Gujarat by its order dated 13/03/2020 in W.P. case no. 3429 of 2020 allowed the petitioner to contend before Appellate Authority that withdrawal order is under challenge on the grounds that there are no teachers because University has not nominated subject experts.

AND WHEREAS Appeal Committee noted that all institutions are bound to adhere to the Norms and Standards of NCTE Regulation, 2014 and after appointing the requisite faculty shall formally inform the Regional Committee about such appointments. The letter of affiliating body granting approval for the selection or appointment of faculty shall also be provided by the institution to the Regional Committee. The terms and conditions of service of teaching including selection procedure shall be as per policy of State Government/Affiliating body.

AND WHEREAS Appeal Committee, is therefore, of the view that appellant institution was required to sort out the issue of selection of faculty with the affiliating body and the affiliating body is within its jurisdiction to restrict the appellant institution for ensuring adherence to the policies of State Government. Appeal Committee, in view of the failure of appellant institution to submit list of faculty appr1oved by affiliating body, decided to confirm the impugned order of withdrawal dated 08/08/2019.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, document on record and online submissions made by appellant, Appeal Committee concluded to confirm the impugned order of withdrawal dated 08/08/2019.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

Appeal Committee noted that appellant institution was called upon to present its case before Appeal Committee in its 5th Meeting – 2020. College, Ballygunge, Swinhoe Street, Kolkata, Calcutta, West Bengal appeared before Appellate Authority on 04/09/2020 and submitted copy of (i) Building Plan approved by Kolkatta Municipal Corporation and (ii) Building Completion Certificate (B.C.C.) issued by Councillor, Kolkatta Municipal Corporation. Appeal Committee noted that appellant institution is conducting B.Ed. programme since 2007 and is recognised for an intake of one unit (50 seats).
