ORDER

WHEREAS the appeal of Akshar Mahila B.Ed. College, Karelibaug, Opp. Arya Kanya Vidyalay, Vadodara (Baroda), Gujarat dated 01/03/2021 is against the Order No. WRC/APW02563/323292/Guj./326th/2021/214103 dated 03.02.2021 of the Western Regional Committee, confirming the earlier order of withdrawal of recognition for conducting B.Ed. Course vide order dated 22/06/2018 on the grounds that "Institution has not submitted the approval letter indicating the name of the faculty members, duly issued by the concerned affiliating body. The letter forwarding the staff list and the staff list submitted by the institution has the round seal of the University and not that of the signing authority / Registrar. In view of above, the Committee decided that the Recognition of the institution already withdrawn by WRC vide order 22nd June 2018 stands."

AND WHEREAS Dr. Dhavalsinh Parmar, Chairman and Mr. Mahesh Bahi M. Rathwa, Office. Suptd. Mahila B.Ed. College, Karelibaug, Opp. Arya Kanya Vidyalay, Vadodara (Baroda), Gujarat presented the case of the appellant institution on 01/04/2021 and 29.5.2021. In the appeal and during personal online presentation and in a letter dated 01/04/2021 it was submitted that "in reference to the minutes of the 325th Meeting of the WRC held on the 9th January, 2021, they have sent a reply to the WRC in their letter outward no. Akshar/325th Meeting/19-20/155 dt. 29/01/2021 enclosing the letter of Shri Govind Guru University, Godhra dated 28/01/2021 approving the faculty and list of approved staff, duly signed by the Registrar of that University. The appellant also submitted that their letter dt. 29/01/2021 was received by WRC on 01/02/2021."

AND WHEREAS the Committee noted that the letter of the appellant dated 29/01/2021 is not in the file of the WRC. In these circumstances, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the said letter, to be sent again to them by the appellant and take necessary

action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC their letter dated 29/01/2021, with all its enclosures, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Akshar Mahila B.Ed. College, Karelibaug, Opp. Arya Kanya Vidyalay, Vadodara (Baroda), Gujarat to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of H.N. Memorial Mahila Mahavidyalaya, Shivaji Nagar, Jhansi, Uttar Pradesh dated 07/02/2020 is against the minutes of the 311th Meeting of the NRC held from 16th to 17th January, 2020, wherein it was decided to reject the application of the appellant institution for grant of recognition for conducting for (ITEP) Pre-Primary to Primary Course on the grounds that "Application of the institution has not been submitted within the prescribed time limit as per Clause 7(2)(b) of NCTE Regulations, 2014."

AND WHEREAS Sh. Rajpal Singh Gaur, Dy. Manager, H.N. Memorial Mahila Mahavidyalaya, Shivaji Nagar, Jhansi, Uttar Pradesh presented online the case of the appellant institution online on 01/04/2021 and 29.5.2021. In the appeal and during online presentation it was submitted that "the Institution submitted online application within the time on 31-07-2019 with the processing fee. The printout of online application was sent to NRC NCTE office on 13-08-2019 through Speed Post receipt no EU945116414IN. The hard copy of the application was delivered by the postal department in NRC NCTE office on 16-08-2019. The tracking Receipt is enclosed. As per NCTE Regulation the last date was 15-08-2019 for online application made on 31-07-2019. 15 August 2019 was National Holiday and therefore, the next date is 16-08-2019 which is the last date. The hard copy of application was delivered on 16-08-2019 in NRC NCTE office within the time limit which was not considered by NRC NCTE."

AND WHEREAS the Committee, noting the submission of the appellant and the fact that the hard copy of the application was despatched by speed post on 13/08/2019 i.e. within 15 days from the date of online submission, concluded that the matter deserved to be remanded to the NRC with a direction to consider the application of the appellant and take necessary action as per NCTE Regulation, 2014.

NOW THEREFORE, the Council hereby remands back the case of H.N. Memorial Mahila Mahavidyalaya, Shivaji Nagar, Jhansi, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Som Sinhji Zala College of Education, Banaskantha, Palanpur, Gujarat dated 28/02/2021 is against the Letter No. WRC/APW04662/323450/B.Ed./307th/GUJ/2019/203756 dated 04.06.2019 of the Western Regional Committee, confirming their earlier order dt. 28/07/2011 withdrawing recognition for conducting B.Ed. course.

AND WHEREAS Sh. Bharatbhai Becharbhai Bantaya, Managing Trustee of Som Sinhji Zala College of Education, Banaskantha, Palanpur, Gujarat presented the case of the appellant institution on 01/04/2021 and 29.5.2021. In the appeal and during personal presentation it was submitted that "Correction of Govt. registered lease deed mentioned plot number & survey number. Permanent Principal is appointed. Endowment fund Rs. 7,00,000 and reserve fund Rs. 5,00,000 is submitted original in NCTE, WRC."

AND WHEREAS the Committee noted that the appellant earlier preferred an appeal to the Council on 24/09/2011 against the order of withdrawal of recognition for B.Ed. course issued by the WRC on 28/07/2011. That appeal was considered by the Council who rejected the appeal and confirmed the order of the WRC vide Appellate Order No. F. 89-375/2011 Appeal/8th Meeting – 2011 dated 04/01/2012.

AND WHEREAS Appeal Committee noted that withdrawal order dated 28/07/2011 was on the grounds that "(i) Approved building plan is not for the entire college. It is only for mess and hostel purpose. (ii) Plot number and survey number is not mentioned in the registered lease deed. The college did not possess land as per Clause 8(5) of the NCTE Regulation, 2005. (iii) Principal has not been appointed till date." The Committee noted that the appellant thereafter pursued matters through Writ Petitions filed before the Hon'ble High Court of Gujarat. In compliance with the directions contained in the order of the Hon'ble High Court dated 19/02/2019 in SCA No. 2918/2019, the WRC considered

a representation of the appellant dt. 23/09/2018 and decided to confirm their earlier order of withdrawal of recognition dt. 28/07/2011 on the ground that the documents submitted by the institution are not as per NCTE Regulations, 2014. The WRC accordingly issued letter dated 04/06/2019.

AND WHEREAS the Committee noted that the appellant approached the Hon'ble High Court of Gujarat through S.C.A. No. 12543 of 2019 and S.C.A No. 22146 of 2019. The Hon'ble High Court, in their order dated 23/07/2019 in SCA No. 12543/2019, dismissed the petition as withdrawn with permission to the petitioner to make a representation to the respondent NCTE. The Hon'ble High Court, in their order dated 02/02/2021 in SCA No. 22146 of 2019, dismissed the petition in view of their order dated 23/07/2019 in SCA No. 12543 of 2019.

AND WHEREAS the appellant, instead of making a representation preferred an appeal against the decision of the WRC dated 04/06/2019 to confirm their earlier order of withdrawal dt. 28/07/2011 that too long after the Hon'ble High Court dismissed the SCA No. 12543 of 2019 with permission to make a representation on 23/07/2019, i.e. after a lapse of one year and seven months to re-grant recognition, which was withdrawn nearly a decade back.

AND WHEREAS the Committee noted that after the appeal of the institution was earlier rejected by the Appellate Authority on 04/01/2012, the withdrawal order attained finality. Thereafter the institution virtually ceased to function as it became ineligible to admit fresh students. There are no provisions in the NCTE Act, 1993 or the Regulations made thereunder, from time to time, to re-grant recognition. The appellant, if he wishes, has therefore, to apply afresh for conducting any teacher education programme, as and when applications are invited by the NCTE.



AND WHEREAS in the above circumstances, the Committee concluded that the appeal deserved to be rejected and the decision of the WRC upheld.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

WHEREAS the appeal of P.S.B. College of Education, Chirala, Wood Nagar Govt. Hospital Road, Chirala, Prakasam, Andhra Pradesh dated 24/02/2021 is against the Order No. SRO/NCTE/APS07312/B.Ed./AP/2020/121806 dated 23.12.2020 of the Southern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "Committee noted that the institution has failed to submit reply / written representation in respect to the Final Show Cause Notice dated 15.11.2019 issued to the institution."

AND WHEREAS Sh. John Frederick, Principal, P.S.B. College of Education, Chirala, Wood Nagar Govt. Hospital Road, Chirala, Prakasam, Andhra Pradesh presented the case of the appellant institution online on 01/04/2021 and 29.5.2021. In the appeal and during online presentation it was submitted that the SRC vide its order dated 23.12.2020 has withdrawn recognition observing deficiencies which were already clarified / ratified by our institution. In order to appreciate various contentions and averments being raised hereinafter by the appellant, it is necessary to state the following few relevant facts in brief. The SRC, conducted expert visit and verified infrastructural & instructional facilities of our institution and issued recognition order dated 12.04.2007 for conducting B.Ed. course of one year from the academic session 2007 with an annual intake of 100 students to our institution. The NCTE issued the new Regulations in 2014 and the institution submitted its compliance to the said new Regulations. Accordingly, the SRC issued revised recognition order dated 29.05.2015 to our institution. The SRC issued the SCN to our institution on 30.01.2019 and directed to submit reply. It is submitted that no other show cause notice other than 30.01.2019 was received by the petitioner. Thereafter, we vide our letter dated 03.07.2019 submitted reply to SCN dated 30.01.2019 alongwith the other supporting documents. It is submitted that the SRC issued the withdrawal order dated 23.12.2020 withdrawing recognition of our institution

observing that no reply to the final show cause notice has been given, However, the institution did not receive the Final Show Cause. The SRC failed to consider that the institution submitted reply to the first show cause notice and has submitted all the documents, however, a wrong finding has been mentioned in the withdrawal order. A copy of staff profiles, BCC, Building Plan, CLU, NEC, FDRs and other documents are enclosed. It is submitted that SRC has withdrawn the recognition of our institution without observing the documents submitted by the institution vide its reply to SCN issued from time to time. It is submitted that SRC failed to observe that our institution fulfils all the requirements pertaining to infrastructural and instructional facilities, which are required for conducting one unit of B.Ed. course. It appears that SRC, NCTE proceeded in arbitrary manner without considering the documents properly and without following the due procedure of SOP.”

AND WHEREAS Appeal Committee noted that appellant had submitted reply dated 03.07.2019 to the Show Cause Notice (SCN) dated 30.01.2019. The impugned order of withdrawal is on the ground that appellant has not submitted reply of the Final Show Cause Notice dated 15.11.2019. Appellant states that final SCN was not received by them. Appeal Committee noted that appellant deposing to have submitted reply to first SCN dated 30.01.2019 is well aware of the documents required by SRC. Appeal Committee decided that Appellant institution is required to submit to SRC a complete compliance along with required documents in original within 15 days of the issue of Appeal Order. Appeal Committee further decided to remand back the case to SRC for revisiting the matter after receiving reply from the appellant institution.

NOW THEREFORE, the Council hereby remands back the case of P.S.B. College of Education, Chirala, Wood Nagar Govt. Hospital Road, Chirala, Prakasam, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Taralupadu College of Education, Mission Compound, Taralupadu, Prakasam, Andhra Pradesh dated 24/02/2021 is against the Order No. SRO/NCTE/APS00560/B.Ed./{AP}/2020/121284 dated 18.12.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C). The institution has also not responded to the Show Cause Notice issued on 18.02.2019."

AND WHEREAS Shri A.J.J. Krupakar, Correspondent of Taralupadu College of Education, Mission Compound, Taralupadu, Prakasam, Andhra Pradesh presented online the case of the appellant institution on 01/04/2021 and 29.5.2021. In the appeal and during online presentation it was submitted that "SRC vide its order dated 18.12.2020 has withdrawn recognition observing deficiencies which were already clarified / ratified by our institution. In order to appreciate various contentions and averments being raised hereinafter by the appellant, it is necessary to state the following few relevant facts in brief. The SRC, conducted expert visit and verified infrastructural & instructional facilities of our institution and issued recognition order dated 17.10.1998 for conducting B.Ed. course of one year from the academic session 1998 with an annual intake of 100 students to our institution. The NCTE issued the new Regulations in 2014 and the institution submitted its compliance to the said new Regulations. Accordingly, the SRC issued revised recognition order dated 11.05.2015 to our institution. The SRC issued SCN to our institution on 24.10.2019 and directed to submit reply. Thereafter, SRC issued final SCN to our institution on 06.12.2019. Thereafter, we vide our letter dated 03.01.2020 submitted our reply to SCN dated 06.12.2019 alongwith the other supporting documents. It is submitted that the SRC issued the withdrawal order dated 18.12.2020 withdrawing recognition of our institution on some new grounds which were not part of the show cause

notices earlier issued by the SRC and for which no opportunity was provided to our institution to ratify the same. It is submitted that the appellant herein is hereby presenting before the Appeal Committee the documents desired by the SRC including the land document i.e. sale deed, NEC, site plan, BCC and staff list, in support of its appeal and for consideration of the same by the Appeal Committee. A copy of land document i.e. sale deed, NEC, site plan, BCC and staff list, necessary affidavits, website, details of teacher training programmes being run by the institution as mentioned in para 5 of the withdrawal order are enclosed. It is submitted that SRC has withdrawn the recognition of our institution without observing the documents submitted by the institution vide its replies to SCN issued from time to time. It is submitted that SRC failed to observe that our institution fulfils all the requirements pertaining to infrastructural and instructional facilities, which are required for conducting one unit of B.Ed. course. Withdrawal order dated 18.12.2020 of SRC is not maintainable and the appeal committee is requested to reverse the decision taken by the SRC and direct the SRC to restore the recognition of our institution."

AND WHEREAS the Committee noted that the reply of the appellant dated 03/01/2020 is not available in the file of the SRC. In these circumstances, the Committee concluded that the matter deserved to be remanded to the SRC with a direction to consider the reply dt. 03/01/2020 to be sent again to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the SRC their reply dt. 03/01/2020, with all its enclosures, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Taralupadu College of Education, Mission Compound, Tarlupadu, Prakasam, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

The appellant is directed to forward to SRC, the documents submitted in appeal, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Prathibha College of Education, Joharapuram, G. Pulla Reddy Engineering College Branch, Dhanalakshmi Nagar, Kallur, Kurnool, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Anna Vinayagar College of Education, Neendakarai B, Ganapathipuram, Agasteeswaram, Kanyakumari, Tamil Nadu dated 20/02/2021 is against the Order No. SRO/NCTE/APSO3656/TN/B.Ed./2020/123621-123627 dated 16.02.2021 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Institution was issued a Final Show Cause Notice (FSCN) dated 07/08/2020. The institution has failed in submission of written representation along with all required documents in response to Final Show Cause Notice."

In the appeal and during online presentation it was submitted that "They have submitted notarized English version of land document; a notarized copy of LUC duly approved by competent authority; NCE which is notarized English translation; Building Plan which is legible; BCC in prescribed format and notarized; and latest staff approval as per NCTE Regulation and notarized the same."

AND WHEREAS the Appeal Committee noted the submission mode online by the appellant. Appellant had to face difficulty in getting certified copy of CLU, NEC, Faculty list etc. from the concerned authorities due to Covid pandemic. The Committee noted that the appellant sent a reply to the Final Show Cause Notice dt. 07/08/2020, which is dated 27/08/2020 and received in SRC on 31/08/2020. In these circumstances, the Committee concluded that the matter deserved to be remanded to the SRC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant and take necessary action as per NCTE Regulations, 2014. The appellant is directed to forward

to the SRC all the documents submitted in appeal, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Anna Vinayagar College of Education, Neendakarai B, Ganapathipuram, Agasteeswaram, Kanyakumari, Tamil Nadu to the SRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Agrasen College, Dhanora, Durg, Chhattisgarh dated 10/02/2021 is against the Order No. WRC/APW08052/723170/B.Ed./2020/212512 dated 11.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Final SCN giving last opportunity was issued to the institution vide dated 06th February 2020. The reply to SCN submitted by the institution vide dated 06th March 2020 was considered by WRC and the WRC found that: The institution has submitted the staff list, which is not approved by the affiliating body. In view of the above, the Committee decided that recognition granted to the institution for B.Ed. course be withdrawn from the academic session 2021-22."

AND WHEREAS Sh. Srikant Das Gupta, Addl. Director, Agrasen College, Dhanora, Durg, Chhattisgarh presented the case of the appellant institution on 01/04/2021. In the appeal and during personal presentation it was submitted that "Staff list of Agrasen College, Dhanora, Durg (C.G.) is duly approved by Hemchand Yadav University, Durg, Chhattisgarh."

AND WHEREAS the Committee noted that the appellant, while submitting a copy of the letter dt. 09/02/2021 issued by the Registrar, Hemchand Yadav University, Durg forwarding the staff list has not submitted the faculty list in the prescribed format. The appellant in their letter dt. 01/04/2021 assured that they will submit the staff list in the prescribed format of NCTE in the next meeting.

AND WHEREAS appellant institution was issued online notice to appear before Appellate Authority to present the case on 29.5.2021. Sh. Srikant Das Gupta, Addl. Director, Agrasen College, Dhanora, Durg, Chhattisgarh presented the case of the appellant institution on 29.5.2021. In the Appeal and during personal presentation the Appellant submitted a list of faculty containing the names of a Principal and 15 faculty

out of which 3 faculty pertaining to Visual Art, Physical Education and Performing Art are on part time basis. Appeal Committee further observed that faculty at serial no. 3 to 11 (Total-9) are appointed in 2020 and 2021 on ad hoc basis and do not possess Ph. D or NET/SLET qualification. Appeal Committee decided that impugned order of withdrawal dated 11.12.2020 issued by WRC deserves to be confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Surju Singh Memorial College of Education and Research, Adharwadi, Jail Road, Kalyan, Thane, Maharashtra dated 20/01/2021 is against the Order No. WRC/APW02371/123311/321st/2020/213135 dated 20.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 28.10.2006 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its premises till date. Accordingly, Show Cause Noted was issued to the institution on 30.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of the above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

AND WHEREAS Sh. A. Kumar Singh, Trustee and Sh. Satish Kumar Singh, Trustee, Surju Singh Memorial College of Education and Research, Adharwadi, Jail Road, Kalyan, Thane, Maharashtra presented the case of the appellant institution on 01/04/2021 and 29.5.2021. In the appeal and during personal presentation it was submitted that "Sir, please forgive us, for the delay in replying to the show cause notice issued to us 30-Sept-2019. We received the notice by post on 18th-Oct-2019. We would like to bring to your kind attention that our whole family was infected by coronavirus and hospitalised. (We can provide the proof of the same if ordered) We somehow fought our way back to normalcy. We all were on death bed. But by the grace of god now everything is fine. Also due to us some of our staff also got infected as a result nobody came to school/office for a long time. Due to this we were unable to send the reply to show cause notice on time. I would like to bring to your kind attention that we have submitted the reply on 22-Dec-2020 and we received the withdrawal letter from WRC, NCTE on 24-Dec-

2020. Also, I would like to bring to your kind attention that we had already applied for premises shifting of our B.Ed. college, around a year back on 24-Oct-2018, but there was no action regarding this application. Kindly accept our request and grant us a chance to fulfil all the requirements and for the well-being of the society and for all associated with the school."

AND WHEREAS the Committee noted that the reply dated 22/12/2020, stated to have been sent is not available in the file of the WRC. The appellant enclosed to the appeal a copy of their letter dated 22/12/2020 purported to be an application for change of premises. On the other hand, the appellant in the appeal submitted that they applied on 24/10/2018 for shifting of premises but there was no action regarding the application.

AND WHEREAS the Committee noted that in the file of the WRC there is no such application dt. 24/10/2018 for shifting of premises. There is also no other correspondence regarding shifting of premises. In the course of presentation, it transpired that the appellant institution has already shifted to a different premises without approval.

AND WHEREAS the Committee noted that according to the provisions of Clause 8 (9) of the NCTE Regulation, 2014, in case of change of premises, prior approval of the Regional Committee concerned shall be necessary, which may be accorded after due inspection of the institution at the new site.

AND WHEREAS the Committee, noting that the appellant neither replied to the Show Cause dt. 30/09/2020, nor obtained prior approval of the Regional Committee for change of premises and in gross violation of the provisions of the NCTE Regulation, 2014 shifted to different premises on their own, the Committee concluded that the appeal deserved to be rejected and the order of the WRC confirmed.



.NOW THEREFORE, the Council hereby confirms the Order appealed against.
