ORDER

WHEREAS the appeal of Vidyasagar Foundation School of Education and Training, Tamna, Simulia, Purulia-Manbazar Road, Damda, Purulia, West Bengal dated 26/12/2020 is against the Order No. ERC/284.30/APE00876/B.Ed./2020/63379 dated 17.12.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "there is a mismatch of floor-wise and total built up area mentioned in Building Completion Certificate (BCC) and blue print of Building Plan (BP). Hence, B.Ed. course is withdrawn under section 17(10 of NCTE Act 1993 from the next academic session 2021-22 is stand valid as per the withdrawal order issued by the ERC F.No. ER-275.14.18/APE00876/B.Ed./2019/61475 dated 02.09.2019."

AND WHEREAS Sh. Anup Kumar Sarkar, Secretary and Dr. D.K. Dikshit, Principal. Vidyasagar Foundation School of Education and Training, Tamna, Simulia, Purulia-Manbazar Road, Damda, Purulia, West Bengal presented the case of the appellant institution on 23/02/2021. In the appeal and during personal presentation it was submitted that "As per direction of the Appellate Authority, vide order No. 89-419/E-139384/2019 Appeal/37th Mtg.-2019/27th November, 2019/86541 dated 23.12.2019, all documents including approved Building Plans with BCC(s) were submitted to the ERC on 02.01.2020 for consideration. A Show Cause Notice had been issued on 28/02/2020 on the ground of Consolidated Building Plan. We humbly want to submit that there was no way to make a Consolidated Building Plan because a separate plan was drawn and subsequently approved for additional built up area required in compliances with the NCTE Regulation 2014. Accordingly, we submitted two building plans with Building Completion Certificates having built up area 1505.042 sq.mt & 1344.2 sq.mt. to the ERC on 11/03/2020 for consideration. But Final Show Cause Notice was issued on 22/07/2020 on the ground of insufficient built up area (1350 sq. mt.) mentioned in the BCC. We are sorry to state that those BPs and BCCs were somehow overlooked by the ERC, Bhubaneswar. Then a Consolidated Building Completion Certificate clubbing two BCCs i.e. total built up area

2849.242 sq.mt (1505.042+1344.2) was submitted to the ERC, Bhubaneswar on 20/07/2020 and that was received by the same office on 29/07/2020 as per tracking statement of India Post, Govt. of India. Nevertheless, from the 284th Meeting of the ERC, held on 17-18th September2020, withdrawal of recognition of the institution from the academic session 2021-2022 was granted on the ground of mismatch of floor-wise and total built up area mentioned in BCC and blueprint of BP. Once again, a request letter to examine the Consolidated BCC and BPs of the building was duly submitted to the ERC. Bhubaneswar on 26/09/2020 as there was no mismatch between BCC and BP(s). Photocopies of these documents are attached herewith. Finally, an order of withdrawal of recognition vide no. ERC-284.30/APE00876/B.ED./2020/63379 dated 17/12/2020 was issued. Thus, we request you to accept the Building Plans and the Consolidated Building Completion Certificate and humbly appeal for your kind consideration to reinstate the recognition from the session 2021-2022. 2. As per direction of the Appellate authority vide order No. 89-419/E-139384/2019 Appeal/37th Mtg.-2019/27th November,2019/86541 dated 23.12.2019, final faculty list in the prescribed pro-forma duly signed by the WBUTTEPA, West Bengal, an affiliating authority, was submitted to the ERC. Bhubaneswar on 02/01/2020. But the Final Show Cause Notice was issued on 22/07/2020 on the ground of non- availability of original approved list of teaching faculty. In reply to this show cause notice Original copy of approved teaching faculty list was submitted on 20/07/2020 (Annexure -B) to the ERC, Bhubaneswar and it is accepted by the ERC, NCTE, Bhubaneswar. 3. As per direction of the Appellate authority vide order No. 89-419/E-139384/2019 Appeal/37th Mtg.-2019/27th November,2019/86541 dated 23.12.2019, the detail format of FDRs was submitted to the ERC, NCTE, Bhubaneswar dated 02/01/2020. A Show Cause Notice was issued on 28/02/2020 on the ground that no original FDRs were submitted to the ERC. In reply to this notice two Original FDRs of Rs. 7 lakh and Rs.5 lakh were submitted to the ERC, Bhubaneswar and the FDRs are accepted by the ERC, NCTE, Bhubaneswar. 4. As per direction of the Appellate authority vide order No. 89-419/E-139384/2019 Appeal/37th Mtg.-2019/27th November,2019/86541 dated 23.12.2019, photocopies of webpage were submitted to the ERC, Bhubaneswar dated 02/01/2020. A Show Cause Notice was issued on 28/02/2020 on the ground that the institutional website had not been updated. Accordingly, photocopies of updated

webpage were submitted to the ERC, Bhubaneswar dated 11/03/2020 and that is accepted by the ERC, NCTE, Bhubaneswar."

AND WHEREAS the Committee noted that the appellant has submitted a consolidated Building Completion Certificate showing a total built up area of 2849.242 sq. mts. and also the building plans to the ERC with their letters dated 20/07/2020 and 26/09/2020 and the appellant has again submitted these documents in appeal also, and explained that construction as per the second plan has been done partially. In the circumstances, the Committee concluded that the matter deserved to be remanded to the ERC with a direction to consider the documents/submissions of the appellant and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward the documents relating to the building plan, Building Completion Certificate etc. submitted in appeal to the ERC within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC with a direction to consider the documents/submissions of the appellant and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward the documents relating to the building plan, Building Completion Certificate etc. submitted in appeal to the ERC within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Vidyasagar Foundation School of Education and Training, Tamna, Simulia, Purulia-Manbazar Road, Damda, Purulia, West Bengal to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Chaitanya College of Education, P.S. Bonangi, Bonangi Road, Parawada, Visakhapatnam, Andhra Pradesh dated 25/12/2020 is against the Order No. SRO/NCTE/APS09328/B.Ed./{AP}/2020/120550 dated 06.11.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the institution has not submitted a Notarized copy of Land Document whereas a photocopy of it submitted. The institution has not submitted a Notarized copy of Land Use Certificate whereas a photocopy of it submitted. The institution has not submitted a Notarized copy of NEC. However, a photocopy of NEC submitted. The institution has not submitted a Notarized copy of Building Plan. However, a photocopy of Building Plan submitted in which Multipurpose Hall Area is not mentioned. The institution has not submitted a Notarized copy of Site Plan. The institution has submitted a photocopy of completion certificate submitted which is not in prescribed format as per NCTE Norms. The institution has submitted a photocopy of Faculty List for B.Ed. Course approved by Registrar, Andhra University, Visakhapatnam consisting of one Principal and eight Lecturers vide dated 22.12.2017. One Lecturer does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017. He is appointed on 01.11.2018. b. Teaching Subject is not mentioned. The institution has failed to submit Notarized copy of Faculty list for the latest academic session. The institution has failed to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs. Website is not working."

AND WHEREAS Sh. P. Venkatramanna, Faculty, Chaitanya College of Education, P.S. Bonangi, Bonangi Road, Parawada, Visakhapatnam, Andhra Pradesh presented online the case of the appellant institution on 23/02/2021. In the appeal and during online presentation it was submitted that "Notarization of the document was overlooked instead the document was attested by the correspondent of the institution. The documents were attested by the correspondent of the institution instead of notarization of the document as mentioned in point 2 of the final show cause notice u/s 17 R. SRC/NCTE/FSCN/AP/2019-112897 dated 10 Dec. 2019. The documents were attested by the correspondent of the institution instead of notarization of the document as mentioned in point 3 of the final show cause notice u/s 17 R. No. SRC/NCTE/FSCN/AP/2019-112897 dated 10 Dec 2019. Notarization of the document was not done instead all the documents were attested by the correspondent of the institution as mentioned in point 4 of the final show cause notice u/s 17 R. No. SRC/NCTE/FSCN/AP/2019-112897 dated 10 Dec 2019. Notarization of the document was not done instead all the documents were attested by the correspondent of the institution as mentioned in point 5 of the final show cause notice u/s 17 R. No. SRC/NCTE/FSCN/AP/2019-112897 dated 10 Dec 2019. Notarization of the document was not done instead all the documents were attested by the correspondent of the institution as mentioned in point 6 of the final show cause notice u/s 17 R. No. SRC/NCTE/FSCN/AP/2019-112897 dated 10 Dec 2019. The said candidate Dabburi Koteswara Rao was appointed on 1st November 2018 for the subject "Education" and the documents were submitted for ratification to Andhra University, Visakhapatnam on 26th November 2018 but unfortunately the ratification date was mentioned as 22nd December 2017. The photocopies of fixed deposits submitted instead of form 'A' as required due to clerical error. Website is working."

AND WHEREAS the Committee noted from the final Show Cause Notice dt. 10/12/2019, that the appellant was required to submit (i) certified copy of land documents issued by the Tehsildar/Revenue officer and (ii) an attested/notarised copy of Land Use Certificate issued by the Competent Authority. The appellant, with their letter dt. 30.12.2019 (received on 01/01/2020) furnished a number of documents related to land,

staff, FDRs, Website. The Committee noted that the SRC, after scrutiny of the reply besides observing that the appellant submitted only photocopies and not notarised copies of the various documents, pointed out certain deficiencies in the Building Completion Certificate, faculty list and FDR documents. The Committee noted that the appellant, along with appeal furnished copies of notarised documents only instead of originally notarised documents. He has given explanation in respect of other deficiencies pointed out in the withdrawal order.

AND WHEREAS Appeal Committee noted that appellant institution is recognised to conduct B.Ed. programme since 2008 and at present is conducting the programme with an intake of 1 unit (50 seats). The Committee, noting that the appellant has since got the documents notarised furnished other explanations also, concluded that the matter deserved to be remanded to the SRC with a direction to consider originally notarised documents and other explanations vis a vis grounds of withdrawal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the SRC, originally notarised documents and explanation regarding all other grounds of withdrawal within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee concluded to remand back the case to SRC with a direction to consider originally notarised documents and other explanations vis a vis grounds of withdrawal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the SRC, originally notarised documents and explanation regarding all other grounds of withdrawal within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Chaitanya College of Education, P.S. Bonangi, Bonangi Road, Parawada, Visakhapatnam, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Abasaheb Kakade Shikshan Shastra Vidyalaya (D.Ed.) Nav Maharashtra Shikshan Mandal, Shevgaon, Ahmednagar, Maharashtra dated 14/12/2020 is against the Order No. WRC/APW02482/1222395/322nd/2020/212615 dated 12.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for D.El.Ed. Course on the grounds that "Recognition was granted to the institution on 17.08.2007 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Notice was issued to the institution on 09.10.2020. The institution has not submitted the reply of the Show Cause Notice till date."

AND WHEREAS Sh. Kailas Maruti Pote, Co-ordinator and Sh. Arun G. Chothe, Principal, Abasaheb Kakade Shikshan Shastra Vidyalaya (D.Ed.) Nav Maharashtra Shikshan Mandal, Shevgaon, Ahmednagar, Maharashtra presented the case of the appellant institution on 23/02/2021. In the appeal and during personal presentation it was submitted that "Institute has received the above referred show cause notice dated 09/10/2020 to which institute had replied with their letter No. 38/2020-21 dated 04/11/2020. It seems that your office have not considered our reply. We would like to inform that institute has replied your letter within stipulated time 30 days from the date of notice). We received your notice on 14/10/2020 and we have replied to this letter on 4th Nov 2020 by speed post. The institute has already asked for your guidance on this issue with our letter No. 38/2020-21 Dated 04/11/2020. Navmaharashtra Shikshan Mandal has purchased its own land for the educational purposes. However due to financial issues it was not possible for Navmaharashtra Shikshan Mandal has taken the land on lease for 30 Years with the

consent of Charity Commissioner from the Friends of the Depressed League. However, simultaneously institute has started a process to shift the institute at a well-equipped building in the vicinity. It gives us great pleasure to inform you that our Navmaharashtra Shikshann Mandals Abasaheb Kakade Shikshan shashtra Vidhyalaya plans to shift the institute to the own premises. We are expecting some time on your behalf, We, have already started a process to shift the institute at our own campus at Bodhegaon, Tal Shevgaon, Dist-Ahmednagar. The infrastructure available at Bodhegaon Campu is upto the mark and fulfilling all the norms set by NCTE. We would like to draw your attention to fact that Navmaharashtra Shikshan Mandals Abasaheb Kakade Shikshan Shastra Vidyalaya, is only, reputed institute in Shevgaon Tahsil. Our institute has appointed approved full time principal & staff with well-equipped library, computer lab, sports facility as per NCTE rules, Regulations & requirements. This institute is having a very good academic performance record with quality education. We have successfully developed very education friendly atmosphere at our campus. since 2007 institute was admitting students full of its intake capacity for all the program."

AND WHEREAS the appellant, with its letter dt. 23/02/2021, enclosed, <u>inter-alia</u>, a copy of their reply dated 04/11/2020 to the Show Cause Notice dt. 09/10/2020 and a copy of track report of speed post indicating that the article was delivered on 10/11/2020. However, this letter is not found in the file of the WRC.

AND WHEREAS in view of the above position, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the reply to the Show Cause Notice to be forwarded again to them by the appellant, and take necessary action as per NCTE Regulation, 2014. The appellant is directed to forward again to the WRC, their reply dt. 04/11/2020 to the Show Cause Notice within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC with a direction to consider the reply to the Show Cause

Notice to be forwarded again to them by the appellant, and take necessary action as per NCTE Regulation, 2014. The appellant is directed to forward again to the WRC, their reply dt. 04/11/2020 to the Show Cause Notice within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Abasaheb Kakade Shikshan Shastra Vidyalaya (D.Ed.) Nav Maharashtra Shikshan Mandal, Shevgaon, Ahmednagar, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of D.El.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

AND WHEREAS Sh. B.G. Solanki, Principal and Sh. Rajesh, Director, Shri Matruvandan P.T.C. College, Simar, Paiki, Sherbug-Gadu, Gadu-Veraval Road, Veraval, Junagarh, Gujarat presented the case of the appellant institution on 23/02/2021. In the appeal and during personal presentation and in a letter dt. 23/02/2021, the appellant submitted that "They did not receive show cause notice. Stating that they fulfil all the requirements requested that they may be given a chance to answer the queries."

AND WHEREAS Appeal Committee noted that appellant institution is conducting D.El.Ed. programme with an intake of 50 seats since the year 2006. Appeal Committee, noting the submission of the appellant, concluded that the matter deserved to be remanded to the WRC with a direction to re-issue their show cause notice to the appellant

and take further action as per the NCTE Regulation, 2014. The appellant is directed to send their reply to the Show Cause Notice within 15 days of its receipt.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC with a direction to re-issue their show cause notice to the appellant and take further action as per the NCTE Regulation, 2014. The appellant is directed to send their reply to the Show Cause Notice within 15 days of its receipt.

NOW THEREFORE, the Council hereby remands back the case of Shri Matruvandan P.T.C. College, Simar, Paiki, Sherbug-Gadu, Gadu-Veraval Road, Veraval, Junagarh, Gujarat to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Bhartiya Shikshan Mahavidyalaya, Bhamti, Pratap Nagar, Cement Road, Nagpur, Maharashtra dated 04/01/2021 is against the Order No. WRC/APW02004/123289/321st/2020/212458 dated 10.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 28.12.2006 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Notice was issued to the institution on 23.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

AND WHEREAS Dr. Kiran Urade, Principal and Sh. Rakesh Pannase, Secretary, Bhartiya Shikshan Mahavidyalaya, Bhamti, Pratap Nagar, Cement Road, Nagpur, Maharashtra presented the case of the appellant institution on 23/02/2021. In the appeal and during personal presentation it was submitted that "Land is held by society (Gopal Education Society, Nagpur) on long term lease of 30 years, building with built up area 14315.34 sq. fts. has been constructed by the society prior to 28.06.2005. Then society had applied for grant of recognition to Start Bhartiya Shikshan Mahavidyalaya (B.Ed. Course), Nagpur in that building. Hence as the building is on the name of the society, the question of acquiring premises on rent had never existed. The reason given by W.R.C. is totally erroneous as building is owned by the society."

AND WHEREAS Appeal Committee noted that appellant institution is conducting B.Ed. programme since the year 2006 in a building stated to have been constructed by

the society. The built up area mentioned by appellant in its appeal memoranda, however, falls short of the minimum requirement as per NCTE, Regulation, 2014. In the course of presentation, the appellant also submitted that they did not receive the show cause notice dt. 23/09/2020. In these circumstances, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to reissue their show cause notice to the appellant and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to send their reply to the show cause notice within 15 days of its receipt.

The institution has not submitted the "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs."

AND WHEREAS Sh. M. Jacob, Member, St. Lawrence College of Education, Arempula, Beside Warangal Highway, Khammam Rural, Khammam, Telangana presented online the case of the appellant institution on 23/02/2021. In the appeal and during personal presentation it was submitted that "It is not true on the part of SRC to make this deficiency. Our institution has made application for shifting of premises to own building and paid Rs.40,000/- as shifting fee. Further, SRC in its letter has demanded to remit fee of additional Rs.1,10,000/-. Accordingly, our institution has submitted additional Demand Draft for Rs.1,10,000/- vide D.D. No. 472060. Further, the SRC has conducted the inspection of our institution for shifting of premises on 19.08.2016. The SRC has considered the VT report of our institution in its 321st meeting of SRC and has issued

show cause notice to submit two documents. They are Original FDRs and faculty list. Accordingly, our institution in letter dated. 25.11.2016 has submitted the original FDRs and approved faculty list to SRC. Even today the original FDRs are with SRC office. We are submitting herewith the approved building plan for kind consideration of the Appeal Committee. It is to humbly submit that the site plan of the institution was very much part of the approved building plan. The site plan was clearly shown in the building plan. The plan as a whole was approved by the Arempula Gram Panchayat. We are submitting herewith the approved site plan for kind consideration of the Appeal Committee. It is to humbly submit that the approved staff list submitted by our institution in response to final show cause notice was duly approved by the Registrar, Kakatiya University, Warrangal and also counter signed by the dean, faculty of education. It is wrong on the part of SRC to say that the staff list is not signed by the Registrar. Further the two faculty members belongs to category of scheduled caste (SC). They are having PG percentage above 50 and as they belong to SC category, a 5 of relaxation is provided in the Rules. Both these staff members are also eligible as per NCTE Norms. Though there was no deficiency, SRC has made it as a point for withdrawal of recognition. We are submitting the approved staff list duly approved by the Registrar, Kakatiya University for kind consideration of the Appeal Committee. Original FDRs are with SRC office even today. Our institution has been maintaining endowment and reserve fund at all times. Further the FDRs are in joint account with SRC. It is to submit that our FDRs are in auto renewal mode.
