ORDER

WHEREAS the appeal of Shikhar Teacher Training Institute, Bholiyawas, Dist. – Neemuch, Madhya Pradesh dated 05/10/2019 is against the Order No. WRC/APW05968/223670/B.Ed./310th/2019/205841 dated 04.09.2019 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that “the Show Cause Notice was issued to the institution vide letter dated 21.12.2016 and reply received on 14.02.2017. The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice. Moreover, the staff profile for approved intake CLU, Building Completion Certificate, Building Plan & NEC are also not submitted in original. Hence, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.”


AND WHEREAS Sh. Arvind, Director and Sh. Hari Ram Muwal, Management Member, Shikhar Teacher Training Institute, Bholiyawas, Dist. – Neemuch, Madhya Pradesh presented the case of the appellant institution on 25/11/2019. In the appeal and during personal presentation it was submitted that they had received Show Cause Notice on 02/01/2017. They had immediately applied for issuing the Non-Encumbrance Certificate in the concerned office of Deputy Registrar, Revenue Department, Government of Madhya Pradesh, Neemuch on 03/01/2017. They requested Deputy Registrar for issuance of Non-Encumbrance Certificate as early as possible and they had also sent two reminders to the office of Deputy Registrar, Neemuch. But the Non-Encumbrance Certificate was received by the institute on 07.02.2017. Hence the delay was on the part of Government agency to issue the required certificate which led to the delay in submission of reply to the issued show cause notice. The copies of the letter written to Deputy Registrar, Revenue Department, Government of Madhya Pradesh, Neemuch are attached for reference.

This was the only pending document in the list of documents asked to submit by NCTE in show cause notice. Since this had to be the latest on the date of reply, immediately after receiving of NEC they sent the reply of show cause notice on 07.02.2017. The delay may please be condoned. The appellant also submitted that with their reply dt. 07/02/2017, they forwarded to the WRC original staff profile duly signed by the concerned affiliating body, viz. Vikram University, originally notarized CLU, NEC, Building plan and Building Completion Certificate. The appellant, with their appeal also submitted these documents.

AND WHEREAS the Committee noted from the file of the WRC that the replies sent by the appellant forwarding the desired documents including a letter dt. 09/01/2018 have been received and are available in the file. In these circumstances, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the documents submitted by the appellant and take further action as per the NCTE Regulations, 2014.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the documents submitted by the appellant and take further action as per the NCTE Regulations, 2014.

NOW THEREFORE, the Council hereby remands back the case of Shikhar Teacher Training Institute, Bholiyawas, Dist. – Neemuch, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Kabi Samrat Upendra Bhanja College of Teacher Education, Bhanjanagar, Ganjam, Orissa dated 30/09/2019 is against the Order No. ER-274.14.1/(ORS/E-2/96 & ERCAPP1862)/B.Ed./2019/61356 dated 22.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:- Faculty list comprises 1+5 instead of 1+15 for running two units (100 intake) of B.Ed. course. Faculties at sl. No. 2 & 3 are on part-time, not accepted. The submitted faculty is not as per NCTE Regulations, 2014. Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."


AND WHEREAS Ms. Sarojini Barai, Principal, Kabi Samrat Upendra Bhanja College of Teacher Education, Bhanjanagar, Ganjam, Orissa presented the case of the appellant institution on 25/11/2019. In the appeal and during personal presentation it was submitted that the filling of Vacancies of this College has already been taken of by School and Mass Education Department, Govt. of Orissa. The appointment of faculty will be made as per the NCTE Regulations. In the course of presentation, the appellant submitted a letter stating therein that the college is a fully Government owned institution and the deficiency of teachers will be fulfilled within the next one year.

AND WHEREAS the Committee noted that, while the ERC issued a recognition order under the provisions of the NCTE Regulations, 2014 on 31/05/2015 permitting the appellant to have two basic units of 50 each of B.Ed. course, the appellant has not

been able to provide the requisite academic staff for conducting this course till date. The appellant has not shown any progress in this regard and has given a vague promise that the needful will be done within the next one year. The Committee, noting that the B.Ed. programme cannot be run without the availability of the prescribed number of teaching staff, has concluded that the ERC was justified in withdrawing recognition and therefore, the appeal deserved to be rejected and the order of the ERC confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the ERC was justified in withdrawing recognition and therefore, the appeal deserved to be rejected and the order of the ERC is confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Shri Vardhmaan Shiksha Mahavidyalaya, Murwara, Khirahni, Katni, Madhya Pradesh dated 05/10/2019 is against the Order No. WRC/APW05743/223619/B.Ed./310th/2019/20609 dated 05.09.2019 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the Show Cause Notice was issued to the institution vide letter dated 30.11.2016 and reply received on 20.01.2017. The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice. Moreover, the staff profile for approved intake is not submitted in original. CLU & FDRs of 12 lakhs are also not submitted. Hence, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS Sh. Ankur Jain, President and Sh. Mayank Jain, Manager, Shri Vardhmaan Shiksha Mahavidyalaya, Murwara, Khirahni, Katni, Madhya Pradesh presented the case of the appellant institution on 25/11/2019. In the appeal and during personal presentation it was submitted that show cause notice was issued on 30.11.2016 and they have received the same on 06.12.2016. After receiving they have immediately applied on 07.12.2016 for the original copy of approved staff profile to the Rani Durgavati University, Jabalpur. In their request letter, they have requested to issue approved staff list as earliest as possible so that they could send it to NCTE on time and they had also sent two reminders to the affiliating body for early disposal but the original staff profile was signed by Registrar of Rani Durgavati University on 11.01.2017 which was received by the institute on 13.01.2017. The staff profile duly sealed and signed by the concerned affiliating body "Rani Durgavati University"


Jabalpur; original notarized CLU, NEC, building plan and Building Completion Certificate were submitted along with the reply dated 19.01.2017, as asked in show cause notice. Every paper was notarized attested true copy of original by notary person duly registered and authorized under Notary Act 1952 & Rule 1956. FDRs of rupees 8 lakhs has already been submitted to NCTE, WRC in the month of September 2014 as per the Rules. These FDRs have validity till 17.09.2019 as per the new norms of revised order, they have to submit FDRs of rupees 12 lakhs after maturing of these 8 lakhs FDRs which was due in the month of September 2019. However old FDRs of rupees 8 lakhs were not returned back to the institution. and they have also sent the information for the same to NCTE on 25.09.2019. The appellant, with their letter dt. 25/11/2019, submitted copies of two FDRs for Rs. 7 lakhs and Rs. 5 lakhs jointly taken with the Regional Director, WRC, with maturity date of 22/11/2024 as also a copy of the letter issued by Bank of Baroda. The appellant also enclosed to the appeal the documents submitted to the WRC.

AND WHEREAS the Committee noted that the documents sent by the appellant with reference to the Show Cause Notice to the WRC have been received and are available in the file. The appellant has since obtained the FDRs also. In these circumstances, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the documents already submitted and the FDRs to be submitted to them and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the WRC the originals of the two FDRs and originals of any other documents, if necessary, within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the documents already submitted and the FDRs to be submitted to them and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the

WRC the originals of the two FDRs and originals of any other documents, if necessary, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Shri Vardhmaan Shiksha Mahavidyalaya, Murwara, Khirahni, Katni, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Hills College of Teacher Education, Lekhi, District Papum Pare, Arunachal Pradesh dated 26/09/2019 is against the Order No. ER-274.14.95/(APE00531)/B.Ed./2019/61337 dated 22.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "1st show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 18.05.2019 on the following grounds: Faculty list not submitted. No reply received and the stipulated time period has already been over. Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

AND WHEREAS Ms. Manjula Manjari Mohapatra, Principal, Hills College of Teacher Education, Lekhi, District Papum Pare, Arunachal Pradesh presented the case of the appellant institution on 25/11/2019. In the appeal and during personal presentation it was submitted that the Show Cause Notice No. ERC/266.14(i).12/APE00531/ B.Ed./2019/59300, dated 10/02/2019 was received at college office on 1st April, 2019 containing the subject - Part Time Faculties are not accepted. No soft information was also received in this regard in between. In compliance, through letter no. HCTE/ADM-NCTE-Compl-I/Reg.2014/B.Ed/ 2018-19, dated 03/04/2019, the undersigned requested the Honourable Regional Director to give at least one month time for Fresh Advertisement-cum-Appointment. To make it further clear, it is mentioned here that the Notification was issued on 16th April, 2019 and interview was scheduled for 12th May, 2019. But due to some unavoidable circumstances, the same was re-scheduled for 8th June, 2019 with proper intimation to the public through college website and the local News Paper. Then, in between the next Show Cause Notice No. ERC-272.14.27/APE00531/B.Ed./2019/60757, dated

17/06/2019 was issued by the Regional Office containing the same and single matter-Fresh Faculty List to be submitted to the Regional Office. In compliance, the undersigned explained the matter in detail to the Regional Director and submitted the current and approved list containing sixteen(16) Faculty Members vide letter no. No. HCTE/ADM-NCTE-Compl-II/Reg.2014/B.Ed./ 2018-19, dated 23/07/2019 which was received at the Regional Office on or before 30th July, 2019 as per Postal Tracking record. (Please find the compliance letter and the Faculty List enclosed). Lastly, to comply with the proceedings of 274th Meeting of the ERC, NCTE held on 15th & 16th July, 2019, the undersigned has also explained the matter through personal visit to the Regional Office on 17th July, 2019 and vide letter no. HCTE/ADM-NCTE-Compl-III/Reg.2014/B.Ed/2018-19, dated 30/07/2019. The undersigned had also appealed to the Regional Director vide letter no. HCTE/ADM-NCTE-Compl-IV(Appeal)/Reg.2014/B.Ed./2018-19 dated 03/08/2019 before issue of the Order for Withdrawal of Recognition for B.Ed. Course from the academic session 2020-21, on 22nd August, 2019 to consider the matter. The realities may further be enquired from the Vice-Chancellor of the Affiliating University i.e. Rajiv Gandhi University, Dr. Joram Muthu, State Representative to ERC, NCTE, Bhubaneswar from the Directorate of Higher Technical Education and from any other valid quarters if applicable. This is for your information and kind consideration please.


AND WHEREAS the Committee noted from the file that the ERC issued a Show Cause Notice dt. 10/02/2019, pointing out that a faculty list of 15 faculty members only was submitted instead of 16 as per NCTE Regulations, 2014 and out of them three faculties are on part – time basis, which is not accepted. The appellant sent a reply dt. 03/04/2019 requesting at least one month's time to appoint fresh teachers on regular basis. This letter has been received in the ERC on 15/04/2019 and is available in their file. The ERC issued another Show Cause Notice on 17/06/2019 pointing out that faculty list is not submitted. The reply of the appellant dt. 23/07/2019 to this Show Cause Notice is however not available in the file. The appellant, with the appeal, enclosed a copy of their reply with a copy of the speed post receipt dt. 26/07/2019. The appellant enclosed to that letter a copy of the approved faculty list.

The appellant in the course of presentation also submitted a copy of the faculty list approved by the Registrar, Rajiv Gandhi University, Rono Hill, Doimukh, Arunachal Pradesh.

AND WHEREAS in view of the position stated above, the Committee concluded that the matter deserved to be remanded to the ERC with a direction to consider the approved faculty list to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, the approved staff list submitted in appeal, within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the ERC with a direction to consider the approved faculty list to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, the approved staff list submitted in appeal, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Hills College of Teacher Education, Lekhi, District Papum Pare, Arunachal Pradesh to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Prabharani Institute of Education (Physical Education College), Vill.+PO – Chanak, Nabagram, Murshidabad, West Bengal dated 01/10/2019 is against the Order No. ER-272.14.119/APE00692/B.P.Ed./2019/60683 dated 14.06.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.P.Ed. Course on the grounds that “Show Cause Notices u/s 17(1) were issued on 01.04.2019 & 18.05.2019. The institution vide letter dated 16.04.2019 stated that due to non-admission of 100 students (one basic unit) with two sections of 50 each as per Norms in last three years, they compelled to run one section with less number of students than the basic unit. The institution has failed to comply the conditions of SCN and does not fulfil the basic unit of 100 students as per NCTE Regulations, 2014. In view of the above, the Committee decided as under: The Committee is of the opinion that recognition granted to B.P.Ed. course of the application bearing Code No. APE00692 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.”


AND WHEREAS Ms. Madhumita Samajdar, President and Sh. Sujit Maitra, Member, Prabharani Institute of Education (Physical Education College), Vill.+PO – Chanak, Nabagram, Murshidabad, West Bengal presented the case of the appellant institution on 25/11/2019. In the appeal and during personal presentation it was submitted that the institution applied for 50 intake and submitted relevant documents according to the norms of NCTE for 50 intake, but NCTE ordered to take 100 intake and to furnish relevant documents for 100 intake. The appellant, in their letter dt. 24.11.2019, submitted that they have made arrangement for the required faculty approved by the Competent Authority of the affiliating body. The appellant has enclosed to this letter a copy of the faculty list, inter-alia, consisting of a Principal, two Associate Professors and Six Assistant Professors, approved by the Registrar,

AND WHEREAS the Committee, noting that the appellant has met the requirements of faculty for 100 students, concluded that the matter deserved to be remanded to the ERC with a direction to consider the documents to be submitted to them and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the approved staff list and copies of other documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the ERC with a direction to consider the documents to be submitted to them and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the approved staff list and copies of other documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

WHEREAS the appeal of Sipajhar B.Ed. College, PO-Sipajhar, Dist. – Darrang, Assam dated 12/09/2019 is against the Order No. ER-274.14.99/(APE00314)/2019/61367 dated 22.08.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that “1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 28.11.2018 on the following grounds:- Faculty list comprising 10 instead of 16 as per NCTE Regulations, 2014, which is not in the NCTE prescribed proforma. Total land area and built-up area not mentioned in the building plan. Building Completion Certificate is not in the NCTE prescribed proforma. Photocopy of two FDRs, of Rs. 5 lakh and 11 lakh are in single mode i.e. in the name of institution only instead of jointly operation mode with RD, ERC, NCTE, Bhubaneswar. No reply received and the stipulated time period has already been over. Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.”


AND WHEREAS Dr. Z. Nath Sarmah, President and Rajani Kanta Nath, Secretary, Sipajhar B.Ed. College, PO-Sipajhar, Dist. – Darrang, Assam presented the case of the appellant institution on 25/11/2019. In the appeal and during personal presentation it was submitted that the reply of the first show cause notice was given on 05.05.2018, vide Memo No. SPJ/B.Ed./NCTE/2018/722. The final show cause notice was not received till date. Principal-1 and teacher-15 have already been appointed. The list of faculty members with approval from the affiliating University i.e. Gauhati University is enclosed. The College authority owns a total land area of 14721 sq. mts. in its own name. Copy of the land holding certificate from the Land Revenue Authority, Government of Assam is enclosed. The College has a built up area of 2871

sq. mts. Land Use Certificate is enclosed. Building Completion Certificate in the prescribed form is enclosed. Copies of FDRs with joint operation mode are enclosed. Copy of building plan is enclosed.

AND WHEREAS the Committee, noting that the appellant has submitted the documents found wanting in the withdrawal order, concluded that the matter deserved to be remanded to the ERC with a direction to consider the documents to be submitted to them by the appellant, and take further action as per the NCTE, Regulations, 2014. The appellant is directed to forward to the ERC all the documents submitted in appeal, with originals thereof, wherever necessary within 15 days of receipt of orders on the appeal.

The appellant is directed to forward to the ERC all the documents submitted in appeal, with originals thereof, wherever necessary within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Sipajhar B.Ed. College, PO-Sipajhar, Dist. – Darrang, Assam to the ERC, NCTE, for necessary action as indicated above.

Education Society, Kreeda Maharshi Meghnath Nageshkar College of Physical Education, Tardal, Hatkangle, Kolhapur, Maharashtra dated 08/10/2019 is against the Order No. WRC/OAPW0327/111423/311th/2019/206844-206851 dated 14.10.2019 of the Western Regional Committee, confirming the earlier withdrawal order dt. 05/09/2017 for conducting for B.P.Ed. Course on the grounds that "on perusal of the replies of the institution dt. 18/06/2018 and 09/06/2018, the Committee observed that the institution has submitted staff list of 1+7 faculty which is inadequate as per Appendix - 7 of NCTE Regulations, 2014. Staff profile is not approved by the affiliating University. FDRs of Rs. 5+3 lakhs are not submitted in original and also additional required FDR Rs. 4 lakhs are not submitted by the institution. Building Completion Certificate is not in proper format and also not issued by Competent authority."

AND WHEREAS Sh. Sanjay D. Bagul, I/c Principal and Sh. Shankar L. Gonugade, Assistant Professor, D.K.T. Education Society, Kreeda Maharshi Meghnath Nageshkar College of Physical Education, Tardal, Hatkangle, Kolhapur, Maharashtra presented the case of the appellant institution on 25/11/2019. In the appeal and during personal presentation it was submitted that they have already published an advertisement of the post Principal and Librarian but they are not getting eligible candidates for those posts. They are getting permission for re-advertisement from their affiliating university and will fill the Principal and Librarian post. When they get the permission for the vacant teachers posts also from their affiliating university as per new NCTE norm 2014 they will work on it when they get the permission as per new roster as per vacant post from the BC cell Pune office. We will fill all vacant posts on priority basis. We get the stamp & sign of authority of our affiliating university on our 03 regular staff profile those are working in the college. We have already

submitted FDR of 3 lacks to WRC NCTE office also we have an original FDR Rs. 5 lacks and as per your demand we are in the process to do additional FDR Rs.4 lacks as soon as we will get the receipt, we will submit both to WRC NCTE office. Our college is run in rural area so we get seal & sign on building completion certificate by sarpanch & Gram Sevak & we send proposal for sign to PWD office as soon as we get the same, we will send on priority basis.

AND WHEREAS the Committee noted that the appellant has not been able to furnish a full faculty list approved by the affiliating body as per the NCTE norms. A copy of the building completion certificate issued by Gram Panchayat Authorities shows that the entire built up area in the ground floor is having MS struss GI Sheets roofing only. According to the provisions of Clause 8 (7) of the NCTE Regulations, 2014 no temporary structure or asbestos roofing shall be allowed in the institution, even if it is in addition to prescribed built up area.

AND WHEREAS the Committee, in view of the above deficiencies, concluded that the appeal deserved to be rejected and the order of the WRC confirmed.

AND WHEREAS after perusal of the memorandum of appeal, affidavit, the documents available on records and considering the oral arguments advanced during the hearing, the Committee, considering the deficiencies, concluded that the appeal deserved to be rejected and the order of the WRC confirmed.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

LUC of Khasra no. 1114/516, 286 not submitted and submitted LUC of Khasra no. 516/2 is for residential purpose. NOC of affiliating body for proposed course of session 2017-18 not submitted. Name of College mentioned in submitted affiliation order and online application differs. So, the institution fails to prove that it is a composite institution as per NCTE Regulations, 2014. The institution has submitted the approved Building Plan signed by the Competent Govt. Authority, however, the details with regard to the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc., have not been indicated thereon. Hence, the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

AND WHEREAS the appellant filed a S.B. Civil Writ Petition No. 12919/2019 before the Hon'ble High Court of Judicature for Rajasthan at Jodhpur. The Hon'ble High Court, in their order dt. 17/09/2019, dismissed the petition with a direction that the petitioner may prefer an appeal, along with an application seeking condonation of delay and if such application for condonation of delay is filed, the Appellate Authority will obviously decide the same in accordance with law.

AND WHEREAS the submission of the appeal has been delayed by two years, four months and 13 days beyond the prescribed period of 60 days.
