ORDER

WHEREAS the appeal of Vidyasagar College of Education, Rupandighi, Phansidewa, Darjeeling, West Bengal dated 15/02/2020 is against the Order No. ER-278.43/APE00736/B.Ed./2020/62263 dated 17.02.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "list of teaching faculty is not duly approved by the affiliating body as per Appendix-4 of NCTE, Regulations, 2014."

AND WHEREAS Dr. Savita Mishra, Principal, Vidyasagar College of Education, Rupandighi, Phansidewa, Darjeeling, West Bengal presented online the case of the appellant institution on 23/07/2020. In the appeal and during personal presentation it was submitted that "The Teaching Faculty list, duly approved by Affiliating Body, comprising of 1+15 faculty, was sent (13.05.2019) to ERC, NCTE, Bhubaneswar. However, it was not in prescribed format. List of approved Faculty members, counter signed by the Affiliating Body (The West Bengal University of Teachers' Training, Education Planning & Administration, Kolkata), in prescribed format is enclosed. The approved Faculty list in prescribed format countersigned by the Affiliating University has also been submitted to ERC, NCTE, Bhubaneswar on 04 February 2020 through e mail, followed by post copy on 06 February 2020 with reference to minutes of ERC 278th meeting dated 16-18 January 2020, uploaded in the web site. Physical attendance of Faculty members is also captured in College through Bio Metric system since August 2019 and uploaded in College web site on weekly basis."

AND WHEREAS Appeal Committee noted that appellant institution was initially granted recognition to conduct B.Ed. course with an intake of 100 seats from the year 2008 – 2009. Appeal Committee further noted that revised recognition order under NCTE Regulation, 2014 was issued in 2015 subject to fulfilment of certain conditions

such as (a) enhancement of built up area, (b) additional infrastructure, (c) additional fund, (d) additional staff and maintenance of upto date website etc. Appeal Committee noted that whereas the appellant institution had complied to the conditions of revised recognition order, the list of teaching faculty submitted by it was not found to be in prescribed performa (Appendix – IV) and approved by affiliating university. Appeal Committee further noted that appellant institution alongwith appeal memoranda has submitted copies of the lists of faculty approved by affiliating university from 2017 onwards.

AND WHEREAS Appeal Committee noted that appellant institution had already forwarded the original of the faculty list to ERC which is seen received in the office of ERC on 10/02/2020 and available on the regulatory file. Appeal Committee, therefore, decided to remand back the case to ERC for revisiting the matter in the context of decision taken in 278th Meeting of ERC held on 16th to 18th January, 2020 and impugned withdrawal order dated 17/02/2020.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online submission made by appellant, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Vidyasagar College of Education, Rupandighi, Phansidewa, Darjeeling, West Bengal to the ERC, NCTE, for necessary action as indicated above.

The above decision is being communicated on behalf of Appeal Committee.

ORDER

WHEREAS the appeal of Haladhar Mahato Teachers Training Institute (B.Ed.), Dighi, Manbazar - II, Purulia, West Bengal dated 19/02/2020 is against the Order No. ER-278.82/ERCAPP736/B.Ed./2020/62258 dated 05.02.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Original list of teaching faculty duly signed by the affiliating body as per NCTE Regulation, 2014 has not been submitted."

AND WHEREAS Sh. Hiralal Mahato, President and Sh. Jagadish Mahato, Founder Secretary, Haladhar Mahato Teachers Training Institute (B.Ed.), Dighi, Manbazar - II, Purulia, West Bengal presented the case of the appellant institution on 23/07/2020. In the appeal and during personal presentation it was submitted that "we have uploaded all the required data along with all faculty details (Teachers List) duly signed by the affiliated authority as per par format on 01/01/2020. In spite of that we have come to know from the minutes of 278th meeting of the ERC held on 16th—18th January, 2020 that "the original list of teaching faculty duly signed by the affiliating body as per NCTE Regulation 2014 has not been submitted". This may be due to congestion of your website or somehow deleted from the record. We have informed all detail through mail. In the meantime, affidavit and hard copy was to sent NCTE and ERC office, Bhubaneswar two times."

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 05/02/2020 is on the ground that appellant institution has not submitted original list of teaching faculty duly signed by the affiliating body, Appellant during the course of appeal hearing on 23/07/2020 submitted before Appeal Committee that list of faculty as approved by affiliating body on 31/12/2019 was uploaded on 01/01/2020. Appeal

Committee having regard to the fact that appellant institution is recognised to conduct B.Ed. course since 2012 decided that it should be given an opportunity to submit original of the list of faculty with approval letter of affiliating body to ERC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Haladhar Mahato Teachers Training Institute (B.Ed.), Dighi, Manbazar_II, Purulia, West Bengal to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Sree Sree Ramakrishna B.Ed. College, Nischintapur, Kulpi, South 24-Pargana, West Bengal dated 25/02/2020 is against the Order No. ER-278.80/(APE00749)/B.Ed./2020/62257 dated 05.02.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Building Completion Certificate (BCC) is not duly signed by the competent authority. Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021."

AND WHEREAS Sh. D. Vikram Das, President, Sree Sree Ramakrishna B.Ed. College, Nischintapur, Kulpi, South 24-Pargana, West Bengal presented online the case of the appellant institution on 23/07/2020. In the appeal and during online presentation it was submitted that "we have submitted the BCC Certificate, but last page was not duly signed by the Competent Authority."

AND WHEREAS Appeal Committee noted that appellant institution was granted recognition for conducting B.Ed. course with an intake of 100 seats from the academic session 2009-10. Revised recognition order under NCTE Regulation, 2014 was issued on 27/05/2015 with an intake of 100 seats from academic session 2015-16.

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 05/02/2020 is on only one ground i.e. 'Building Completion Certificate (B.C.C.) is not duly signed by Competent Authority.' In this regard, Appeal Committee noted that appellant institution in response to Show Cause Notice (SCN) dated 21/02/2019 had submitted to ERC few photographs of college building and copy of certificate dated 21/05/2019 issued by Block Land and Land Reform Officer, South 24 Pargana,

Government of West Bengal. Though this certificate was not in the prescribed performa yet it had a mention of total land area (4896 sq. meters) and total built up area of 3625 sq. meters. Keeping in view that appellant institution is recognised for the last 10 years and possess adequate built up area, withdrawal of recognition only on the ground that B.C.C. is not duly signed is considered to be a harsh measure.

AND WHEREAS Appeal Committee noted that appellant, of late has been able to obtain a B.C.C. in prescribed Performa which is signed by Nirman Sahayak, Belpukur Gram Panchayat, South 24 Pargana and is countersigned by Pradhan, Balpukur Gram Panchayat. Appeal Committee decided that appellant institution is required to submit this B.C.C. in original to the office of ERC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online presentation made by appellant, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Sree Sree Ramakrishna B.Ed. College, Nischintapur, Kulpi, South 24-Pargana, West Bengal to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of S.M. Krishna College of Education, Davanagere, Kailas Road, Davangere, Karnataka dated 18/02/2020 is against the Order No. SRO/NCTE/APSO2066/B.Ed/KA/2019/13015 dated 10.12.2019 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the institution was issued Final Show Cause Notice on 14.10.2019. But the institution has not yet submitted its reply till date."

AND WHEREAS Sh. Gangadhar, Principal, S.M. Krishna College of Education, Davanagere, Kailas Road, Davangere, Karnataka presented online the case of the appellant institution on 23/07/2020. In the appeal and during online presentation it was submitted that "SRC has mentioned that it has issued final Show Cause Notice whereas our institution has not received any notice from NCTE. Neither we have been given any reminder. The affiliating university has called our institution and informed that the SRC, NCTE has withdrawn recognition of our institution. Thereafter we saw the decision in the website. Thereafter we contacted SRC and obtained a xerox copy of the withdrawal order. Further we submit that our institution is 16 years old institution and one of the best academic record holders in the University. Further, our institution is in our own land and building from the starting of the college. We have all the facilities as per the NCTE Regulations. We were not given reasonable opportunity to submit the documents to SRC. We are submitting herewith all the documents as required under Regulations for kind perusal of the Appeal Committee. Inspite of having all the facilities, infrastructure,

instructional and staff as per NCTE Regulations, our institution recognition has been withdrawn. We humbly request to peruse the documents submitted."

AND WHEREAS Appeal Committee noted that appellant institution was granted recognition for conducting B.Ed. course with an intake of 100 seats from the academic session 2006-07. After issue of revised recognition order dated 29/05/2015 under NCTE Regulation, 2014 for 100 seats, the appellant had requested SRC by its letter dated 14/06/2016 for reduction in the intake from 100 seats to 50 seats. SRC informed the appellant institution by its letter dated 13/02/2017 that its request for reduction in the intake has been accepted and fresh formal recognition under 2014 Regulations will be issued after the appellant institution submits the list of faculty according to the changed norms. Appeal Committee noted that two Show Cause Notice (SCN) dated 26/04/2019 and 14/10/2019 were issued to appellant institution. Appeal Committee noted that whereas appellant institution has failed to submit reply to SRC's letter dated 13/02/2017 and the two SCNs dated 26/04/2019 and 14/10/2019, SRC has also failed to appreciate that appellant institution, with its request for reduction in intake having been made and accepted, was not required to create additional facilities. Appellant with its appeal memoranda has attached copies of building plan, building completion certificate, FDRs and list of faculty approved by affiliating university. Having noted that appellant institution is functioning since 2006-07, Appellant institution is required to submit a consolidated reply to the S.C.N. to SRC enclosing therewith all required documents within 15 days of the issue of Appeal order. Appeal Committee decided to remand back the case to SRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of the Appeal, affidavit, documents on record and online presentation made by appellant, Appeal Committee concluded to remand back the case to SRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of S.M. Krishna College of Education, Davanagere, Kailas Road, Davangere, Karnataka to the SRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Vinayak College of Education, Kotputli, Dabla Road, Kotputli, Jaipur, Rajasthan dated 24/02/2020 is against the Order No. NRC/NCTE/RJ-1635/225th Meeting/2013/78240-243 dated 26.08.2014 of the Western Regional Committee, refusing recognition for conducting for B.Ed. Course on the grounds that "the institution has requested to consider its application after the ban imposed by the State Govt. is lifted."

AND WHEREAS Sh. Akhilesh Agarwal, Chairman and Sh. Tejasvi Agarwal, Secretary, Vinayak College of Education, Kotputli, Dabla Road, Kotputli, Jaipur, Rajasthan presented the case of the appellant institution on 23/07/2020. In the appeal and during personal presentation it was submitted that the Regional director has not considered the NOC available from the State Govt. in our case in the year 2008 itself and for their own wrong decision at every stage, took shelter of ban imposed by State Govt. on B.Ed. course. There was no ban in the year 2008 and our institute should be deemed as old institute for purposes to grant us recognition of B.Ed. course as our institute stand equally with all other colleges to whom recognition was granted in the year 2008. Even the State Govt.'s first letter dated 17.11.08 vide which they imposed restrictions to grant recognition to any new colleges was not applicable to our case as we have applied for approval in the year 2008-09 and does not fall under the category of "new" college for the purpose of State Govt.'s such restrictions. That we are regularly losing opportunities and incurring losses on account of non-proper utilisation of resources which are lying idle for last more than 10 years for one reason or another and just because of wrong decisions of NRC at different stages. We have been following regularly since long to get some decision of NRC and finally came to know about rejection order 26.08.2014 on 20.02.2020 from the office of western regional council,

NCTE, Dwarka, Delhi where this case has been shifted now. We have obtained copy of this letter by hand, hence this appeal with request to condone the delay in filing the same as the reasons for delay are far from our control. NRC itself has not mentioned any fact about withdrawal of file by society in any of its communication/refusal order dated 10.01.2012 and not represented this at the time during the hearing of the case in appeal and anytime thereafter at any stage in any of its show cause notices etc. We reiterate that no such request letter has been sent by any of the authorised signatory of the society and it seems to be afterword story to defeat somehow our case. written at each stage that we are sound enough and having capacity to run the course effectively and we are ready since 2008-09 vide another letter dated 24/01/2012. Regional Director has quoted one letter dated 08.02.2011 from society in their order and issued one more show cause on 23.10.2013 on that basis. Society never wrote any such letter and not received any show cause notice dated 23.10.2013 which is mentioned in rejection order date 26-08-2014. Our college fulfil all measures and maintains all required standards as per guidelines of NCTE since 2008-09 and we have developed whole required infrastructure after investing lot of funds in that year from the hard earned money of our society members for obtaining B.Ed. Course approval. Baseless ground. No clarity of any kind."

AND WHEREAS Appeal Committee noted that appellant institution had submitted application in the year 2007 seeking recognition for B.Ed. course. The application was processed in the office NRC and first refusal order was issued on 10/01/2012. Appellant preferred appeal dated 27/02/2012 against the refusal order and Appellate Authority by its order dated 18/04/2012 remanded back the case to NRC with a direction to examine the entire matter taking into account the reply of appellant institution to the Show Cause Notice (SCN) dated 30/08/2011.

AND WHEREAS Appeal Committee noted that while the case of appellant institution was being processed by NRC and a SCN dated 23/10/2013 was also issued, NRC came across a letter signed by Secretary, Pawan Tanay Education Society and received in the office of NRC on 08/02/2011 (Dy. No. 19805) which stated that financial

position of applicant society is not good and its application be returned with Fix Deposit Receipts to enable recover the financial status. Appeal Committee noted that above letter bears the same signature which are appended on the application seeking recognition.

AND WHEREAS Appeal Committee noted that after NRC noticed this letter a S.C.N. dated 23/10/2013 was issued to appellant institution seeking its written representation within 30 days. Appeal Committee noted that after considering reply dated 16/01/2014 of the appellant institution, the application seeking recognition was refused as appellant in its letter had requested that its application be considered after the ban imposed by State Government is relaxed.

AND WHEREAS Appeal Committee noted that impugned rejection order dated 26/08/2014 allowed the applicant 60 days time to prefer appeal in terms of Section 18 of the NCTE Act and Rules framed thereunder. Appellant did not prefer any appeal and from the regulatory file it is observed that appellant addressed a letter to NRC in September, 2019 stating that it had not received any final order in its case.

AND WHEREAS Appeal Committee noted the submission made by appellant on 23/07/2020 stating that management Committee of the applicant society had undergone a change on 08/02/2011 and the letter dated 08/02/2011 signed by Mr. Umesh Saran Bansal seeking return of application and Fix Deposit Receipts was not valid.

AND WHEREAS Appeal Committee noted that appellant institution by a letter dated 20/02/2020 enclosed with the appeal memoranda has requested for condonation of delay in preferring appeal. Appellant has quoted its reminder letters dated 15/01/2014, 28/04/2015, 12/09/2016 and 14/02/2018, 18/09/2019 and stated that he had personally visited the office of NRC several times and every time he was told that their case will be considered in the next meeting.

AND WHEREAS Appeal Committee noted that after issue of impugned rejection order dated 26/08/2014, the first communication received and available on regulatory file is dated 18/09/2019. Certainly, there was a long delay of more than 5 years in preferring appeal. Moreover, the NCTE had come up with revised NCTE Regulation in 2009 and 2014 and the application made by appellant institution is of 2007. With the changed Norms and Standards for B.Ed. course, the old applications have no relevance at this stage. Appeal Committee decided (i) not to condone the delay in preferring appeal, (ii) confirm the impugned rejection order dated 26/08/2014. Applicant is however, free to apply fresh as and when NCTE issues notification inviting applicant for the course.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded (i) not to condone the delay in preferring appeal (ii) confirm the impugned rejection and dated 26/08/2014 issued by NRC.

NOW THEREFORE, the Council hereby confirms the Order appealed against.

ORDER

WHEREAS the appeal of Nikhil Banga Sikshan Mahavidyalaya, Bishnupur, Bankura, West Bengal dated 20/02/2020 is against the Order No. ER-278.48/APE00336/B.Ed./2020/62262 dated 06.02.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "list of teaching faculty submitted by the institution is not as per Appendix-4 of NCTE, Regulation, 2014."

AND WHEREAS Dr. Bhim Chandra Mondal, Principal, Nikhil Banga Sikshan Mahavidyalaya, Bishnupur, Bankura, West Bengal presented online the case of the appellant institution on 23/07/2020. In the appeal and during personal presentation it was submitted that "Nikhil Banga Sikshan Mahavidyalaya has submitted the faculty list having 8 (eight) faculty members duly approved by Registrar of affiliating University which is as per NCTE, Regulation – 2014."

AND WHEREAS Appeal Committee noted that appellant institution was granted recognition for conducting B.Ed. course with an intake of 100 seats by an order dated 12/03/2007. The appellant institution while seeking revised recognition under NCTE Regulation, 2014 sought recognition for only 50 seats and revised recognition order dated 27/05/2015 was accordingly issued for one unit (50 seats). Appeal Committee noted that staffing pattern as mentioned in Appendix – 4 of NCTE Regulation, 2014 is for intake of 2 units of 50 seats totalling 100 seats. Appeal Committee noted that wherever, applicants opted for seeking recognition of only one unit, the one each faculty required in Health/Physical Education, Fine Arts and Performing Arts (Music/Dance/Theatre) cannot be proportionately divided. Appellant institution has forwarded with its appeal memoranda a list containing the names of 1 Principal and 7

faculty members. The list is approved by the affiliating body on 14/08/2019 and the faculty covers subjects like History, Bengali, Education, Physical Science, Life Science etc. If ERC was not satisfied with distribution of faculty subject wise, it should have clearly mentioned the fact in the Show Cause Notice. Appeal Committee noted that for an intake of 100 seats 2 faculty to teach language are required. Proportionately divided for 50 seats one faculty to teach language is required and appellant institution has Dr. Santanu Golui as faculty for Teaching Bengali.

AND WHEREAS Appeal Committee decided to remand back the case to ERC for revisiting the matter considering the list of faculty submitted by appellant institution by its letter dated 27/08/2019.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during online presentation of the case, Appeal Committee concluded to remand back the case to ERC for revisiting the matter considering the list of faculty submitted by appellant institution by its letter dated 27/08/2019.

NOW THEREFORE, the Council hereby remands back the case of Nikhil Banga Sikshan Mahavidyalaya, Bishnupur, Bankura, West Bengal to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of District Institute of Education and Training (DIET), Bagrul, Hardiya, Harda, Madhya Pradesh dated 31/01/2020 is against the Order No. WRC/APP2513/222/268th/MP/2016/180117 dated 14.02.2017 of the Western Regional Committee, refusing recognition for conducting for D.El.Ed. Course on the grounds that "Show Cause Notice was issued to the institution for inadequacy of teaching faculty. The institution has not satisfactorily responded to the SCN. The institution has submitted a staff list where only four faculty members have been appointed whereas the requirement one Principal and seven faculty members. Hence recognition is refused."

AND WHEREAS Sh. Manoj Jain, Principal, District Institute of Education and Training (DIET), Bagrul, Hardiya, Harda, Madhya Pradesh presented the case of the appellant institution on 23/07/2020. In the appeal and during personal presentation it was submitted that at the time of refusal there were only four faculty members posted in the institution. Now Department has posted 8 faculty members. So, we have fulfilled the requirements of NCTE for granting recognition for 2 years D.El.Ed. Program.

AND WHEREAS Appeal Committee noted that all District Institute of Education and Training (DIET) operate under a scheme funded by the Ministry of Human Resource Development (Government of India) in conjunction with the respective State Government. Appointment of faculty in DIETs is regulated by posting / transfer policy of the Government. Creation of posts and filling up of resultant vacancies involves decision making at different levels and adherence to financial proprieties. Recognition was rightly refused by WRC when the DIET was unable to submit list of faculty as per NCTE Regulations. Appeal Committee noted that appellant institution had already forwarded to WRC on 03/05/2017 a list containing the name of Principal and required

number of faculty, Appeal Committee decided to remand back the case to WRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of District Institute of Education and Training (DIET), Bagrul, Hardiya, Harda, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.
