### ORDER

**WHEREAS** the appeal of Gyandeeep Degree College, Newada, Tadiyawan, Hardoi, Lucknow, Uttar Pradesh dated 13/01/2021 is against the Order No. NCTE / NRC / NRCAPP201616097 / Bachelor of Elementary Education[B.El.Ed.]/UP/2017-2018/2; dated 28.01.2017 of the Northern Regional Committee, refusing recognition for conducting for B.El.Ed. Course on the grounds that "the applicant institution has not submitted the reply of the SCN within the stipulated time. Hence, the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution."

**AND WHEREAS** Dr. Gyanendra Pratap Singh, Manager, Gyandeeep Degree College, Newada, Tadiyawan, Hardoi, Lucknow, Uttar Pradesh presented the case of the appellant institution on 24/02/2021. In the appeal and during personal presentation it was submitted that "Gyandeeep Degree College Nevada Hardoi had applied online in NCTE on 31.05.2016 for recognition of B.El.Ed. course and on 16.05.2016 the college manager applied for NOC for affiliation of B.El.Ed. course in the previous affiliated CSJM University Kanpur but Kanpur university did not provide NOC to the college. After this, even after the issuance of show cause notice by the NCTE, the college manager applied for NOC in the concerned university but still the university did not provide NOC. After this, the college manager could not reply to the show cause notice sent by the NCTE due to which the said application was cancelled by NCTE on 28.03.2017. After this, by UP Govt in December 2020, all the colleges of Hardoi district were shifted from CSJM University Kanpur to Lucknow University, Lucknow and after this, the manager of Gyan

deep Degree College Nevada Tadiyawan, Hardoi, to get the NOC of B.El.Ed. Lucknow University applied in Lucknow, after which NOC has been given on 03.01.2021. Therefore, please grant the application file to be restarted to provide recognition for the B.El.Ed. course."

**AND WHEREAS** the submission of the appeal has been delayed by three years, seven months and 16 days beyond the prescribed period of sixty days.

**AND WHEREAS** the Committee noted that according to the provisions of Section 18 (1) of the NCTE Act, 1993, any person aggrieved by an order made under Section 14 or Section 15 or Section 17 of the Act may prefer an appeal to the Council within such period as may be prescribed. According to the provisions of Rule 10 of the NCTE Rules, 1997, any person aggrieved by an order made under the above mentioned Sections of the Act may prefer an appeal to the Council within sixty days of issue of such orders. According to the provisions of Section 18 (2) of the NCTE Act, no appeal shall be admitted if it is preferred after the expiry of the period prescribed therefor; provided such an appeal may be admitted after the expiry of the period prescribed therefor, if the appellant satisfied the Council that he had sufficient cause for not preferring the appeal within the prescribed period.

**AND WHEREAS** the Committee noted that the appellant, in the appeal, has not given any reason, whatsoever, for not preferring the appeal within the prescribed period. In these circumstances, the Committee decided not to admit the appeal on grounds of delay of three years and seven months.

**AND WHEREAS** after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee noted that the appellant, in the appeal, has not given any reason, whatsoever, for not preferring the appeal within the prescribed period. In these circumstances, the

Committee decided not to admit the appeal on grounds of delay of three years and seven months.

**ORDER**

**WHEREAS** the appeal of Late Shri Govindrao Wanjari College of Education, Borkhedi (Gate), Bori Post Office, Wardha Road, Nagpur (Gramin), Nagpur, Maharashtra dated 13/01/2021 is against the Order No. WRC/APW01782/123241/321<sup>st</sup>/2020/213289 dated 01.01.2021 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 09.08.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 09.10.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

**AND WHEREAS** Dr. Bharti Sharma, Principal, Late Shri Govindrao Wanjari College of Education, Borkhedi (Gate), Bori Post Office, Wardha Road, Nagpur (Gramin), Nagpur, Maharashtra presented online the case of the appellant institution on 24/02/2021. In the appeal and during online presentation it was submitted that "Appellant society had constructed the college building on the land purchased by the society and the college was shifted to the building on 15<sup>th</sup> August 2008 within three years from the date of recognition. The appeal, also submitted that they had sent reply to the Show Cause Notice dated 09/10/2020 on 16/10/2020 by speed post. The appellant enclosed a copy of the said reply and a copy of the track report showing that the article was delivered to the addressee on 26/10/2020."

**AND WHEREAS** Appeal Committee noted that appellant institution is conducting B.Ed. programme since 2005 and the present intake of the programme is one unit (50




seats). Appellant during its online submissions pointed out that reply to Show Cause Notice dated 09/10/2020 was sent by speed post on 16/10/2020 and track report indicates its delivery at the receiving end. The Committee, in the above circumstances, concluded that the matter deserved to be remanded to the WRC with a direction to consider the appellant's reply dated 16/10/2020 to the Show Cause Notice, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC again a copy of their reply dt. 16/10/2020, within 15 days of receipt of orders on the appeal.

**AND WHEREAS** after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee concluded to remand back the case to WRC with a direction to consider the appellant's reply dated 16/10/2020 to the Show Cause Notice, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC again a copy of their reply dt. 16/10/2020, within 15 days of receipt of orders on the appeal.

**NOW THEREFORE**, the Council hereby remands back the case of Late Shri Govindrao Wanjari College of Education, Borkhedi (Gate), Bori Post Office, Wardha Road, Nagpur (Gramin), Nagpur, Maharashtra to the WRC, NCTE, for necessary action as indicated above.

**ORDER**

**WHEREAS** the appeal of Modern Teachers Training Girls College, Sainik Basti, Akashwani Road, Churu, Rajasthan dated 09/01/2021 is against the Order No. WRC/NCTE/RJ-777/STC/321<sup>st</sup>/2020/212685 dated 14.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for D.El.Ed. Course on the grounds that "Recognition was granted to the institution on 17.08.2007 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Notice was issued to the institution on 30.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of the above, the Committee decided that the recognition of STC programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

**AND WHEREAS** Sh. Mahendra Singh Shekhawat, Secretary and Sh. Ashok Kumar, Principal, Modern Teachers Training Girls College, Sainik Basti, Akashwani Road, Churu, Rajasthan presented the case of the appellant institution on 24/02/2021. In the appeal and during personal presentation it was submitted that "NRC, NCTE had granted recognition for 1 year B.Ed. course vide letter No. NRC/NCTE/F-3/RJ-465/8391 dated 13.08.2005 in rented premises. Copy of Recognition letter for 1 year B.Ed. course is annexed. The NRC, NCTE had granted Recognition for 2 year D.El.Ed. (STC) course vide letter No. NRC/NCTE/F-7/RJ-777/2007/24813 dated 17.08.2007 in rented premises. Copy of Recognition letter for 2 year D.El.Ed. (STC) course is annexed. As per conditions mentioned in Recognition Order, this institution had applied to NRC, NCTE for shifting of premises to newly constructed building as per norms of NCTE on own land on 24.06.2008 along with necessary documents and processing fees of Rs. 40,000/- vide D. D. No.



100303 dated 16.06.2008. Copy of receipt letter and Demand Draft are annexed. The NRC, NCTE had issued revised Recognition Letter for 2 years B.Ed. course to this institution vide letter No. NRC/NCTE/RJ-465/2015/74902 dated 24.04.2015. Copy of revised Recognition Letter for 2 years B.Ed. course is annexed. The NRC, NCTE had taken no action on the application for shifting of premises submitted by this institution till 2016. Instead of granting permission for shifting of premises on our own land, NRC, NCTE had issued a show cause notice to this institution vide letter No. NRC/NCTE/RJ-465/158541 dated 22.09.2016 for B.Ed. course and NRC/NCTE/RJ-777/158540 dated 22.09.2016 for D.El.Ed. (STC) course. This institution had submitted reply of show cause notice for B.Ed. and D.El.Ed. (STC) course dated 22.09.2016 to NRC, NCTE on 18.10.2016 and requested to NRC, NCTE for granting permission for shifting of premises at new site. The NRC, NCTE had not taken any action on the application of this institution submitted for granting permission of shifting of premises at new site. The WRC, NCTE had issued a show cause notice to this institution vide letter No. WRC/NCTE/RJ-465/B.Ed./316<sup>th</sup>/2020/209990 dated 27-09-2020 for B.Ed. course and WRC/NCTE/RJ777/STC/316<sup>th</sup> / 2020/ 210467 dated 30-09-2020 for D.El.Ed. (STC) course. This institution had submitted reply of show cause notices issued by WRC, NCTE for B.Ed. course and D.El.Ed. (STC) course to WRC, NCTE on 23.10.2020. Copy of reply letter is annexed. The reply letter of show cause notices submitted to WRC, NCTE by speed Post was delivered to WRC, NCTE on 27.10.2020 at 14.06.11 P.M. The WRC, NCTE had not considered the reply of this institution submitted on 23.10.2020 which was delivered to WRC, NCTE on 27.10.2020 at 14.06.11 P.M. and decided to withdraw the Recognition of D.El.Ed. (STC) course on the ground that institution had not submitted the reply of show cause notice dated 30.09.2020. This institution had submitted a representation in respect to Withdrawal of Recognition of D.El.Ed. (STC) Course to R.D., WRC, NCTE on 23.11.2020 but no action has been taken by the WRC, NCTE on the representation of this institution. This institution has again submitted a representation in respect to Withdrawal of Recognition of D.El.Ed. (STC) Course to R.D., WRC, NCTE on 08.01.2021. This institution was granted Recognition for B.Ed. Course on 13.08.2005 and D.El.Ed. (STC) Course on 17.08.2007 in rented premises. This institution had applied to NRC, NCTE for shifting of college in newly constructed building

on own land on 24.06.2008. NRC, NCTE had not taken any action regarding permission for shifting of premises to this college. NRC, NCTE had issued show cause notice on 22.09.2016 for B.Ed. and D.El.Ed. (STC) Course to this institution. This institution had submitted reply of both notices to NRC, NCTE on 18.10.2016 and requested to NRC, NCTE for granting permission for shifting of premises to this college at new site. Again NRC, NCTE had not taken any action regarding permission for shifting of premises to this college. WRC, NCTE had issued a show cause notice to this institution on 27-09-2020 for B.Ed. course and on 30-09-2020 for D.El.Ed. (STC) course. This institution had submitted reply of show cause notices issued by WRC, NCTE for B.Ed. course and D.El.Ed. (STC) course. WRC, NCTE had not considered the reply of this institution and withdrawn the Recognition of D.El.Ed. (STC) Course on illegal, unlawful, unjustified, mala-fide and unconstitutional basis. Therefore, it is prayed that the Withdrawal Order for D.El.Ed. (STC) Course issued by WRC, NCTE be set aside and directions be issued to WRC, NCTE to restore the Recognition of D.El.Ed. (STC) Course to this institution."

**AND WHEREAS** the Committee, noted that the reply to the show Cause Notice dt. 30/09/2020 was sent by the appellant by speed post on 23/10/2020 and the appellant submitted a copy of the reply sent and also a copy of the track report showing that the article was delivered on 27/10/2020. This reply is, however, not available in the regulatory file of the WRC.

**AND WHEREAS** in the above circumstances, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the reply to the Show Cause Notice, to be sent again to them by the appellant and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC the reply dt. 23/10/2020 to the Show Cause Notice within 15 days of receipt of orders on the appeal.

**AND WHEREAS** after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC with a direction to consider the reply to the Show Cause

Notice, to be sent again to them by the appellant and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC the reply dt. 23/10/2020 to the Show Cause Notice within 15 days of receipt of orders on the appeal.

**NOW THEREFORE, the Council hereby remands back the case of Modern Teachers Training Girls College, Sainik Basti, Akashwani Road, Churu, Rajasthan to the WRC, NCTE, for necessary action as indicated above.**

**ORDER**

**WHEREAS** the appeal of Vandniya Rastrasant Tukdoji Maharaj Shikshan Mahavidyalaya, Khelbabuji, Daryapur Road, Anjangaon Surji, Amravati, Maharashtra dated 08/01/2021 is against the Order No. WRC/APW003502/123416/322<sup>nd</sup>/2020/212437 dated 10.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 28.10.2006 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Notice was issued to the institution on 06.10.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 17(3) of the NCTE Act from the next academic session 2021-22."

**AND WHEREAS** Sh. Prafulla J., Incharge Principal, Vandniya Rastrasant Tukdoji Maharaj Shikshan Mahavidyalaya, Khelbabuji, Daryapur Road, Anjangaon Surji, Amravati, Maharashtra presented the case of the appellant institution on 24/02/2021. In the appeal and during personal presentation it was submitted that "College got permission in 2007-2008 it was running on rental building. Then the institution bought its own land in 2010 but we did not get the permission from NCTE to move to the new place. However since the information of the new building has been with the NCTE and University since 2012, we are ready to take action subject to NCTE Regulation."

**AND WHEREAS** the appellant, in their letter dated 24/02/2021, given in the course of presentation, submitted that they shifted to their own new premises on 14/08/2012;




since shifting from August, 2012, all the communications with the NCTE and the concerned University are made from the address of their own premises; almost after 14 years, on 06/10/2020, a Show Cause Notice under Section 17 of the NCTE Act was given; and a reply to the Show Cause Notice was sent by speed post on 13/11/2020 and as per the track report, the article was delivered on 19/11/2020. The appellant enclosed a copy of their reply dt. 13/11/2020 and a copy of the track report. This reply is, however, not available in the file of the WRC.

**AND WHEREAS** the Committee noted from the copy of the reply to the Show Cause Notice that the appellant informed the WRC that they have shifted to their own premises but failed to inform about shifting.

**AND WHEREAS** the Committee noted that according to the provisions of Clause 8(9) of the NCTE Regulations, 2014, in case of change of premises, prior approval of the Regional Committee shall be necessary, which may be accorded after due inspection of the institution at the new site. The institution has to submit application for change of premises, in the specified format along with the processing fee and other relevant documents, for prior approval of change of premises.


**AND WHEREAS** the Committee noted that the appellant in violation of the provisions of the NCTE Regulation, 2014 and without applying for change of premises and without prior applying for change of premises and without prior approval of the Regional Committee, has shifted to new premises. In these circumstances, the Committee concluded that the appeal deserved to be rejected and the order of the WRC confirmed.

**AND WHEREAS** after perusal of the memorandum of appeal, affidavit, and the documents available on records, the Committee concluded that the WRC was justified in withdrawing recognition. The appeal deserved to be rejected and the order of the WRC is confirmed.



NOW THEREFORE, the Council hereby confirms the Order appealed against.

**ORDER**

**WHEREAS** the appeal of Symboyzia Girls College, Shahganj, Maharani Bagh, Agra, Uttar Pradesh dated 17/10/2020 is against the Order No. NRC/NCTE/UP-2030/315<sup>th</sup> Meeting/2020/209565-70 dated 21.09.2020 of the Northern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution. Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college."

**AND WHEREAS** Dr. Girraj Singh Rana, Secretary, Symboyzia Girls College, Shahganj, Maharani Bagh, Agra, Uttar Pradesh presented the case of the appellant institution on 24/02/2021. In the appeal and during personal presentation it was submitted that "They have already appointed faculty of their B.Ed. course according to revised Regulation 2014 in which 16 lecturers are working in their institution including principal. The first file for 4 teachers approval dated 08.04.2019 is pending in the university. The second file for re approval of 5 teachers dated 12.02.2020 is pending in the University. The third file for 04 teacher's approval dated 19.02.2020 is pending in the University. The fourth file for 3 already approved teachers. The fifth file of 16 presently working teachers. salary disbursement document submitted website link. Please consider our situation and reinstate recognition order of our institution."

**AND WHEREAS** in the course of presentation, the appellant submitted that they could not submit reply to the show cause notice due to Covid – 19 pandemic situation. The appellant, with their letter dt. 24/02/2021, submitted copies of letters issued by the

affiliating University approving faculty, faculty list, salary disbursement statements along with bank statements, website pages and other related documents.

**AND WHEREAS** the Committee, noting that the appellant has submitted the documents mentioned in para 4 of the withdrawal order, concluded that the matter deserved to be remanded to the NRC with a direction to consider the documents submitted in the appeal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the NRC the documents submitted in appeal, with originals thereof, wherever necessary, as required by the NRC, within 15 days of receipt of orders on the appeal.

**AND WHEREAS** after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to NRC with a direction to consider the documents submitted in the appeal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the NRC the documents submitted in appeal, with originals thereof, wherever necessary, as required by the NRC, within 15 days of receipt of orders on the appeal.

**NOW THEREFORE, the Council hereby remands back the case of Symboyzia Girls College, Shahganj, Maharani Bagh, Agra, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.**

**WHEREAS** the appeal of Sant Ramkrishna Kanya Mahavidyalaya, Balkeshwar, Agra, Uttar Pradesh dated 16/11/2020 is against the Order No. NRC/NCTE/UP-1243, UO-2327 & UP-2708/317<sup>th</sup> Meeting/2020/209709-14 dated 28.09.2020 of the Northern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Latest list of the faculty for B.Ed. course duly approved by the concerned affiliating body has not been submitted. Bank statement of the payment of salary to the faculty for last six months has not been submitted. Hence, Committee decided to withdraw the recognition for the B.Ed. course of the institution with effect from the end of the current academic session 2020-2021. A detailed order of withdrawal of recognition be issued to the institution as well as to the concerned authorities."

**AND WHEREAS** Sh. Manmohan Chawla, Secretary and Sh. R.K. Chawla, Director, Sant Ramkrishna Kanya Mahavidyalaya, Balkeshwar, Agra, Uttar Pradesh presented the case of the appellant institution on 24/02/2021. In the appeal and during personal presentation it was submitted that "Show Cause Notice was issued online by the NRC NCTE at the meeting on 17 January 2020, In which 30 days' time was given But the meeting was conducted by the NRC NCTE on 14.02.2020 before 30 days, due to which our reply was not accepted by the NRC NCTE. Whereas, all the staff is approved by the Affiliating Body. Approval letters have been given with the letter in the NRC NCTE."

**AND WHEREAS** the Committee noted that the appellant, with their letters dt. 25/12/2020 and 23/02/2021, inter-alia submitted copies of letters issued by Dr. Bhimrao Ambedkar University, Agra during the years 2009, 2013, 2017 and 2019 approving faculties for the B.Ed. course in the appellant institution and copies of salary disbursement statements and statements issued by Central Bank of India, Agra. The appellant, with their letter dt. 23/02/2021, in addition to other documents, enclosed a list giving the

particulars of staff and signed by the Secretary of the institution. This list is not authenticated / approved by the affiliating University. In this list, the appellant has given a reference to the letter (s) of approval issued by the University from time to time. The appellant has, however, not submitted the latest faculty list duly approved by the concerned affiliating body as mentioned in the withdrawal order.

**AND WHEREAS** Appeal Committee noted that appellant has not bothered to submit a faculty list approved by the University Authorities. He merely prepared a list, enclosed a host of letters of the University and simply gave the references of the University letters. What was required is a list signed by the University authorities. Salary statements and bank statements corresponding to the list of faculty approved by University then could have been verified by the Regional Committee.

**AND WHEREAS** in view of the above position, the Committee concluded that the appeal deserved to be rejected and the order of the NRC confirmed on the ground that the appellant has not submitted the latest faculty list approved by the affiliating University.

**AND WHEREAS** after perusal of the memorandum of appeal, affidavit, and the documents available on records, the Committee concluded that the NRC was justified in withdrawing recognition. The appeal deserved to be rejected and the order of the NRC is confirmed.

**NOW THEREFORE, the Council hereby confirms the Order appealed against.**

**ORDER**

**WHEREAS** the appeal of Nutana College of Education, LIC Colony, B.I.E.T. Road, Davanagere, Karnataka dated 07/01/2021 is against the Order No. SRO/NCTE/APSO2197/TN/B.Ed./2020/120869 dated 28.11.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the institution was issued a Final Show Cause Notice (FSCN) dated 23.09.2019 (the correct date is 28/08/2019). The institution has failed in submission of written representation along with all required documents in response to Final Show Cause Notice."

**AND WHEREAS** Dr. Diwakar Niak, Principal, Nutana College of Education, LIC Colony, B.I.E.T. Road, Davanagere, Karnataka presented online the case of the appellant institution on 24/02/2021. In the appeal and during online presentation it was submitted that "Institution has submitted reply to both the show cause notices issued by SRC. The first show cause notice was issued by SRC on 01.03.2019 and we have sent reply on 01.04.2019 through speed post. Further, final show cause notice was issued by SRC on 28.08.2019. In reply to final show cause notice our institution has submitted all the documents vide our letter dated.18.09.2019 through speed post. We are submitting copy of the replies and also the speed post receipts of both replies for kind consideration of Appeal Committee. Inspite of submission of reply for both the notices, SRC without considering the reply of our institution has withdrawn recognition stating that our institution has not submitted reply for the final show cause notice. Injustice has been caused to our institution by SRC without considering the replies submitted by our institution and withdrawing recognition. Further, we wish to submit before the Appeal Committee that our institution is 16 years old institution and our institution is regularly getting rank under Davanagere University every year. Further our institution is having all the documents, infrastructure and instructional facilities as prescribed by NCTE

Regulations 2014. For the kind consideration of the Appeal Committee we are submitting following documents. 1. Certified copy of the Land Documents. 2. Approved Building Plan. 3. Approved Building Completion Certificate from the Government Engineer. 4. Land Use Certificate issued by the Commissioner 5. Encumbrance Certificate and English Version of the same. 6. Form 'A' issued by the Manager, Vijaya Bank (now merged with Bank of Baroda) for having FDRs for Rs.12 lakhs with FDR Certificates. 7. Approved Site Plan and 8. Staff list approved by the Registrar, Davanagere University. We are having all the necessary documents sought by the SRC. In spite of submitting all the documents to SRC, recognition of our institution has been withdrawn for no fault."

**AND WHEREAS** the Committee noted that the SRC, after taking into account the reply received on 23/09/2019 to the final show cause notice dt. 28/08/2019, withdrew recognition on the ground that the institution has failed in submission of written representation along with all required documents. This ground is not sustainable as it is contrary to the facts and devoid of details.

**AND WHEREAS** the Committee, noting that the appellant has submitted a number of documents vis a vis those mentioned in the show cause notice dt. 28/08/2019, concluded that the matter deserved to be remanded to the SRC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the SRC all the documents submitted in appeal within 15 days of receipt of orders on the appeal.

**AND WHEREAS** after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee concluded to remand back the case to SRC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the SRC all the documents submitted in appeal within 15 days of receipt of orders on the appeal.

In the appeal and during personal presentation it was submitted that "Certified land photocopy have already submitted on 27.03.2019/l.no-111438. English translated notarized Non-Encumbrance Certificate have already submitted on date 27.03.2019/l.no-111438. Competent authority approved Building Plan have submitted already on date 27.03.2019/l.no-111438. Competent authority approved Site Plan have submitted already on date 27.03.2019/l.no-111438. Competent authority approved built up area certificate have already submitted on date 27.03.2019/l.no-111438. Affiliating University Registrar approved staff list have already submitted on date 27.03.2019/l.no-111438."

**ORDER**

**WHEREAS** the appeal of Raidighi B.Ed. College, Raidighi, South 24-Pargana, West Bengal dated 18/01/2021 is against the Order No. ER-275.14.52/APE00674/B.Ed./2019/61478 dated 02.09.2019 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Total built up area mentioned in building completion certificate as 1360.02 sq. mts. which is less than required 1500 sq. mts. even for running one basic unit (50 intake) of B.Ed. course. Faculty list submitted only 1+6 instead of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course. Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

**AND WHEREAS** the submission of the appeal has been delayed by one year two months and 23 days beyond the prescribed period of sixty days. The appellant submitted that the delay occurred as the institution was badly affected by the cyclone 'Bulbul' during 2019 and later the entire area was affected by Covid – 19 pandemic. The Committee accepted the submission and decided to consider the appeal.

**AND WHEREAS** the appellant filed a W.P. (C) 1672/2021 before the Hon'ble High Court of Delhi at New Delhi, praying that the order of withdrawal, as per the provisions of Section 17(1) of the NCTE Act, 1993, would come into effect only from the academic session 2020-21 as stated in the said order. The Hon'ble High Court, in their order dt. 08/02/2021, directed that the withdrawal order will come into effect from the academic session 2021-22 and consequently, the petitioner is entitled to participate in the counselling and admit students for the academic session 2020-21.



**AND WHEREAS** Dr. Sasabindu Jana, Secretary and Arindam Bhattacharya, Professor, Raidighi B.Ed. College, Raidighi, South 24-Pargana, West Bengal presented the case of the appellant institution on 24/02/2021. In the appeal and during personal presentation it was submitted that Institution has total built up area of 1813.44 sq. mtrs. The revised Building Completion Certificate was submitted to ERC. Thus, there is no deficiency in the institution to run the B.Ed. Course with one basic unit (50 seats). It is submitted that even after issuance of revised recognition order, the institution is conducting only one basic unit (50 seats) of B.Ed. Course. A copy of Building Completion Certificate is attached. It is submitted that the institute also vide its letter dated 21.06.2019 requested the ERC to reduce the intake from two basic units (100 seats) to one basic unit (50 seats). A copy of letter is attached. However, notwithstanding the above request made by the institution, the ERC has considered the matter only in respect of two basic units (100 seats), which is contrary to request made by institution vide its letter dated 21.06.2019. It is submitted that as the institution is running B.Ed. Course with only one basic unit (50 seats), therefore, as per NCTE Regulations, 2014 only 8 faculty (1+7) is required. The institution has 11 approved faculty (1+10) which is more than sufficient for one basic unit (50 seats) and therefore, the ERC is not justified in withdrawing recognition of the appellant institution. A copy of faculty list is attached."

**AND WHEREAS** the appellant with their letter dated 23/02/2021 submitted a copy of the Building Completion Certificate, duly signed by a Government Engineer on 26/08/2019, showing a built-up area 1813.44 sq. mts. and a copy of faculty list consisting of a Principal and 10 Assistant Professors, duly signed by the Registrar, the West Bengal University of Teachers' Training Education Planning & Administration.

**AND WHEREAS** the Committee, noting that the appellant intends to have only one unit of 50 students, concluded that the matter deserved to be remanded to the ERC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC, the documents submitted in appeal within 15 days of receipt of orders on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC, the documents submitted in appeal within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Raidighi B.Ed. College, Raidighi, South 24-Pargana, West Bengal to the ERC, NCTE, for necessary action as indicated above.

**WHEREAS** the appeal of Rajasthan B.Ed. College, Near Railway Crossing, Jaipur Road, Dausa, Rajasthan dated 22/01/2021 is against the Order No. WRC/NCTE/RJ-602/B.Ed./321<sup>st</sup>/2020/212402 dated 09.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 13.08.2006 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 30.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

**AND WHEREAS** Dr. C.L. Meena, Founder Director and Dr. R.S. Nagar, President, Rajasthan B.Ed. College, Near Railway Crossing, Jaipur Road, Dausa, Rajasthan presented the case of the appellant institution on 24/02/2021. In the appeal and during personal presentation it was submitted that "NRC, NCTE had granted recognition for 1 year B.Ed. course vide letter No. NRC/NCTE/F-7/ dated 13.08.2006 in rented premises. The NRC, NCTE had issued revised Recognition Letter for 2 years B.Ed. course to this institution vide letter No. NRC / NCTE / F-7 / RI-602/2015/105237 dated 26.05.2015. This institution had applied to NRC, NCTE for shifting of premises to newly constructed building as per norms of NCTE on own land on 21.10.2016 along with necessary documents. The NRC, NCTE issued a show cause notice to this institution vide letter No. NRC/NCTE/RJ-602/158514 dated 21.09.2016. This institution had submitted reply of show cause notice dated 21.09.2016 to NRC, NCTE on 26.10.2016 and requested NRC,



NCTE for granting permission for shifting of premises at new site. The NRC, NCTE had not taken any action on the application of this institution submitted for granting permission of shifting of premises at new site. That WRC, NCTE had issued a show cause notice to this institution vide letter No. WRC/NCTE/RJ-602/B.Ed./316<sup>th</sup> / 2020/ 210471 dated 30-09-2020 for B.Ed. course. That due to Covid-19, the required document has not been prepared in due time. So, this institution had submitted reply of show cause notice issued by WRC, NCTE for B.Ed. course along with application for granting permission for shifting of building on our own land with all required documents and processing fees of Rs. 1,50,000/- vide D. D. No. 024153 dated 02.12.2020 to WRC, NCTE on 02.12.2020. The WRC, NCTE issued a show cause notice to this institution vide letter No. WRC/NCTE/SCNRJ/2020/211709 dated 05-11-2020 for revised recognition order. This institution has submitted reply of show cause notice to WRC, NCTE on 19.12.2020. That WRC, NCTE had not considered the reply of this institution submitted on 02.12.2020 on the ground that institution has not submitted the reply of show cause notice dated 30.09.2020 till date. Reply of show cause notice was delayed due to Covid – 19. It is prayed that the Withdrawal Order for B.Ed. Course issued by WRC, NCTE be set aside and directions be issued to WRC, NCTE to restore the Recognition of B.Ed. course to this institution.”

**AND WHEREAS** the Committee noted that the ground of withdrawal is that the institution has not replied to the Show Cause Notice dated 30/09/2020. The appellant enclosed a copy of their reply dt. 02/12/2020 sent by speed post affixing thereon the speed post receipt dt. 04/12/2020. The appellant also enclosed a copy of their reply dt. 19/12/2020 sent by speed post on that date to another show cause notice dt. 05/11/2020. These replies are, however, not available in the file of the WRC.

**AND WHEREAS** in the above circumstances, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the replies of the appellant dt. 02/12/2020 and 19/12/2020 of the Show Cause Notices issued to them, to be sent to them again by the appellant, and take necessary action as per the NCTE





Regulation, 2014. The appellant is directed to forward to the WRC their replies to both the Show Cause Notices, within 15 days of receipt of orders on the appeal.

**AND WHEREAS** after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC with a direction to consider the replies of the appellant dt. 02/12/2020 and 19/12/2020 of the Show Cause Notices issued to them, to be sent to them again by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC their replies to both the Show Cause Notices, within 15 days of receipt of orders on the appeal.
