ORDER

WHEREAS the appeal of Indian College of Education (B.Ed.), Chidri Bidar, Bidar, Karnataka dated 23/10/2020 is against the Order No. SRO/NCTE/APS02435/B.Ed/KA/2020/18700 dated 24.09.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the institution has not shifted its institution to own permanent building, which is a violation of the NCTE Regulations 2002, 3(c). The institution has also not responded to the Final Show Cause Notice issued on 19.07.2019."

AND WHEREAS Mohd. Asif, Manager, Indian College of Education (B.Ed.), Chidri Bidar, Bidar, Karnataka presented online the case of the appellant institution on 26/02/2021. In the appeal and during online presentation it was submitted that "Since long we are running our institute in our permanent and owned building and the same has been submitted earlier before your kind authority and we are ready to produce the related documents as and when asked by you. We have not received any final show cause notice as referred. Had we received any notice / letter from your kind office, we would have responded immediately. Therefore, I most humbly request you, kindly drop the withdrawal order."

AND WHEREAS Appeal committee noted from the regulatory file that SRC by its letter dated 11/06/2004 had informed the applicant society that pending construction of a permanent building on the land owned by institution, the institution may provide facilities in suitable temporary premises and institution should shift to its permanent building within 3 years. Appellant by its letter dated 08/08/2004 submitted to SRC


copies of sale deed of land with Land survey no. 41/P1 at village Zamistanpur, Bidar, Karnataka, Recognition order dated 02/12/2004 was issued thereafter. Appeal Committee noted that appellant institution by its letter dated 01/12/2016 has submitted two land documents. One of these document with land survey no. 41/P1 was submitted earlier in the year 2004. The other document is a Gift deed dated 21/07/2015 pertaining to land survey no. 112/1C land mentioned in both the documents is situated at village Chidri, Dist. Bidar, Karnataka. Building Plan and Building completion Certificate (B.C.C.) submitted by appellant institution mentions the location of building at Survey No. 112. Visiting Team conducted inspection of the appellant institution some where in October, 2004 and it is mentioned against entry in para 11 thereof that institution intends to function from its own building but is not functioning from its own building. There is nothing on the regulatory file to suggest as to when the appellant institution shifted from the building where initial inspection was conducted before grant of recognition.

AND WHEREAS Appeal Committee noted that after issue of revised recognition order dated 18/05/2015, the appellant had submitted to SRC the copies of (i) sale deed, (ii) gift deed the building plan and the Building Completion Certificate.

AND WHEREAS Appeal Committee noted that by issue of Final Show Cause Notice (SCN) dated 19/07/2019 SRC required the appellant institution to submit processing fee of Rs. 1,50,000/- towards shifting fee and certain other documents. This S.C.N. as per submission made by appellant was not received by appellant.

AND WHEREAS Appeal Committee decided to remand back the case to SRC for reissuing the SCN which is required to be replied by appellant institution within 15 days.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during online presentation, Appeal Committee concluded to remand back the case to SRC for reissuing the SCN which is required to be replied by appellant institution within 15 days.



NOW THEREFORE, the Council hereby remands back the case of Indian College of Education (B.Ed.), Chidri Bidar, Bidar, Karnataka to the SRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Bethany Navajeevan College of Education, Killiyoor, Puthukkadai, Bethany Nagar, Vencode, Killiyoor, Kanyakumari, Tamil Nadu dated 26/01/2021 is against the Order No. SRO/NCTE/APSO8054/TN/B.Ed./2021/122712 dated 08.01.2021 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "The institute submitted copies of Sale Deeds dt.27.09.2007 and 12.02.2001 in favour of "Bethany Navajeevan Province" whereas the name of managing trust is "Bethany Navajeevan Trust" which is the different one and is not allowed under NCTE Regulations. Other documents such as NEC, BCC, Building Plan, LUC etc. can not be accepted on the face of deficiency of land documents. The institute also submitted a copy of Lease Agreement dt.03.04.2012 between private parties which is not acceptable and allowed under NCTE Regulations. Notarized English translation of NEC has not been submitted. The Building Plan submitted by the institute is neither legible nor approved by the competent authority. The institute submitted a copy of letter dt.15.12.2007 issued by the Registrar, TTEU regarding approval of 16 faculty along with the proforma. All faculty members are shown to be appointed after the notification of NCTE (amendment) Regulations, 2014 and as they are not possessing NET qualification hence are not qualified. Website of the institute is not functional and required information have not been uploaded."

AND WHEREAS Dr. Selvarajja, Administrator, Bethany Navajeevan College of Education, Killiyoor, Puthukkadai, Bethany Nagar, Vencode, Killiyoor, Kanyakumari, Tamil Nadu presented the case of the appellant institution on 26/02/2021. In the appeal and during personal presentation it was submitted that "Bethany Navajeevan Province is a parent Society. Our institution, namely, Bethany Navajeevan College of Education was established by the Bethany Navajeevan Province which is a Registered Society under the Tamil Nadu Societies Registration Act 1975. In order to establish and administer the college has created the trust namely "Bethany Navajeevan Trust". The Society has

demarcated the land in favour of the trust for the purpose of running the college. Thereafter the College was established in the year 2008. Only for the better and proper administration of the college the Province has created the Trust namely Bethany Navajeevan Trust. The NCTE Regulation 2014 also makes it very clear that the institution owned or administered by a Registered Society shall separately demarcate the land in favour of the college. In the present case of Bethany Navajeevan Province the land had already been separately demarcated in favour of the college. Accordingly, the Province which established the college and the trust for its administration has demarcated the set land in favour of the college. The head and members of the Province and the Trust are the same. There is no separate entity for Province and Trust both are one and the same. The land is exclusively earmarked only for the purpose of the college. With regard to the other documents such as NEC, BCC, building plan, LUC etc. are concern the same are vest in the name of trust/province. The same was considered by the NCTE even at the time of granting continuation of approval during the year 2015. No subsequent change is made. The Institution has not submitted any lease agreement from the private parties at any point of time since from the year of its establishment. The same land is maintained and utilized for the purpose of the college. Notarized English translated NEC is submitted herewith. Building plan approval was already submitted and the same was approved by the competent authorities viz. the panchayat as well as the Director of Town and Country Planning. We are again enclosing the copy of the same for your kind perusal. With regard to the faculty the college is offering B.Ed. course with an annual intake of 100 students with one Principal and fifteen other teaching faculties. They all possess required qualification as per the NCTE regulation 2014. The affiliating University Tamil Nadu Teachers Education University also has granted Qualification approval in respect of all the faculties. The qualification approval has been obtained from the university on 20-2-2020 in the revised perfoma. As such the college fulfils the faculty criteria. The website of the institution is functional, and all the information's are periodically uploaded."

AND WHEREAS Appeal Committee noted that appellant institution is conducting B.Ed. programme since 2008 and provisional revised recognition order was issued on 30/04/2015 for conducting B.Ed. course with an intake of 2 units (100 seats).



AND WHEREAS Appeal Committee noted that appellant institution is administered by Bethany Navjeevan Trust. As explained by appellant institution the Trust is part of a larger unit which is known as Bethany Navjeevan Province. The members of the Trust are members of the Province. Appeal Committee further noted that appellant institution is conducting B.Ed. programme from the location where it was granted recognition in the year 2008. The technicalities of some of the documents in the name of Trust and some other documents in the name of Province are not serious enough so as to warrant withdrawal of recognition, more so when the appellant institution has been conducting the programme from the same land and building since 2008. Appeal Committee decided that appellant institution is required to submit all the documents submitted by it with its appeal memoranda to SRC within 15 days. Appeal Committee further decided to remand back the case to SRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Bethany Navajeevan College of Education, Killiyoor, Puthukkadai, Bethany Nagar, Vencode, Killiyoor, Kanyakumari, Tamil Nadu to the SRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Smt. Rewaben Odhavjibhai Patel Womens B.Ed. College, At Post – Tankara, Morbi-Rajkot Highway, Rajkot, Gujarat dated 20/11/2020 is against the Order No. WRC/NCTE/APW00500/323134/B.Ed./321st/2020/212893 dated 18.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that “Recognition was granted to the institution on 14.02.2005 on rented premises with a condition that to shift to the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 28.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22.”

AND WHEREAS Sh. D.M. Kavar, Campus Director and Sh. K.G. Bhoraniya, I/C Principal, Principal, Smt. Rewaben Odhavjibhai Patel Womens B.Ed. College, At Post – Tankara, Morbi-Rajkot Highway, Rajkot, Gujarat presented the case of the appellant institution on 26/02/2021. In the appeal and during personal presentation it was submitted that “College started in June, 2005 in a building constructed by Trust on 2.5 acre of land which was leased one. The Trust has its own building. However, when a Show Cause Notice was received, the Trust paid Rs. 1,50,000/- for the transfer of the college in the land and building of its own. The proposal was sent with documentary evidences.”

AND WHEREAS Appeal Committee noted that appellant institution is conducting B.Ed. programme since 2004 and after considering the replies to various Show Cause Notices was issued a Restoration order dated 12/04/2019 for B.Ed. course with one unit (50 seats).

AND WHEREAS appellant during the course of appeal hearing on 26/02/2021 submitted copies of (i) sale deed, (ii) Building Plan, (iii) Building Completion Certificate, (iv) Non- Encumbrance Certificate. Appellant further submitted that the appellant institution by its letter dated 26/10/2020 had submitted a Demand Draft of Rs. 1,50,000/- towards shifting fee.

AND WHEREAS Appeal Committee could not find the aforesaid letter and documents on the regulatory file which are reportedly sent by the appellant institution by Speed Post on 11/11/2020. Appeal Committee decided that appellant institution is required to resubmit originals and copies of documents submitted to NCTE by its letter dated 26/10/2020. WRC should also make efforts to trace the Demand Draft and other original documents submitted by appellant institution through speed post. Appeal Committee further decided to remand back the case to WRC for revisiting the matter after locating the Demand Draft and documents submitted or alternatively seek copies of these documents from the appellant institution.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter after locating the Demand Draft and documents submitted or alternatively seek copies of these documents from the appellant institution.



NOW THEREFORE, the Council hereby remands back the case of Smt. Rewaben Odhavjibhai Patel Womens B.Ed. College, At Post – Tankara, Morbi-Rajkot Highway, Rajkot, Gujarat to the WRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of G.B.R. College of Education, Anaparthi, Rajanagaram Road, Anaparthi, East Godavari, Andhra Pradesh dated 03/02/2021 is against the Order No. SRO/NCTE/APSO0256/B.Ed./A.P./2020/8817-8823 dated 24.09.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Institutions was granted recognition on rented premises with a condition to shift its building to new permanent building. The institution has not yet shifted to its own permanent building. The institution has not shifted to own permanent building, which is a violation of the NCTE Regulations 2002, 3(c). The institution also has not rectified the following deficiencies: - The institution has not submitted application for shifting of premise from rented to owned as required under NCTE Regulations. As per the recognition order No.F. AP/NEW/B.Ed./173/SRO/NCTE/2002- 2003/6120 dated 28.02.2003. The institution shall shift to its own premises within three year from the date of recognition (In case the course is started in rented). As per VT report at the time of recognition nature of possession of land was on lease. The institution has not submitted certified copy of Registered Land documents. The institution has submitted notarized copy of building plan but building details not readable. The institution has submitted notarize copy of site plan but survey No. and total area not mentioned. The institution has submitted notarized copy of Building Completion Certificate but multipurpose hall not mentioned."

AND WHEREAS Sh. G. Hari Prasad, Administrative Officer and Sh. T. Adi Reddy, Secretary & Correspondent, G.B.R. College of Education, Anaparthi, Rajanagaram Road, Anaparthi, East Godavari, Andhra Pradesh presented the case of the appellant institution on 26/02/2021. In the appeal and during personal presentation it was submitted that "The institution has not shifted to own permanent building which is a violation of the NCTE Regulation 2002, 3(c). Explanation: We have paid an amount of Rs.40000/- towards shifting inspection and the shifting inspection was carried out on 29-03-2011. Thereafter

the SRC served a show cause notice to fulfil the deficiencies and the same were rectified and submitted to SRC NCTE by hand on 07-07-2011. The institution has also not submitted application for shifting of premises from rented to owned as required under NCTE regulations. Explanation: Application for shifting of premises from rented to own on 26-06-2009 and the shifting inspection was carried out on 29-03-2011. A copy of the acknowledgement of the application submitted at SRC NCTE by messenger is enclosed. As per recognition order no. F.AP/New /B.Ed/173/SRO/NCTE/2002-2003/6120, dated 28-02-2003. The institution shall shift to its own premises within 3 years from the date of recognition Explanation:- As per the conditions given in the FR copy issued on 28-02-2003 to start B.Ed. course, application for shifting of premises from rented to own building was submitted on 26-06-2009 and the shifting inspection was carried out on 29-03-2011. A copy of the acknowledgement of the application submitted at SRC NCTE by messenger is here with enclosed for your kind reference. As per VT report at time of recognition nature of possession of land was on lease Explanation: As the institution has shifted to its own permanent building which is in its own land of extant 5.51 acres, this point doesn't stand. The institution has not submitted the certified copies of registered land documents. Explanation: We submitted certified copies of registered land documents whenever SRC sent the notices on various issues. Anyhow again we are herewith submitting the certified copies of registered land documents for your kind reference. The institution has submitted the notarized copy of building plan, but building details are not readable. Explanation: We submitted the notarized copy of building plan whenever SRC sent the notices on various issues. Anyhow again we are herewith submitting the notarized copy of building plan for your kind reference. The institution has submitted notarized copy of site plan but survey no and total area not mentioned. Explanation: Revised and notarized copy of site plan with survey no and total area is herewith enclosed for your kind reference. The institution has submitted notarized copy of Building Completion Certificate, but multipurpose hall not mentioned. Explanation: We have submitted the BCC in format downloaded from NCTE website, but the column related to multipurpose hall is not there. Any how we have a multipurpose hall with required built up area as per norms and the same was earmarked in the plan for your kind reference."



AND WHEREAS Appeal Committee noted that reasons given for withdrawal of recognition in order dated 24/09/2020 are contrary to the submissions made by appellant and documentary evidence available on the regulatory file. Appeal Committee noted that appellant institution had submitted a Demand Draft of Rs. 40,000/- on 18/09/2007 and SRC had also issued letter dated 10/03/2011 informing the appellant institution that inspection will be carried out during 21-25th March, 2011.

AND WHEREAS appellant institution submitted with its appeal memoranda the relevant documents such as (i) copy of sale deed, (ii) Building Plan, (iii) Building Completion Certificate. Appellant further submitted track report of speed post by which it had replied to the SCN dated 06/03/2019. Appeal Committee, therefore, decided that SRC needs to consider the land & building documents with reference to inspection report and shall first decide to either approve the proposed shifting or refuse it on valid grounds.

AND WHEREAS appellant institution is directed to forward to SRC originals / copies of required documents with a self-contained proposal of shifting. Appeal Committee further decided to remand back the case to SRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to SRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of G.B.R. College of Education, Anaparthi, Rajanagaram Road, Anaparthi, East Godavari, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Shikshan Shastra Mahila Mahavidyalaya, Raver, Savada Road, Raver, Jalgaon, Maharashtra dated 02/02/2021 is against the Order No. WRC/APW04479/123538/322nd/2020/212559 dated 11.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Recognition was granted to the institution on 22.11.2008 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted the institution in its own premises till date. Accordingly, Show Cause Notice was issued to the institution on 29.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. AND WHEREAS Ms. Tina Hari Jawle, Adm. Officer & Sh. Nishikant Milind Bimbe, Staff, Shikshan Shastra Mahila Mahavidyalaya, Raver, Savada Road, Raver, Jalgaon, Maharashtra presented the case of the appellant institution on 26/02/2021. In the appeal and during personal presentation it was submitted that "Recognition was granted to the institution in the premises rented for 90 years. On the receipt of the show cause notice dated 29/09/2020, this fact, together with supporting document, was made known to the WRC by reply dated 29/10/2020 sent by speed post number em404512655in dated 29/10/2020 which was received by WRC 06/11/2020 as per tracking report downloaded from the (indiapost.gov.in). Even after receiving the reply, WRC wrongly stated in the order of withdrawal that no reply to Show Cause Notice was given."

AND WHEREAS Appeal Committee noted that a Show Cause Notice (SCN) dated 29/09/2020 was issued to appellant institution and the impugned order of withdrawal

dated 11/12/2020 is on the ground that 'Institution has not submitted reply to Show Cause Notice.'



WHEREAS the appeal of K.G.V.A. Sanghas Matoshree Kantamma Sanganagouda Patil College of Education, Hirur, Muddebihal, Bijapur, Karnataka dated 08/02/2021 is against the Order No. SRO/NCTE/APSO8950/TN/B.Ed./2021/123189 dated 22.01.2021 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "the institution has not responded to the Final Show Cause Notice issued on 01.09.2020.

AND WHEREAS Sh. S.B. Patel, President, K.G.V.A. Sanghas Matoshree Kantamma Sanganagouda Patil College of Education, Hirur, Muddebihal, Bijapur, Karnataka presented online the case of the appellant institution on 26/02/2021. In the appeal and during online presentation it was submitted that "In-spice of submission of all documents, the SRC has withdrawn recognition. It is not true that our institution has not responded to the Final Show Cause Notice. Subsequent to issuance of Revised Provisional Recognition Order we have submitted all the documents to SRC. Further, SRC has informed that inspection will be conducted as per new Regulations 2014 and informed our institution to pay Rs.1.50 Lakhs for inspection fee. Our institution has paid Rs.1.50 Lakhs through Demand Draft even though there was no shifting. The SRC has sent inspection to our institution on 22.10.2016. Inspection letter copy attached. The VT members conducted inspection and sent the VT Report to SRC. Along with VT Report also we have again submitted all the documents. Till date SRC has not provided any information after the inspection. In the year 2019, a Show Cause Notice was received by our institution whereas there was no mention about inspection report consideration. Our institution has submitted the reply along with all the documents on 16.11.2019 again. Thereafter, SRC has sent the Final Show Cause Notice for which our institution has made reply on 10.01.2021. Copy of the reply sent to SRC and the Speed Post Receipt statement

K. N. K. P.

is enclosed. Our institution from the year 2015 has submitted all the documents to SRC three times. Even then, the SRC without considering the VT Report, Land Documents, Building Plan, Building Completion Certificate, Land Use Certificate, Non-Encumbrance Certificate, Form A for FDRs, approved Staff list submitted by our institution three times has taken decision to withdraw recognition. Our institution from the date of recognition is running in the own land and building. Though we have submitted documents three times, injustice has been caused by SRC by withdrawing recognition to our institution. We are submitting all the documents before the Appellate Authority for kind perusal and consideration. We humbly request to render justice to our institution by granting continuation of recognition to our B.Ed. college.”

AND WHEREAS Appeal Committee noted that appellant institution is conducting B.Ed. programme since 2007 and as per revised recognition order dated 28/05/2015 was allowed to conduct the programme with 2 units (100 seats). Appeal Committee noted that final Show Cause Notice dated 01/09/2020 was issued to appellant institution for the following deficiencies:-

- (i) Area of Multipurpose Hall and Built-up area not mentioned in building plan.
- (ii) Non submission of site plan.
- (iii) Survey number mentioned in land document is different.
- (iv) Institution is required to submit latest approved staff list.

AND WHEREAS Appeal Committee noted that whereas appellant stated to have submitted reply to S.C.N. by speed post, no evidence has been furnished. Appellant with its appeal memoranda has however, submitted (i) land documents, (ii) Land Use Certificate, (iii) Non Encumbrance Certificate, (iv) List of faculty approved by affiliating University, (v) FDRs, (vi) Building Plan indicating the area of auditorium . Appeal Committee noted that Building Plan, Building Completion Certificate and C.L.U. pertain to property at Survey No. 19/3. Previous records available on regulatory file which were submitted for the purpose of seeking recognition also mention the same Survey No. 19/3.

AND WHEREAS Appeal Committee, therefore, decided that SRC is required to revisit the case after appellant submits within 15 days copy of its reply to final S.C.N. enclosing therewith originals of required documents wherever necessary and copies of other documents.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee concluded that SRC is required to revisit the case after appellant submits within 15 days copy of its reply to final S.C.N. enclosing therewith originals of required documents wherever necessary and copies of other documents.

NOW THEREFORE, the Council hereby remands back the case of K.G.V.A. Sanghas Matoshree Kantamma Sanganagouda Patil College of Education, Hirur, Muddebihal, Bijapur, Karnataka to the SRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Yerra Krishnamurthy College of Education, Maripivilasa, Seethanagaram Mandal, Vizianagaram, Andhra Pradesh dated 08/02/2021 is against the Order No. SRO/NCTE/AOS00594/B.Ed./(A.P.)/2021/24081-4088 dated 08.01.2021 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "The institution has submitted photocopy of Land Document. (i) The institution has not submitted certified copy of land documents. The institution has submitted photocopy of Building & Site plan which is not readable. Date inspection not mentioned in Building Completion Certificate. The institution has not submitted letter regarding approval of faculty issued by the affiliating body. The institution has not submitted "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs."

AND WHEREAS the representative of Yerra Krishnamurthy College of Education, Maripivilasa, Seethanagaram Mandal, Vizianagaram, Andhra Pradesh presented online the case of the appellant institution on 26/02/2021. In the appeal and during online presentation it was submitted that "Our institution is in own land and building from the year1999 itself. Further, we have submitted Land Documents during initial recognition and also submitted during issuance Revised Recognition Order during the year 2015. Further, in response to the Show Cause Notice also we have submitted the Certified Copy of the Land documents to SRC. Our institution is having 5 Acres of land exclusively of the B.Ed. college. We are submitting Certified Copy of the Land Documents in Original and Translated English Version of Land Documents with Notary attestation for kind consideration. We have submitted clear Building Plan earlier also and for the reply of Show Cause Notice also. The Site Plan is also clearly mentioned in the Building Plan

itself and it has also been approved in the Building Plan itself. We are submitting the Building Plan for kind consideration. We submit that the inspection of our institution for issuance of Building Completion Certificate was done by Assistant Engineer. The Engineer has inspected our B.Ed. College building on 04.06.2015. we are submitting herewith the copy of the BCC for kind consideration. It is to submit that Andhra University does not have procedure to issue separate letter for approval of the staff list. The Dean and the Registrar of the University verify the staff profiles, original marks cards and personally they see all the staff members and affix seal and signature on the Staff Profile format. We have submitted the approved staff profile format in response to the Show Cause Notice. Our institution is having only one Unit of B.Ed. (50 Students). Our institution is having 11 staff members in total as per NCTE Regulations. We are submitting herewith the approved Staff List for kind consideration. We submit that the Original FDRs were submitted to the SRC and after verification of the Original FDRs, SRC has returned the Original FDRs to our institution in its letter No.68722 dated.29.06.2015. The same FDRs were submitted in response to the Show Cause Notice. Inspite of Original FDRs verification, SRC has made it as deficiency. We are submitting herewith the Form A issued by the Bank Manager and also Manager attested FDR copies for Rs.5 Lakhs and Rs.7 Lakhs for kind consideration. Further, both the FDRs are renewed upto the year 2025."

AND WHEREAS Appeal Committee noted that appellant institution is conducting B.Ed. programme since 1999 and the Provisional Revised Recognition order dated 12/05/2015 was issued for an intake of 100 seats (2 units). Appeal Committee noted that appellant institution in its appeal memoranda has stated that institution is having 11 faculty as it is having one unit (50 seats) of B.Ed. programme.

AND WHEREAS Appeal Committee noted from the regulatory file that although the appellant institution informed SRC that affiliation committee of Andhra University is allotting 50 students, yet neither the appellant formally requested SRC to reduce the intake nor did SRC issued any formal order to this effect.



AND WHEREAS Appeal Committee noted that appellant institution, with its appeal memoranda has submitted the documents found wanting in the impugned withdrawal order dated 08/01/2021. The list of faculty approved by affiliating University is for 50 seats (one unit). Appeal Committee, therefore, decided to remand back the case SRC to revisit the matter and formally decide on reduction of the intake after the appellant institution submits original notarised copy of land documents, faculty list, Building Plan, Building Completion Certificate, Site Plan, FDRs with form 'A' within 15 days of the issue of appeal order.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online submission, Appeal Committee concluded to remand back the case SRC to revisit the matter and formally decide on reduction of the intake after the appellant institution submits original notarised copy of land documents, faculty list, Building Plan, Building Completion Certificate, Site Plan, FDRs with form 'A' within 15 days of the issue of appeal order.

NOW THEREFORE, the Council hereby remands back the case of Yerra Krishnamurthy College of Education, Maripivilasa, Seethanagaram Mandal, Vizianagaram, Andhra Pradesh to the SRC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of St. Francis College of Education, Suryapet, Janagoan Road, Gandhinagar, Suryapet, Nalgonda, Telangana dated 28/01/2021 is against the Order No. SRO/NCTE/APS00358/B.Ed./{TS}/2020/121292 dated 18.12.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C). The institution has also not responded to the Final Show Cause Notice issued on 21.11.2019."

AND WHEREAS Sh. Prabhakar Reddy, Chairman and Sh. L. Reddy, Associate, St. Francis College of Education, Suryapet, Janagoan Road, Gandhinagar, Suryapet, Nalgonda, Telangana presented the case of the appellant institution on 26/02/2021. In the appeal and during personal presentation it was submitted that "Institution submitted application for shifting along with Rs. 1,50,000/- DD's towards shifting permission, processing fee. The NCTE VT committee visited on 21/08/2016 and thoroughly verified all the documents, infrastructural facilities as per the NCTE norms and guidelines. The committee satisfied and advised to submit latest approved staff particulars and original FDR's. As per the decision of 321st meeting of NCTE we submitted the latest staff approval and original FDR's to the NCTE on 06/10/2016 with inward no. 178160. Committee wrongly mentioned that we have not responding to Final Show cause notice. We have given reply to the final show cause notice submitted through SPEED post on 18/12/2019 with no: EN422135371IN IVR :6978422135371. Committee with drawn the recognition of our college on the basis of not responded to the final show cause notice. In the above circumstances I am requesting to reconsider and drop the action against the withdrawal order of our college."

AND WHEREAS Appeal Committee noted that appellant institution was granted recognition in 2003 to conduct B.Ed. programme. Appeal Committee observed from the regulatory file that appellant institution submitted a Demand Draft of Rs. 40,000/- by its letter received in the office of SRC on 09/11/2009 towards shifting fee inspection. Committee further noted that SRC by its letter dated 26/02/2014 asked the appellant institution to further pay Rs. 10,000/- towards inspection fee. Appellant institution further deposited Rs. 10,000/- by its letter dated 27/03/2014. Appellant institution continuously had requested SRC to conduct inspection.

AND WHEREAS provisional revised recognition order was issued to appellant institution on 26/05/2015 and after that appellant again requested for inspection to be conducted.

AND WHEREAS Appeal Committee noted that SRC wrote a letter dated 03/08/2016 to appellant institution wherein decision of SRC was conveyed that title deed is in order; LUC is in order. In this letter inspection fee of Rs. 1,50,000/- for causing inspection to 2nd Unit of B.Ed. was required to be submitted.

AND WHEREAS Appeal Committee understands that if any institution applies for additional intake it has to submit a fresh application and application fee consists of Inspection fee. It is not clear whether SRC had asked the appellant institution inspection fee for the basic unit or for the additional unit. One inspection is required to be conducted in case of shifting and appellant institution had paid inspection fee at the rates prevalent at the time of applying for shifting. Appellant has also paid the additional amount which SRC had asked for from time to time.

AND WHEREAS the impugned order of withdrawal dated 18/12/2020 is on the ground that (i) the management has not shifted its institution and (ii) the institution has not responded to final Show Cause Notice dated 21/11/2019. Appellant institution in its appeal memoranda submitted copy of its letter dated 18/12/2019 sent by speed post to

K. K. K.

SRC stating that the S.C.N. which was common to many institutions as learnt from Sri Venkateshwara College of Education, was not received by them.

AND WHEREAS Appeal Committee, noting that grounds of impugned withdrawal order dated 18/12/2020 are not compatible to the facts of the case as available on regulatory file, decided to remand back the case for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded that grounds of impugned withdrawal order dated 18/12/2020 are not compatible to the facts of the case as available on regulatory file, decided to remand back the case for revisiting the matter.


WHEREAS the appeal of Pratap College of Education, Ramapuram, Vetapalemm Chirala, Prakasam, Andhra Pradesh dated 04/02/2021 is against the Order No. SRO/NCTE/APS07001/B.Ed./{AP}/2020/122050 dated 29.12.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Institution has not submitted certified copy of land document. The institution has submitted building plan but not readable and not legible. The institution has not submitted the "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs. The institution has submitted a faculty list which is not approved by the Affiliating body. Some deficiencies are: - (A) Five Lecturers do not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017. (B) A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution."

AND WHEREAS Sh. M.S. Rao, Secretary and Correspondent, Pratap College of Education, Ramapuram, Vetapalemm Chirala, Prakasam, Andhra Pradesh presented online the case of the appellant institution on 26/02/2021. In the appeal and during online presentation it was submitted that "SRC vide its order dated 29.12.2020 has withdrawn our recognition observing deficiencies which were already clarified / ratified by our institution. SRC NCTE vide its order dated 01.05.2007 granted recognition to the appellant institution for running B.Ed. course in the appellant institution. Revised recognition order dated 06.05.2015 was issued to the appellant institution. It is submitted that SRC issued show cause notice dated 12.10.2018 to the appellant institution for submitting the documents. Appellant institution vide its letter dated 15.11.2018

submitted relevant documents to SRC. SRC issued another show cause notice dated 15.11.2019 to appellant institution for submitting the documents. The appellant institution vide its letter dated 12.12.2019 again submitted the documents desired by SRC and already submitted by the appellant. Surprisingly, the SRC issued the withdrawal order dated 29.12.2020 without looking into the documents already submitted by the appellant institution. It is submitted that the appellant institution is once again submitting the following documents as were submitted by the appellant to SRC. (a) Certified copy of land documents. (b) A clear & legible copy of the building plan (c) Form A issued by the Bank in respect of FDRs for Endowment & Reserve Funds (d) Staff List as per the NCTE norms and a letter issued by the affiliating body in this regard. That it is submitted that in view of the SOP, SRC ought to have issued another (2nd) show cause notice in light of the show cause notice dated 15.11.2019 before taking the impugned decision of refusal. That it is submitted that SRC has taken the impugned decision without observing that the petitioner vide its earlier replies, have already submitted the documents as desired by the SRC vide its show cause notices issued from time to time, and if any document was further required to be submitted on the part of the institution, the institution ought to have been provided an opportunity for submitting the same. It is submitted that the petitioner institution does not lack infrastructural and instructional facilities required as per the NCTE norms. It is submitted that SRC NCTE is wrong in taking the decision of rejection as no show cause notice on the grounds on which rejection order has been decided was issued to the Petitioner institution. That it is submitted that withdrawal order issued by the SRC is totally devoid of merit and is not as per statutory provisions, as mandated under NCTE Act, 1993. Appeal committee is requested to accept the appeal of the Appellant institution, so that the same be considered by it on merits."

AND WHEREAS Appeal Committee noted that appellant institution is recognised to conduct B.Ed. programme with an intake of 100 seats since 2007. Appeal Committee further noted that appellant institution is functioning from the land and building owned by applicant society since its very beginning. Appeal Committee noted that zerox and attested copies of the documents found to be wanting in the impugned order of withdrawal are available on regulatory file. Appellant institution is required to submit once again to



WHEREAS the appeal of Shradhalaya Janjati Teacher Training Institution, Shree Ganesh Nagar, Rawatbhata, Chittorgarh, Rajasthan dated 06/01/2021 is against the Order No. WRC/NCTE/RJ-722/STC/321st /2020/212347-212352 dated 07.12.2020 of the Western Regional Committee, withdrawing recognition for conducting for D.El.Ed. Course on the grounds that "Recognition was granted to the institution on 22.12.2006 on rented premises with a condition to shift the institution in its own premises within a period of three years from the date of issue of recognition order. The institution has not shifted in its own premises till date. Accordingly, Show Cause Noted was issued to the institution on 27.09.2020. The institution has not submitted the reply of the Show Cause Notice till date. In view of above, the Committee decided that the recognition of STC programme of the institution be withdrawn under clause 7(15) from the next academic session 2021-22."

AND WHEREAS Sh. Abdul Gaffar Mirza, Treasurer and Sh. R.K. Sharma, Representative, Shradhalaya Janjati Teacher Training Institution, Shree Ganesh Nagar, Rawatbhata, Chittorgarh, Rajasthan presented the case of the appellant institution on 26/02/2021. In the appeal and during personal presentation it was submitted that "Shradhalaya Janjati Teacher Training Institutions sponsored and run by Shradhalaya Ashram Smaiti, Kota and is affiliated to Department of Elementary Education, Bikaner and is also running B.Ed. programmes. WRC, NCTE has granted permission to the appellant - institution for conducting BSTC (D.El.Ed.) Course with an annual intake of 50 students in rented premises with a condition to shift to its own premises within three years of such recognition vide order No. NRCNCTE/F-7/RJ-722/9784-93 dated 22.12.2006. Thereafter, the matter of appellant was considered by WRC, NCTE in its 316th Meeting held on 27th - 28th and 4th August, 2020 and WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition/permission to

run the programme in rented premises and have not yet applied for shifting of their institution. WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision. Thereafter, the respondent/WRC, NCTE has issued Show Cause Notice dated 27.09.2020 (as it is mentioned in impugned withdrawal order) to the appellant, however, the appellant never received any such show cause notice in respect of BSTC (D.El.Ed.) course. It is pertinent to mention here that the appellant received Show Cause Notice vide WRC/RJ-560/BED/316th/2020/210050 dated 27.09.2020 in respect of Shardhalaya Janjati B.Ed. College (File Coe No. B.Ed. RJ-560). Thereafter, appellant-institution replied to aforementioned show cause notice dated 29.09.2020 vide letter No. ShJJB.ED.6/RB/2020/Reag-1 dated 20.10.2020. The reply was received by the respondent/WRC, NCTE on 23.10.2020 (A copy of reply dated 20.10.2020 is annexed. It is important to note that the appellant - institution also made an application dated 20.10.2020 for shifting of premises to plot no. 1, block-B (Part-A), Shree Ganesh Nagar, Rawatbhat Distt. Chhittorgarh (Rajasthan). The appellant has also paid requisite fee of Rs. 1,50,000/- vide DD No. 153794 dated 20.10.2020. (A copy of application for shifting of premises alongwith its enclosures is annexed. Thereafter, the WRC in its 321st meeting held on 9th to 11th November, 2020 decided to withdraw the recognition granted to the appellant institution for conducting STC programme. WRC has withdrawn the recognition granted to the appellant for conducting STC course with and annual intake of 50 students vide withdrawal Order File No. WRC/NCTE/RJ-722/STC/321st/2020/212347-212352 dated 07.12.2020, without appreciating the facts and circumstances of the present case."

AND WHEREAS Appeal Committee noted that impugned order of withdrawal dated 07/12/2020 was issued as the appellant has not shifted to its own premises and has also failed to submit reply to Show Cause Notice (SCN) dated 27/09/2020.

AND WHEREAS Appeal Committee noted that appellant institution is a composite institution conducting B.Ed. and D.El.Ed. programmes. Appellant in its appeal memoranda stated that Show Cause Notice seeking written representation in respect of B.Ed. programme was received whereas no Show Cause Notice in respect of D.El.Ed. programme was received. The subject matter of S.C.N. being the same for B.Ed. and

D.El.Ed. programme, the appellant institution had submitted a common reply dated 20/10/2020 which is available on the regulatory file.

AND WHEREAS Appeal Committee noted that there is a little difference in the names of institutions;

- (i) Shradhalaya Jayanti B.Ed. College
- (ii) Shradhalaya Jayanti Teacher Training Institution

Appellant institution as per extant regulations is therefore, required to submit two separate proposals for shifting enclosing therewith Demand Draft on account of processing fee. Inspection to be conducted in this case can be done for assessing the instructional and infrastructural requirement of a composite institution with intake of B.Ed. and D.El.Ed. programmes. Appeal Committee decided that appellant institution is required to submit separate replies to the S.C.Ns as well as separate proposals for shifting within a period of 15 days of the issue of appeal order.

AND WHEREAS After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded that appellant institution is required to submit separate replies to the S.C.Ns as well as separate proposals for shifting within a period of 15 days of the issue of appeal order.

NOW THEREFORE, the Council hereby remands back the case of Shradhalaya Janjati Teacher Training Institution, Shree Ganesh Nagar, Rawatbhata, Chittorgarh, Rajasthan to the WRC, NCTE, for necessary action as indicated above.
