ORDER

WHEREAS the appeal of Sahdev Chandravansi B.Ed. College, Village – Nawadihkalan, Bishrampur, Palamau, Jharkhand dated 17/03/2020 is against the Order No. ERC-279.17/APE00910/B.Ed/2020/62422 dated 26.02.2020 of the Eastern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Building Completion Certificate (BCC) is not duly signed by the competent authority. Building Plan (BP) is not duly approved by the competent authority. Website of the Institution is not functional as per clause 7(14)(i) of the NCTE Regulation, 2014."

AND WHEREAS Sh. R.M. Tewari, Adviser, Sahdev Chandravansi B.Ed. College, Village – Nawadihkalan, Bishrampur, Palamau, Jharkhand presented the case of the appellant institution on 26/10/2020. In the appeal and during personal presentation it was submitted that "Building Completion Certificate (BCC) signed by govt. Engineer on 22.02.2020. Building Plan (BP) already approved by competent authority (Govt. Engineer) by building construction department Govt. of Jharkhand. Website regular update and mandatory disclosure filled up by the institution time to time amendment. (www.scbc.in)."

AND WHEREAS Appeal Committee noted that appellant institution is recognised to conduct B.Ed. programme with an intake of 100 seats since the year 2008. Appellant with its appeal memoranda had submitted copies of Building plan, Building Completion Certificate and printout of website pages. Appeal Committee noted that total built up area for B.Ed. and D.El.Ed. programmes as mentioned in the Building plan & Building Completion Certificate is 4121.71 sq. meters and these documents are authenticated by Assistant Executive Engineer, Jharkhand State Building Construction Corp.

AND WHEREAS Appeal Committee decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order original of (i) Building plan, (ii) Building Completion Certificate (B.C.C.) and (iii) copy of Printout of website pages. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to ERC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Sahdev Chandravansi B.Ed. College, Village – Nawadihkalan, Bishrampur, Palamau, Jharkhand to the ERC, NCTE, for necessary action as indicated above.

ORDER

WHEREAS the appeal of Maa Sharda Educational Institute, Village – Gatheora, Panna Road, Gatheora, Chhatarpur, Madhya Pradesh dated 21/08/2020 is against the Order No. WRC/APP201660209-(A)/9839/313th/{M.P.}B.El.Ed./2020/208656 dated 23.06.2020 of the Western Regional Committee, withdrawing recognition for conducting for B.El.Ed. Course on the grounds that "The Committee considered the matter keeping in view the order of the Appellate Authority dated 05.12.2019 and decided as under:-Speaking order for withdrawal of recognition be issued."

AND WHEREAS Sh. Vikas Singh, Officer Superintend, Maa Sharda Educational Institute, Village – Gatheora, Panna Road, Gatheora, Chhatarpur, Madhya Pradesh presented the case of the appellant institution on 26/10/2020. In the appeal and during personal presentation it was submitted that "Institute has been submitted all documents dated 14 December 2019 by Madhur Courier Ref. No. 1161363273. According to WRC, NCTE New Delhi, institute has not submitted all document with the direction of appeal authority. WRC NCTE New Delhi has not given any show cause notice to the institute. WRC NCTE New Delhi has directly issued withdrawal order letter no. WRC/APP201660209-(a)/9839/313th/B.EI.Ed./2020/208656 dated 23-06-2020) without any show cause notice. Institute could submit all documents at the time of first appeal (list of faculty approved by affiliating MCBU University Chhatarpur MP with University letter. Letter no. 2810/2019 dated 04-10-2019)."

AND WHEREAS Appeal Committee noted that appellant institution was issued a Recognition order dated 05/12/2018 for conducting B.El.Ed. programme with an intake of 50 seats from academic session 2018-19. Subsequently a Show Cause Notice (SCN) dated 27/09/2018 was issued on the grounds that 'on re-examination it was found that Assistant Professors/Lecturers do not have Ph.d. or NET/SET. Appellant did not

submit any reply to S.C.N. resulting in issue of first withdrawal order dated 08/08/2019. The withdrawal order was appealed against and consequently an appeal order dated 05/12/2019 was issued. By the order of Appellate Authority appellant was required to submit to WRC a revised list of faculty, which the appellant stated, was approved by affiliating University on 04/10/2019. By the order dated 05/12/2019 of the Appellate Authority, WRC was also required to re-assess and ensure that appellant institution fulfils the eligibility criteria for conducting the B.El.Ed. programme with reference to para 1.2 of Appendix – 3 of NCTE Regulation, 2014. Therefore, Regional Committee was required to issue a speaking order afresh.

AND WHEREAS Appeal Committee noted that WRC in its 313th Meeting held from 25th to 27th February, 2020 considering the order dated 05/12/2019 of the Appellate Authority did not examine the matter holistically and passed on instructions to the office of WRC to issue a speaking order. The decision taken in the meeting of WRC was simply reproduced in the impugned withdrawal order dated 23/06/2020.

AND WHEREAS Appeal Committee noted that office of WRC has not been able to acknowledge the Appeal order in its true spirit and perspective. WRC is required to consider the revised list of faculty approved by affiliating body on 04/10/2019 and submitted along with its appeal memoranda. Appellant institution is required to resubmit to WRC within 15 days of the issue of appeal order the list of faculty approved by affiliating University on 04/10/2019. While revisiting the case WRC is also required to take into consideration the basic eligibility criteria as para 1.2 of Appendix – 3 of NCTE Regulation, 2014.

AND WHEREAS Appeal Committee decided to remand back the case to WRC for revisiting the matter after appellant institution submits within 15 days of the issue Appeal order the revised list of faculty.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded

to remand back the case to WRC for revisiting the matter after appellant institution submits within 15 days of the issue Appeal order the revised list of faculty.

NOW THEREFORE, the Council hereby remands back the case of Maa Sharda Educational Institute, Village – Gatheora, Panna Road, Gatheora, Chhatarpur, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Bharat College of Education, Karar Krishnaswamy Street, Vellore, Tamil Nadu dated 26/08/2020 is against the Order No. SRO/NCTE/APSO6139/TN/B.Ed./2020/14145 dated 21.01.2020 of the Southern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the institution on 03.10.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 04.12.2019. The institution did not submit its reply/representation in response to Final Show Cause Notice (FSCN)."

AND WHEREAS Dr. S. Rekha, Principal (Incharge), Bharat College of Education, Karar Krishnaswamy Street, Vellore, Tamil Nadu presented online the case of the appellant institution on 26/10/2020. In the appeal and during online presentation it was submitted that "SRC has mentioned that it has issued Final Show Cause Notice whereas our institution has not received any notice from NCTE. Neither we have been given any reminder. It was only ascertained that the affiliating university has called our institution and informed that the SRC, NCTE has withdrawn recognition of our institution. Thereafter we contacted SRC and obtained a xerox copy of the withdrawal order. Further we would submit that our institution is 14 years old institution and one of the best academic record holder in the university. Further, our institution has own land and building from the starting of the college. We have all the facilities as per the NCTE Regulations. We are submitting herewith all the documents as required under

regulations for kind perusal of the appeal committee. We humbly request to peruse the documents submitted and accord recognition to our institution for running B.Ed. college."

AND WHEREAS Appeal Committee noted that appellant institution was recognised to conduct B.Ed. programme in the year 2007 with an intake of 100 seats. Appeal Committee further noted that appellant institution was issued a revised recognition order dated 01/05/2015 for an intake of 2 units (50+50=100). Appeal Committee further noted that appellant institution by its letter dated 29/10/2015 submitted to SRC copies of land documents, Encumbrance Certificate, C.L.U., Building Plan and Staff list.

AND WHEREAS appellant during the course of online appeal hearing stated that institution continues to function from the same land and building where it was granted recognition in the year 2007 and after issue of revised Recognition order dated 01/05/2015 had submitted to SRC copies of required documents. Appellant with its appeal memoranda submitted copies of (i) land documents with English translation, (ii) Building Plan, (iii) B.C.C. with built up area of 2113.92 sq. meters, (iv) N.E.C. dated 05/08/2020 (v) Site Plan, (vi) FDRs with Form – A, (vii) Faculty list containing the names of a Principal + 15 faculty approved by Tamilnadu Teachers Education University on 29/08/2019. Appeal Committee decided that appellant institution is required to submit original of the faculty list, N.E.C., B.C.C. and copies of other documents to SRC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to SRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online submission of arguments, Appeal Committee concluded to remand back the case to SRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Bharat College of Education, Karar Krishnaswamy Street, Vellore, Tamil Nadu to the SRC, NCTE, for necessary action as indicated above.

Course on the grounds that "Institution did not submit certified copy of land documents. The LUC is not in proper format of State Government and only issued for the purpose of NCTE activities instead of generally. Further the NEC shows the House Site. The NEC shows the "House Site". The Building Plan is not approved, and the site of Hall and Classrooms are less than the requirement of NCTE Regulations. The BCC is not approved. The institute vide its letter dt. 20.09.2019 mentioned that "Principal Approved and staff approval pending at the University (writing for the approval)." The institute did not submit Form 'A' and original FDR's. Domain name of the website being run by the institution not provided."

AND WHEREAS Dr. A. Parkash, Director and Sh. S.S. Kumar, Principal, Our Lady College of Education M.Ed., Maduravoyal, Thriuvalluvar, Chennai, Tamil Nadu presented online the case of the appellant institution on 26/10/2020. In the appeal and during online presentation it was submitted that "Land documents were submitted repeatedly to SRC. Our institution is in same land and building from the date of recognition. Certified copy of land documents was submitted to SRC. In the state of Tamilnadu, the certified copies are computerized and issued with qr code. Whereas SRC has misconstrued as xerox copy. We are submitting certified copy for kind perusal. The State Government of Tamilnadu does not have any specified format for land use certificate. The LUC is issued locally by the Tahsildar. Our institution has submitted LUC and SRC has granted recognition for B.Ed. and M.Ed. courses considering it. Now SRC is objecting the LUC. The LUC is issued by the Tahsildar and valid for documentation.

Appeal Committee further decided that for a composite institution existing for last 16 years the above documents are enough evidence to continue the recognition and appellant institution without creating any encumbrance on the land and building of the institution should ensure enough built up area and adequate required faculty as per existing NCTE Regulations. Appellant institution is required to submit to SRC within 15 days of the issue of appeal orders originals of faculty list, Building Completion Certificate, FDRs and authenticated copies of C.L.U., N.E.C. and Building Plan. Appeal Committee decided to remand back the case to SRC for revisiting the matter.

Appellant along with its appeal memoranda submitted (i) faculty list comprising the names of one Principal and 15 Assistant Professors, (ii) Building Plan, (iii) FDRs with Form 'A',

(iv) C.L.U., (v) N.E.C., (vi) Building Completion Certificate with a built up area of 40964 sq. feet endorsed by Union Engineer Maduravol Town Panchayat.

AND WHEREAS Appeal Committee decided that appellant institution is required to submit originals and copies of the documents as required by SRC once again to SRC within 15 days of issue of appeal orders. Appeal Committee further decided that for a composite institution existing for last 16 years the above documents are enough evidence to continue the recognition and appellant institution without creating any encumbrance on the land and building of the institution should ensure enough built up area and adequate required faculty as per existing NCTE Regulations. Appellant institution is required to submit to SRC within 15 days of the issue of appeal orders originals of faculty list, Building Completion Certificate, FDRs and authenticated copies of C.L.U., N.E.C. and Building Plan. Appeal Committee decided to remand back the case to SRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee concluded to remand back the case to SRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of Our Lady College of Education, Maduravoyal, Chennai, Tamil Nadu to the SRC, NCTE, for necessary action as indicated above.

WHEREAS the appeal of Sanjivanie Mahavidyalaya, Bahraich, Lucknow Road, Kaiserganj, Bahraich, Uttar Pradesh dated 28/08/2020 is against the Minutes of 311th Meeting of NRC held on 16th – 17th January, 2020 (Items No. 1) of the Northern Regional Committee, rejecting the application for conducting B.Ed. Course on the grounds that "The application of the institutions has not been submitted within prescribed time limit as in clause 7(2). (b) of NCTE Regulations, 2014. Therefore, the applications is liable to be summarily rejected."

AND WHEREAS Sh. A.K. Kanojia, Assistant Professor and Sh. Manoj Kr. Srivastava, Sr. Accountant, Sanjivanie Mahavidyalaya, Bahraich, Lucknow Road, Kaiserganj, Bahraich, Uttar Pradesh presented the case of the appellant institution on 26/10/2020. In the appeal and during personal presentation it was submitted that "As per information running on the portal of NRC, NCTE last date for submission of online applications for new ITEP course session 2020-21 was 31-07-2019, which was extended by NRC, NCTE up to 31-08-2019. We applied and submitted for recognition for B.El.Ed. course session 2020-21 vide application No. Fr-NRC-2021-07900002 with requisite fees of rupees 300000 (three lac only) on dated 08-07-2019 vide transaction id 032f0b939ab812e3cebb. The original file along with other related documents was sent by speed post " to Director NRC, NCTE G-7, sector-10, Dwarka, New Delhi-110075" on dated 27-08-2019 which was dully received by NRC (NCTE) on dated 30-08-2019 at 15:56:41 (3:56 p.m.1st). The hard copy was also submitted within extended date (extended by NRC, NCTE) of 31-08-2019. Copy of acknowledgement of speed post and tracking record from post office are enclosed." We have however, as yet not revived any communication from NRC, NCTE office."

AND WHEREAS Appeal Committee noted that appellant has preferred appeal against the decision taken by NRC in its 311th Meeting held from 16th to 17th January,

ORDER

WHEREAS the appeal of F.S. College of Education, Near Balaji Mandir, Shikohabad, Ferozabad, Uttar Pradesh dated 04/09/2020 is against the Order No. NRC/NCTE/UP-1275/311th Meeting/2019/208568 dated 10.07.2020 of the Northern Regional Committee, withdrawing recognition for conducting for B.Ed. Course on the grounds that "as per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution."

AND WHEREAS Sh. Yogesh Yadav, Representative and Sh. J.K.S. Chouhan, Director, F.S. College of Education, Near Balaji Mandir, Shikohabad, Ferozabad, Uttar Pradesh presented the case of the appellant institution on 26/10/2020. In the appeal and during personal presentation it was submitted that "We have submitted a comprehensive reply dated 17.04.2018 in person which was entered vide Dy. No. 82 dated 17.04.2018, well before 30 days period stipulated in the Show Cause Notice dated 28.03.2018. A copy of this reply is attached as a material proof and original receipt will be presented during personal hearing in the Appeal. We have submitted a comprehensive reply dated 17.07.2019by Speed Post No. EU919008283IN: 6985919008283 dated 17.07.2019, booked from SP Firozabad HO{283203} UP, well before 30 days period stipulated in the Show Cause Notice dated 20.06.2019. A copy of this reply is attached as a material proof along with Speed post receipt. It may be appreciated that the replies as were submitted by us have not been considered reasons best known to NRC and the withdrawal order has been passed. Whereas we had submitted reply to the Revised recognition order issued to our college and also the show cause notices as and when issued to us."

AND WHEREAS Appeal Committee noted that appellant institution was recognised to conduct B.Ed. programme in the year 2004 and additional intake in B.Ed. programme was granted in the year 2008. The revised recognition order dated 06/06/2015 was v

issued for an intake of 4 units of 50 seats each subject to the condition that appellant institution will create additional facilities (a) additional built up area, (b) additional infrastructure, (c) adhere to the staff norms as per Regulation, 2014. As the appellant institution did not submit compliance of the terms and conditions of revised recognition order, a Show Cause Notice (SCN) dated 28/03/2018 was issued seeking written representative within 21 days. Appeal Committee noted that a second S.C.N. dated 20/06/2019 was also issued to appellant institution incorporating the comments of affiliating University (BRA University, Agra) wherein it was reported that appellant institution has not got its faculty approved by the University.

a reply dated 12/07/2019 which is available on regulatory file. Appeal Committee perused the reply to S.C.N. and noted that the list of faculty enclosed with this reply was neither approved nor countersigned by affiliating University and the copies of University letters conveying approval of faculty (8+9) were very old and dated 09/08/2004 and 31/03/2008. For an intake of 200 seats of B.Ed. programme, the institution is required to possess one Principal and 30 faculty approved by affiliating body. Obviously, the appellant had failed to get the faculty approved by affiliating body as per NCTE Regulation, 2014.

AND WHEREAS Appeal Committee noted from the regulatory file that appellant institution had filed a Writ Petition No. 2307/2020 in the High Court of Delhi and Hon'ble High Court by its order dated 14/08/2020 had allowed the petitioner institute to participate in the Counselling for academic session 2020-21 and incompliance of the Court's order NRC by its letter dated 08/11/2020 had informed the affiliating body and Department of Higher Education, Government of Uttar Pradesh that institution is permitted to give admission for the academic session 2020-21 and will not be permitted to admit students from academic session 2021-22.

AND WHEREAS Appeal Committee noted that operation of impugned order of withdrawal dated 10/07/2020 has been postponed to academic year 2021-22 and the Regional Committee has now enough time to retrospect the whole matter. Appellant states to have submitted replies to the Show Cause Notices. Most important of the

22

points to be examined is whether after the grant of revised recognition order the appellant had appointed the required number of faculty duly approved by affiliating University. Appellant institution is required to submit to NRC within 15 days of the issue of appeal order a consolidated list of faculty countersigned by affiliating body. List of faculty shall be in the prescribed format indicating the dates of appointment of each faculty member. The list of faculty approved by University then should be matched with the bank statements as evidence of salary having been remitted into the accounts of each faculty. Appeal Committee decided to remand back the case to NRC for completing this exercise and for the purpose may seek such required documentary evidence as it deems necessary from the appellant institution. Appellant institution will be required to submit documents required by NRC with 15 days of these being called for.

AND WHEREAS with these limited observations, Appeal Committee decided to remand back the case to NRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to NRC for revisiting the matter.

NOW THEREFORE, the Council hereby remands back the case of F.S. College of Education, Near Balaji Mandir, Shikohabad, Ferozabad, Uttar Pradesh to the NRC, NCTE, for necessary action as indicated above.
