

#### CHAPTER 1

#### Introduction

- 1.1 The National Council for Teacher Education (NCTE) was established on 17th August, 1995 by an Act of Parliament, namely, the NCTE Act, 1993 (No.73 of 1993). The NCTE Act has given a broad mandate to the Council to achieve planned and co-ordinated development of teacher education and to regulate and maintain norms and standards in the teacher education system. Section 12 of the NCTE Act defines in explicit terms the broad functions of NCTE for achieving the goal of planned and co-ordinated development of teacher education. The NCTE Act makes provisions for laying down regulations, norms and standards and procedures for establishment and recognition of programmes in teacher education institutions. At the same time, it also provides direction as to how these regulations will ensure the quality improvement in teacher education. Within the framework of the devised mechanism, the NCTE has given recognition to 11861 teacher education institutions covering different courses with an intake of 1096053 up to 31st March, 2009.
- 1.2 The National Council for Teacher Education has been playing a pro-active role in the field of teacher education. Ever since its establishment in 1995, the NCTE has endeavoured to keep pace with the developments around and adopted a judicious approach of developing a right perspective in the field of teacher education at different levels i.e. Primary, Elementary and Secondary. It has given priority to the preparation of teachers for elementary education to achieve the national goal of Universalisation of Elementary Education (UEE) in the context of the constitutional mandate of Right to Education being a Fundamental Right.
- Application of information and communication technologies (ICTs) as a component in the working of offices of the NCTE to bring transparency and efficiency in the procedure of granting recognition and disposal of appeals has been further strengthened. A new and improved Management Information System (MIS) has been developed and is being further improved to have a functional online linkage of Regional Committees with the NCTE Headquarters. This brings all information concerning the activities performed by

the Regional Committees, especially in regard to various stages of processing of applications for grant of recognition in the public domain. This has brought transparency in the functioning of the Regional Committees. Websites of all the recognized teacher education institutions are also being linked to the website of the NCTE.

#### CHAPTER 2

### Overview of the activities during 2008-09

The affairs of the National Council for Teacher Education are managed by the 2.1 Council consisting of 43 official and non-official members headed by the Chairperson. The Council is constituted by the Central Government i.e. Union Ministry of Human Resource Development under Section 3 of the NCTE Act. The Council constituted in October, 2007 for a period of two years, continued to look after the affairs of the NCTE during the year 2008-09. The headquarters of NCTE is located at New Delhi and it has four Regional Committees under it. The Headquarters formulate policies and procedures for grant of recognition and prescribe norms and standards for teacher education courses. The National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2007 formulated under Section 32 of the NCTE Act and notified on 10th December, 2007, continued to regulate recognition procedure during the period. The Regional Committees are vested with the powers to grant recognition to the institutions to offer teacher education programmes in accordance with the regulations, norms and standards prescribed by the NCTE. The four Regional Committees located at Bhubaneswar, Bhopal, Jaipur and Bangalore covering specified States/Union Territories under their respective jurisdiction are constituted and notified by the NCTE, with a Chairperson nominated by the Council. The Regional Committees were last constituted by the NCTE vide Notification dated 7th July, 2008. The Regional Committees are assisted by the Regional Director and other officials.

The regulatory functions of the NCTE include activities germane to the academic norms and standards relating to various aspects of teacher education. Such regulations provide, inter-alia, the mode of functioning of the Council, co-option of members to the Council and the norms, guidelines and standards in respect of the minimum qualifications for a person to be employed as a teacher; courses of training in teacher education; starting of new courses or training in recognised institutions; tuition fees and standards in respect of examinations leading to teacher education qualifications. The Council examines and reviews periodically adherence by recognized institutions to the norms and standards laid down by it and advises them accordingly. Suitable performance appraisal mechanism for enforcing accountability on recognised institutions has also been evolved.

NCTE also encourages and supports activities like seminars, workshops and brings out publications, etc., with a view to improve quality of the teacher education programmes and upliftment of teacher education as a whole. The Council also undertakes surveys and studies related to various aspects of teacher education and publishes the results thereof.

#### 2.2 Status regarding institutions seeking recognition

There has been a consistent increase in the number of applications received by the Regional Committees, which have been vested with powers to grant recognition to the institutions desirous of starting teacher education courses. The Regional Committees made all-out efforts to expedite processing of applications by streamlining the procedure and ensured that the applications are processed within the time frame prescribed in the Regulations.

#### 2.3 Status of recognition of institutions

As on 31st March, 2009, 11861 teacher education institutions were recognised with an intake of 1096053 having 14405 teacher education courses at different levels like Pre-primary, Elementary, B.El.Ed., B.Ed. (Face-to-Face and Distance Mode), M.Ed. (Face-to-Face and Distance Mode), M.Ed. (Part Time), C.P.Ed., B.P.Ed., M.P.Ed. and others. Many institutions are conducting multiple courses having different levels. Status of the courses and the intake as on 31st March, 2009 in comparison to 31st March, 2008 is indicated in Annexure I. The region-wise and State/UT-wise (within the region) break-up is given in Annexures I (A), I (B), I (C) and I (D).

#### 2.4 Revision of Regulations, Norms and Standards

A number of provisions of the NCTE Act, Rules and Regulations have been a subject of judicial scrutiny and interpretation at the level of the Hon'ble Supreme Court of India and several High Courts in the country in response to writ petitions filed by aggrieved parties in matters relating to recognition of teacher education institutions. While disposing the petitions, the Courts made such observations which warranted modifications in the existing rules and regulations. Moreover, the Ministry of Human Resource Development also issued directions to NCTE on 27th May, 2008 under Section 29 of the NCTE Act to review the NCTE Regulations, Norms and Standards. In view of the observations made by the courts and in compliance of the directions issued by the Ministry of HRD, an exercise of the revision of Regulations and Norms and Standards was undertaken and for this purpose, a committee comprising of experts in the field of teacher

education was constituted to make recommendations. The revised Regulations, Norms and Standards were notified in the Gazette of India on 31.08.2009.

#### 2.5 Revision of Norms and Standards

The unprecedented expansion in the system of teacher education, especially in the private sector, has not been based on any systematically drawn plan of its development which addresses the trained manpower needs in the sectors of school and teacher education. As per the provisions of the NCTE Act, Rules and Regulations, fulfillment of the laid down Norms and Standards makes an institution eligible for NCTE's recognition. However, since the laid down Norms and Standards were too liberal, it helped a large number of institutions to obtain NCTE's recognition. The Norms and Standards notified in December 2007, which were in force during this period, were found to be wanting in some aspects in the context of maintenance of proper standards. The Expert Committee formed for revision of the Regulations, Norms and Standards took care of this aspect and recommended rationalization of the norms and procedure of recognition so as to ensure that the standards are revised upward for the sake of qualitative improvement in the teacher education programmes and institutions and the element of discretion in their enforcement is eliminated.

The Committee noted that the Norms and Standards for the recognition of teacher education institutions were first promulgated by the NCTE in 1996 and were later revised. The NCTE Regulations of November, 2007 had notified the Norms and Standards in respect of the following 13 teacher education programmes:

Certificate in Education Programme (C.Ed.)

Diploma in Education Programme (D.Ed.)

Bachelor of Elementary Education Programme (B.El.Ed.)

Bachelor of Education Programme (B.Ed.)

Master of Education Programme (M.Ed.) Full Time

Master of Education Programme (M.Ed.) Part Time

Certificate in Physical Education Programme (C.P.Ed.)

Bachelor of Physical Education Programme (B.P.Ed.)

Master of Physical Education Programme (M.P.Ed.)

Bachelor of Physical Education (B.P.Ed.) – Four Years Integrated

Diploma in Education Programme (D.Ed.) - Open and Distance Learning

Bachelor of Education Programme (B.Ed.) – Open and Distance Learning

Master of Education Programme (M.Ed.) – Open and Distance Learning

Out of the above 13 programmes, the Committee observed that 4 Years B.P.Ed. (Integrated) programme is being offered by Laxmi Bai National Institute of Physical Education, Gwalior only. The programme is good but its coverage is limited and there is little possibility of its expansion outside the sphere of the existing institution. The present Norms and Standards of this programme is simply an endorsement of the Norms prepared by the institution itself for this course where it is being run at present. Similar is the situation for the M.Ed. (Part Time) programme. The Committee did not recommend the norms for these two programmes. However, recognition of these programmes in the existing institutions would be continued and any application from a new institution for such programmes would be dealt under the category of innovative programmes.

Based on the review and recommendations of the Expert Committee, the Norms and Standards of the following programmes have been revised:

Diploma in Early Childhood Education Programme (D.E.C.Ed.)

Diploma in Elementary Education Programme (D.El.Ed.)

Bachelor of Elementary Education Programme (B.El.Ed.)

Bachelor of Education Programme (B.Ed.)

Master of Education Programme (M.Ed.)

Diploma in Physical Education Programme (D.P.Ed.)

Bachelor of Physical Education Programme (B.P.Ed.)

Master of Physical Education Programme (M.P.Ed.)

Diploma in Elementary Education Programme (D.El.Ed.) (Through Open and Distance Learning)

Bachelor of Education Programme (B.Ed.) (Through Open and Distance Learning)

Master of Education Programme (M.Ed.) (Through Open and Distance Learning)

Elementary teacher training programmes in different states are offered by different names like D.Ed. STC, Diploma in Basic Education, Diploma in Primary Education, etc., though for recognizing them, the same existing norms for D.El.Ed. are applied by all States. In order to bring uniformity in the nomenclature, avoid confusion and to facilitate the maintenance of records / data, it has been decided that all the existing institutions imparting the elementary teacher education programme be asked to change the nomenclature of this programme to D.El.Ed.

### 2.6 NCTE framed Norms and Standards for Diploma in Visual Arts Education and Diploma in Performing Arts Education

The Government of Gujarat had to recruit some 17000 primary teachers, out of which 7% positions were earmarked for Arts and Music teachers. The candidates possessing Sangeet Visharad diploma awarded by Akhil Bhartiya Gandharva Mahavidyalaya, Mumbai and Brihad Gujarat Mahavidyalaya, Ahmedabad were not selected by the State Education Department as their qualifications were not considered valid. The aggrieved candidates sought relief from the Hon'ble High Court of Gujarat through a writ petition. The NCTE pleaded that in the case of Arts and Music teachers it was the responsibility of the State Governments to prescribe qualifications, as mentioned in the footnote of the NCTE Regulations notified in 2002, but the Hon'ble Court did not accept the NCTE's plea by pointing out that the NCTE Act, 1993 entrusts this responsibility to the NCTE and it shall be failing in its duty if it does not lay down norms and standards for Arts teachers. The Hon'ble Court further directed the NCTE to undertake and complete this task on a priority basis.

In compliance of the order of the Hon'ble Court, the NCTE constituted a Committee of experts to evolve norms for recognition of Art Teacher Education programme, namely, Diploma in Visual Arts Education and Diploma in Performing Arts Education. The Norms and Standards for Art and Music teachers have also been notified as part of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009.

#### 2.7 Deliberations on Curriculum Framework

A High Powered Committee was entrusted with the task of developing the Curriculum Framework of Teacher Education. The Committee finalized the draft document. It was shared widely with teacher educators across the country for its further improvement at two widely attended consultative conferences of eminent teacher educators and other stakeholders organized by NCTE at the Department of Education, Rajasthan Vidyapeeth, Udaipur on January 22-23, 2009 and at the Department of Education (IASE), Osmania University, Hyderabad on January 29-30, 2009. The consultative conferences deliberated on all the chapters of the draft Curriculum Framework. In the light of the discussions, it was suggested that the committee should further refine the Curriculum Framework before its finalization as its different aspects are flexible, open for discussion and need modification to suit the local needs. The draft Curriculum Framework was thoroughly reviewed by the Committee and placed before the Council in its meeting held on 4th August, 2009 which approved it with certain suggestions for

its further refinement by a select committee which has accordingly been done. Thereafter, it has been placed in public domain for further feedback, obtaining the comments from all concerned and inputs from the State Governments/UTs. The framework has been fine tuned in the light of these inputs before its publication as suggested by the Council.

#### 2.8 NCTE renews MOU with NAAC

National Council for Teacher Eduation (NCTE) and National Assessment and Accreditation Council (NAAC), an autonomous body of the UGC, renewed their MOU on October 7, 2008 to foster quality assurance and quality sustenance in pre-service teacher education in the country by working in close cooperation with each other in pursuit of excellence in teacher education. The National Council for Teacher Education (Recognition Norms and Procedure), Regulations, 2009 prescribe NAAC accreditation for different teacher education programmes offered by the teacher education institutions and the MoU would help NAAC to achieve the targets of accreditation.

#### 2.9 NCTE-NAAC National Consultative Committee


In pursuance of and for implementation of the NCTE-NAAC MoU, a 15 member National Consultative Committee was constituted under the Chairmanship of Chairperson, NCTE with Prof. H.A. Ranganath, Director, NAAC as its Co-Chairperson. The terms of reference of the National Consultative Committee are:

- (a) To evolve and review norms and standards of accreditation of teacher education programmes;
- (b) To analyze the periodic feedback received on issues such as recognition, assessment, accreditation, etc. and suggest necessary measures for improving the processes;
- (c) To facilitate formulation of appropriate strategies for achievement of the aims and objectives of this MoU; and
- (d) To ensure effective implementation of the decisions taken in this regard.

#### 2.10 Strengthening Environmental Education in Teacher Education

#### Initiating a joint project:

National Council for Teacher Education and Centre for Environment Education, Ahmedabad, have been working together over the last three years towards



#### Developing resource books:

As a part of this initiative, a set of three Resource Books on Environmental Education (EE) for Teacher Education has been developed jointly by the NCTE and CEE and published in English and Hindi, under the guidance of a Project Advisory Committee comprising national level experts in teacher education and environmental education. The Resource Books have been developed based on the NCTE's curriculum on Environmental Education in Teacher Education.

#### Orienting key trainers:

To ensure effective use of this educational resource, the users need to be oriented appropriately with hands-on experience of using interactive and experiential teaching-learning methodologies involved in the suggested resource books. For this purpose, six orientation and dissemination workshops were organized at Lucknow, Chandigarh, Bangalore, Hyderabad, Ahmedabad and Shillong during November, 2008 to February, 2009. Around 135 key resource persons were trained in the use of Environmental Education (EE) material embodied in these resource books for Teacher Educators at D.Ed., B.Ed. and M.Ed. levels. Environmental Education is usually an elective subject in B.Ed. and one of the special papers at the M.Ed. level. These workshops were aimed at:

- Training master trainers to use EE Resource Books as part of teacher education programmes, besides strengthening their understanding of EE and ESD through providing hands-on experience in using interactive and experiential teaching-learning methodologies.
- Discussing possible ways of using EE Resource Books at various levels of teacher education like D.Ed., B.Ed. and M.Ed..
- Exploring ways in which master trainers could further train and orient teacher educators in their respective states/districts.
- Facilitating networking for EE and teacher education in the country.
- Developing action plans for strengthening ESD in teacher education by using these Resource Books.

#### 2.11 NCTE Intel Teach Professional Development Collaborative Project

NCTE and Intel Teach signed an MoU in December 2006 towards jointly providing professional development programmes to teacher educators in all teacher education institutions in the country. This collaborative efforts was named Project XPDITTE (Xcelerated Professional Development for Integration of Technology in Teacher Education). The objective of this collaborative project is to prepare future teachers for the knowledge economy where the use of technology can help shape their success.

To achieve this goal, Intel Teach and NCTE are working together to impart sustained professional development to teacher educators in all the recognized teacher education institutions across the country and make ICT an integral part of the Teacher Education Curriculum. Around 7145 Master Trainers & Master Trainer Peer Teachers have been imparted Professional Development training under project XPDITTE.

# 2.12 Study on Demand and Supply Estimates of Teachers and Teacher Educators (2007-08 - 2016-17)

#### Objective of the Study

- To study the trends and to take stock of the teachers and teacher educators at different school stages upto 2006-07 in States/UTs.
- To study the trends of the intake and out-turn in teacher education institutions for various courses meant for various school stages upto 2006-07 in States/UTs.
- To estimate demand and supply of teachers and teacher educators at different school stages from 2007-08 to 2016-17.
- To develop locational plan of the requirement of teacher education institutions from the standpoint of geographical and demographic considerations and constraints in the States/UTs.

To provide academic and technical inputs, a Technical Advisory Group (TAG) of experts was constituted by the Council which helped in the development of detailed guidelines and formats for collecting necessary data and information

from the states and UTs. In the states and UTs, Directors of SCERTs/ Principals of SIEs/ Directors of Education have been appointed as nodal officers at NCTE HQs. The study is to cover all the states/UTs.

#### 2.13 Progress of the Study during 2008-09

Projections of Child Population Age-cohort (5-8 years) for the years 2007-08 to 2016-17:

Based on the deliberations and methodology suggested by the experts, age-cohort projections of school-going (5-18) for all the states/ UTs including all India have been worked out which is based on the projection of Census 2001 by RGI office and Report of the Technical Group on Population Projection constituted by National Commission on Population (May 2006) revised in December, 2006. This document has been released by the Office of the Registrar General & Census Commissioner, India. A meeting of the experts who were associated with earlier meeting on 5th December, 2007 was held on 4th April, 2008 which discussed in details the methodology. Based on their expert opinion, the projections have been carried out.

#### The Meeting of the Technical Advisory Group (TAG)

A meeting of the Technical Advisory Group (TAG) was held on 10<sup>th</sup> September, 2008 at NCTE Hqrs. under the Chairperson, NCTE. The agenda of the meeting was to discuss the methodology of working out demand and supply estimates of teachers and teacher educators at school stages: 2007-08- 2016-17. Some of the decisions emerged from the meeting pertained to: (i) Separate projections of school age cohort for pre-primary classes. (ii) Consideration of giving weightage to teaching load of school teachers at the secondary and senior secondary stage. (iii) Circulation of the draft report to the members of TAG as and when they are ready.

#### Progress on Data Collection from the States/ UTs

Partial data from 15 States/UTs - Andaman & Nicobar Islands (UT), Chandigarh (UT), Chhattisgarh, Goa, Gujarat, Himachal Pradesh, Haryana, Kerala, Madhya Pradesh, Mizoram, NCT of Delhi, Punjab, Rajasthan, Tamil Nadu and Puducherry was received by 31st March, 2008. The process of data collection continued from other states/ UTs. By 31st March, 2009, the data from the remaining states was also received except UTs of Dadra & Nagar Haveli, Daman & Diu and Lakshadweep.

#### Progress on Drafting of the Reports of the States/UTs

The project team took the task of processing of the data received from the states/UTs. After tabulation and generating tables, the draft report of the first three chapters of the states/UTs of Arunachal Pradesh, Assam, Bihar, Chhattisgarh, Gujarat, Haryana, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Karnataka, Madhya Pradesh, Maharashtra, Mizoram, Nagaland, Orissa, Punjab, Rajasthan, Tripura, Uttarakhand, Uttar Pradesh, West Bengal and NCT of Delhi was developed. In case of Andhra Pradesh and Kerala, the final drafts containing nine chapters were sent to the nodal officers of the respective states and also to the TAG members. The report of Tamil Nadu state was also finalized while the process of finalization of reports of the remaining states/UTs is in progress.

#### CHAPTER 3

#### **National Headquarters**

3.1 The headquarters of the Council is located at Delhi in accordance with the NCTE Act. The NCTE headquarters formulates policy and procedures for grant of recognition and also prescribes norms and standards for teacher education courses. Section 12 of the NCTE Act defines the broad functions of the Council to ensure planned and co-ordinated development of teacher education and for determination and maintenance of standards for teacher education.

Appeals under Section 18 of the NCTE Act preferred by institutions aggrieved by the decision of the Regional Committees under Section 14, 15 and 17 are also dealt with at the NCTE headquarters. To improve the quality of teacher education, the NCTE headquarters also undertakes academic activities such as surveys and studies relating to various aspects of teacher education; making recommendations to the organisations/establishments concerned with teacher education; promoting innovations and research in various areas of teacher education and formulating schemes for various levels of teacher education. Besides these aspects, it also facilitates the functioning of the Regional Committees and provides administrative support and policy guidelines to the Regional Committees.

#### 3.2 Role of Establishment at NCTE headquarters

The Council is headed by the Chairperson and assisted by the Vice Chairperson and Member Secretary. For the purpose of enabling the Council to discharge its functions efficiently, the Council under Section 10 of the NCTE Act has the power to appoint such number of officers and other employees as it may consider necessary provided that the category of posts equivalent to Group 'A' posts in the Central Government shall be subject to the approval of the Central Government. The Chairperson, Vice Chairperson and Member Secretary are also members of the Council. The total sanctioned strength of the staff in the Council including the strength in the offices of the Regional Committees is 123. The NCTE headquarters is responsible for recruitment/appointment of the officers and other employees of the Council up to Group 'C'-level and for their further posting at the headquarters and at the offices of the Regional Cmmittees, as the case may be, for the purposes of smooth and efficient functioning of NCTE.

#### 3.3 Disposal of Appeals

In terms of the provisions of Section 18 of the NCTE Act, any person aggrieved by the orders issued by the Regional Committees under Section 14, 15 and 17 can prefer an appeal in the prescribed Form to the Council within 60 days of issue of such orders along with the prescribed fee and with the memorandum of appeal. On receipt of the memorandum of appeal, the Council calls for the records of the case from the concerned Regional Committee and after giving the appellant a reasonable opportunity of being heard, passes such order as it may deem fit. The Council endeavours to dispose of every memorandum of appeal within a period of 3 months from the date of its filing. The Council ordinarily does not allow more than three adjournments in any appeal.

During the year 2008-2009, the Appeal Committee held 10 meetings and 508 appeals were heard, considered and disposed. Out of these, the Council confirmed the Orders passed by Regional Committees in 282 cases, reversed the Regional Committees' orders in 152 cases and remanded back 68 cases to the Regional Committees for reconsideration. In respect of 6 appeals, the appellants had withdrawn the appeal preferred by them.

#### 3.4 Right to Information Act

This Act, which came into being in the year 2005, is being followed in letter and spirit by the NCTE. An Under Secretary is nominated as the Public Information Officer and the Member Secretary is nominated as the Appellate Authority in the NCTE headquarters. In each of the four Regional Committees of NCTE, an Under Secretary has been nominated as the Public Information Officer and the respective Regional Director as the Appellate Authority.

#### 3.5 Inspection Under Section 13

For the purposes of ascertaining whether the recognised institutions are functioning in accordance with the provisions of the NCTE Act, the Council may cause inspection under Section 13 of such institutions. Rule 8 of the NCTE Rules, 1997 provides that for inspection of the recognized institutions, the Council shall approve a panel of names of experts in teacher education or educational administration who may be able to inspect the recognized institutions.

The Council did not have any panel of experts for the purpose of inspections under Section 13 of the NCTE Act and Rule 8 of the NCTE Rules. Therefore, the Council requested the education departments of various universities, Directors of SCERTs

and DIETs to suggest names of suitable persons to be included in the panel of experts. The panel was circulated among the members of the Council and their suggestions were incorporated in it. The panel was finally approved by the Council in its meeting held on 24th December, 2008. A panel of 500 experts is now available with the Council for the purpose of inspections under Section 13 of the NCTE Act.

During the year 2008-09, inspections of about 400 recognized institutions were caused. It was found that 160 of these institutions were not being run in accordance with the norms prescribed by the NCTE and as such necessary action was initiated against them.

#### 3.6 Council and its meetings

The composition of the Council is given at Annexure II. During 2008-09, one meeting of the Council was held on 12<sup>th</sup> December, 2008 wherein the following major decisions were taken:

The Council ratified the action taken by the NCTE with the approval of Chairperson, NCTE in re-constitution of the Regional Committees and nominating one of its members as its Chairman in respect of all the four Regional Committees.

The Council ratified the action/decision taken by the Chairperson, NCTE for extending the last date for taking the final decision on the recognition of institutions for the academic session 2008-09 to 31st August, 2008 instead of 15th May, 2008, as provided in the NCTE Regulations, 2007 by way of amendment to the Regulation and according permission to the Regional Committees for granting recognition/permission for the 2008-09 session even after the extended date of 31st August, 2008 in certain cases on the specific recommendation of the Regional Committees.

The Council was assured that the directions issued by the Ministry of Human Resource Development under Section 29 of the NCTE Act shall be acted upon.

The Council approved the list of experts placed before it for inspection of institutions under Section 13 and further authorized the Chairperson to keep revising the list and adding more persons of integrity to the list that NCTE may come across for conducting such inspections.

#### 3.7 NCTE Foundation Day

The National Council for Teacher Education celebrated its 13<sup>th</sup> Foundation Day on 18<sup>th</sup> August, 2008 at the India Islamic Cultural Centre Auditorium, Lodi Road,

New Delhi. Shri M.A.A. Fatmi, Minister of State for HRD graced the occasion as the Chief Guest. Prof. Mrinal Miri, former Vice-Chancellor, NEHU delivered the Foundation Day Lecture. On the occasion, Prof. C.L. Anand former Vice-Chancellor, Arunachal University, was honoured by the NCTE for his distinguished contribution to Teacher Education.

#### 3.8 NCTE Library

In order to formulate a policy for books to be recommended for libraries in the teacher education institutions, a Committee consisting of four members was constituted on 29.09.2008. The Committee met on 18.12.2008 and 01.04.2009 at NCTE Hqrs., New Delhi for finalization of the list of books and the policy for acquisition of new books. The titles of the books/reference books finalized by the Committee have been published in the Manual for Teacher Education Institutions and Teacher

Educators. About 353 reference books/journals have been included in the list recommended by the Committee.

#### **Publications of NCTE:**

NCTE published Anweshika "Indian Journal of Teacher Education" Vol- V(1) and Vol-V(2)". 5000 copies of the Journal were printed and out of which 3240 copies were distributed.

#### CHAPTER 4

#### **Regional Committees**

#### 4.1 Eastern Regional Committee (ERC)

During the year 2008-09, nine meetings of the Eastern Regional Committee were held to consider the matters related to grant of recognition to various teacher education institutions and other related issues. 277 applications for various courses were received and processed by the Regional Committee.

#### 4.2 Northern Regional Committee (NRC)

During the year 2008-09, fifteen meetings of the Northern Regional Committee were held to consider matters related to grant of recognition to teacher education institutions and other related issues. 2038 applications for various courses were received and processed by the Regional Committee.

#### 4.3 Southern Regional Committee (SRC)

During the year 2008-09, sixteen meetings of the Southern Regional Committee were held to consider matters related to grant of recognition to teacher education institutions and other related issues. 372 applications for various courses were received and processed by the Regional Committee.

#### 4.4 Western Regional Committee (WRC)

During the year 2008-09, thirteen meetings of the Western Regional Committee were held to consider matters related to grant of recognition to teacher education institutions and other related issues. 775 applications for various courses were received and processed by the Regional Committee.
