Introduction

- 1.1** The National Council for Teacher Education (NCTE) was established on 17th August, 1995 by an Act of Parliament, namely, the NCTE Act, 1993 (No. 73 of 1993). The NCTE Act has given a broad mandate to the Council to achieve planned and co-ordinated development of teacher education and to regulate and maintain norms and standards in the teacher education system. Section 12 of the NCTE act defines in explicit terms the broad functions of NCTE for achieving the goal of planned and co-ordinated development of teacher education. The NCTE Act makes provisions for laying down regulations, norms and standards and procedures for establishment and recognition of programmes in teacher education institutions. At the same time, it also provides direction as to how these regulations will ensure the quality teacher education. Within the framework of the devised mechanism, the NCTE has given recognition to 11712 teacher education institutions covering different courses with an intake of 1111680 up to 31st March, 2010.
- 1.2** The National Council for Teacher Education has been playing a pro-active role in the field of teacher education. Ever since its establishment in 1995, the NCTE has endeavoured to keep pace with the developments around and adopted a judicious approach of developing a right perspective in the field of teacher education at different levels of the School System. It has given priority to the preparation of teachers for elementary education to achieve the national goal of Universalisation of Elementary Education (UEE) in the context of the constitutional mandate under the Right of Children to Free and Compulsory Education (RTE) Act, 2009.
- 1.3** Application of information and communication technologies (ICTs) as a component in the working of offices to the NCTE to bring transparency and efficiency in the procedure of granting recognition and disposal of appeals has been further strengthened. A new and improved Management Information System (MIS) has been developed and is being further improved to have a functional online linkage of Regional Committees with the NCTE Headquarters. This would bring all information concerning the activities performed by the Regional Committees, especially in regard to various stages of processing of applications for grant of recognition in the public domain. This has brought transparency in the functioning of the Regional Committees. Websites of all the recognized teacher education institutions are also being linked to the website of the NCTE.

- Empower the future teachers by preparing them as effective teachers for tomorrow.
- Support select colleges to develop as model colleges of education in terms of their ICT deployment, usage and integration.
- Take "Project XPDITTE" forward for promoting qualitative teaching and learning practices.

The main focus of the second phase of the MoU with NCTE would be online learning and sharing. Intel also intends to recognize excellence in education by instituting awards in all categories of teacher education.

2.3 National Curriculum Framework for Teacher Education

The National Curriculum Framework for Teacher Education (NCFTE) aims at improving the quality of teacher education by addressing contemporary concerns and defining a new vision of teacher education. It will bring important changes in the existing teacher education programmes which should help teachers become professional practitioners and more humane in their approach towards learning needs of children. The Framework emphasizes that the teachers should be so oriented that they impart education to children through activities, discovery and exploration of environment and surroundings. It focuses on inclusive education, development of a perspective of equitable and sustainable development, gender issues, role of community in education and information and communication technology (ICT) in schooling as well as e-learning.

2.4 Seminar on Bridging Teaching and Learning

The English and Foreign Languages University, Hyderabad organized an NCTE sponsored National Seminar on Quality Education on 16th – 17th November, 2009 on "Bridging Teaching and Learning in the Education of English Language in Schools and Teacher Education Institutions". It was an attempt to probe into sub-themes like ICT, multilingualism, educational research and classroom-based studies with a focus on teacher education and ELT. It provided a platform to as many as 42 teachers and teacher educators to make presentations and share their experience on the themes.

2.5 International Conference on Peace Education

Janardan Rai Nagar Rajasthan Vidyapeeth University organized NCTE sponsored International Conference on "Role of Teacher Education Institutions in Promoting Culture of Peace" on 19th to 21st February, 2010 at Lokmanya Tilak Teachers Training College (C.T.E.). Nearly 200 participants attended the conference and presented papers on topics related to the theme. The conference recommended bringing out a comprehensive source book on Peace Education for teacher educators covering components such as, the conceptual wealth presenting the relevant world views, philosophical and sociological dimensions, literacy contributions, gleanings from great thinkers, the Indian cultural heritage as a repository of peace and human welfare, institutional efforts in promoting peace, human right movement and epistemological and pedagogical nuances and strategies for augmenting behaviour transformation.

2.6 Amendment in clause 7(1) of Regulations, 2009.

In order to address the difficulties faced in processing the applications received online clause 7(1) of the Regulations, 2009 has been amended in the following manner:

- (a) Application will be summarily rejected only if the following are not submitted at the time of initial online application :
- The processing fees as provided under Rule 9 of the NCTE Rules, 1997 as amended from time to time.
 - Hard copy in triplicate of the print-out of the uploaded online application.
 - Copy of the registered land documents issued by the competent authority, indicating that the society / institution applying for the course possessed land on the date of application.
- (b) The other documents listed in clause 7(1) of the Regulations, 2009, e.g. certified copy of the registered land document, building plan approved by the competent authority, notarized copy of the CLU, fixed deposit receipts of Rs. 5.00 lakhs and Rs. 3.00 lakhs towards endowment fund and reserve fund, respectively and an affidavit in the prescribed form on Rs. 100/- stamp paper, ought to be submitted at the time of initial submission of application.

3.3 Right to Information Act

RTI Act, which came into being in the year 2005, is being followed in letter and spirit by the NCTE. An Under Secretary is nominated as the Public Information Officer and Member Secretary is nominated as the Appellate Authority in the NCTE Headquarters. In each of the Regional Committees of NCTE, an Under Secretary has been nominated as the Public Information Officer and the respective Regional Director as the Appellate Authority.

3.4 Inspection Under Section 13

Section 13 of the National Council for Teacher Education Act, 1993 provides that for the purpose of ascertaining whether the recognized institutions are functioning in accordance with the provisions of this Act, the Council may cause inspection of any such institutions, to be made by such persons as it may direct, and in such manner as may be prescribed. Rule 8 of the NCTE Rules, 1997 provides that for inspection of the recognized institutions under Section 13 of NCTE Act, the Council shall approve a panel of names of experts in teacher education or educational administration who may be able to inspect the recognized institutions. Such a panel has already been prepared and has been functional.

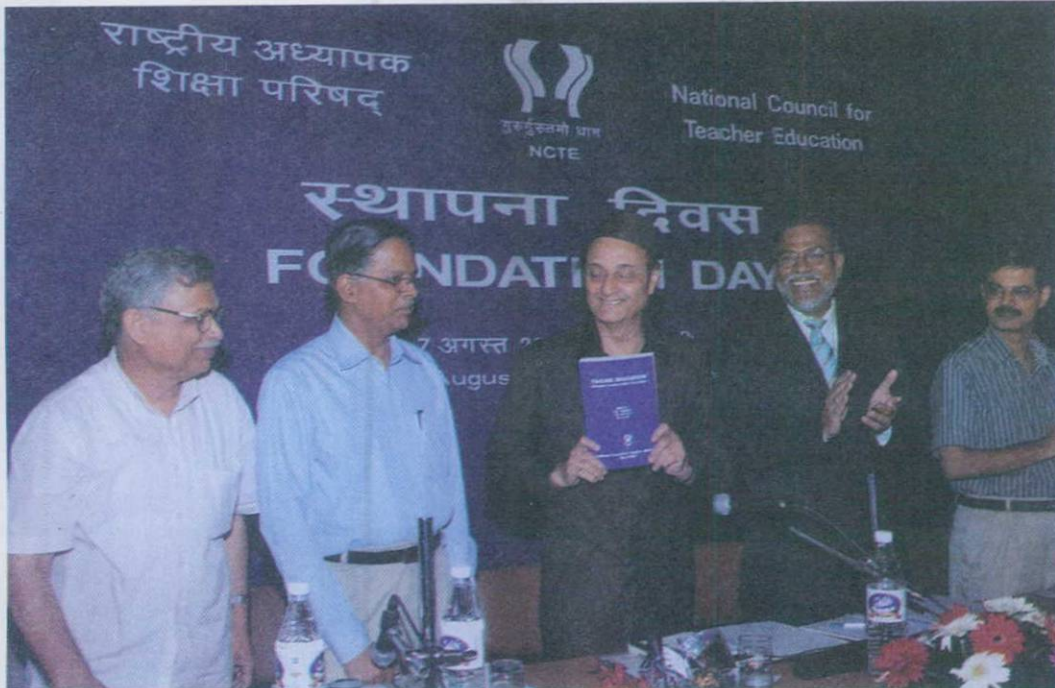
During the year 2009-2010, 116 teacher training institutions were inspected under Section 13 of the NCTE Act. On scrutiny of the inspection reports submitted by the inspection teams it was found that 21 institutions were not being run in accordance with the norms prescribed by the NCTE and as such appropriate action was initiated against them.

3.5 Council and its meetings

The composition of the Council is given at Annexure II. During 2009-10, three meetings of the Council were held on 2nd June 2009, 4th August 2009 and 23rd March 2010.

3.6 NCTE Foundation Day

The NCTE observed its 14th Foundation Day on August 17, 2009 at the India International Centre, New Delhi. Dr. Narender Jadhav, Member, Planning Commission, Govt. of India chaired the morning session of the function and Dr. Karan Singh, graced the occasion as the Chief Guest Speaker on the occasion. 3.7 Education Day Celebrated

NGTE celebrated the Education Day on 11th November, 2009 in the memory of Maulana Abdul Kalam Azad, Prof. Deepak Pental, Vice Chancellor, Delhi University presided the conference and launched the memorial lecture series. Dr. Shantha Sinha, Chairperson, National Commission for Protection of Child Rights delivered the memorial lecture on the title "Right to Education (RTE) – implications for India's Democracy".

CHAPTER 4

Regional Committees

4.1 Eastern Regional Committee (ERC)

During the year 2009-10, eleven meetings of the Eastern Regional Committee were held to consider the matters related to grant of recognition to various teacher education institutions and other related issues. 250 applications for various courses were received and processed by the Regional Committee.

4.2 Northern Regional Committee (NRC)

During the year 2009-10, twenty meetings of the Northern Regional Committee were held to consider matters related to grant of recognition to teacher education institutions and other related issues. 336 applications for various courses were received and processed by the Regional Committee.

4.3 Southern Regional Committee (SRC)

During the year 2009-10, twenty meetings of the Southern Regional Committee were held to consider matters related to grant of recognition to teacher education institutions and other related issues. 191 applications for various courses were received and processed by the Regional Committee.

4.4 Western Regional Committee (WRC)

During the year 2009-10, seventeen meetings of the Western Regional Committee were held to consider matters related to grant of recognition to teacher education institutions and other related issues. 641 applications for various courses were received and processed by the Regional Committee.
