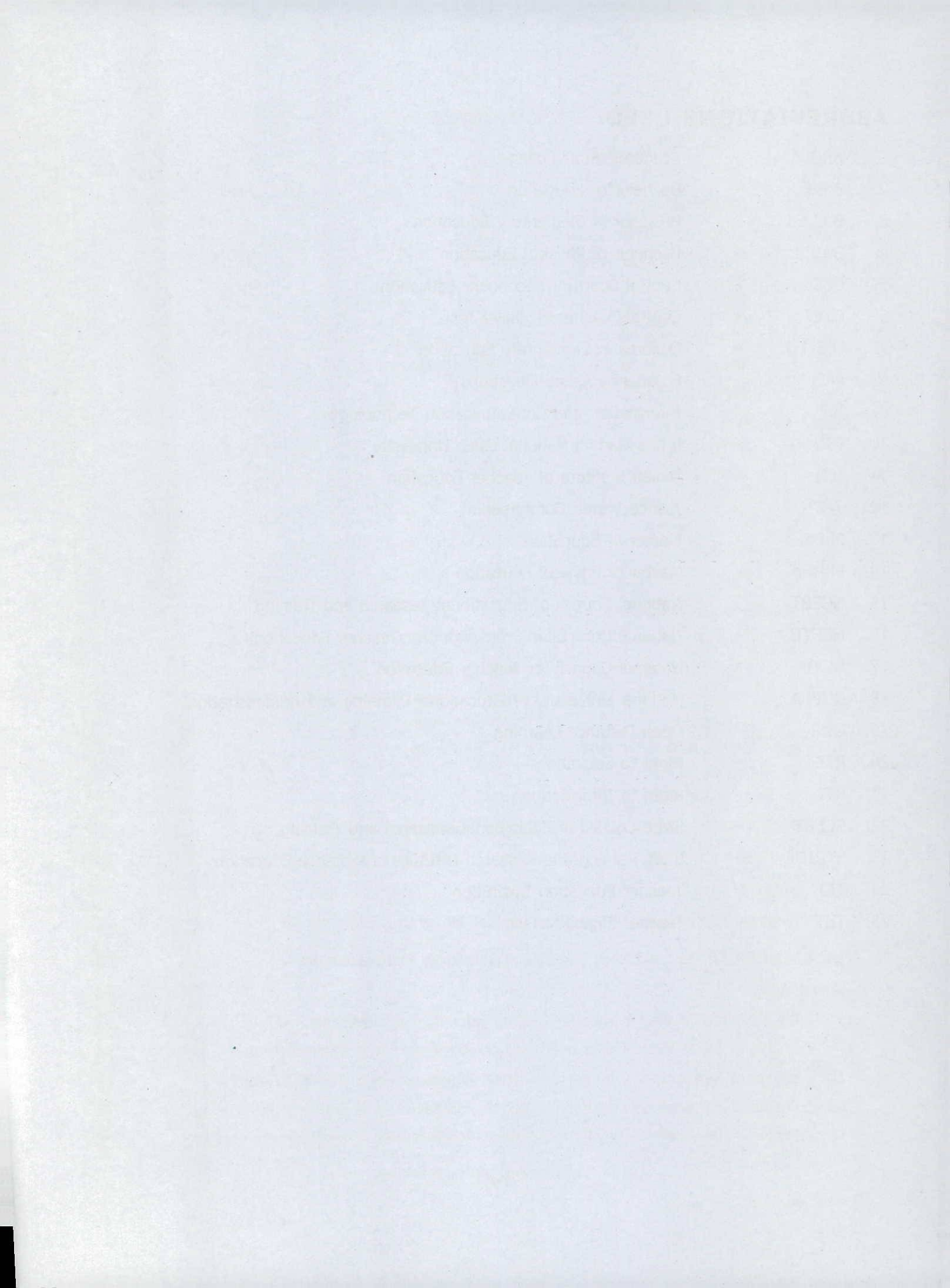
It is a matter of pleasure to present the NCTE Annual Report 2015-16, as Chairperson of the NCTE. The Report embodies brief account of the progress, major achievements and new initiatives undertaken in teacher education by the council during the year 2015-16. The duration of three programmes- B.Ed, B.P.Ed. & M.Ed - has been increased to two years, providing more professional rigour and at par with best international standards. The NCTE conducted a variety of innovative and development programmes. A wide basket with 15 programmes (Programme categories) is on offer, recognizing for the first time three new programmes – 4 year B.A./B.Sc.B.Ed, 3 years B.Ed (Part time) and 3 years B.Ed.M.Ed. Programmes. To improve its functioning, for better discharge of its mandate and for ensuring greater transparency, and efficiency, the NCTE initiated the process of introducing e-governance including revamping of website, online selection of Visiting Team Members, online appeal process, online RTI and Grievances modules etc.

I convey very deep appreciation to the officers concerned for timely preparation of the A.R. This report of NCTE presents an overview of efforts made by the council to provide quality teacher education to our teachers. We hope that the information presented in this Annual Report 2015-16, will prove to be useful information resource for all those working for development of teacher education in the country.

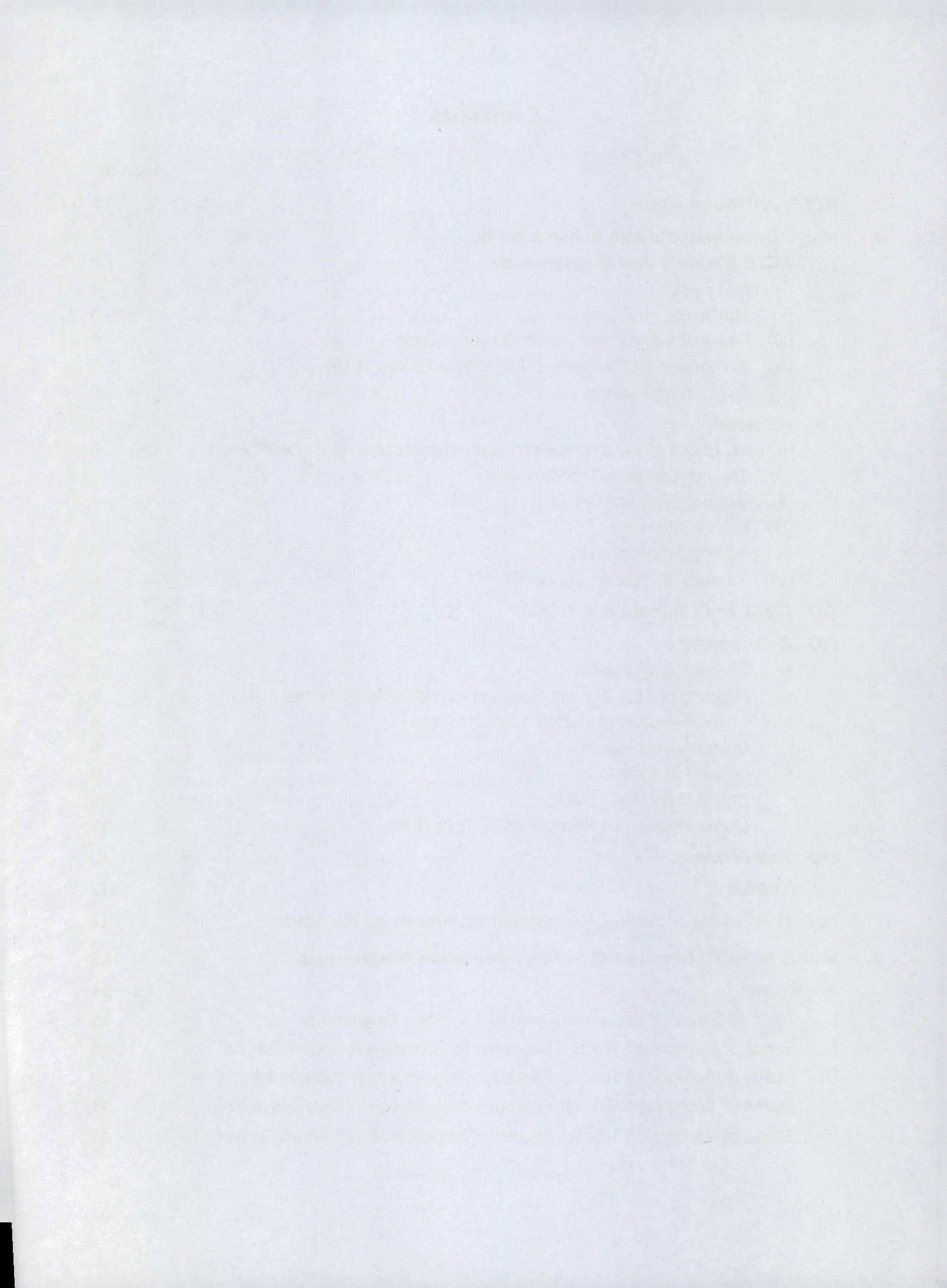

CHAPTER : 1

NCTE : AN INTRODUCTION

The National Council for Teacher Education (NCTE), a statutory body established by an Act of Parliament (Act No. 73 of 1993), started functioning on 17th August, 1995 with its Head Office in New Delhi with a mandate to achieve planned and co-ordinated development of the teacher education through-out the country; for regulation and proper maintenance of norms and standards in the teacher education system and for matter connected therewith. Besides eminent educationists, Education Secretary of the HRD Ministry, Education Secretaries of State Governments, Members of Parliament, Heads of National Educational Institutions like NCERT, NUEPA, UGC, the Council comprises three full time members, namely, Chairperson, Vice-Chairperson and Member Secretary who are appointed by the Government of India. They are vested with executive powers and as such are responsible for implementing the NCTE Act, Rules and Regulations made there under and also the policy decisions of the Council taken from time to time. The Central office of the NCTE is presently located in Hans Bhawan, Bahadur Shah Zafar Marg, New Delhi.

As per the provisions of the NCTE Act, 1993, four Regional Committees look after matters related to Teacher Education in different regions, namely, East, West, North and South. The offices of Regional Committees are presently located at Bhubaneswar, Bhopal, Jaipur and Bengaluru. Each Regional committee comprises a Chairperson, some eminent educationists and Administrators and Education Secretaries of Education Departments of the State Governments located in the region. The Regional Director, a full time official of the NCTE, functions as Executive Head of the Regional office as well as Convener of the Regional Committee. The Regional Committees are specially empowered to implement Sections 14, 15 and 17 of the NCTE Act, in accordance with the Regulations, Norms and Standards framed from time to time for different programmes of Teacher Education. It receives and processes applications for new institutions and applications for additional programmes / intake in the existing recognized institutions under Section 14 and 15 of the NCTE Act respectively. The Regional Committees have the powers to withdraw recognition of a recognized Institution under Section 17 of the NCTE Act provided it is established that the concerned institution has contravened provisions of the NCTE Act or Rules and Regulations made thereunder.

The NCTE's Central office, also known as NCTE Hqrs. is organized under several sections / divisions with specific tasks assigned to each of them. Some of the important Sections / Divisions are:

1. Academic Section
2. Regulations Section
3. Inspections Section
4. Appeal Section
5. Legal and Vigilance Section
6. EDP Section

The Academic Section deals with academic matters including development of Curriculum Frameworks for different Teacher Education Programmes, Publication of Journals, Books, and Monographs on important themes of Education, organization of lectures, etc. The Regulations Section collects and examines feedback regarding the implementation of the Regulations in vogue and coordinates the development of new regulations, as and when required. The Inspection Section conducts inspection of recognized Teacher Education Institutions under Section 13 of the NCTE Act. After causing the inspection, the VT reports are analysed by a group of experts to draw conclusion and formulate recommendations for communicating to the concerned institution. The institutions aggrieved by the decisions of a Regional Committee under Section 14, 15 or 17 of the NCTE Act are provided an opportunity to file an Appeal with the Council under Section 18 of the NCTE Act. The Appeal Section functions as the Secretariat for the Appellate Authority constituted by the Council. After examining the appeals, the Appeal Committee recommends the action deemed appropriate in the matter. The Legal Section keeps track of the cases filed against the NCTE in the Hon'ble Supreme Court of India and various High Courts and Coordinates with the NCTE's Counsels. The EDP Section manages the NCTE's website which is being further improved to have a functional online linkage of Regional Committees with the NCTE Hqs. It is proposed to bring the entire system of application processing in Public domain. It is also proposed to link websites of all teacher education institutions to the Website of NCTE.

MAJOR DEVELOPMENTS AND ACHIEVEMENTS

Every year NCTE undertakes several activities to implement its mandate. Some of the activities undertaken during a particular year are in continuation of the activities initiated and completed during the preceding years and some new activities are also undertaken in response to the new demands emanating from the emerging imperatives and priorities in the field. The present chapter presents a broad overview of the activities and programmes undertaken by the Council during 2015-2016 in furtherance of its goals and objectives.

(a) NCTE Mandate and Programmes

(i) NCTE Act

The National Council for Teacher Education (NCTE) was established by an Act of Parliament (No. 73 of 1993) with a mandate to achieve planned and co-ordinated development of teacher education throughout the country, for regulation and proper maintenance of norms and standards in the teacher education system, and for matters connected therewith. The NCTE came into existence on 17th August, 1995. Its headquarters in Delhi, with 4 Regional Committees in Bhubaneswar, Bhopal, Jaipur, and Bengaluru.

(ii) Functions

NCTE is mandated to carry out the following functions:

- *Coordinate and monitor teacher education* and its development in the country.
- *Lay down norms* for any specified category of courses or trainings in teacher education, including the minimum eligibility criteria for admission thereof; and the method of selection of candidates, duration of the course, course contents and mode of curriculum.
- *Lay down guidelines for compliance* by recognised institutions, for starting new courses or training, and for providing physical and instructional facilities, staffing pattern and staff qualification.
- *Lay down standards in respect of examinations* leading to teacher education qualifications, criteria for admission to such examinations and schemes of courses or training programmes.
- *Lay down guidelines regarding tuition fees and other fees* chargeable by recognised institutions.
- *Examine and review* periodically the implementation of the norms, guidelines and standards laid down by the Council, and to suitably advise the recognised institution.

- *Make recommendations to the Central and State Government, Universities, University Grants Commission and recognised institutions in the matter of preparation of suitable plans and programmes in the field of teacher education.*
- *Formulate schemes for various levels of teacher education and identify recognised institutions and set up new institutions for teacher development programmes.*
- *Undertake surveys and studies relating to various aspects of teacher education and publish the results thereof.*
- *Take all necessary steps to prevent commercialization of teacher education.*
- *Evolve suitable performance appraisal system, norms and mechanism for enforcing accountability on recognised institutions.*
- *Lay down guidelines in respect of minimum qualifications for a person to be employed as a teacher in schools or in recognised institutions.*
- *Promote and conduct innovation and research in various areas of teacher education and disseminate the results thereof.*
- *Perform such other functions as may be entrusted to it by the Central Government.*

(iii) Regional Committees: Territorial Jurisdiction

The applications for establishing a Teacher Education Institution or a Teacher Education programme are submitted to and evaluated for recognition by the 4 Regional Committees of NCTE which cover the following States/UTs under their jurisdiction.

- *Eastern Regional Committee, Bhubaneswar: Arunachal Pradesh, Assam, Bihar, Jharkhand, Manipur, Meghalaya, Mizoram, Nagaland, Odisha, Sikkim, Tripura, West Bengal. (N=12)*
- *Western Regional Committee, Bhopal: Goa, Gujarat, Madhya Pradesh, Maharashtra, Dadra and Nagar Haveli, Daman & Diu, Chhattisgarh. (N=7)*
- *Northern Regional Committee, Jaipur: Haryana, Himachal Pradesh, Punjab, Rajasthan, Uttar Pradesh, Chandigarh, Delhi, Uttaranchal. (N=8)*
- *Southern Regional Committee, Bengaluru: Andhra Pradesh, Karnataka, Kerala, Tamil Nadu, Lakshadweep, Andaman & Nicobar Islands, Pondicherry, Telangana. (N=8)*

(iv) Recognised Programmes of NCTE (Regulations 2014)

NCTE notified Revised Regulations and Norms and Standards on November 28, 2014 for the following Teacher Education Programmes (offered F2F and through ODL):

1. Diploma in early childhood education programme leading to *Diploma in Preschool Education (DPSE)*.

2. Elementary teacher education programme leading to *Diploma in Elementary Education* (D.El.Ed.).
3. Bachelor of elementary teacher education programme leading to *Bachelor of Elementary Education* (B.El.Ed.) degree.
4. Bachelor of education programme leading to *Bachelor of Education* (B.Ed.) degree.
5. Master of education programme leading to *Master of Education* (M.Ed.) degree.
6. Diploma in physical education programme leading to *Diploma in Physical Education* (D.P.Ed.).
7. Bachelor of physical education programme leading to *Bachelor of Physical Education* (B.P.Ed.) degree.
8. Master of physical education programme leading to *Master of Physical Education* (M.P.Ed.) degree.
9. Diploma in elementary education programme through *Open and Distance Learning System* leading to *Diploma in Elementary Education* (D.El.Ed.).
10. Bachelor of education programme through *Open and Distance Learning System* leading to *Bachelor of Education* (B.Ed.) degree.
11. Diploma in arts education (Visual Arts) programme leading to *Diploma in Arts Education* (Visual Arts).
12. Diploma in arts education (Performing Arts) programme leading to *Diploma in Arts Education* (Performing Arts).
13. 4-year Integrated programme leading to *B.A.B.Ed./B.Sc.B.Ed. (Integrated)* degree.
14. Bachelor of education programme *3-year (Part Time)* leading to *Bachelor of Education* (B.Ed.) degree.
15. 3-year Integrated programme leading to *B.Ed. M.Ed. (Integrated)* degree.

(v) Programme Features

- A *wide basket* with 15 programmes (programme categories) is on offer, recognizing for the first time three new programmes – 4-year B.A/B.Sc.B.Ed., 3-year B.Ed. (Part-time), and 3-year B.Ed.-M.Ed. programme.
- The *duration* of three programmes – B.Ed., B.P.Ed., M.Ed. – has been increased to two years, providing more professional rigour and at par with best international standards.
- Henceforth, in place of stand-alone institutions, teacher education shall be established in *composite institutions* (multi-disciplinary or multi-teacher education programmes).

- Each programme curriculum comprises three components—*theory, practicum, internship*; and at least 25% of the programme is devoted to school-based activities and internship.
- *ICT, Yoga Education, Gender and Disability/Inclusive Education* are compulsory part of each programme curriculum/syllabus.
- More *integrated teacher education* programmes are encouraged.
- The teacher educator M.Ed. Degree comes with *specialization* in either *Elementary Education* or in *Secondary/Senior Secondary Education*.
- Open and Distance Learning (ODL) has become more rigorous with built-in quality assurance mechanisms.
- In-service teachers have more option to acquire higher TE qualifications—D.El.Ed. (ODL), B.Ed. (ODL), B.Ed. (Part-Time). However, M.Ed. (ODL) programme has been dropped from the basket of programmes.
- NOC from affiliating university/body is mandatory at the time of making an application.
- Provision of application, payment of fees, visiting team reports, etc. are online. Centralized computerized visiting team for transparent use by both HQs and Regional Committees for inspection/monitoring. (For this, E-Governance is in the process of implementation).
- Each teacher education institution to have compulsory accreditation in every 5 years from an accrediting agency recognized by NCTE. (An MoU has already been signed with NAAC in this regard).

(b) Academic

(i) NCTE-QCI MoU for E-Monitoring of (Elementary and Diploma Level) Teacher Education Programmes

- NCTE entered into an MoU with Quality Council of India (QCI) on January 6, 2016 for its National Accreditation Board for Education and Training (NABET) to do E-Monitoring of above 18,000+ TEIs once in every year, and Accreditation of above 8,000+ TEIs at elementary and diploma level once in every 5 years.
- There is a joint National Consultative Committee to devise parameters, processes, proformas and action plan, and NABET shall be independently monitoring and accrediting TEIs (independent of NCTE).
- This will further add to enhancing transparency and quality of TEIs and teachers in the country.

(ii) Teacher Eligibility Test (TET)

The National Council for Teacher Education has been declared as an academic authority following the Right to Education Act, 2009. As per the provisions contained under RTE Act, NCTE has issued guidelines for conducting the Teacher Eligibility Test dated 11.2.2011, the guidelines have been circulated to all the States and Central Board of Secondary Education for conducted TET within the ambit of the guidelines issued.

The NCTE has been receiving representations from different quarters across the country including some legal issues. The issues were discussed with the Ministry of HRD at different fora. the Ministry of HRD addressed these issues and constituted a Committee to examine the proposed study of teacher eligibility test vide order dated 5.2.2016. The Committee has had several rounds of meetings and prepared a draft guideline which have been forwarded to the Ministry for their consideration.

(iii) School Internship

NCTE Recognition, Norms and Procedure, Regulations, 2014 notified on 28.11.2014 have a provision of internship of 20 weeks for TEFs which has spread over 2 years i.e. 4 weeks in first year of the programme and 16 weeks in the second year. Several State Govts. Universities, students and other stakeholders represented to the Ministry as also NCTE for smooth implementation of School Internship. Ministry of HRD vide order dated 10th March, 2016 constituted a Committee comprising of following persons for suggesting ways to institutionalize internship in Teacher Education programmes in government schools.

- (a) Smt. Rina Ray, Additional Secretary, Department of School Education and Literacy, MHRD - Chairperson
- (b) Shri Naresh Pal Gangwar, Secretary (Secondary Education), Govt. of Rajasthan - Member

- (d) Shri D. Senthil Pandiyan, Secretary (School Education), Govt. of Uttrakhand - Member
- (e) Shri K. Rajeshwara Rao, Principal Secretary (Secondary Education), Govt. of Tripura - Member
- (f) Chairman, National Council for Teacher Education - Member
- (g) Commissioner, Kendriya Vidyalaya Sangathan - Member

(iv) Publication of Journals

NCTE publishes three refereed quarterly journals such as:

- *Anweshika* in Hindi.
- *Indian Journal of Teacher Education* in English.
- *Teacher Support* in Hindi and English.

(v) Journals on Teacher Education

In its endeavour to keep the teacher educators informed about the changing scenario in teacher education, particularly about the new developments in its theory and practice, the NCTE has been publishing two Journals, namely, *Anweshika* and *Teacher Support*. *Anweshika*, a bilingual journal in English and Hindi, was primarily a Research Journal addressed to teacher educators and educational researchers. *Teacher Support*, also a bilingual magazine, aimed at providing professional support to school teachers in their day-to-day work including teaching of different school subjects. During the year 2015-2016, the NCTE decided to bring out two separate journals in English and Hindi on Teacher Education. The title *Anweshika* has been retained for the journal in Hindi and the Journal in English has been titled as "Indian Journal of Teacher Education" (IJTE).

During 2015-2016, the following Journals have been published:

- Indian Journal of Teacher Education (Vol. 1, No. 2 & 3), May-August, 2015 & Sep – Dec, 2015
- *Anweshika* (Vol. 10, No. 2 & 3), May-August, 2015 & Sep – Dec, 2015
- *Teacher Support* (Vol. 4, No. 2 & 3), May-August, 2015 & Sep – Dec, 2015

The Journals are available in NCTE for sale.

(c) Right to Information Act, 2005

As per the provisions of the RTI Act, 2005, one officer at the NCTE Head Office has been appointed as the Public Information Officer to deal with applications received under the Act. Likewise, in all the Regional Offices an Officer (Section Officer or Under Secretary) has been designated as Public Information Officer. During 2015-2016, 1031 applications were received under the RTI Act and disposed of appropriately.

(d) E-Governance

To improve its functioning, for better discharge of its mandate and for ensuring greater transparency, and efficiency initiated the process of introducing e-governance. To start with, the following actions have been taken by the NCTE:

- **Revamping of Website :**

A dynamic and vibrant website for the organisation is in place and it has been constantly improved upon to have a wide range of information catering to both – general citizens and Teacher Training Institutes (TTIs). It carries information on roles and responsibilities of each NCTE divisions, information on Amendments, Acts, Rules and Regulations, Resource bank on various publications, journals, teacher training modules, appeal orders etc. In addition, the website consists of online modules on RTI, Grievance & Redressal. Using the web interface, a prospective citizen can lodge RTI and Grievance requests and also login into the system to track the status and view the responses.

- **Mapping of Teacher Education Institutions (TEIs) through Geographical Information system (GIS) :**

For providing comprehensive status of existing recognised TEIs spread across the country in the public domain, a Geographical Information System (GIS) has been introduced online for mapping the TEIs. The TEIs are feeding their authentic information with regard to status of recognition, approved courses, total intake, infrastructural and instructional facilities, management type, longitude and latitude, TEI website, etc. This massive work is in progress, though one is able to access information those TEIs which are already in public domain today.

- **Online Selection of Visiting Team Members :**

Keeping in view the importance of the Inspection of Institutions prior to recognition, the entire inspection process starting from selection of Visiting Team [VT] Members, scheduling of inspection dates, allocation of institutes for inspections, conduct of inspections and submission of inspection reports, online has been computerized through a programme.

- **Online Appeal Process :**

The Appeal module has been made online. The main activity of the Appeal Section is to receive Online Appeal from the concerned institution, enter data of the institution in the software and process it in chronological order. Thereafter, invite Appellant Institutions by way of notice for hearing by the Appeal Committee. After hearing by the Appeal Committee, convey the decision of the Appeal Committee to the Appellant Institutions and other concerned authorities in the shape of Appellate Order.

- **Online RTI module :**

The RTI module has been made online. RTI Module has been integrated for submission of RTI applications/first Appeals with online payment gateway option made. This is a portal to file RTI applications/first appeals online along with payment gateway. Payment can be made through internet banking, debit/credit cards of Master/Visa. Through this portal, RTI applications/first appeals can be filed by Indian Citizens for all Ministries/Departments and few other Public Authorities of Central Government.

- **Online Grievance module :**

The Public Grievance Redressal System has been made online. Grievance Module facilitates Indian Citizens for all problems faced by them in handling the NCTE Website and its all online services or any other complaints related to NCTE or its employees.

- **Online Modules on Recognition of TEIs/TEPs :**

A comprehensive e-solution has been conceptualized and developed to streamline the process of recognition starting from receipt of applications online. The module has been improved to have a built-in work flow management system for all stake holders (including Institutes, State Government, Central Government, Affiliating Universities, NCTE Regional Centers and HQ) who are involved in the process of granting recognition. The system has facilities to send automated alerts (emails, SMS) to the stake holders and also track any application and find out at which stage it is pending. The prospective institutes applying for any Teacher Education Programs can also track through their individual dashboards, the status of the applications along with any observations/shortcomings worked out by the Regional Committees.

In order to bring in total transparency even the internal processes of Scrutiny, Issue of Show Cause Notices, Getting Clarifications, Regional Committee Meeting and its decisions, Physical Conduct of Inspections and its Report Submission, Receipt of FDR, Grant of Recognition etc. have been automated.

Applicant Institutes are also provided with "Single-Sign-On" feature to login into the e-Recognition system and track the status of the Recognition Process and all other dealings with NCTE.

(e) Inspection

Section 13 of the NCTE Act, 1993 provides for inspection of recognised teacher education institutions for the purposes of ascertaining whether the recognised institutions are functioning in accordance with the provisions of the Act and Rules and Regulations made thereunder. After conducting inspection of a TEI in the manner prescribed under Rules, the Council has to communicate its view to the concerned institution in regards to the results of the inspection and after ascertaining its opinion recommends action to be taken by the institution concerned.

During 2015-16, the NCTE conducted inspection of 28 B.Ed. Colleges in the State of Chhattisgarh, Punjab, Haryana, Rajasthan, Gujrat, Uttar Pradesh, Madhya Pradesh, West Bengal, Bihar in compliance to the section 13 of the NCTE Act 1993.

To monitor the functioning of recognised TEIs from time to time and to grant recognition to new TEIs/Programmes the NCTE has to cause inspection with the help of experts for which the Council maintains a Panel of VT experts in the shape of a Database. Empanelment of experts is a continuous process and the panel is updated regularly. Efforts are being made to empanel

experts of considerable experience in the academic field through a transparent process. The Council is in the process of developing an On-line Database for the purpose. The Inspection Policy Framework developed by a group of experts describes the purpose of Inspection under sections 13, 14 and 15 of the NCTE Act with the following selection criteria.

At least 10 years of experience in the field of Teacher Education (including Art and Physical Education/educational administration).

Serving/retired Professor/Associate Professor in Education and Art and Physical Education as per Regulation 2014 in Universities or recognised TELs;

OR

Serving/retired Principal of NCTE Recognised Teacher Education Institution or head of Deptt of Education in a multi faculty institution.

OR

Serving/retired Educational Administration such as Director/Joint Director of SCERT/SIE, Joint Commissioner in KVS.NVS or Officer holding equivalent positions in MHRD/UGC/Central/State Education Board/State Education Deptt.

OR

Serving/retired Professor/Associate Professor their Educational Research Organisation like NCERT etc.

In accordance with the Regulation 2014, the experts are to be selected at the Headquarter level and the Regional Committees will select the names from the central list of experts so prepared by the Council. NCTE Hqrs has invited applications from experts to be empanelled as VT members and has selected through a Scrutiny Committee, about 1108 experts have been finalized and approved online. In line with that an e-solution has been created whereby the selection of the VT's for any specific inspection will be done through computerized randomised selection to eliminate any subjectivity in choosing VTs.

(f) Appeal

Appeals under Section 18 of the NCTE Act, 1993

Section 18 of the NCTE Act, 1993 provides an opportunity to an Institution aggrieved by the order passed by Regional Committees under Sections 14, 15 and 17 of the NCTE Act to prefer an appeal with the Council against the order. The Council has constituted a Committee under the Chairpersonship of Prof. M.A. Khader to examine the appeal and pass an order deemed appropriate. The aggrieved party is provided an opportunity to personally present its case before the Committee. During 2015-2016, the Appeal Committee heard 505 Appeals in 16 meetings held between 1st April, 2015 and 31st March, 2016 and out of these, 384 cases were disposed of/order issued.

(g) Prevention of Sexual Harassment of Women at the workplace

No case of sexual harassment of women at the workplace came up during the period and no case is pending.

CHAPTER : 3

STATUS OF NCTE RECOGNISED TEACHER EDUCATION PROGRAMMES – REGION AND STATE-WISE

1. Introduction

As explained in Chapter 1, the NCTE Act, 1993 had envisaged establishment of four Regional Committees to process the applications of Teacher Education Institutions intending to offer a Teacher Education Programme. On the basis of detailed examination of the application and assessment of the applicant's fitness and preparedness, the Regional Committee takes a decision to either grant or refuse recognition for the proposed programme. The status of the recognised Teacher Education Programmes during 2015-2016 is briefly described below.

2. Eastern Region

During the year, the Eastern Regional Committee received 1746 applications which included 205 applications from the Government Institutions and the rest from the non-government institutions. The Eastern Regional Committee (ERC) held 25 (twenty five) meetings during the year to consider the matters related to grant of recognition to the teacher education institutions.

3. Western Region

During the year, the Eastern Regional Committee received 909 applications which included 68 applications from the Government Institutions and the rest from the non-government institutions. The Western Regional Committee (WRC) held 27 (Twenty Seven) during the year to consider the matters related to grant of recognition to the teacher education institutions.

4. Northern Region

During the year, the Northern Regional Committee received 4793 applications which included 73 applications from the Government Institutions and the rest from the non-government institutions. The Northern Regional Committee (NRC) held 19 (Nineteen) meetings during the year to consider the matters related to grant of recognition to the teacher education institutions.

5. Southern Region

During the year, the Southern Regional Committee received 1751 applications which included 57 applications from the Government Institutions and the rest from the non-government institutions. The Southern Regional Committee (SRC) held 25 (Twenty five) meetings during the year to consider the matters related to grant of recognition to the teacher education institutions.
