Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 7 above.

If District Institute of Education and Training, Sangrur-148001, (Punjab) contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.

In exercise of the powers vested under Section 14(3)(a) of the National Council for Teacher Education (NCTE) Act, 1993, the Northern Regional Committee grants recognition to District Institute of Education and Training, Sangrur-148001, (Punjab) for E.T.T. of Two year from the academic session 2000-2001 with an annual intake of 100 (One Hundred) students, subject to fulfilling the following conditions:

- 1. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this
