ORDER

For the purposes and in pursuance of the provisions contained in Section 13 of the NCTE Act, 1993. NCTE Headquarters conducted inspection of the Swami Vivekanand Sr. Secondary School, Yamuna Nagar, Haryana on 26.09,2003 and after having received the report/findings from the inspection team and seeking response of the institution on the deficiencies reported by the inspection team, the same are forwarded to the office of NRC to take further necessary action in accordance with the provisions of the NCTE, Act, Rules, Regulations etc. The deficiencies pointed out are as under:

- The Principal does not possess the qualification of M. Ed. / M.A. (Edn.). It is also not clear as to whether she has necessary (1) experience of teaching in elementary schools required for exemption from possession of PG Degree in Education.
- The institution has nine lecturers, out of which only five have PG Degree in education. It is also not clear as to whether they have (11) necessary experience of teaching in elementary schools required for exemption from possession of PG Degree in Education.
- It is also not clear as to whether the institution has made arrangement of instructors for teaching Arts and Craft, Music, (1111) Physical Education, J.T. Literacy etc.
- The educational technology lab does not have adequate number (IV) electronic publications on education.
- The library resources are extremely poor. It has very small number of books on education, does not subscribe educational (v) journals / periodicals and encyclopedia is also not available.
- The teachers are being paid meager consolidated salaries in cash which is not in accordance with the State/Central Government (vi)
- The institution does not maintain Endowment and Reserve Fund. (vii)
- It has also been reported that the Institution has not appointed teaching staff superately for their elementary programme. (viii) Instead, the teaching staff of school run by them is also being used for Taking D. Ed classes
