WHEREAS, the institution, namely, Tika Ram Girls College, Sonepat (Haryana) – 131001 and its Managing Society is: Tika Ram Education Society has made application to Northern Regional Committee (in short NRC) of National Council for Teacher Education (for short NCTE) seeking permission to start new course of B.P.Ed. from academic session 2004-2005 vide covering letter dated 30.12.2003 and the same was received in the office of NRC on 31.12.2003.

- 2. HOWEVER, the said application was found incomplete, in as much as, all the essential documents were not found proper as per requirement, hence vide communication / letter dated 26th April, 2004 the institution was intimated the deficiencies and the fact that the application has been carried forwarded by the Regional Committee for consideration for the subsequent academic year.
- 3. AND WHEREAS, the institution being aggrieved of the aforesaid order, preferred an appeal under Section 18 of NCTE Act, 1993 before the Appellate Authority of NCTE wherem the Appellate Authority vide its order dated 13.10.2004 remanded the case to NRC, Jaipur with the directions to give reasonable opportunity to the institution and reprocess the case by causing inspection. Consequently the inspection of the institution was carried out on 05.12.2004 by a visiting team of expert constituted by NRC.
- 4. AND WHEREAS, the NRC in its 87th meeting examined the entire matter. After careful perusal of the original file, inspection report and other related documents and being satisfied of the deficiencies and the fact that the institution does not fulfill required conditions for proper conduct of the new course or training in teacher education as determined by the Regulations, decided to provide a reasonable opportunity to the institution for making a written representation before refusing permission. Pursuant to the above decision, opportunity was given to the institution to make representation, vide communication / letter dated 07th February, 2005 issued by Regional Director wherein the following existing deficiencies were also pointed out:
 - No Objection Certificate from the State Government has not been submitted in original.
 - (ii) Land Ownership documents were not proper. In fresh documents, being photo copies of revenue record, submitted by the institution land is not shown either in the name / khatedari of the instittion or its Managing Society. Further, original or true certified copies of the documents were not submitted and name of the documents contained seal of the issuing authority, the designation of the issuing authority was also not clear.
