 - d. The institution shall within one month of the receipt of Recognition order, convert the NCTE from time to time. Endowment-Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - e. That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
 - f. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government. Etc.
 - The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
 - The institution shall regularly update its website.
 - The institution shall fulfill the conditions given in 7(11 & 12) of NCTE Regulation dt. 13.01.2006. Contd. 2....
