 - The institution shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation du C. 21.07.2006.
 - The institution shall adhere to all the other regulations and guidelines as framed by d. NCTF from time to time.
 - The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period u. of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - That the Reserve Fund for an amount of Rs. Three Lakhs be minimized in the 1. form of FDR in favour of the management/institution.
 - Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory hodies like UGC and State Government. 120
 - The institution shall submit to the Regional Committee a Scif-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating 11 University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant
