ORDER

Dayawanti Memorial College of Education, Near Country Club, Panchgaon, Rauru Road, Vill. - Pada, Sub-Tehsil - Tauru, Gurgaon, Haryana submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of B.Ed. Course in terms of section 14(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition for B.Ed. Course of One year duration with an annual intake of 100 (One Hundred Only) (One Unit) w.e.f. the session 2006-2007 to Dayawanti Memorial College of Education, Near Country Club, Panchgaon, Rauru Road, Vill. - Pada, Sub-Tehsil - Tauru, Gurgaon, Haryana at the following address :-

3. The institution shall ensure the fulfilment of the following :-

- Selection of qualified staff through duly constituted selection committee as per the norms of NCTE / State Govt. / Affiliating University given effect before the commencement of the course.
- The institution shall maintain the teaching staff strength of 1+7 for the proposed B.Ed. Course.
- The institution shall note that with regard to NET / SET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government. Etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

- i. The institution shall regularly update its website.
- j. The institution shall fulfill the conditions given in 7(11 & 12) of NCTE Regulation dt. 13.01.2006.

4. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993. The NCTE Hqrs. may also cause inspections under Section 13 of the NCTE Act, 1993.
