 - Selection of qualified staff through duly constituted selection committee as per the norms of NCTE / State Govt. / Affiliating University given effect before the n. commencement of the course
 - The institution shall maintain the teaching staff strength of 1+7 for the proposed 6.
 - The institution shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. C. 21.07.2006.
 - The institution shall adhere to all the other regulations and guidelines as framed by d. NCTE from time to time.
 - The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period U. of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the f. form of FDR in favour of the management/institution.
 - Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government. 12 Etc.
 - The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each scademic year along with a copy of the approval of the affiliating h. University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts thily audited by a Chartered Contd. 2 Accountant.
