- The institutions shall ensure the fulfillment of the following :-
  - The institutions shall maintain the teaching staff strength of 115 for the (a) proposed C.P.F.d. Course.
  - The institutions shall adhere to all the other regulations and guidelines as (b) framed by NCTE from time to time.
  - The institutions shall within one month of the receipt of the Recognition (c) order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.
  - That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in (d) the form of FDR in favour of the managements / institutions.
  - Further, the recognition is subject to fulfillment of all such other (e) requirements as may be prescribed by other regulatory bodies like SCERT. UGC and State Government etc.
  - The institutions shall submit to the Regional Committee a Self-Appraisal (f) Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
