Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **SHREE RAM MULAKH COLLEGE OF EDUCATION DIVYA YOG MANDIR, SECTOR-7, PANCHKULA, HARYANA** for conducting **D.ED.** course of **2** years duration with an annual intake of **50** students in the 1st year and the same for the IInd year under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following :-


- (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
