 - The institution shall, within one month of the receipt of recognition (i)order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii). The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 4. The principal is retained and as per his date of birth he may continue for two years. Hence the institution is directed to appoint qualified principal within two year form the date of the issue of the Order and report to the NRC, NCTE with complete details on the prescribed format. If the institution fails to appoint qualified principal within the stipulated time necessary action will be taken as it deems fit under the provision of the NCTE Regulation.
