WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 LORD SHIVA COLLEGE OF EDUCATION VPO- DAHAR PANIPAT-132103, HARYANA Submitted an application (Code No. APN05023) to the Northern Regional Committee of National Council for Teacher Education for grant of recognition / permission for starting C.P.ED. NCTE Act, 1993, the Regional Committee hereby grants recognition to LORD EDUCATION VPO- DAHAR PANIPAT-132103, COLLEGE OF HARYANA for conducting C.P.ED. course with an annual intake of 50 students. under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following :-
  - (1). The Institution shall within one month of the receipt of Recognition order. convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
  - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc., wherever applicable.

The Institution shall submit to the Regional Committee a Self-Appraisal Report at

- If the institution contravenes any of the above conditions or any of the provisions
  of the NCTE Act, Rules, Regulations and Orders made or issued there under, the
  Regional Committee may withdraw the recognition under the provisions of Section
  17(1) of the NCTE Act; 1993.
