- AND WHEREAS the matter was placed before the Emergency meeting of Northern Regional Committee held on 2nd September 2009, the committee considered the legal opinion of the legal counsel of NRC Jaipur dated 01.09.2009 and subsequent order of Hon'ble High Court of Rajasthan at Jaipur Bench, as communicated by the legal counsel mentioning the direction of the Hon'ble High Court of Rajasthan at Jaipur Bench to pass an order regarding recognition by 04.09.2009, the committee decides to issue order under clause 7(11) of NCTE regulation, 2007 w.e.f. session 2008-2009
- NOW, THEREFORE, in pursuance to the above orders, the recognition order is passed. In exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to AMBIKA TEACHER TRAINING COLLEGE, MALSISAR, WARD NO. - 13, DISTT. -JHUNJHUNU, RAJASTHAN for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred) students w.e.f the academic session 2008-09 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007. This order is subject to final out come of SLP filed by NCTE in the Hon'ble Supreme Court of India.
