**ORDER**

WHEREAS **Bhagat Phool Singh Mahila College of Education, VPO-Khanpur, Tehsil-Gohana, Distt.-Sonapat, Haryana** of recognition (**HR-200**) for **additional intake in the existing B.Ed. course one years (1) duration under section 15(1) of the NCTE Act, 1993** to the Northern Regional Committee, NCTE.

2 AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3 AND WHEREAS In its **124<sup>th</sup> (1st Sitting) meeting held on 17<sup>th</sup> - 19<sup>th</sup> December, 2008** the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and committee decided to issued a Conditional Recognition order and ask the institution (I) appoint duly selected staff with the requisite qualification as per NCTE norms and standards and inform the Regional Committee. Accordingly letter of intent prior to recognition was issued to the institution on 28.12.2008.

4 AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its **142<sup>nd</sup> meeting held on 14<sup>th</sup> -16<sup>th</sup> June, 2009**. The original file of the institution along with all other related documents, affidavits, ACT of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time etc were considered and the committee decided that:-

- **The deficiency communicated to the institution still exists.**

5 AND WHEREAS the committee decides to refuse recognition and return FDRS if submitted.

6: NOW THEREFORE recognition to **Bhagat Phool Singh Mahila College of Education, VPO-Khanpur, Tehsil-Gohana, Distt.-Sonapat,**



Haryana, for the course in **additional intake in the existing B.Ed.** is hereby refused.

6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
