

WHEREAS in terms of Section 14 (1) of the NCTE Act, 1993, BRIGHT LAND COLLEGE OF EDUCATION, VILL & POST - JANT SAYARWAS, DISTT. - REWARI, HARYANA for recognition (HR-1100) for B.ED Course of One years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 16.11.2007

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- AND WHEREAS the Northern Regional Committee in its 139th meeting held on 10th 12th April, 2009, after considering the application and reply submitted by the institution, the documents attached herewith, the affidavit and the input received from the visiting team in the form of report, decided to refuse recognition, accordingly a refusal order was issued to the institution vide this order no. F.NRC/NCTE/F73/HR-1100/2009/1023-1030 dated 23.04.2009.
- AND WHEREAS the above said institution, thereafter preferred an appeal dated 22.07.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was enough ground to accept the appeal, set-aside NRC's order dated 23/04/2009 and remanded back the case to NRC for deciding the case on merit within 15 days of issue of this order.
- AND WHEREAS the matter was placed before the committee in its 150th Meeting held on 09th 11th October, 2009 and the committee examined the case thoroughly and decided that the recognition may not be granted.
- AND WHEREAS the institution filed a Writ Petition No. 12496/2009 before the Hon'ble High Court of Deli-i & the Hon'ble High Court of Delhi directed to NRC to grant recognition to the institution within 4 days thereafter.
  - AND WHEREAS as per the direction the matter was placed before the NRC in its 152<sup>nd</sup> (2<sup>nd</sup> Sitting) held on 06th December, 2009 and the committee decided conditional recognition for B.Ed. programme be granted subject to fulfillment of clause 7(9) of NCTE Act within one month. Further, the institution was directed not to admit the students before the compliance of clause 7(9). Accordingly conditional order under clause 7(9) was issued to the institution on 07.12.2009.
  - AND WHEREAS the matter was placed before the Hon'ble High Court of Delhi on 21.12.2009 in court case Writ Petition (civil) No. 12496/2009 and the Hon'ble High Court of Delhi directed that a similar order be passed as was passed in the case of Lord Krishna as the case in hand is also similar in nature to that of Lord Krishna. The court directed that the recognition order be passed as expeditiously as possible preferably within a period of three days. This decision has been communicated to NRC office through its Legal Counsel Mr. V.K. Rao by fax letter dated 21.12.2009.
  - NOW, THEREFORE, in compliance of the Hon'ble Court and in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to BRIGHT LAND COLLEGE OF EDUCATION, VILL & POST - JANT SAYARWAS, DISTT. - REWARI, HARYANA for conducting B.Ed. Course of secondary (level) of one year duration with an annual intake of 100 (One Hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE Hqtrs vide letter File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:-
    - The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, falling which the recognition will be effective from the academic session 2010-2011 only.

- Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
  - Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.
