ORDER

WHEREAS **I.P.S.E. College Of Education, Sco-17, Sector- 13, Vpo-Jundla, Distt- Karnal, Haryana, (HR- 1764)** had submitted application for recognition of **B.Ed. of 100 seats** of one year (1) duration under section **14(1)** of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **03.10.2008**.

2. AND WHEREAS on perusal the documents submitted by institution the Committee **in its 139th meeting held from 10th to 12th April, 2009** decided to close the file. Accordingly the institution was informed vide NRC order dated **12.05.2009**.

3. AND WHEREAS the institution preferred in appeal to the Appellant Authority against the said order on 23.06.2009. The Appellant Authority accepted the appeal of the institution order of NRC dated 12.05.2009 were set aside and the case was remanded back to the NRC with direction to cause inspection of the institution

4. AND WHEREAS the appeal order was placed before the NRC Committee **in its 149th meeting held from 13th to 14th September, 2009** and the Committee decided to process the application. Accordingly the application was processed and VT conducted on 11.12.2009 was placed **in 154th meeting held from 09th to 11th January, 2010** and the NRC Committee decided to issue **Show Cause Notice** to the institution. Accordingly the **Show Cause Notice** was issued vide NRC letter dated **20.01.2010**.

5. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on **29.01.2010**. The original file of the institution, reply of the Institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the **Northern Regional Committee in its 157th meeting held on 24th to 27th March 2010** and the committee observes the following:

- **The deficiencies related to Library, Science lab, and Psychology lab still exists.**

6. AND WHEREAS Hence the committee decides to refuse recognition for **B.Ed. course.**

7. NOW THEREFORE grant of recognition **I.P.S.E. College Of Education, Sco-17, Sector- 13, Vpo- Jundla, Distt- Karnal, Haryana,** for the course in **B.Ed** in term of section **14(3)(b)** of the NCTE Act, 1993 is hereby **refused.**

8. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
