**ORDER**

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 **Lingaya's College of Education, Kanwara, Badarpur Sayad, Faridabad, Faridabad-121002, Haryana (HR-1158)** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **M.Ed. Course of one year duration with an annual intake of 25 (Twenty Five only) students on 28.11.2007.**

2. AND WHEREAS, the matter was placed in **139<sup>th</sup> Northern Regional Committee Meeting held from 10<sup>th</sup> - 12<sup>th</sup> April, 2009** and the Committee decided to ask the institution to submit the legally valid documents as per regulation related with certain points pointed out in the said meeting. Accordingly a letter was issued on **25.05.2009.**

3. AND WHEREAS, the matter was placed in **144<sup>th</sup> Northern Regional Committee Meeting held from 12<sup>th</sup> to 14<sup>th</sup> July, 2009,** the committee decides to direct the Lingaya's University to change the name of Lingaya's College of Education to Department of Education. Only after this the case of M.Ed. course will be processed. Further, the Institution is directed to obtain CLU as per clarification to be given by State Government of Haryana and the committee will decide the recognition accordingly. Accordingly a letter was issued on **31.07.2009.**

4. AND WHEREAS, the matter was placed in **153<sup>rd</sup> Northern Regional Committee Meeting held from 11<sup>th</sup> to 12<sup>th</sup> December, 2009,** the committee observed that the request of change of name from LINGAYAS COLLEGE OF EDUCATION to DEPARTMENT OF EDUCATION is permitted but the Institution is yet to submit CLU. Only after receiving CLU the case will be considered for M.Ed. recognition. Accordingly a letter was issued on **17.12.2009.**

5. AND WHEREAS, the matter was placed in **154<sup>th</sup> Northern Regional Committee Meeting held from held on 9<sup>th</sup> to 11<sup>th</sup> January, 2010** and the committee decided that VT may be constituted.

6. AND WHEREAS, the inspection conducted U/s 14 on **13.02.2010** was placed in **159<sup>th</sup> Northern Regional Committee Meeting held from 28<sup>th</sup> April to 1<sup>st</sup> May, 2010** and the committee decided to issue a letter under clause 7 (9) of regulations 2007. Accordingly letter of intent prior to recognition was issued on **13.05.2010.**

7. AND WHEREAS, the matter was placed in **162<sup>nd</sup> Northern Regional Committee Meeting held from 24<sup>th</sup> to 27<sup>th</sup> June, 2010** and the committee decided that VT may be sent for all courses file numbers HR-209, HR-210, HR-276, and HR-751. The decision in respect of HR-1158 is to be kept pending till the VT submits the report of above mentioned courses:

8. AND WHEREAS, the matter was placed in **168<sup>th</sup> Northern Regional Committee Meeting held from 5<sup>th</sup> to 8<sup>th</sup> October, 2010** and the Committee decided that show-cause notice under section 17 of NCTE Act, 1993 be issued to the institution before withdrawal of the recognition .

9. AND WHEREAS, the matter was placed in **170<sup>th</sup> Northern Regional Committee Meeting held from 21<sup>st</sup> to 22<sup>nd</sup> October, 2010** and the Committee observed that a Show Cause be issued U/s 15(3)(b) instead of inadvertent mentioning of Section 17 in earlier minutes dated 5-8, October, 2010. Accordingly a Show Cause Notice was issued on **11.11.2010.**

10. AND WHEREAS, the reply was placed in **172<sup>nd</sup> Northern Regional Committee Meeting held from 12<sup>th</sup> - 13<sup>th</sup> November, 2010.** The reply of the institution dated 19.10.2010 in response to the Show Cause Notice issued in respect of M.Ed. Course and two Hundred seats for B. Ed. Course has been considered **and the Committee decided that the permission/ recognition order under Clause 7(11) of NCTE Regulations 2009 and Section 15 (3)(a) of NCTE Act 1993 for M.Ed. course with an annual intake of 35 seats from the academic session 2010-2011 be issued subject to the following conditions while the institution be permitted to continue with 200 seats (B. Ed and B. Ed. Add. intake)**

11. **NOW THEREFORE,** in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants/permitted recognition to **Lingaya's College of Education, Kanwara, Badarpur Sayad, Faridabad, Faridabad-121002, Haryana (HR-1158)) for M.Ed. Course of one year duration with an annual intake of 35 Students (Thirty Five) under clause 7(11) of NCTE Regulations from the academic session 2010-2011 subject to the following conditions:-**

- (i) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- (ii) Formal order for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund in the joint name of an authorized representative of the management and the Regional Director, Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations.

11. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

12. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

14. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

15. In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
