WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Tagore College of Education, Amargarh Road, Sandhir, Tehsil-Nilokheri, Distt- Karnal-132001 (HR-923) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. Course of one year duration with an annual intake of 100 (One Hundred only) students on 27.06.2007.

- AND WHEREAS, the application was processed and inspection conducted U/s 14 on 24.10.2008 was placed in 134th Northern Regional Committee Meeting held from 20th - 22nd November, 2008 and the NRC considered the letter No. 12/16-2003 c-II(3) dated 19,11.2008 of the State Govt. of Haryana and also the NCTE HQtrs letter No. 49-27/2007/NCTE(N&S) Part dated 19.11.2008 and decided to keep pending all B.ED proposals of various institutions including new visiting team reports till further order from the NCTE HQtrs.
- AND WHEREAS, the matter was placed in 136th Northern Regional Committee Meeting held from 19th - 21st January, 2009 and the NRC considered the Hon'ble High Court of Delhi orders in writ petition No. 8846 of 2008 and discussed in detail in respect of the letters received from the State Govt of Haryana, Public Notice issued by NCTE with regard to stopping of recognition of STC course and stopping the processing of B.Ed applications as per the direction of NCTE HQs until further. Accordingly a letter dated 06.02.2009 was issued to the institution.
- AND WHEREAS, the matter was placed in 137th Northern Regional Committee Meeting held from 28th February - 1st March, 2009 and the Committee decided to issue Show Cause Notice for refusing the recognition to the institution on certain points. Accordingly Show Cause Notice was issued on 08.03.2009.
- AND WHEREAS, the matter was placed in 139th Northern Regional Committee Meeting held from 10th - 12th April, 2009 and the Committee decided to refuse the recognition under clause 14 (3) (b) of the NCTE Act, 1993. Accordingly an order was issued on 23.04.2009.
- AND WHEREAS, the institution preferred an appeal against the said order on 08.10.2009 to the Council and the Council rejected the appeal and NRC's order dated 23.04.2009 was confirmed vide Appellate Authority order dated 19.07.2010.
- AND WHEREAS, the Appellate Authority again considered the appeal dt. 08.10.2009 and accepted the appeal; set aside the NRC order dt. 23.05.2009(Correct dt. 23.04.2009) and remand back the case to NRC for issuance to letter of Intent Prior to Recognition under clause 7(9) of the NCTE Regulations in supersession of the Council's order dated 23.05.2009 (Correct dt. 19.07.2010). The matter was placed in 166th Northern Regional Committee Meeting held on 9th September, 2010 and the Committee decided that in compliance of the order of the Appellate Authority, Order under clause 7(9) of NCTE Regulations 2009 be issued. Accordingly the order was issued on 14.09.2010.
- AND WHEREAS, the reply was placed in 170th Northern Regional Committee Meeting held from 21st - 22nd October, 2010 and the Committee decided that the institution be asked to submit the approval of the Affiliating/Examining Body within 30 days. Accordingly a letter was issued on 03.11.2010.
- AND WHEREAS, the reply was placed in 172nd Northern Regional Committee Meeting held from 12th - 13th November, 2010 and the Committee decided that, Recognition order under clause 7(11) of NCTE Regulations 2009 and section 14(3)(a) of NCTE Act 1993 for B.Ed. course with an annual intake of 100 seats from the academic session 2010-2011 be issued subject to the usual conditions.
- NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Tagore College of Education, Amargarh Road, Sandhir, Tehsil-Nilokheri, Distt- Karnal-132001 (HR-923) for B.Ed. Course of one year duration with an annual intake of 100 (One Hundred) Students under clause 7(11) of NCTE Regulations from the academic session 2010-2011 subject to the following conditions:-
 - The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.

- (ii) Formal order for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund in the joint name of an authorized representative of the management and the Regional Director, Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations.
- 11. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 12. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- 14. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.
- 15. In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
