ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Geeta Arya College of Education, Julana, Distt- Jind, Haryana (HR-1447) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. Course of one year duration with an annual intake of 100 (One Hundred only) students on 01.02.2008.

- 2. AND WHEREAS, the application was processed and inspection conducted U/s 14 on 29.05.2010 was placed in Northern Regional Committee162nd Meeting held on 24th to 27th June, 2010 and the Northern Regional CommitteeCommittee decided to to issue Show Cause Notice on certain points and directed the Institute to submit reply within 30 days.. Accordingly SCN was issued on 22.07.2010.
- 3. AND WHEREAS, the matter was considered in 163rd NRC Meeting held from 29th to 31st July, 2010 and the Committee decided to issue Letter under clause 7(9) of regulations 2007.
- 4. AND WHEREAS, the reply of the institution was placed in **Northern Regional Committee 169th Meeting held from 12th to 13th October, 2010** and the Committee decided to direct the institution for approval of the university regarding faculty be submitted within 30 days. Accordingly a letter was issued on 22.10.2010.
- 5. AND WHEREAS, the reply of the institution was placed in Northern Regional Committee 171st Meeting held from 28th to 29th October, 2010 and the Committee decided that recognition order under clause 7(11) of NCTE regulations 2009 in terms of section 14(3)(a) of NCTE Act, 1993 for B.Ed. Course with an annual intake of 100 seats from the academic session 2010-11 be issued.
- 6. NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Geeta Arya College of Education**, **Julana**, **Distt- Jind**, **Haryana (HR-1447)** for **B.Ed. Course** of one year duration with an annual intake of **100 (One Hundred) Students** under **clause 7(11)** of NCTE Regulations from the **academic session 2010-2011** subject to the following conditions:-
 - (i) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
 - (ii) Formal order for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
 - (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund in the joint name of an authorized representative of the management and the Regional Director, Northern Regional Committee.

- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - . Land and Building Particulars
 - · Staff Profile
 - · Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.
- In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
