WHEREAS, the **L.N.T. College Of Education, 79, Milestone, G.T. Road, Panipat, Haryana**, was granted recognition for running B.Ed. Course of one year duration with an annual intake of 100 students vide this office order no. F.NRC/NCTE/F-7/HR-490 / 32927-32933 dated 27.11.2007.

2. AND WHEREAS, the Show Cause notice under section 17 of NCTE Act was issued on **09.01.2010** with a direction to submit reply within **21** days.

3. The original file of the Institution, reply of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the **Northern Regional Committee in its 161st meeting held from 26th to 29th May, 2010** and the committee observes the following:

- The reply of Institution vide letter number 232 / 10 dated 19 Feb 2010 in response to letter NRC / NCTE / F-3 / HR-490 / 151 Meeting / 2009 / 14814 dated 8 January 2010 is not satisfactory.

4. Hence, the committee decides to withdraw recognition of B.Ed. Course from academic session 2010 - 2011.

5. NOW THEREFORE, recognition to **L.N.T. College Of Education, 79, Milestone, G.T. Road, Panipat, Haryana**, for the course in B.Ed. Course is hereby withdrawn from 2010-2011 academic session.

6. If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993
