Course of Two years duration with an annual intake of 50 students vide this office order no. F.NRC/NCTE/HR- 1059 / 2008/57105-57111 dated 19.08.2008.

- AND WHEREAS, the Show Cause notice under section 17 of NCTE Act was issued on 04.11.2009 with a direction to submit reply within 21 days.
- The original file of the Institution, reply of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 161st meeting held from 26th to 29th May, 2010 and the committee observes the following:
 - The response submitted by the Institute through letter number Memo 211 dated 23 November 2009 is not satisfactory.
- Hence, the committee decides to withdraw recognition of D.Ed and B.Ed. courses from academic session 2010 - 2011.
- NOW THEREFORE, recognition to Ch. Het Ram Johari Lal Memorial College Of Education, Vpo- Khara Kheri, On Bhattu Road, Distt- Fatehabad, Haryana for the D.Ed. Course is hereby withdrawn from 2010-2011 academic session.
- If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993 By order
