Amended Order

The Para 7 and sub-point (i) & (ii) of Order No.F.NRC/NCTE/F-7/HR-1429/APPEAL/Emerg.Meeting/2010/26848-854 dated 26th August, 2010 may be read as under:-

NOW, THEREFORE, in exercise of the powers vested under section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Maharishi Dayanand College of Education, VPO-Litani, Tehsil-Uklana, Distt.-Hisar, Haryana (HR-1429) of one year duration with an annual intake of 100 (one hundred) students under clause 7(11) of NCTE Regulations, 2007 subject to the following condition:-

- i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- ii) Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

The other conditions of the order will remain unchanged.
