ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Major Nafe Singh Kungariya College of Education, Kunger, Bawani Khera, Bhiwani, Haryana-127041 had submitted application for recognition/ permission of D. Ed. Course to the Northern Regional Committee, NCTE on 12.12.2007.

- AND WHEREAS, the institution filed a writ petition no. 9067/2008 and the matter was placed in NRC 134th Meeting held on 20th - 22 November, 2008 and Committee decided that NRC considered the letter No. 12/16-2003 C-II (3) dated 19.11.2008 of the State Govt. of Haryana and also the NCTE Hqtrs letter No. 49-27/2007/NCTE (N&S) Part dated 19.11.2008 and decided to keep pending all B. Ed. Proposals of various Institutions including new visiting team report till further order form the NCTE Hqtrs.
- AND WHEREAS, the matter was placed in NRC 137th Meeting held on 28th Feb to 1st March, 2009, the Committee decided not to have inspection and the file is to be closed and FDRs are to be returned. Accordingly letter was issued on 12.03.2009.
- AND WHEREAS, the institution preferred an appeal and the Council remand back the case and directed to inspect the institution. The matter/Appeal order was placed in NRC 153rd Meeting held on 11th – 12th December, 2009 and Committee decided to do as directed.
- AND WHEREAS, the inspection conducted U/s 15 on 29.12.2009 was placed in NRC 155th Meeting held on 23rd - 25th January, 2010 and the Committee decided to issue Show Cause Notice. Accordingly Show Cause Notice was issued on 23.02.2010.
- AND WHEREAS, the reply of SCN was placed in NRC 159th Meeting held on 28th April to 1st May, 2010 and the Committee decided to issue Letter under clause 7 (9) of regulations 2007. Accordingly Letter of Intent Prior to Recognition under clause 7 (9) of regulations 2007 was issued on 13.05.2010.
- AND WHEREAS, the reply of LOI under clause 7 (9) of regulations 2007 was placed in NRC 162nd Meeting held on 24th to 27th June, 2010 and the Committee decided to issue Show Cause Notice. Accordingly SCN was issued on 22.07.2010.
- AND WHEREAS, the matter was placed in NRC 165th Meeting held on 1st 2nd September, 2010 and the Committee decided that the institution to submit the approval of Affiliating University, as per provision under clause 7 (9) of NCTE Regulations 2009, for appointment of faculty. Accordingly a letter was issued on 18.09.2010.
- 9. AND WHEREAS, the matter was placed in NRC 168th Meeting held on 05th to 8th October, 2010 and the Committee decided that the recognition for D.Ed. course under clause 7 (11) of NCTE, Regulations, 2009 and section 15 (3) (a) of NCTE, Act, 1993 from the session 2010-2011 with an annual intake of 50 seats in view of the letter of approval of faculty appointment by the concerning body.
- NOW THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the NRC hereby grants recognition/permission to Major Nafe Singh Kungariya College of Education, Kunger, Bawani Khera, Bhiwani, Haryana-127041 for D. Ed. Course of one year duration with an annual intake of 50(Fifty only) Students under clause 7(11) of NCTE Regulations from the academic session 2010-2011 subject to the following conditions:-
 - The admissions of students shall be made only after affiliation by the examining body before (i) the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.

- Formal order for recognition/permission will operate for 2010-2011 only if the requirement of 180 (ii) teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund (iii) and reserve fund accounts into joint account to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE (iv) regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of (v) clause 8(12) of the NCTE Regulations.
- 11. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, the institution must transfer the land within six month in the name 15. of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
