

ORDER 26587

WHEREAS in terms of Section 14(1) of the NO!E Act, 1993 I.P.S.E. College of Education, SCO-17, Sector-13, Jani Road, VPO- Jundla, Distt- Karnal, Haryana-132001 (HR-1764) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of one year duration with an annual intake of 100 (One Hundred) students on 03.10.2008.

AND WHEREAS the original file of the institution, reply to deficiency letter and other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the NRC in its 139th meeting held on 10-12 April, 2009 and the Committee decided to close the file and return the FDRs if submitted. Accordingly, closure order was issued to the institution vide order No.F.NRC/NCTE/F-7/HR-1764/139 MEETING/ 2009/ 2051-52 dated 12.05.2009.

AND WHEREAS the institution preferred an appeal dated 23-06-2009 to the NCTE, New Delhi under Section 18 of the NCTE Act, 1993 against the said order. The Council after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, came to the conclusion vide order F.No.89-454/2009-Appeal/99917 dated 07-08-2009 that the institution should be got inspected to ascertain availability of necessary infrastructure, instructional and other facilities in accordance with the norms prescribed by the NCTE to become eligible for recognition by NCTE. Accordingly, the appeal of the institution was accepted, orders of NRC dated 12.05.09 were set aside and the case was remanded back to the NRC for inspection of the institution immediately and thereafter to issue order.

AND WHEREAS the institution was inspected on 11.12.2009. The original file, VT report dated 11.12.2009 along with all relevant documents, Act of NCTE 1993, Regulations and Guidelines of NCTE published from time to time were considered by the NRC in its 154th meeting held on 09-11 January, 2010 and the Committee decided to issue Show Cause Notice to the institution with the direction to submit reply within 21 days. Accordingly, Show Cause Notice was issued vide letter No.F.NRC/NCTE/F-3/HR-1764/154 Meeting/2009/15321 dated 20.01.2010. In response, the institution submitted reply vide its letter dated 24.01.2010, received on 29.01.2010.

AND WHEREAS the matter was placed before the 157th Meeting of NRC held on 24-27 March, 2010. The Committee decided to refuse recognition for B.Ed. course. Accordingly, order of refusal of recognition was issued vide F.No.NRC/NCTE/F-7/HR-1764/2010/20494-20501 dated 16.04.2010.

AND WHEREAS the institution preferred an appeal dated 05-04-2010 to the NCTE, New Delhi under Section 18 of the NCTE Act, 1993 against the said order. The Council after perusal of documents, memorandum of appeal, affidavit, VT report and after considering oral arguments advanced during the hearing, came to the conclusion vide order F.No.89-245/2010-Appeal dated 31-05-2010 that there is adequate ground to accept the appeal and set aside NRC's order 16.04.10 and remand back the case to NRC for issuance of letter of intent prior to grant of recognition in respect of institution under Section 7(9) of the NCTE Regulations 2009 immediately. The decision of the Council would, however, be effective from the date of withdrawal of the said ban on further recognition of B.Ed. course in the State of Haryana.

AND WHEREAS the matter was placed before the Emergency Meeting of NRC held on 19.07.2010. The Committee decided to issue Show Cause Notice to the institution with the direction to appoint faculty within 90 days. Accordingly, Show Cause Notice was issued vide letter F.NRC/NCTE/HR-1764/Emergency Meeting/ 2010/ 26082 dated 28.07.2010. A letter dated 26.07.2010 in this regard was received from the institution on 27.07.2010 along with supporting

AND WHEREAS the matter was placed before the 163<sup>rd</sup> Meeting of NRC held on 29-31 July, 2010. The Committee decided to issue letter under Clause 7(11) of Regulations 2007.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to I.P.S.E. College of Education, SCO-17, Sector-13, Jani Road, VPO- Jundla, Distt- Karnal, Haryana-132001 for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One Hundred) Students under clause 7(11) of NCTE Regulations, 2007. The decision of the Council would, however, be operative from the date of withdrawal of the ban on further recognition of B.Ed course in the State of Haryana.

- (i) Order for recognition will operate for 2009-2010 only if the requirement of 180 teaching days in the University/Affiliating Body.
- (ii) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
