ORDER

WHEREAS, J.R MEMORIAL COLLEGE OF EDUCATION, NATIONAL ITI ENGINEERING AND MANAGEMENT COLLEGE, NEAR UMA BHARTI SENIOR SECONDARY SCHOOL, JHAJJAR ROAD, REWARI, STATE- HARYANA-123401 was granted recognition for running B. Ed. Course of one year duration with an annual intake of 100 students vide this office order number F/NRC/NCTE/F-7/HR-415/27451-57 dated 13.09.2007.

AND WHEREAS, the original file of the institution along with all other related documents, Act of NCTE 1993 Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 163rd meeting held from 29th to 31st July, 2010 and the Committee observes the following:-


- Faculty has not been selected through the dully constituted selection committee as per NCTE norms for B. Ed.
- The list of Faculty approved by the affiliating University has not been submitted.

Hence, the committee decided to withdraw the recognition of B. Ed. programme from 2010 – 2011 academic session.

AND WHEREAS the institution preferred an appeal to the Appellate Authority against the NRC decision taken in 163rd meeting held from 29th to 31st July, 2010 and the council after perusal of documents, memorandum of appeal, VT Report, affidavit and after considering oral arguments advanced during hearing., the Council reached the conclusion that there was enough ground to accept the appeal and that it should be accepted. Accordingly the appeal was accepted and NRC's decision dated 29th to 31st July 2010 was reversed with a direction to the NRC to restore recognition to the institution within 15 days of issue of this order.

NOW THEREFORE the recognition to J.R MEMORIAL COLLEGE OF EDUCATION, NATIONAL ITI ENGINEERING AND MANAGEMENT COLLEGE, NEAR UMA BHARTI SENIOR SECONDARY SCHOOL, JHAJJAR ROAD, REWARI, STATE- HARYANA-123401 for B. Ed. course is hereby restored.
