WHEREAS in terms of Section <u>14(1)</u> of the NCTE Act, 1993 <u>Bhagwan Parshuram College of Education</u>, <u>Vill & Post- Bali Brahamanan</u>, <u>Tehsil- Gohana</u>, <u>Distt- Sonepat- 131301</u>, <u>Haryana</u>, (<u>HR-283</u>) has submitted an application (Code No. APN02296) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting <u>B.Ed.</u> Course of <u>one year</u> duration with an annual intake of 100 (One Hundred) students on 03.01.2005.

AND WHEREAS a Letter of Conditional Recognition was issued on 27.08.2006 with condition to appoint staff by a duly constituted selection Committee with the requisite qualification as per Norms and Standards of NCTE and affiliating University and inform the Regional Committee by sending signed copy of the minutes along with an Affidavit. Also to complete the minor civil construction works and to send photographs.

AND WHEREAS the original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the Northern Regional Committee in its  $141^{\rm st}$  meeting held from  $22^{\rm nd}$  to  $24^{\rm th}$  May, 2009 observed that:

 The list of Faculty selected by dully constituted selection committee as per NCTE Norms is not submitted.

Hence, the committee decided to withdraw the conditional recognition granted to the Institution.

Further, the committee decided to seek information from affiliating body about the admitted students and students appeared in the University examination prior to academic session 2009 - 10. Accordingly withdrawal order issued on 09.06.2009

AND WHEREAS the institution preferred an appeal on **06.07.2009** against the withdrawal order of NRC **dated 09.06.2009** to the Appellate Authority. And the Appeal Committee after perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the hearing the Council reached the conclusion that there was adequate grounds to accept the appeal. Accordingly the appeal was accepted and NRC's order dated 09.06.2009 was reversed, with the direction to NRC to issue appropriate orders so that the institution is recognized from the year of affiliation of the institution by the University, after issuing conditional order of recognition.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Bhagwan Parshuram College of Education, Vill & Post- Bali Brahamanan, Tehsil- Gohana, Distt- Sonepat- 131301, Haryana,** for conducting **B.Ed.** Course of **one** year duration with an annual intake of **100 (One Hundred)** Students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:

The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010 failing which the recognition will be effective from the academic session 2010-2011 only.

Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliation Body.

The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- · Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
