

- AND WHEREAS, the Show Cause notice under section 17 of NCTE Act was issued on 09.11.2009 with a direction to submit reply within 15 days.
- AND WHEREAS, The original file of the Institution, reply of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 160th meeting held from 18th to 20th May, 2010 and the committee observes the following:
 - The Institute is running D.Ed. course without Faculty appointed through dully constituted selection committee.
 - Bills for purchase of equipments along with Stock register have not been submitted.
- Hence, the committee decides to withdraw the D.Ed. recognition from 2010 2011 academic sessions. 4.
- NOW THEREFORE, recognition to Rao Jairam College Of Education, Bundabaj Nagar, Ateli Road, Mohindergarh, Haryana, for the course in D.ED. Course is hereby withdrawn from 2010-2011 academic session.
- If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993
