Add.** Course of One year duration with an annual intake of **25** students vide this office order no. **F.NRC/NCTE/HR- 951/2008/64665-64671 dated 03.10.2008.**
- 2. AND WHEREAS, the inspection of the institution was conducted on **18.06.2009** under section 13 of the NCTE Act, 1993. Northern Regional Committee in its **162nd** meeting held on **24th to 27th June, 2010**, after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, decided to issue Show cause notice under section 17 of the NCTE Act, 1993. **The Show Cause Notice under section 17 was issued on 22.07.2010.**
- 3. AND WHEREAS, The original file of the Institution, reply of the Institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 163rd meeting held from 29th to 31st July, 2010 and the committee observes the following:
- The deficiencies communicated through letter number NRC/ NCTE / HR-952 / 162 Meeting / 2010 / 25921 dated 22 July 2010 still exist.
- The deficiencies communicated through letter number NRC/NCTE / HR-951 / 162 Meeting / 2010 / 25925 dated 22 July 2010 still exist

Hence the committee decides to withdraw the recognition of B.Ed. Additional and M.Ed. additional programmes from 2010 – 2011 academic session but the Institute is allowed to continue with B. Ed. and M.Ed. programmes.

- 4. NOW THEREFORE, recognition to **Tika Ram College of Education, Sonepat, VPO- Sonepat, Tehsil-Sonepat, District- Sonepat, Haryana**, for **M.ED. Add.** Course is hereby **withdrawn** from 2010-2011 academic session.
- 5. If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993.
