WHEREAS, the **Vivekanand College Of Education, VPO- Bawwa, Distt- Rewari, Haryana**, was granted recognition for running D.Ed. Course of Two years duration with an annual intake of 50 students vide this office order no. F.NRC/NCTE/F-7/RR 1283/57414-20 dated 19.08.2008.

2. AND WHEREAS, the Show Cause notice under section 17 of NCTE Act was issued on 10.12.2009 with a direction to submit reply within 15 days.


3. The original file of the Institution, reply of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 161st meeting held from 26th to 29th May, 2010 and the committee observes the following:

- Submitted building plan does not indicate khasra number.
- Building plan is not approved by competent authority.
- All labs are ill equipped.
- Faculty for B.Ed. and D.Ed. has not been appointed through dully constituted committee.

4. Hence, the committee decides to withdraw recognition of D.Ed. course from academic session 2010 - 2011.

5. NOW THEREFORE, recognition to **Vivekanand College Of Education, VPO- Bawwa, Distt- Rewari, Haryana**, for the course in D.Ed. Course is hereby withdrawn from 2010-2011 academic session.

6. If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993
