- The deficiencies communicated through letter number NRC/NCTE / HR-951 / 162 Meeting / 2010 / 25925 dated 22 July 2010 still exist

Hence the committee decides to withdraw the recognition of B.Ed. Additional and M.Ed. additional programmes from 2010 - 2011 academic session but the Institute is allowed to continue with B. Ed. and M.Ed. programmes.

- NOW THEREFORE, recognition to Tika Ram College of Education, Sonepat, VPO- Sonepat, Tehsil-5. Sonepat, District- Sonepat, Haryana, for B.ED. Add. Course is hereby withdrawn from 2010-2011 academic session.
