  - The deficiencies communicated to the Institute through letter number NRC / NCTE / F-3 / HR-586 / 151 meeting / 2009 / 11906 dated 4 November 2009 still exists.
  - The reply in respect of deficiencies communicated to the Institute through letter number NRC / NCTE / F-3 / HR-743 / 151 meeting / 2009 / 11915 dated 4 November 2009 has not been replied till date.

- 4. Hence, the committee decides to withdraw recognition of B.Ed., D.Ed. and C.P.Ed. Courses from academic session 2010 2011.
