#### ORDER

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 **S. D. College of Education, Vill- Siwah, Panipat, Haryana-132103 (HR-1734)** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed. Course** of **one year** duration with an annual intake of **100 (One Hundred only)** students on **23.07.2008.** 

2. AND WHEREAS, the application was processed and inspection conducted U/s 14 on 08.09.2008 was placed **in Northern Regional Committee137<sup>th</sup> Meeting held from 28<sup>th</sup> Feb, to 01<sup>st</sup> March, 2009 and the Northern Regional Committee decided to issue Show Cause Notice for refusing the recognition to the institution on certain points. Accordingly SCN was issued on 08.03.2009.** 

3.AND WHEREAS, the reply of the institution was considered in  $139^{th}$  NRC Meeting held from  $10^{th}$  to  $12^{th}$  April, 2009 and the Committee decided to refuse the recognition under section14(3)(b) of the NCTE Act 1993 on following points :

CLU is not issued by the competent authority on the prescribed format.

LLU IS HOL ISSUED by the competence development.
 In response to our letter, the State Government recommendation is negative.

Accordingly refusal order was issued on 23/04/2009.

4.AND WHEREAS, the institution preferred an appeal against the said order dated 23/04/2009, and after perusal of documents, memorandum of appeal, affidavit, Vt Report and after hearing oral arguments advanced during the presentation, the Council came to the conclusion that there was adequate ground to accept the appeal and set aside NRC's order dt. 23.04.2009 and remand back the case to NRC for issuing Letter of Intent prior to recognition. Accordingly, the appeal was accepted and the case remanded to the NRC for issuing Letter of Intent prior to grant of recognition under clause 7(9) of the NCTE Regulations vide appeal order dt. 12.02.2010.

5.NOW THEREFORE, the matter was considered in 156<sup>th</sup> Northern Regional Committee meeting held from 22<sup>nd</sup> to 23<sup>nd</sup> Feb, 2010 and the Committee decided that **As per appeal Committee order, LOI for causing inspection prior to 7(9) may be issued.** 

6.AND WHEREAS, the matter was considered in 158<sup>th</sup> Northern Regional Committee 158<sup>th</sup> Meeting held from 19<sup>th</sup> to 22<sup>nd</sup>

April, 2010 and the Committee decided to proceed as per the decision of appeal committee. Accordingly Letter of Intent Prior to recognition was issued on 05.05.2010.

7. AND WHEREAS, the reply of the institution was considered in 163<sup>rd</sup> Northern Regional Committee Meeting held from 29<sup>th</sup> to 31<sup>st</sup> July, 2010 and the Committee decided to issue Show Cause Notice on certain points. Accordingly a Show Cause Notice was issued on 09.09.2010.

8.AND WHEREAS, the reply of the institution was considered in 171<sup>st</sup> Northern Regional Committee held from 28<sup>th</sup> to 29<sup>th</sup> October, 2010 and the Committee decided that the institution needs to clarify the position with documentary evidence on the comments of the Postal Department and send reply on the above points within 30 days. Accordingly a letter was issued to the institution on 13.11.2010.

9.AND WHEREAS, the matter was considered in 173<sup>rd</sup> Northern Regional Committee Meeting held from 24<sup>th</sup> to 26<sup>th</sup> November, 2010 and the Committee decided that the institution be asked to clarify its position with documentary evidences from revenue/Postal Authority and reply within 30 days. Accordingly a letter was issued to the Institution on 10.12.2010.

10.AND WHEREAS, the institution filed a S.B. Civil Writ Petition No. 14644/2010 in the High Court of Judicature for Rajasthan Jaipur Bench, Jaipur was received on 20.12.2010.

11.AND WHEREAS, the matter was considered in 176<sup>th</sup> Northern Regional Committee held from 07<sup>th</sup> to 11<sup>th</sup> January, 201**0** and the matter was earlier placed in Emergency Meeting held from 24-26 December, 2010 wherein inadvertently the matter was deferred for further progress in the case. The matter has now been considered. Since the institution provided a Notarized copy of a letter from the Branch Post Master dated 3.12.2010 addressed to the Regional Director, NRC, Jalpur enclosing therewith a letter from Assistant Supdt., Post, Sub-Division, Panipat addressed to SBM, B.P. Panipat, the same may be accepted as proof of address in terms of the orders of the Hon'ble Court dated 6.12.2010. However, since the original letter addressed to Regional Director, NRC, Jaipur is yet to be received by him, the Regional Director must verify the veracity of the letter dated 3.12.2010 issued to him by the Postal Authority immediately and obtain the original letter addressed to him.

Hence, the Formal Recognition order under clause 7(11) of the NCTE Regulation 2009 for B.Ed. course with an annual intake of 100 students be issued on the usual terms and conditions on submission of original letter dated 3.12.2010 addressed to Regional Director. This letter would need verification from the concerned Postal Authority in due

12.Now THEREFORE, in exercise of the powers vested under section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants/permitted recognition to S.D. College of Education, Vill- Siwah, Panipat, Haryana-132103 (HR-1734)

for B.ED. course of one year duration with an annual intake of 100 students under clause 7(11) of NCTE Regulations subject to the following conditions:-

(i) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.

(ii) Formal order for recognition/permission will operate for 2010-2011 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be

effective from the academic session 2011-2012.

The Institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund in the joint name of an authorized representative of the management and the Regional Director, Northern Regional Committee

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from

time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations.

13. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

14. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

15.If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

16. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

Copy of the Application Form

Land and Building Particulars

Staff Profile

Recognition letter

Information for having fulfilled the norms & standard and other required conditions.

17.In case If the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
